Black Writers Take Places on Picket Lines

HOLLYWOOD (NNPA) - Black writers in this entertainment capital, who make up about three percent of 9,000-member Writers Guild of America, are voicing unequivocal support for a work stoppage against movie stu-

dios and television production companies.

Film and television scribes began picketing studios and production companies Monday morning, after last-ditch talks between the guild and the Alliance of Motion Picture and Television Producers, brokered with a federal

mediator, failed to avert what could be a crippling dispute for the entertainment industry.

After months of contentious negotiations, writers and their employers were unable to reach agreement on a new contract to replace the one that expired midnight Oct. 31. The strike vote

was backed by 90 percent of guild members.

Talks broke down over payments to writers for DVD sales and content shown on computers and new-media devicezs such as cell-phones and video iPods. The last writer's strike, in 1988, lasted 22

NAACP-National Urban League, A House Divided During War for Equal Justice

WASHINGTON (NNPA) - On the eve of yet another national march for racial justice this week, the NAACP and the National Urban League appear strange-

ly divided over an important case of alleged racial injustice.

The case involves more than 50 current and former Black workers at the Indianapolis-based Eli Lilly and Co. that employs some 13,000

people. Dozens of African-Americans from Dallas, Atlanta, Memphis and Charlotte have joined a race discrimination lawsuit against the drug maker and nearly 200 others are poised to testify in the case,

appearing to lend credibility to allegations first made in a lawsuit filed last year. The suit accuses the company of hostility toward Black employees, an accusation that Eli Lilly has vehemently

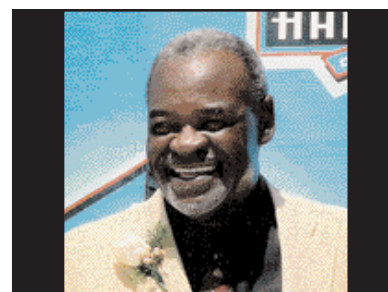

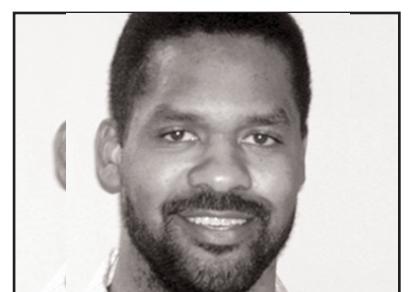

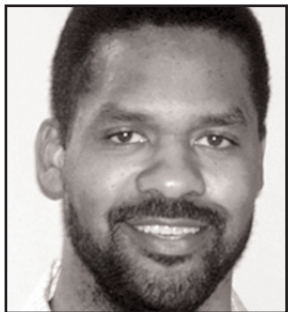

Besieged Somalians Want Ethiopians to Go Home

(GIN) – Ethiopian soldiers who claimed to be defending Somalia's "transitional" government in Mogadishu are facing stepped-up condemnation from Somali elders and

civil society, as fighting escalates and hospitals are overwhelmed.

The clashes pit government forces backed by Ethiopian troops against insurgent remnants of the ousted Union of Islamic Courts and allied clan militias.

"We want a government. We are not refusing a government. But Ethiopians, they are killing our children. They are arresting our people. We cannot support that," said Abdullahi Sheik Hassan, of the Hawiye elders council.

"We are appealing to the international community, particularly to the U.N., to intervene to stop the atrocities being perpetrated in Mogadishu before it is too late," Mohamed Hassan Haad, the chairman of the Hawiye [the predomi-

nant clan] elders' council, told the U.N. news agency IRIN on Nov. 12.

The interim government took power nearly a year ago with the military help of neighboring Ethiopia.

In a related development, hundreds of stone-

throwing Somalis, including women and children, staged a mass protest in north Mogadishu, where an angry mob dragged the dead body of an Ethiopian soldier through the streets on Thursday.

Temporary Protected Status: Liberians Pursue Permanent Life in America

WASHINGTON (NNPA) - Torli Krua of the Universal Human Rights International Group hummed down the street to the beat his penny loafers made as they hit the pavement.

Krua, who was visiting Washington from Boston, was headed to Bethel World Outreach. The church, a spiritual home to a population of Liberians around Washington, was holding a Bible study that Krua did not want to miss.

"I don't want to be late," Krua said, "but today I was at Congress for a meeting about TPS." When the acronym left his lips, he sighed. "I'm sure they won't mind. They're Liberians. TPS is their problem, too." He laughed.

The U.S. grants Temporary Protected Status (TPS) to people

from countries such as Liberia where there was armed conflict, and countries where natural disaster or some other circumstance makes going home unsafe. The special status is an opportunity for foreign nationals to live in the U.S., work, pay taxes, own homes and businesses, and have children.

"No one expected the war to go on for as long as it did," Krua said. "But it did and now you have thousands that are in between two places that they call home."

Last year the seven countries that were assigned the special status were Burundi, El Salvador, Honduras, Liberia, Somalia, and Sudan. Only the Liberians, who number about 4,000, were told that their special status would expire at midnight on September 30, 2007. On September 12, however, President Bush signed a bill that gave the Liberians permission to stay another

18 months and continue working.

Some of the Liberians who have re-assembled their lives in the U.S. are daunted by the possibility that they may be ordered to return to the homeland they fled which remains afflicted with poverty and post-war trauma.

"The new government seems progressive, but so did the old government. The country is still not stable. There's no telling when war will break out again," says 27-year-old Eugene Moore. Moore, who left Liberia in 1996, settled in Virginia after he was granted the special status. "I've made my home here, and I would like to stay."

The Liberians are hoping that the 18-month grace period that President Bush approved will be enough time for them to successfully lobby for permanent residency in the U.S.

"With an 85 percent

unemployment rate, if TPS Liberians were to return, there would be no jobs for them to take care of their children," said Samuel Abu, counselor for public affairs at the Liberian Embassy. "At least if they are continued the opportunity to live and work here, they can send money back home to their families, and slowly help the country to regain its balance."

Abu sighed over the phone, catching his breath from the case he was trying to make. "Liberians here are extremely hard workers. Most of them have denied the welfare wagon and end up making an honest and very good living despite

With 240,000 Liberians, the U.S. has the largest population of Liberians outside of their country.

U.S. Rep. Michael Capuano (D-Mass.) is a co-sponsor of the Liberian Refugee Immigration Protection Act, which has drawn bi-partisan support. The bill would remove the bar that prevents Liberians with the special status from applying for permanent residency.

Aside from winning the immigration lottery (where nationals of other countries receive an opportunity at a U.S. green-card), or marrying an American citizen, the Liberians with the temporary protected status have no other legal path to permanent residency. Employers can file for permanent status for an employee, but they would have to show why the job could not be performed by a permanent resident. The process can cost up to

\$15,000.

"We are literally in between a rock and a hard place," Moore said. "I cannot comfortably live here from stress of having to pack up at any time and return. But I barely know the country that I left 10 years ago."

Liberia, slightly larger than the state of Tennessee at 44,548 square miles, has a population of 2.8 million people. The West African country was settled by the American Colonization Society in 1821 for former slaves. The conflict between those settlers, later known as Americo-Liberians, and the indigenous people that they met in the land, are believed by many to have been at the root of the Civil War that devastated the country during the 1990s.

Evicted White Farmers Threaten Class Action Suit

(GIN)-White commercial farmers whose lands were confiscated by Zimbabwean Pres. Robert Mugabe for allocation to Blacks, are stepping up their fight to recover their properties.

An organization claiming to represent 4,300 White farmers says it will move the case to Tribunal of the Southern African Development Community

(SADC).

The SADC Tribunal was launched in 2005, and has a mandate to ensure that member countries adhere to the rule of law.

The move comes in the wake of a Zimbabwean Supreme Court ruling that gives the government rights to acquire all farming equipment and machinery belonging to the dispossessed Whites.

President Robert

Mugabe launched a fast-track land reform program in 2000, but was unable until now to take title to the farming equipment and machinery the whites left behind. The equipment will become part of a program billed as the "The Mother of All Farming Seasons", under the newly-created Agricultural, Engineering and Mechanisation Ministry.

DCHHS Now Offering Flu Shots to the Entire Family

Dallas County Health and Human Services (DCHHS) is now offering the protection of flu vaccinations to the entire family. "DCHHS has received our first shipment of flu vaccine for children through the Vaccines for Children Program (VCF) and are now able to offer the protection of the flu shot to the entire family," stated Zachary Thompson, DCHHS Director.

Recent studies have shown that children less than 2 years old, even healthy children are more likely than older children to end up in the hospital with serious complications if they get influenza. These complications can include pneumonia, dehydration, worsening of long-term

medical problems like heart disease or asthma, encephalopathy, and other bacterial infections, including sinus and ear infections. In some cases, these complications can lead to death. The Centers for Disease Control and Prevention recommends children 6 months of age to age 5 receive the flu vaccine. Those receiving it the first time need two doses four weeks apart.

"Anyone who wishes to protect themselves and loved ones from getting the flu should get the flu shot every year," said Dr. John Carlo, DCHHS Medical Director. "Getting a flu shot is particularly important for individuals at increased risk of having

complications from the flu such as individuals 50 years and older, persons with chronic health conditions, pregnant women, healthcare workers, and all school-age children." "The flu vaccine also would be particularly helpful for those who are traveling this upcoming winter or those who work in confined spaces with others such as the office setting," Dr. Carlo continued. "Further, vaccinating school-age children and children aged 6-35 months offers the best protection against flu not only for these children but also those who may live in their households and who cannot be vaccinated such as children less than 6 months of age."

DCHHS offers flu shots from 8 a.m. to 4 p.m., Monday through Friday on the first floor of the DCHHS building, 2377 N. Stemmons Freeway, Dallas, TX 75207. The Children's Immunization Clinic is also open until 6 p.m. Wednesdays. The cost is \$20 for adults. Seniors with Medicare and children with Medicaid receive their shots for free. While the cost is \$10 for children on their first visit, \$5 for children who have previously visited the clinic, no one will be refused service due to their inability to pay. rejected as being without merit and has promised a prompt and thorough investigation, says Patty Martin, Lilly's vice president for global diversity.

On one hand, the NAACP has become a plaintiff in the discrimination lawsuit, also involving a noose threat, and has participated in protests with alleged victims. On the other hand, the National Urban League is scheduled to give Eli Lilly and several other companies top honors at its 51st Annual Equal Opportunity Day Awards Dinner this week.

Marc Morial, president and CEO of the NUL which prides itself as "the nation's oldest and largest community-based movement devoted to empowering African-Americans to enter the economic and social

mainstream", said in an emailed response to an interview request: "The National Urban League chose to honor Eli Lilly with its Corporate Leadership Award long before we recently learned through press reports that the NAACP had joined a lawsuit against the company."

He added, "We stand by our decision to honor Eli Lilly, which is based on their work with us on efforts to reduce health disparities in a number of our affiliate cities. We respect the NAACP, and share with them a century long commitment to equal employment opportunity. While we express no opinion on the merits of the lawsuit at this time, we also do not dismiss the merits inasmuch as we have not heard directly from the NAACP which we are open to." The divided house

between the two historic civil rights organizations reveals the need for unifying policies among civil rights organizations, says Dr. Ron Walters, director of the African-American Leadership Center at the University of Maryland.

Eli Lilly is listed among a list of corporate financial sponsors of the annual dinner on which awards are sometimes based, says Walters.

"Corporations work like that. You get in trouble over here. You cover your [rear] over here. And this gave them an opportunity to do it by probably big bucks to the National Urban League," Walters says. "And then, the results is that the Urban League gets put into a situation where they can't refuse to acknowledge this. And

so they do it. But, they shouldn't do it because there ought to be an etiquette and understanding in the civil rights community, which says when one organization goes out and launches a principled protest against a company or an entity, then the others should reframe from acknowledging those [companies] until the air clears. There ought to be at least an ethic among them that says that."

NAACP Interim President Dennis Hayes has issued a statement criticizing Eli Lilly, saying, "Discriminatory practices whether in policy or experience should not be tolerated, are against the law and do not make good business sense... Companies have much to lose by improperly addressing offensive behavior of staffers and fostering a

culture of unequal treatment."

Plaintiffs in the lawsuit say that the company has many racial "minority" friendly policies but that they were rarely applied.

At least one incident involves a noose threat. Lead plaintiff Cassandra Welch had worked for the company 12 years when she was fired in 2004 after complaining to Lilly's human resources department about alleged discrimination by several managers.

Welch said she found a Black doll with a noose around its neck after raising complaints, according to the NAACP statement, which also said Welch was fired after being accused of sending falsified e-mails to a co-worker about non-Eli Lilly business.

At NNPA press

time this week, the NUL had given no indication that it is considering withdrawal of the award to Lilly, slated to be made on Thursday, Nov. 15.

That's the night before a coalition of major Black organizations have planned a protest march on the United States Department of Justice against a rising level of racial violence, hate expressions and unequal justice toward African-Americans across the nation.

"You have a conflict here between the organizational interests and the coalition interests," says Walters, "all of whom are working together for the interest of the whole community."

Of Morial's silence on the issue, Walters says, "He's out there on this one. There isn't a good response."

Seven Possible Do's When Foreclosure Looms

1. Sell the property: If you can find a buyer before the house is auctioned, you can sell it and keep whatever equity still exists.

2. Work out a deal: Your lender may be willing to work with you, rather than lose money at a foreclosure sale.

3. Refinance with a subprime lender: Your credit is poor right now because of the mortgage delinquencies. This means most or all of the traditional banks will not work with you. However, if there is equity in the property, you may be able to find a lender who will refinance you -- at a higher-than-normal rate. These are called subprime loans. These are risky so read everything carefully.

4. File Chapter 7 bankruptcy: If you can't get caught up in time, you will not be able to keep the house -- but you'll general-

ly be able to delay the foreclosure sale a month or even several months. Any remaining debt to the lender will be wiped out.

5. File Chapter 13 bankruptcy: If you can afford to make the future mortgage payments and the delinquent payments, too, file for a Chapter 13 bankruptcy. This is different than Chapter 7, in which assets are liquidated but debts are wiped clean. With Chapter 13, you keep your assets and, under court supervision, you repay your debts under a three-to-five-year plan.

6. Short sale/deed in lieu of foreclosure: A short sale takes place when the bank allows you to sell your property even though their mortgage won't be paid. Be careful -- the bank may allow the sale to go through, but only on the condition that you repay the deficiency. In a deed in lieu of foreclosure, the

property is signed over to the bank in exchange for the bank giving up its rights against you. Lenders spend close to or more than \$30,000 to foreclose on a property. Most lenders will consider these options to avoid foreclosure costs.

7. Walk away from the house: Pack your things and leave. The only issue remaining is whether your lender can sue you for any deficiency still owed after the sale, and that depends on the type of mortgage you have. Talk to a lawyer first.

Any sale or transfer of property has tax consequences, including a foreclosure sale or a deed in lieu of foreclosure. Seeing an accountant is a good idea.

Here are two options NOT to consider. In other words, they're scams.

1. Signing over your property title to another company: Some companies say that after the mortgage

is current they will re-sign the property back over to you. This rarely happens. Instead, the company is likely to pull out equity, not make any mortgage payments and allow the property to be foreclosed. You will not be able to save the property from future foreclosures because the property is no longer in your name.

2. High-interest second mortgage: When a property has equity, there are companies that will give you a second mortgage, in an amount as high as 70 percent of the equity available. The interest rate could be as high as 18 percent and the fees can be exorbitant. They are hoping that you'll blow the money and default -- which allows them to take the property from you.

Justice Department, led by Al Sharpton and others, to further illustrate the injustice against Blacks vis-à-vis hate crimes and nooses. The Megan Williams (Logan, West Virginia) kidnapping and torture will be highlighted as well.

A "Back to Jena" effort may soon take legs because of what took place after the 40,000 folks who went there for one day returned home. Oh yes, what happened as a result of the "Day of Presence" by Susan Taylor and Michael Eric Dyson in New Orleans on August 29, the 2nd anniversary of Katrina. Anybody heard what the "Now what?" move is?

You see, we have a lot of "What's" on our collective plate, and the establishment is busy doing their "So what?" routine in response to our "Whats?"

So the real question for Black people is "Now what?" Isn't it time we realize that white folks are not going to "make it all better" for us? Don't you think it's time we implemented some new strate-

gies, some substantive strategies rather than mere symbolic actions?

Our dearly departed brother, Ken Bridges, pointed out a few years ago that a march is an event, not a movement.

Will we keep doing the same things every time something happens that we don't like, all the while expecting something different from those against whom we demonstrate? Will we stay with our one-dimensional strategy or move to a multi-dimensional strategy? Will we ever move from events to the institutionalization of economic freedom for Black people in America?

Believe me, this is not a diatribe against marching or against Blackout Days or Gas-out Days. The brothers and sisters that organize these events, and especially those who participate in them, make the sacrifices necessary for their success. But if the "success" of marching is not followed by the success of some kind of collective action, we will have simply

allowed the answer to the "What?" question to be "So what?" If it all ends at that point, we have accomplished little beyond a symbolic gesture to demonstrate how angry we are about our treatment in this country. Are you willing to settle for that? Or, are you willing to take the next step, after the march, to demonstrate not just how angry you are but how serious you are?

The only things taken seriously in this country by those in charge are money and power. If Black people are not willing to use the power of our dollars to attain true freedom in this country, all the marches and protests in the world, from now until eternity will not, in and of themselves, change the status quo.

I reiterate the two things we can do: Work collectively on withdrawing your local dollars from entities that do not support you (Blackout), and then re-channel those dollars, or a portion thereof, to Black businesses (Black-in).

When we show folks that

we are willing and able to put them out of business by not buying their products, their behavior toward us will change. More importantly, when we spend more with our own businesses they will grow and create more jobs for our people.

The other thing we must do, in cases like Jena and Megan Williams and all the rest, is target some national company or companies and refuse to buy their products until they step into the fray and take a public stand against injustice on our behalf. Stop trying to extort money from them; that's not going to solve our problem. But, believe me, if a major company is hurting just a little bit, because we have withdrawn our dollars, it will speak out and demand an end to our mistreatment.

One thing the rulers of this country believe, although they misunderstand Solomon's point is, "...money is the answer to everything." Ecclesiastes 10:19

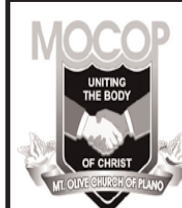

weeks and was estimated to have cost the industry more than \$500 million.

Veteran TV comedy writer and playwright Michael Ajakwe, whose credits include "Martin," "The Parkers," "Soul Food" and "Eve," said he backed the strike "one-hundred percent."

"I think the Guild leadership has shown a lot of courage because the producers just don't seem to value what we do," he said. "Writers have made financial concessions in the past, but this time we have to fight. It is going to be hard - and as black writers we have our own issues with diversity - however, this is one time when we're all on the same page."

A guild member for twenty years, Ajakwe was on the picket lines Tuesday afternoon outside Paramount Studios on Melrose Avenue. He

revealed that a couple of potential feature movie script sales might now be in jeopardy because of the strike.

"Those projects are now on hold," he said. "The companies are trying to paint us as greedy, but we're not. We need each other and everybody can get their fair share."

Another guild member, screenwriter Takashi Bufford, who penned the 1996 movie "Set It Off" starring Queen Latifah and Jada Pinkett-Smith, was more forthright.

"The Guild made significant concessions in '88 and now they want to offer us crumbs off the table," he said. "We're trying to get a simple, legal principle established that if a writer's work is to be exploited in the new mediums, then they should get a piece of the action."

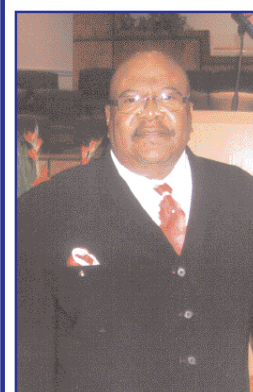
