## Obama Wins Most Texas Delegates

WASHINGTON (AP) — Sen. Barack Obama has won the overall delegate race in Texas thanks to a strong showing in Democratic county conventions this past weekend.

Obama picked up seven of nine outstanding

delegates, giving him a total of 99 Texas delegates to the party's national convention this summer. Sen. Hillary Rodham Clinton won the other two, giving her a total of 94 Texas delegates, according to an analysis of returns by The Associated Press.

Texas Democrats held both a presidential primary and caucus. Clinton narrowly won the popular vote in the state's primary March 4, earning her 65 national convention delegates to Obama's 61.

## Condoleezza Rice on Race

(Washington Times) Secretary of State Condoleezza Rice said yesterday that the United States still has trouble dealing with race because of a national "birth defect" that denied black Americans the opportunities given to whites at the country's very founding.

"Black Americans were a founding population," she said. "Africans



and Europeans came here and founded this country together — Europeans by choice and Africans in chains. That's not a very pretty reality of our founding."

As a result, Miss Rice told editors and reporters at The Washington Times, "descendants of slaves did not get much of a head start, and I think you continue to see some of the

effects of that."

"That particular birth defect makes it hard for us to confront it, hard for us to talk about it, and hard for us to realize that it has continuing relevance for who we are today," she said.

Race has become an issue in this year's presidential campaign, which prompted a much-dis-

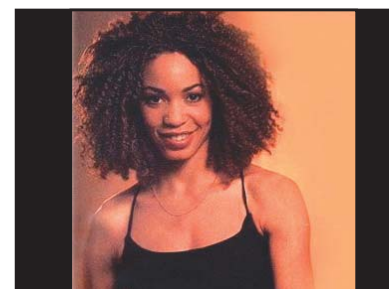

## Reuben R. Rogers

Reuben R. Rogers' ability to transport the emotion of a piece into his accompaniment is akin to that of a fine woven tapestry, creating a blanket of rhythm and harmony that is welcomed by vocalists and instrumentalists alike. From a hard-hitting groove to a featherlike touch, with each interjection, Rogers echoes



an affirmation of the soloist's statement, rendering a musical conversation in which the narrative is smoothly passed.

Born November 15, 1974, and raised in the Virgin Islands, Rogers was exposed to varieties of music that included Calypso, Reggae, Gospel and Jazz. In his formative years, Rogers received encouragement from his parents to

explore his exceptional musical talent. He began with the clarinet, experimented with the piano, drums and guitar, yet at the tender age of 14 found his true passion in the bass.

Rogers' potential was well recognized by numerous awards, grants and scholarships from the St. Thomas Arts Council and other local organizations. This in turn opened the door for

Rogers' summer studies at Interlochen Arts Camp in Michigan and in Boston at Berklee College of Music. Upon completion of their five-week summer program, Berklee awarded Rogers a scholarship toward his degree studies. He earned his Bachelor of Music in 1997 from Berklee College of Music.

Rogers' peers continue to influence and enrich

his musical style and direction. He has toured extensively all over the globe, and has recorded on over 60 CDs.

Ever committed to supporting the arts in the Virgin Islands, Rogers returns when his schedule permits to conduct music workshops in local schools and organize fundraising concerts that benefit the education of today's island youth.

## Don Braden

A native of Cincinnati, Ohio (and a former Harvard University Engineering student),

saxophonist/composer/educator Don Braden has toured the world with jazz greats Betty Carter, Wynton Marsalis, Tony Williams, Freddie Hubbard, Roy Haynes, and many others. He has recorded on nearly fifty CDs as a sideman and has produced thirteen CDs as a leader, the latest of which is "Workin'", released in 2006 on the HighNote



label. He has composed music for countless concerts, for all of his CDs and for a number of independent films; plus he spent four years as composer for the CBS sitcom "Cosby" and has written for "Little Bill." In 2000, he was one of the recipients the Doris Duke Foundation New Works composer's grant.

Braden's first exposure to music came from his parents' record collection, and from radio. Although there were no musicians in his family, he showed a strong interest in music early on. At age 13, he started playing

tenor sax in middle school band class, and two years later, joined his first professional band -- influenced by and performing the music of "contemporary jazz" groups, like The Crusaders. After being introduced to acoustic jazz in high school, Braden went on to be chosen first chair for the McDonald's All-American High School Jazz Band and the McDonald's All-American High School Marching Band, and to receive a Yamaha Instrument Award.

He works extensively as an educator, teaching for

Litchfield Performing Arts, the

New Jersey Performing Arts Center, and the Prins Claus Conservatoire in Groningen, Holland. He

worked for eight years as an adjunct professor at William Paterson University, and has been a guest clinician at many other schools. His web site is [www.DonBraden.com](http://www.DonBraden.com).

## Cindy Blackman



Born in Ohio and raised in Connecticut, Cindy began her musical career as a New York street performer. She spent three semesters at Berklee College of Music in Boston, Massachusetts and also studied with legendary teacher Alan Dawson. Cindy moved to New York City in the 80's and since that time, she has been seen and heard by millions of people all over the world performing with her own group and during her 11 year stint with retro funk rocker Lenny Kravitz, since 1993.

In 1998, Cindy released her first drumming

instructional video entitled, "Multiplicity" through Warner Brothers publications.

Cindy has been touted as "one of the hottest drummers in the business, by the Star-Gazette and is regarded as one of the top drummers in the world. She is a solid, dependable drummer who can easily move from straight-ahead jazz to rock to funk and back again.

She's upheld the backbeat and created texture for a veritable "Who's Who" in jazz: Jackie McLean, Joe Henderson, Don Pullen, Hugh Masekela, Pharaoh Sanders, Sam Rivers, Cassandra Wilson, Angela Bofill, Bill Laswell, Buckethead.

In early 2000, Cindy released the acclaimed solo album entitled "Works On Canvas." She released her seventh solo release "Someday" in 2004.

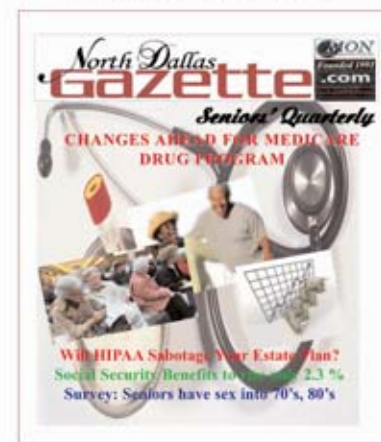

## Changing America- Asking More Of Yourself

On March 1, 1968 the bipartisan National Advisory Commission on Civil Disorders issued its final report to the American people. The report's conclusion was a succinct but memorable message: "our nation is moving towards two societies - one white, one black - separate and unequal."

In 1967, significant racial violence erupted in 126 American cities with 75 of the incidents considered major riots. The riots that were turning such cities as Los Angeles, Newark, Detroit and Cleveland into racial battlegrounds were even more troubling since in the years before the riots some of the most significant civil and voting rights reforms in the nation's history had been signed into law.

Answers were needed. President Lyndon B. Johnson responded by appointing the National Advisory Commission on Civil Disorders on July 28, 1967. Better known as the Kerner Commission (its Chairman was Illinois Governor Otto Kerner) the panel of eleven experts was mandated to seek the truth in determining what had happened, why the riots had occurred, and what could be done to prevent similar events from happening again.

The commission's controversial 1968 report was brutally honest. It rejected the highly anticipated notion that black militants or any other organizations were responsible for the riots. Instead it concluded that the riots resulted from devastating poverty, hope-

lessness and limited opportunity that had long permeated America's urban ghettos.

Among their many findings: One in five African-Americans lived in squalor and deprivation in ghetto neighborhoods; the unemployment rate was double for African-Americans, as compared to whites; ghetto communities were neglected by the government, wracked with crime, and traumatized by police brutality; rates of African American infant mortality were triple the rate of white children.

The statistics weren't new. But the Kerner Commission laid the blame for many of these conditions on white racism stating, "What white Americans have never fully understood -- but what the Negro can never forget -- is that the white society is deeply implicated in the ghetto. White institutions created it. White institutions maintain it and white society condones it." Institutional racism was the culprit.

So where does America stand 40 years after Kerner? A report by the Washington, D.C. based Eisenhower Foundation updating the Kerner study confirms that progress has been made but gaps remain between blacks and whites in poverty, education, crime and unemployment.

The black middle class has grown. There are more opportunities for jobs and education. Yet some employers still steer minority applicants into the worst jobs; real estate agents send

them to less desirable neighborhoods and mortgage lenders accept fewer applications from minorities than from similarly qualified whites. The wealthiest 10 percent of school districts in the United States spend nearly 10 times more than the poorest 10 percent. African-American unemployment has remained twice as high as white unemployment during each of the four decades since 1968.

The poverty rate for blacks has dropped to about 24 percent but that is still three times the white rate. Minorities receive longer sentences than whites for the same crimes.

In spite of the obvious progress that has been made in our diverse society there is still unease in many areas, an unease that does not bode well for America.

Instead of resolving the black and white disparity described in Kerner's 1968 America we must now deal with quadruple racial societies overlaid with gradients of gender, sex and class. This adds additional complexity to the search for equitable solutions.

Experience has shown that throwing money at problems does not solve them since corrupt politicians control the ultimate distribution of funds. The result is added frustration for the aggrieved as they become encumbered by another layer of hopelessness precipitated by a perception that the system is denying equal economic, political and social opportunity.

But the beauty of

America is that the majority in this country-- black and white, rich and poor-- see within this imperfect nation a potential much greater than what had been. And the journey has begun to take this country beyond the limitations of its divisions and distrusts in order to achieve the promise embedded in its constitution.


However, the journey is not yet complete. For those that realize this the question becomes, "What are you doing about it?" What are you doing to preserve your right to live in this great country? If you are going to sit back and be a spectator who simply points an accusing finger then America will quietly append the list of great empires of the past.

This challenge is not about the President. It's not about the Congress. It's about each of us individually seeking the common goals that uplift us instead of the divisive goals that separate us. If you are willing to ask more of yourself and participate in the fight and the struggle then there is hope that America will again become a nation of "we the people" instead of "we the few", a message that was so eloquently articulated in Obama's "More Perfect Union" speech on March 18, 2007.

This is the doorway to the America of our dreams.

# Congresswoman Waters Receives Prestigious Award In South Africa

Pretoria, South Africa – South African President Thabo Mbeki presented Congresswoman Maxine Waters (CA-35) with the “Order of the Companions of OR Tambo Silver Award,” one of the most prestigious awards granted by the South African government. Congresswoman Waters received this great honor because of her work on behalf of the people of South Africa throughout her career, especially her role in fighting against the former apartheid regime in South Africa.

“I am deeply honored to receive South Africa’s most prestigious award, the Companion of OR Tambo. I thank President Mbeki for recognizing my contribution to ending

apartheid. This is a day I will never forget,” said



Waters during the presentation ceremony.

Throughout the 1980s, Congresswoman Waters organized marches and rallies in Los Angeles to protest the racist system of apartheid in South Africa. She led sit-ins at the South African consular office in

Los Angeles and put her own freedom on the line when she was arrested for protesting the apartheid regime in front of the South African Consulate in Washington, D.C.

In 1986, as a member of the California Assembly, Rep. Waters called for the divestment of funds from corporations doing business with South Africa’s apartheid regime and helped to make the call for divestment a national movement sweeping from state to state and city to city. She did this by authoring Assembly Bill 134, to divest a record \$12 billion from public pension funds in California, thus fortifying California’s opposition to the apartheid regime.

In 1990, when ANC

leader Nelson Mandela made an 8-city tour of the U.S., Rep. Waters chaired the welcoming committee that greeted him and his wife Winnie Mandela with a motorcade to City Hall, a Hollywood star-studded reception, and a 6-hour concert and rally attended by 90,000 supporters.

The following year, Rep. Waters traveled to South Africa for the first time to attend the ANC national conference in Durban, South Africa, the first ANC conference since the unbanning of the ANC and Nelson Mandela’s release from prison. Three years later, following the dismantling of apartheid and South Africa’s first democratic elections, she was a member of the official U.S. del-

egation to attend the inauguration of President Nelson Mandela in Pretoria.

Congresswoman Waters continued her efforts to expand and improve debt relief programs for poor countries through legislation and public advocacy. In 2005, she and other debt relief advocates convinced the leaders of the G-8 creditor nations to completely cancel the debts of over twenty of the world’s poorest countries. Last year, she introduced H.R. 2634, the Jubilee Act for Responsible Lending and Expanded Debt Cancellation. This bill would expand existing debt cancellation programs and ensure that the benefits from debt cancel-

lation will not be eroded by future lending to these impoverished nations. This bill now has 98 cosponsors.

Congresswoman Waters also leads congressional efforts to address the HIV/AIDS epidemic, which infects over 18% of the adult population of South Africa. She is currently the Co-Chair of the CBC Task Force on HIV/AIDS. She has introduced legislation to allow people in developing countries like South Africa to have access to generic HIV/AIDS drugs at affordable prices, and she is working with her colleagues to increase funding for international HIV/AIDS treatment and prevention programs.

Precinct caucuses began immediately after polls closed primary night and quickly devolved into chaos in many parts of the state because of an unprecedented turnout of

more than 1 million Democrats. The state party was never able to provide complete results from the caucuses, which is why the AP withheld nine delegates.

The precinct caucuses

elected delegates to about 280 county and state senate district conventions on Saturday. The AP awarded the remaining delegates based on results from Saturday’s conventions, showing Obama with

about 58 percent of vote, compared to 42 percent for Clinton.

Obama won 38 delegates through the caucus/convention system, and Clinton won 29.

The final delegate allo-

cation will be decided at the party’s state convention June 6-7, and the numbers could change if either campaign is unable to maintain the level of support they had over the weekend.

Obama leads the overall

race for the Democratic nomination with 1,631 delegates, including separately chosen party and elected officials known as superdelegates. Clinton has 1,501, according to the latest AP tally.

cussed speech last week by Sen. Barack Obama, one of the two remaining contenders for the Democratic nomination.

Miss Rice declined to comment on the campaign, saying only that it was "important" that Mr. Obama "gave it for a whole host of reasons."

But she spoke forcefully on the subject, citing personal and family experience to illustrate "a paradox and contradiction in this country," which "we still haven't resolved."

On the one hand, she said, race in the U.S. "continues to have effects" on public discussions and "the deepest thoughts that people hold." On the other, "enormous progress" has been made, which allowed her to become the nation's chief diplomat.

"America doesn't have an easy time dealing with race," Miss Rice said, adding that members of her family have "endured terrible humiliations."

"What I would like understood as a black American is that black Americans loved and had faith in this country even when this country didn't love and have faith in them — and that's our legacy," she said.

Miss Rice also said that what "attracted" her to candidate George W. Bush during the 2000 presidential campaign was not foreign policy, but his "no child left behind" initiative, which she said gave equal opportunities to black and white students.

The proposal, much criticized by Mr. Obama and his Democratic rival Sen. Hillary Rodham Clinton, has been successful, Miss Rice said.

# HUD Secretary Jackson Resigns Amid Probe

WASHINGTON (AP) — HUD Secretary Alphonso Jackson, his tenure tarnished by allegations of political favoritism and a criminal investigation, announced his resignation Monday amid the wreckage of the national housing crisis. He leaves behind a trail of unanswered questions about whether he tilted the Department of Housing and Urban Development toward Republican contractors and cronies.

The move comes at a shaky time for the economy, with soaring mortgage foreclosures imperiling the nation's credit markets.

In announcing that his last day at HUD will be April 18, Jackson said only, "There comes a time when one must attend more diligently to personal and family matters."

Some Congressional Democrats had pushed for him to leave.

House Speaker Nancy Pelosi, D-Calif., said HUD will be called on to work with Congress on assisting refinancing for borrowers faced with imminent foreclosure.

The ethical allegations against Jackson "meant that the Bush administration's ineffective housing policies were being burdened by an even more ineffective HUD Secretary," Sen. Patty Murray, D-Wash., said after Jackson's announcement.

President Bush called Jackson "a strong leader and a good man." Ties between the two men go back to the 1980s when they lived in the same Dallas neighborhood. It was Jackson's personal ties to Bush that brought him to Washington, where he displayed a forceful personal style at HUD for seven years, first as the agency's No. 2

official and since 2004 in the top slot.

those in need, Jackson was capable of ill-advised public comments.

Last year, after the subprime mortgage crisis erupted, many policy-makers underlined the disproportionate impact of the high-risk, high-cost mortgages on minorities and the elderly, who often are targets of predatory lending practices that lure people into loans they are incapable of repaying.

Asked about the problems with subprime mortgages last June, Jackson insisted that many such borrowers were not unsophisticated, low-income people but what he called "Yuppies, Buppies and Guppies" — well-educated, young, black and gay upwardly mobile achievers — with expensive cars who bought \$400,000 homes with little or no money down.

In announcing his departure, Jackson said that in his time at HUD, "We have helped families keep their homes. We have transformed public housing. We have reduced chronic home-

ship."

Bush has been cool to the idea of a big federal housing rescue. "The temptation of Washington is to say that anything short of a massive government intervention in the housing market amounts to inaction," the president said recently. "I strongly disagree with that sentiment."

On Monday on his way out of the country for a trip built around a NATO summit, Bush said he wants Congress to modernize HUD's Federal Housing Administration, allowing more struggling homeowners to refinance their mortgages.

In October, the National Journal first reported on the criminal investigation of Jackson. The FBI has been examining the ties between Jackson and a friend who was paid \$392,000 by Jackson's department as a construction manager in New Orleans. Jackson's friend got the job after Jackson asked a staff member to pass along his name to the Housing

Authority of New Orleans.

In another instance of alleged favoritism that came to light in February, the Philadelphia housing authority alleges that Jackson retaliated against the agency because it refused to award a vacant lot worth \$2 million to soul-music producer-turned-community developer Kenny Gamble for redevelopment of a public housing complex.

Jackson's problems began in 2006, when he told a group of commercial real estate executives that he had revoked a contract because the applicant who thanked him said he did not like President Bush. Jackson later told investigators "I lied" when he made the remark about taking back the contract.

The probe of Jackson's comment by the HUD inspector general ended with no action taken against him, but the investigators brought to light friction between the HUD secretary and some contractors who have long done business with the agency, a number of them donors to Democrats.

In the IG probe, some of Jackson's own aides contradicted his account of one incident in which investigators found the HUD secretary had blocked a contract for several months to one heavily Democratic donor. Jackson blamed his aides for the delay in the award.

Jackson was the first black leader of the housing authority in Dallas, where his integration efforts caused clashes with some local homeowners in predominantly white neighborhoods.

## Advancement Project Applauds Resignation Of HUD Secretary Alphonso Jackson

Advancement Project, a national racial justice organization that brought a lawsuit against U.S. Department of Housing and Urban Development (HUD) Secretary Alphonso Jackson on behalf of public housing residents in New Orleans who were shut out of their homes after Hurricane Katrina, is pleased to learn the Secretary is resigning, effective April 18. Secretary Jackson's announcement comes amid allegations of impropriety and favoritism at the agency, including a federal criminal investigation into contracts Jackson awarded after Katrina relating to New Orleans public housing. While the hurricane caused the worst affordable housing crisis in recent history, HUD responded by demolishing thousands of habitable public housing apartments and devising a redevelopment plan to replace less than 20 percent of the units. Consequently, a majority of the public housing families remain displaced and New Orleans' homeless population is double what it was before Katrina.

Alphonso Jackson will be most remembered for having turned his back on the people of New Orleans. We are glad to see him go, but the damage has been done. The people suffering, without a place to call home, are the people of New Orleans; the thousands of families who lived in public housing before Katrina and the working poor, many of whom remain displaced outside the city they used to call home.

While it is HUD's mission to provide affordable housing across the country, the exact opposite took place in the recovery and rebuilding of New Orleans. It therefore comes as no surprise that Jackson is under criminal investigation for his post-Katrina dealings. HUD agents, city officials, and developers appeared to have colluded in the largest Black removal in U.S. history. HUD's intent in New Orleans was never to bring back the majority-black and working poor residents of New Orleans. In the storm's aftermath, when Jackson said that 'New Orleans was not going to be as black as it had been for a long time, if ever again', we realized that we had to fight for people's right to return home.

In addition to the lawsuit filed by the Advancement Project, residents organized themselves and met with members of Congress, including Representative Maxine Waters (D-Calif.), who took the lead to pass the Gulf Coast Hurricane Housing Recovery Act of 2007 in the House. The legislation, opposed by HUD and now stuck in the Senate, would provide for one-for-one replacement of demolished units.

Secretary Jackson's resignation and tarnished tenure as the nation's housing chief should be a call-to-action for HUD to reverse decisions made in New Orleans and the Gulf Coast. With the change in leadership, HUD now has the opportunity to fulfill its mission and provide affordable housing for families who are still in desperate need.

## Sean Levert, One-Third of the 1980s R&B Trio LeVert, Dies at 39

### Family Requests FBI Investigation

CLEVELAND (AP) - Sean Levert, one-third of the 1980s R&B trio LeVert and a son of the lead singer of the O'Jays, Eddie Levert, died on Sunday after falling ill while serving a jail term at the Cuyahoga County jail where he was locked up for not paying child support. He was 39. The family of the R&B singer wants the FBI to look into his death after a



jail medical emergency.

His cousin, Michael Gibson, says Levert never had any kind of outburst like the kind he the jail warden described.

The warden says Levert was pounding on his cell door so guards strapped him in a restraint chair. The warden says his breathing became shallow and he was taken to the hospital.

An autopsy was incon-

clusive about a cause of death, according to the Cuyahoga County coroner's office, but foul play has been ruled out. He died at Lutheran Hospital in Cleveland late Sunday, less than an hour after he was taken there from the jail, said the coroner, Frank Miller. Mr. Levert was sentenced last week to one year and 10 months in jail for failing to pay \$89,025

in child support.

FBI spokesman Scott Wilson says agents would meet with Levert's family.

Sean and Gerald Levert formed LeVert in the 1980s with a childhood friend, Marc Gordon. Their hits included "Baby I'm Ready," "(Pop, Pop, Pop, Pop) Goes My Mind" and "Casanova." "Casanova" was nominated for a Grammy in 1988 for best

R&B performance by a duo or group with vocal. It was also nominated for best R&B song.

Gerald Levert had success as a solo artist after leaving their trio; he died in 2006 at age 40 of an accidental mix of prescription and over-the-counter drugs.

Sean Levert found a new partner last year and was trying to revive the group.

## Texas Boasts Top 10 Economy In National Ranking

WASHINGTON, DC—In the American Legislative Exchange Council's (ALEC) first economic ranking of all 50 states, Texas, with no income or inheritance tax, low business taxes, low minimum wage, "right-to-work" status, and recently enacted tax cuts, was ranked as the 10th best state in the country. The report, RICH STATES, POOR STATES: ALEC-Laffer State Economic Competitiveness Index, was a collaborative effort from authors Dr. Arthur Laffer, nationally recognized economist, and Stephen Moore of the Wall Street Journal.

According to the authors, Texas was also ranked number one in terms of economic performance and has attracted almost 700,000 residents of other states

since 1997, a net domestic migration. The state could improve its competitiveness by lowering its property and sales taxes, improving its tort liability system, and reducing workers' compensation costs.

The authors identify 16 policy variables with a proven impact on the migration of human and investment capital in and out of states. According to their findings, a record eight million Americans moved from one state to another last year, revealing which states have the most dynamic and desirable economies, and which are "has-been" states. The winners in this contest are generally the states with the lowest tax, spending and regulatory burdens. The biggest losers are California, the Northeast, and the Midwest.

"The historical evidence is clear: States that keep spending and taxes low exhibit the best economic results, while states that follow the tax-and-spend path lag far behind. Today, many states stand at a crossroads, and it will soon become apparent if lawmakers choose to use history as a guide for their actions. No state has ever taxed its way into prosperity. This is not about Republican

versus Democrat, or left versus right. It is simply a choice between economic vitality and economic malaise," said Jonathan P. Williams, Director of ALEC's Tax and Fiscal Policy Task Force.

taught among all of today's athletes. He shared his thoughts and expressed his feelings in a way that assured us he understands what life is all about, which includes an obligation to "give something back."

Theda Rudd, Professor at Michigan State University and Business Consultant, painted a vivid picture of her life, which included the untimely death of her 33 year-old husband, during her pregnancy, and all of the issues she faced immediately thereafter. Her story is one that moved from trials to tragedy but ultimately ended in triumph because she refused to give up and was dedicated to carrying on the legacy of her husband's hard work to build a franchise business. I told her there's a great book inside of her waiting to be written. Keep an eye out for this sister.

Dr. Boyce Watkins, "The People's Scholar," Professor at Syracuse University, and regular guest on nightly news shows, is a refreshing young brother who is unafraid and unwavering in his "callouts" to awaken our people. He also gets in the faces of those "conservative" talk show hosts; he doesn't allow them to talk-over his response, take him off track, or twist his words. It was an emotional moment and a special moment because Dr. Hilliard's wife, Patsy Jo, was in attendance. Haki's words, written for that special occasion, were absolutely beautiful.

Nowhere else can you get a line-up like that, along with educational workshops, entertainment by four of the best soloists and spoken word artists I have ever heard, and great food and fellowship.

I felt so blessed to be in the company of those in attendance, and even after the conference was over many of us convened to listen to Baba Serikali and witness the talents of his young "men" as they demonstrated

their Marshall Arts skills, their discipline, their Black consciousness, and their educational acumen.

I appreciate the opportunity they gave me to speak, especially Dr. Thomas Scott (Brother K) who recommended me. I also appreciate now being added to the "Hall of Fame" list of past speakers. Just go to the website (<http://louisville.edu/edu/bfa/>) and you will see what I mean.

Finally, but certainly not in the least was the pleasure and honor of meeting Dr. Joseph McMillan and his family. At 80 years of age, yes, slowed down a little by illness and other issues in his life, was there every morning bright and early, ready to "start on time."

He is a man among men and a glowing example of staying in the race, determined to finish his course. Despite obstacles that would make most of us give up, Dr. Mac seems to thrive on challenges and has a history of turning stumbling blocks into stepping stones. It is to him that I owe my deepest gratitude for allowing me to be a part of this historic national conference.
