U.S. Sen. Barack Obama has won enough pledged and super delegates and has seized the Democratic presidential nomination. By doing so, he has defeated Sen. Hillary Clinton by becoming the presumptive Democratic nominee and the first African-American to be nominated for the U. S. presidency by a major party.

HIV/AIDS Numbers Decline, Many Not Convinced

HIV rates are declining in prison, according to the U. S. Bureau of Justice Statistics, but AIDS activists paint a different picture of the disease's prevalence both in and out of prison.

Laura M. Maruschak, a statistician for Bureau, studied statewide HIV rates for 2005 and 2006, and found that the number of HIV positive prisoners decreased by a little more than three percent (from 22,676 to 21,980). Despite this drop, the overall

AIDS rate among pris-

oners was 0.46 percent compared to 0.17 percent for the U.S. general population.

The report, "HIV in Prisons 2006," further indicated that the number of AIDS-related deaths in state and federal prisons dropped to 167 from 203; and the states with the

largest numbers of AIDS related deaths were Florida (28), New York (14), Pennsylvania (13), Georgia (10) and Louisiana (10).

The data does not include information on the flow of HIV positive inmates in and out of pris-

Dallas County Health officials Announce Salmonella Investigation

Dallas County Health and Human Services feder (DCHHS) is assisting with an multi-state investigation of an outbreak of relatively rare species of Salmonella bacteria efforknown as the Saintpaul for

strain. DCHHS epidemiologists are working in partnership with multiple federal, state and local agencies to identify the source of the outbreak.

"DCHHS epidemiologists are coordinating our efforts with the Centers for Disease Control

(CDC), U.S. Food and Drug Administration (FDA), the Food and Safety Inspection Service (FSIS), Texas Department of State Health Services and local health departments from across Texas to pinpoint the exact source of the implicated

tomatoes," said Zachary Thompson, DCHHS Director.

To date, there have been 21 cases of the Saintpaul strain of the Salmonella bacteria reported in Texas. The majority of these cases have been reported in Harris County but a few



Dr. Treadwell's special interests include projects which enhance the human growth of young people, activities which "stimulate the development of grassroots indigenous leadership, and projects that strengthen the infrastructure of neighborhoods and communities." She wants to improve the quality of

This prolific writer, scholar and administrator has received many fellowships and is a member of many professional organizations such as the American Cell Biology Society, American Association for the Advancement of Science and the American Association of University Women. She also is a member of Sigma XI, Omicron Delta Kappa and Phi Eta Sigma honorary society and Delta Sigma Theta sorority.

Bo Diddley

Bo Diddley, a founding father of rock 'n' roll whose distinctive "shave and a haircut, two bits" rhythm and innovative guitar effects inspired legions of other musicians, died Monday after months of ill health. He was 79.

Diddley died of heart failure at his home in Archer, Fla., spokeswoman Susan Clary said. He had suffered a heart attack in August, three months after suffering a stroke while touring in Iowa. Doctors said the stroke affected his ability to speak, and he had returned to Florida to continue rehabilitation.

The legendary singer and performer, known for his homemade square guitar, dark glasses and black hat, was an inductee into the Rock and Roll Hall of Fame, had a star on


Hollywood's Walk of Fame, and received a lifetime achievement award in 1999 at the Grammy Awards. In recent years he also played for the elder President Bush and President Clinton.

Diddley appreciated the honors he received, "but it didn't put no figures in my checkbook."

"If you ain't got no money, ain't nobody calls you honey," he quipped.

His first single, "Bo Diddley," introduced record buyers in 1955 to his signature rhythm: bomp ba-bomp bomp, bomp bomp, often summarized as "shave and a haircut, two bits." The B side, "I'm a Man," with its slightly humorous take on macho pride, also became a rock standard.

The company that issued



his early songs was Chess-Checkers records, which also recorded Chuck Berry and other stars.

Howard Kramer, assistant curator of the Rock and Roll Hall of Fame in Cleveland, said in 2006 that Diddley's Chess recordings "stand among the best singular recordings of the 20th century."

Diddley's other major songs included, "Say Man," "You Can't Judge a Book by Its Cover," "Shave and a Haircut."

Diddley's influence was felt on both sides of the Atlantic. Buddy Holly borrowed the bomp ba-bomp bomp, bomp bomp rhythm for his song "Not Fade Away."

Bo Diddley, a founding father of rock 'n' roll whose distinctive "shave and a haircut, two bits" rhythm and innovative guitar effects inspired legions of other musicians, died Monday after months of ill health. He was 79.Rolling Stones frontman Mick Jagger has paid tribute to guitarist Bo Diddley, describing him as an "enormous force in music".

Jagger, whose band covered the Diddley songs Mona and Crackin' Up, paid tribute to the Mississippi-born musician.

He said: "He was a wonderful, original musician who was an enormous force in music and was a big influence on The Rolling Stones.

"He was very generous to us in our early years and we learned a lot from him.

"We will never see his

like again."

Didley's contribution to music was rewarded in 1999 with a lifetime achievement prize at the Grammy Awards.

Truth Misused Leads To Freedom Abused

Therefore, putting away falsehood, let every one speak the truth with his neighbor, for we are members one of another. (Ephesians 4:25)

If ye continue in My Word, then ye are my disciples indeed; and ye shall know the Truth, and the Truth shall make you free. (John 8:31-32)

cott McClellan's tell-all tome "What Happened: Inside the Bush White House and Washington's Culture of Deception" has created a firestorm of controversy and much discusthat sion auestions McClellan's motivation for writing the book.

As with most controversies there are those that believe Mr. McClellan did the right thing in exposing the Bush administration's lies and others that express outrage since revealing the inner secrets of the White House is perceived as a lack of loyalty that breeches the unwritten code of honor high level government officials are supposed to embrace.

Little if any effort seems to be expended in determining if McClellan is telling the truth. However, true to previous precedent when anyone dared challenge the Bush administration attack squads were quickly deployed to undermine the perpetrator's credibility, loyalty, and patriotism. If you don't like the message, attack the messenger seems to be the administration's response against whistle blowers.

McClellan's book goes beyond the simple expose. He declares that President Bush "convinces himself to believe what suits his needs at the moment," and has engaged in "selfdeception" to justify his political ends. He calls the war in Iraq a strategic blunder and identified the administration's biggest mistake as "a decision to turn away from candor and honesty when those qualities were most needed."

This deliberate distaste

for truth, especially in an administration that champions its Christian foundation, casts an ominous shadow over America, its image, and its future role in orchestrating world affairs.

Now, as in the past, disclosing any truth that rebukes the deceptions and lies of those in power will activate opposition. For ages, those who dared to advocate for truth have been denounced as seditious, heretical, divisive or disgruntled.

Some people have a pattern of lying, often including lying to themselves first. When these people make their way into positions of power they continue their destructive behavior. The only reason they survive is that their deception and lies are rarely publicly identified.

John 3:20 says, "For every one that doeth evil hateth the light, neither cometh to the light, lest his deeds should be reproved." When men see that they cannot maintain their exalted position by perverse interpretation of the scriptures they will revert to malicious acts to assault the character and motives of those who dare to shine the light on their misdeeds. Incredibly, the same people who are being deceived will accept without question the accusations made against the brave souls who demand the truth be told.

What is the duty of the messenger of truth? The truth is not received for the messenger alone but through its revelation the knowledge of God's truth might enlighten the earth.

Leaders Dismayed By Anti-Immigrant Violence

The African continent is "shocked" by the xenophobic attacks in South Africa, declared African Union President Jakaya Kikwete of Tanzania, after a meeting of African heads of state examining the project for a Pan-African government.

Images of looting, burnings, destruction of shacks and beatings of defenseless immigrants from Zimbabwe, Mozambique, Nigeria, Somalia, among other countries, have filled newspapers and television continent-wide. The unexpected violence has left at least 50 dead, hundreds injured and tens of thousands homeless or displaced from Johannesburg and other South African cities.

Speaking out against the attacks, Zambian President Levy Mwanawasa recalled that the freedom of South Africa was achieved as a collective effort by South Africa and its neighboring

countries. He appealed to South Africans to reflect on the unity that is talked about and promoted in Africa, adding that the South African government has laws to deal with illegal immigrants.

Mozambican President

Mozambican President Armando Guebuza Thursday called on Mozambicans not to react with hatred to the wave of mob violence.

Meanwhile, Cape Town has been on a knife-edge after anti-immigrant violence reached the port city where angry mobs attacked Somalians and Zimbabweans and looted their homes and shops.

Ironically, South Africa marked Africa Day on Sunday in Johannesburg under the banner "united in diversity." Within sight of the stage, however, was Central Methodist Church, sheltering some 2,000 Zimbabweans, barricaded inside against the gangs who have been terrorizing refugees.

"It is almost as though the South African authorities want this to happen," said Anderson Ingwe, 28, a car mechanic. If that is so, then they should just say peacefully: 'You are not welcome, Zimbabweans. Now go home.'

Critics are faulting President Thabo Mbeki for failing to visit any of the trouble spots. Calls for his resignation appeared this weekend in The Sunday Times and other local papers.

Meanwhile, taking a stand against violence, some 5,000 people from non-governmental organizations communities affected by the violence and social-movement groups joined an antixenophobia protest in central Johannesburg and the suburb of Hillbrow Sunday. The protesters delivered a memorandum to the provincial government demanding security for foreigners and human-

itarian support.
South Africa, with a population of 48.5 million, has a shortfall of 2.4 million houses and one in four South Africans doesn't have a job.

cases also reported in Dallas, Tarrant, Cameron, Fort Bend, and Hays counties. State Health authorities say the investigation is in its early stages but that consumption of raw tomatoes is the likely source of infection. Specific type and source of tomatoes are under investigation.

"DCHHS has received reports of four cases in Dallas County." said Dr. Wendy Chung, DCHHS Chief Epidemiologist. Until the exact source of infections are determined, federal and state health agencies are recommending to consumers to follow the general precautions listed below:

- Wash cutting boards, dishes, utensils and counter tops with hot water and soap when switching between types of food products.
- Wash your hands thoroughly and often with

soap and warm water especially after going to the restroom, before preparing or serving food and after changing a diaper.

- Thoroughly wash all raw vegetables under running water,
- Refrigerate within 2 hours or discard cut, peeled, or cooked vegetables, including tomatoes,
- Keep tomatoes that will be consumed raw separate from raw meats, and raw seafood, and raw produce items.
- People who want to reduce their risk of Salmonella infection avoid eating raw Roma or full-sized round tomatoes other than those sold attached to the vine or grown at home or cooked at 145 degrees F. for at least 15 seconds to kill Salmonella.
- Avoid purchasing bruised or damaged tomatoes and discard any pro-

duce that may appear spoiled, and

• Persons with increased risk of severe infection, including infants, elderly persons, and those with impaired immune systems, should not eat any uncooked full-size round or Roma tomatoes other than those attached to the vine or grown at home.

Most people infected with Salmonella develop diarrhea, fever, and abdominal cramps 12 to 72 hours after infection. The illness usually lasts four to seven days, and most persons recover without treatment. Some people may need hospitalization due to severe diarrhea and dehydration. The elderly, infants, and those with impaired immune systems are more likely to have a severe illness. information Further regarding the multi-state investigation may be found at either of these websites:www.cdc.gov or www.fda.gov.





Collin County Dems Look to The Fall Campaign - Together

Sunday afternoon Teresa Gilbert Taylor, CEO of NtheKnow Marketing, hosted a mixer for Collin County Democrats at Prince Bistro in Plano. Supporters of Senator Barack Obama clearly outnumbered those for Senator Hillary Clinton, but all were invited and welcomed. The attendees strongly believe victory in November is possible only if both sides begin to work together.

Nader Saad, a long time activist in North Carrollton, was pleased with the Democratic Rules Committee's allocation of the Michigan and Florida delegates on the previous day. He described the televised discussions as, "Very professional, civil and distributed very fair to both sides." Saad believes that following a healing period, both sides will come together to elect the nominee for the party. Supporters of both candidates are, "In general, very passionate about their candidate. But they are also very educated, wholly understand what is at stake nationally and why they need to unite," according to Saad.

A key obstacle to re-elec-

tion for Cornyn is his consistent support President George Bush's policies.

In the end, Saad and other attendees believe the issues, not personalities, will lead to the democrats uniting. He cited their shared concerns regarding the war in Iraq and the major influence of lobbyists on Washington. **Taylor** added the high price of gas, and Veterans serving their country, only to come home and not receive the complete medical treatment they need - physical and mental, as well as the needs of senior citizens across the country are important

Taylor is the President of the 368 member DFW Obama, and Precinct 85 Captain and Senate District 8 Delegate, which represents Collin and part of Dallas county. She is also spearheading the Democrats United group, which hosted Sunday's event. 

Theatre Three's current production is guaranteed to be a crowd pleaser. Rarely can one go wrong when showcasing man's best friend, the dog. In fact, a trio of triple threat dogs will sing, dance and act their way right into your heart. You won't find stupid pet tricks here, which is a good thing since these dogs are the stars of Theatre Three's main stage show, A Dog's Life.

The top dog is Jack. As a pound puppy, Jack competes with the other dogs to get adopted before the dreaded 30-day deadline. To these dogs, the term deadline is taken literally. Jack, played by Gregory Lush, is an adorable mutt who

admits he's not very talented. He eats. He sleeps. And he...well, some things are better left unsaid. Mr. Lush, unlike his character, displays ample talent as he sings tunefully and dances nimbly across the set. When he interacts with his human, Joel (Cedric Neal), undeniable chemistry unfolds. Anyone who's ever owned a pet will recognize it instantly. Mr. Neal, a skilled actor, holds his own vocally, as well.


The other dogs in the show, aptly named Big (Marcus Dog Mauldin) and Little Dog (Megan Kelly Bates) complete the tail-wagging triumvirate with singing and dancing abilities commensurate with that of Jack. Mr. Mauldin's character comes across as the gruff canine that's all bark and no bite. An imposing actor, he translates his physical presence and vocal strength in a compelling manner.

Ms. Bates plays her character, a terrier, perfectly as an overly caffeinated canine. Calling her hyperactive would be an understatement. Yet, her performance is anything but understated. Her voice nicely complements the other cast members. The contrast of her character to Mr. Mauldin's works well, and serves as a reminder that dogs, like people, have their own unique personalities.

The other human characters in the story are adequately performed by two versatile supporting actors, Mark C. Guerra and Rhianna Mack. The set, though minimal, is transformed by Sam Nance's effective use of lighting into a variety of venues called for in the script. All elements of this show come together nicely in a production that has literally, gone to the dogs.

Texas To Refund Unemployment Taxes To Companies

The Texas Workforce Commission is mailing \$148 million in refund checks to nearly 360,000 Texas employers.

TWC collects unemployment insurance taxes from Texas employers for the Unemployment Compensation Trust fund, which funds benefits to workers who become unemployed through no fault of their own and are actively seeking work.

The trust fund has risen to \$1.7 billion, about \$738 million more than the minimum required by state law, enabling TWC to send employers a refund of about \$400, on average.

"This is how government should work," said TWC Chairman Tom

Pauken. "This surplus tax refund and historically low UI tax rates are among the many reasons Texas is a great place to do business."

Employers must have had payroll during 2008, paid all due taxes, and been in business for at least 18 months prior to Oct. 1 2007, among other requirements, to receive the refund.

Many employers will have additional savings on unemployment insurance taxes this year due to a decrease in the minimum tax rate to 0.1 percent, from 0.29 percent last year, and the elimination of the obligation assessment component of the tax.

Black people? Are we paralyzed by our own self-denial and self-abasement? Do we truly believe in our collective ability to "accomplish what you will," as Marcus Garvey espoused? Have we succumbed to the name "Toby" and given up on our true identity?

Are we ensconced in the power of our own consciousness, or are we languishing in the powerlessness of having been reduced to mere "nonpeople" in this land of plenty?

As for me, I believe rhetoric both spoken and written are vital to our learning and our prosperity, but it can only lead to positive outcomes if appropriate action follows. It's not enough just to know; we must act upon our knowledge.

It's not enough just to believe; the manifestation of our beliefs must be evident in our actions. It's not enough to convene intellectual confabs to discuss our plight; we must leave not only with a commitment to the cause but also with a commitment to appropriate and commensurate action. At the end of the day, if we fail to act we will have accomplished very little.

Consciousness is the key to action; it is the key to positive and appropriate behavior both individually and collectively. In that vein I invite you to read the words of Amefika Geuka, of West Palm Beach, Florida, excerpted from his outstanding "Black Paper" titled, From Rhetoric to Action:

"Now is the time for Nationalists to move from rhetoric to ACTION! We must prove that ours is more than a rhetorical concept, and most importantly that we are more than theorists and rhetoricians.

We must demonstrate that we are capable of conceptualizing, develop-

ing, implementing, and conducting programs and ventures that will improve the living conditions and life chances of our people, those at home and those abroad! It is time for us to become the party in power, and retire the Integrationists/Assimilati onists to the back rows from which vantage point the loyal opposition spews forth its rhetoric in reaction to action taken by the power-wielders."

Amefika Geuka is coconvener of the Bring Back Black movement, which was initiated in December 2006 Cincinnati, Ohio, and which has since "given birth" to the Nationalist Black Leadership Coalition (NBLC). His words remind me of where we are and where we should be in this country, having been here since its inception.

Black people have allowed ourselves to be duped into believing that someone else will take care of us, in spite of the fact that for the last four centuries there has been no real indication of that being the case. Geuka has written several "Black Papers" that not only describe our past and current situation, they also provide a plan that takes us from rhetoric to action and then on to the successful outcome of controlling our own destiny.

He says, "[NBLC's] vision is of a transformed Black community where our people radically improve the quality of their lives and surroundings. We will accomplish this by implementing programs and ventures designed specifically for the unique needs of people of African descent without apology! This will result in the complete elimination of the 'slave mentality' and dependence on the gratuity of others that it promotes. We will cease to be the 'weakest link in the

chain,' or weakest 'patch' in the 'quilt-like' fabric of American society and that of the world."

You can also arrange to set up a chapter of the NBLC in your city by inviting him to come and personally lay out the plan that will take us from rhetoric to action. Prior to the current political campaign, Geuka proposed that Black people in this country designate a President Black America (POBA), much in line with articles I have written asking, "Who speaks for Black people?" We see politicians rushing to microphones pledge their allegiance to other groups, but we never hear them offer similar support to Black Americans, upon whose backs the wealth of this country was generated.

As Amefika Geuka states, "Blacks collectively need a champion! We need a strong, unwavering voice to reassure us of who we are and from whence we came...Our President Of Black America will singlemindedly advocate and promote the interests of Black people, without reservation, without hesitation, without apology, and most of all without fear. He or she will have no interest in playing to the mainstream media, seeking photo opportunities, currying favor with political parties, multinational corporations, foundations, or philanthropists. His/her objective will be to build the capacity of Blacks to do for self! The POBA will be the foremost cheerleader for Black America!"

ons, and the Justice Department has no idea of where inmates go when released, but is exploring ways to get that data.

There are also times when some states fail to submit year-end data—mostly because states do not have the facilities to track the numbers, Maruschak told The Final Call

"The bigger states are the ones that we always try to get no matter what. We force the issue and get some numbers because when a Georgia, Texas or California would drop out, you would see an artificial decrease. If we are talking about a small state reporting a small number, it doesn't affect the data," she said.

"The whole service community is saying the numbers are up," said Cynthia Davis, director of Education Outreach Programs for the Charles R. Drew University of Medical and Science. Her organization helps service some 15-20 prisons in California and many inmates have no clue of their HIV status because of a lack of mandatory testing inmates.

"We don't know what the actual numbers are. At a recent training, a health professional estimated that there are 1,200 people in prisons who are HIV infected, but their internal numbers were upward of 3,000. That's a big discrepancy and we don't have a handle on the amount of prisoners in California or nationally who are infected or know their status," Davis said. Davis supports legislation to test inmates, including Rep. Maxine Waters' proposed Stop AIDS in Prison Act of 2007, which was introduced in April. The act would allow for routine non-mandatory HIV counseling and testing upon entry and release and enable prisoners to request testing without being penalized.

"This would help determine numbers more accurately, because often if you're found to be positive, then you lose a lot of privileges that are afforded non-HIV positive inmates, like certain jobs, housing status and even work time credit. They'll send you to an institution that primarily cares for people with HIV/AIDS, but once persons are comfortable in an institution they don't want to move," Freddie Williams told The Final Call. Inmates also don't want to extend their stay by losing work time credit if they report their status, he said.

Williams speaks from experience. He spent 20 years in prisons in Arizona and California and contracted HIV in 1994 as a result of drug abuse. Today, he is an HIV prevention and certified substance abuse counselor in Lancaster, Calif.

AIDS researchers say any decline in numbers is a result of more advanced medications, but federal and state funding needs to target more outreach and education, especially to minority communities.

Despite an increase in new HIV/AIDS diagnoses

in 2006 among Whites and Asians/Pacific Islanders, the disease is still more prevalent among Blacks and Latinos. The Centers for Disease Control and Prevention's 2006 AIDS statistics were:

- Blacks 67.7 AIDS cases per 100,000;
- Latinos 25.5 AIDS cases per 100,000;
- Whites—8.2 8.2 AIDS cases per 100,000;
 Asians/Pacific Islanders
- 6.7 per 100,000. "When AIDS first struck, the CDC labeled it 'G.R.I.D.' meaning gay-related immunodeficiency disease, and tried to combat it using a social model instead of a medical

instead of a medical model; and of course the White gay male population began to get a handle on it through education and funding, but now that it has become a people of color disease, they don't have any money to fund it," Mr. Williams said.

He adds, "Looking forward we need to begin to mobilize community by community and we need to mobilize through our churches because if we don't do anything to get a handle on this and recognize that it has become a people of color pandemic, we will be in a world of trouble."

Thousands of miles have been traveled; millions of voices have been heard," Obama told more than 20,000 supporters in St. Paul, Minn., Tuesday night. "And because of what you said, because you decided that change must come to Washington, because you believed that this year must be different than all the rest, because you chose to listen not to your doubts or your fears, but to your greatest hopes and highest aspirations, tonight we mark the end of one historic journey with the beginning of another, a journey...a journey that will bring a new and better day to America. Because of you, tonight I can stand here and say that I will be the Democratic nominee for the president of the United States of America."


The historic win has sent a wave of euphoria through the Black community and America in general as supporters cheered at the news after a longfought primary contest against Sen. Hillary Clinton (D-N.Y.).

But, it is not just an American celebration, but a world celebration, says the Rev. Jesse Jackson Sr., a former Democratic presidential contender.

"The whole world is celebrating today, and rightfully so," says Jackson in a phone call from the United Republic of Tanzania to the NNPA News Service. "It is a glorious, mountaintop moment in American history. It is a great victory for Barack, Michelle and a hard fought campaign. It is a greater victory for America, a redemptive moment, a transformative moment, and so we have reason to celebrate."

Clinton, who would have been the first woman nominee, did not concede Tuesday night. But it is Obama who will be running in the general election against Republican Sen. John McCain in the fall

(Washington Post) The price of regular at a Shell gas station in Petworth gleamed defiantly in the midday sun: \$3.91 a gal-

But unlike the customers rolling up to the station's pumps this week, resigned to the fact that their wallets were about to take a beating, Rocky Twyman and company had a plan to bring that number tumbling down

Some would say the proof of whether Twyman has the ear of the Almighty is in the result. On the first day of the movement, April 23, the national average price of a gallon of unleaded was \$3.53, according to AAA. As of yesterday, it was \$3 96


