The line of people at the Orlando World Center Marriott weaved through the corridors and wrapped around corners as more than a thousand awaited the opening of the ballroom, where presumptive Democratic nominee Sen. Barack Obama was about to speak.

"Yesterday, the crowd was polite to Sen. John McCain here at the National Urban League Conference. But, today, for Sen. Obama, it's more of a love fest!" reported one excited CBS Radio newsman, among the horde of reporters observing the crowd waiting for Obama.

He was right. People were waiting in line as early as 7 a.m. Saturday morning for the anticipated 2 p.m. speech. The ballroom, which seated well over 1,000 people, had

been close to full for presumptive Republican nominee McCain the day before. For Obama, an overflow crowd had to be seated in an adjacent room to watch the speech on close circuit television.



Legislating to Protect Home Ownership

The mortgage foreclosure crisis is in full swing and not looking to ease soon. Mortgage lenders continue to report their highest foreclosure and delinquency rates in five years. Rising default rates have not only affected those in the subprime market, but higher mortgage rates are putting a squeeze on borrowers with good credit, as they have in metro-Atlanta.

Mortgage reform legislation recently passed by the House of Representatives and the U.S. Senate will go a long way in ensuring there is some relief for those families caught up in the current housing crisis.

H.R. 3221, the American Housing Rescue and Foreclosure Prevention Act, set for signature by President Bush this week, would provide relief to millions of Americans affected by this crisis by instituting the reform necessary to ensure these problems do not recur. This important legislation incorporates a number of bipartisan bills designed to modernize the Federal Housing Administration (FHA), the **GSEs** reform (Government Sponsored Enterprises) Fannie Mae and Freddie Mac, and increase liquidity in the markets.

legislation This designed to help borrowers who are at risk of default by allowing them to refinance with a loan guarantee from the government. The existing lender would voluntarily decrease mortgage debt below the home's current value. which will give the owner equity in the house. Lenders may also be able to recoup more money than

if the house went in to foreclosure and the government would receive part of the gain if housing prices rise in coming years. Moreover, with fewer foreclosures and forced sells, nearby homes would be more likely to retain their value, thus saving whole communities from devasta-

The legislation passed by the House and now under consideration in the Senate increases the Veterans Affairs home loan limit. The bill would also provide \$11 billion in tax benefits including tax credits for first-time homebuyers, a real property tax deduction for non-itemizers, an additional \$10 billion in mortgage revenue bonds for states and would improve access to low-income housing.

As a member of the House Financial Services Committee, I have worked with my colleagues to build greater financial literacy. To that end I have introduced legislation, H.R. 3133. the Financial Literacy for Homeowners Act, which would provide

grants to states and nonprofit agencies to educate consumers on mortgage lending practices.

It would also create a national toll free number where consumers report cases of abuse by lenders. It is of utmost importance that we provide consumers with education about lending laws, counseling and referral services. H.R. 3221 contains many of the provisions of my legislation, and would provide \$180 million for housing counseling programs.

I remain concerned about the inordinate percentage of minority families suffering during this crisis and the affects this has on our communities. The facts are disturbing at best: black and Hispanic individuals have been disproportionately targeted for high cost subprime loans and are more likely to face foreclosure.

Georgia's 13th Congressional district. neighborhoods with an excessive number of foreclosures have become magnets for crime. Solving this

problem is a matter of protecting our neighborhoods. We should also focus on the high social costs involved with this crisis, as schools can expect to receive less property tax funding as home values fall.

H.R. 3221 will allow many Americans to remain in their homes and fight predatory lenders. Consumers will be ensured of acquiring good loans, credit availability will be preserved, lender and consumer interests will be aligned, consumers will get a simple, understandable and meaningful disclosure of their loans terms and mortgage originators will no longer have incentives to steer consumers into bad

I am hopeful continued negotiations on this measure will prove fruitful and the Senate acts soon to pass this necessary legislation. In my opinion, all involved should get behind this strong legislation address this housing crisis, not only for our economy's sake bur for those millions of affected Americans.

Power Struggle Stalls Zimbabwe Talks

An offer to make opposition leader Morgan Tsvangirai third vice president has been rejected, dimming hopes for a power sharing agreement between Pres. Robert Mugabe and Tsvangirai, the declared winner of the first voting round.

"They have offered Morgan the post of third vice-president and nothing else, which is obviously a position totally unacceptable to (Tsvangirai's party) the MDC," said one source. Pres. Mugabe already has two vice presidents who are figure-heads

Although South African President Thabo Mbeki and lead mediator insists that the talks have not broken down, insiders are predicting a protracted and bitter struggle. Negotiators for the two sides have returned home for consultations.

Tsvangirai and the 84year-old Mugabe have signed an accord to begin talks on sharing power after a months-long election dispute. The meeting was their first since Tsvangirai formed his MDC party in1999.

"Given the polarization of the parties, nobody expected that this was going to be a walk in the park," observed Sydney Masamvu of International Crisis Group. Be that as it may, I think it is a setback, which can be resolved if both parties approach these talks with sincerity and recognize the need for an economic and political recovery."

Namibia Demands Return of 'Genocide' Skulls

German universities are holding dozens, perhaps hundreds, of human skulls, remains of the colonial-era Herero massacre in their scholarly archives. Namibia is now demanding that they be returned.

According to public broadcaster ARD, the skulls were spirited away to Germany following the 1904 killings for "scientific research" aimed at proving the racial superiority of Whites to Blacks.

"It is believed that a total of at least 300 Herero skulls were taken to Germany in the early 20th century," ARD reported. Some 47 skulls are still stored at the Medical History Museum at the Charite teaching hospital in Berlin and at least a dozen more at Freiburg University in south-western Germany.

"According to a Unesco convention these things must be repatriated to their country of ori-

gin," Namibian ambassador Peter Katjavivi told ARD. "We have institutions in Namibia that would be prepared to undertake that important assignment."

Katjavivi said the remains were deeply important to Namibians.

He said, "It is a question of regaining our dignity, it is a question of regaining our history. And it is a question of finally bringing those skulls to have a proper burial."

HIV and AIDS on the Rise Among Hispanics in Dallas Metroplex

Dallas County Health and Human Services (DCHHS) is reporting that the number of Hispanics living with HIV/AIDS in the in the Dallas Eligible Metropolitan Area (EMA) rose from 1,497 cases in 2002 to 2,342 cases in 2006 representing a 57% increase over the four year time span. The Dallas EMA includes Collin, Dallas, Denton, Ellis, Henderson. Hunt, Kaufman, and Rockwall counties. Even more troubling is the rapid rate of the progression of the disease from positive HIV status to a diagnosis of AIDS. Between 2002 and 2006, nearly 33% of Hispanics had both diagnoses within one month compared to 25% and 22% of diagnoses among blacks and whites, respectively. This disparity was maintained at the one year mark, with 42% of Hispanics receiving an AIDS diagnosis within one year of initial HIV diagnosis. This is attributed to late diagnosis of the disease in the Hispanic community.

community. "Since the beginning of the HIV/AIDS epidemic, the rate of diagnosis for Hispanics/Latinos has continuously increased at disproportionate rates," said Zachary Thompson, DCHHS Director. "The rate of progression of the disease among our own Hispanic community underscores the need for early testing. We encourage everyone to know your status by getting tested, getting treated and getting educated about HIV/AIDS in order to stop the devastation to our communities," Thompson.

According to the CDC, Hispanics represented approximately 18% of the living people HIV/AIDS nationwide. Of that 18% of Latinos living with HIV/AIDS, 23.6% were Hispanic/Latino female adults and adolescents, and 74.8% were Hispanic/Latino male adults and adolescents, living with HIV/AIDS. Of the reported AIDS cases for Hispanic/Latino male adults and adolescents, male-to-male sexual contact was the highest transmission category at 43%. Injection drug use came in second at Hispanic/Latino women adults and adolescents the reported AIDS cases indicated that high-risk heterosexual contact was the highest transmission category at 49% followed by Injection Drug Use at

- Never leave anyone in a closed, parked vehicle in hot weather, even for ashort period.

Coma, paralysis and death can follow a heat stroke if emergency treatment is not immediately given. Heat can be fatal to anyone, but people over 60 are at the highest risk, especially if they are frail or have pre-existing heart disease, respiration problems or diabetes. To a lesser extent, babies and young children, people with a history of alcoholism and others using certain drugs and medications are at high risk of heat illness.

People most at risk of heat illness from exertion may include: athletes, military personnel and manual laborers.

If you think you may be suffering a heat stroke, seek medical attention immediately.

working to protect the vote," he said.

Morial called on NUL members to make September 'Voter Empowerment Month'. So, we will dedicate our efforts during that month to register people to vote."

The NUL has teamed with the National Coalition on Black Voter Participation for a strong grassroots registration effort.

This is part of a national effort to encourage participation in an election, which has already drawn interest of historic proportions due to the heated race between two U. S. senators, Republican John McCain, a Vietnam veteran, and Democrat Barack Obama, who could become the nation's first African-American president.

"The thing you've got to do is stimulate people to participate. You've got to focus on the fundamentals of democracy, which are registering people to vote and encouraging people to double check their vote," Morial says. "In registration, there's been so much purging in some states and so many games they play in efforts to disqualify voters."

Meanwhile, the Housing Rescue and Foreclosure Prevention Act that was passed by the House and Senate last week and signed by President Bush aims to enable at least 400,000 troubled homeowners to refinance their homes, "switching from risky sub prime mortgages to safer loans backed by the Federal Housing Administration," described by U. S. Rep. Bennie Thompson.U. S. Rep. Maxine Waters (D-Calif.), among the leading advocates for the Act, said the bill is a Godsend.

"We've got to help these people keep their homes," she said in an interview. She described how some homeowners were enticed into loans at "teaser" rates, but were left holding the bag when the interest rates quadrupled and simply could not afford to pay.

Waters particularly worked to get the \$4 billion, stipulated in the bill, into city neighborhoods where vacated houses are causing values of neighborhoods to drop and reat-

tracting crime and drugs. "This money will help buy the homes, rehabilitate them and put them back on the market," Waters says.

Morial, who warned the nation about a pending sub prime lending crisis at a press conference just before NUL's convention in St. Louis last year, anticipates being a part of disseminating the benefits of


the Act.

"We will be proposing new NUL initiatives called 'Restore Our Homes'; establishing 50 home ownership centers throughout the country to enhance the counseling that we're already doing to help people to save their homes and to help people to become homeowners by getting mortgages for the first

time," he said.

In his keynote address to the thousands of conventioneers, Morial was set to talk about rebuilding America.

Because most people are not willing to go back to high school, he says there must be a greater commitment to what he calls, "Second Chance" programs.





Sales Tax Holiday Brings Relief to Family Budgets

With the rising cost of gasoline, groceries and other goods, the annual clothing sales tax holiday will help families' back-toschool budgets go farther, Texas Comptroller Susan Combs said today.

Combs announced that the 10th annual sales tax holiday will take place Aug. 15-17. During the tax holiday weekend, most clothing and shoes priced less than \$100 can be purchased tax free. The tax break applies to both children's and adults' apparel.

"We estimate shoppers will save about \$54 million in sales tax during the sales tax holiday, including approximately \$42.1 million in state sales tax and \$11.9 million in local sales taxes," Combs said.

The shoppers' gain is not expected to have a significant impact on sales tax collections.

"Though the national economy has slowed, Texas sales tax revenue continues to grow at a healthy pace," Combs said. "Through June, state sales

tax collections for fiscal 2008 were up 6.1 percent compared to the same point in fiscal 2007. Cities' and counties' calendar year-todate sales tax revenues were up an average of 5.1

percent."

Combs reminds families that school backpacks and messenger bags costing less than \$100 are now included in the sales tax holiday, but school supplies are taxable.

Since 1999, the clothing sales tax holiday has saved shoppers more than \$388 million in state and local sales taxes.

By Any Other Name Despite Dallas City Council Decision Caesar Chavez Blvd. Debate Continues

Trinity River The Corridor Project Committee brought mixed bag of victory and compromise for the Hispanic Community in its decision rename Industrial Boulevard to Riverfront Boulevard instead of the consumerendorsed choice, Caesar Chavez Blvd. In the Tuesday meeting of the committee, Dallas Mayor Pro-Tem, Dr. Elba Garcia, inserted a new motion for the consideration of Ross Avenue between Houston Street and Greenville Avenue to be a compensatory option to bear the name of the heralded Hispanic-American hero.

The passage of the motion regarding Industrial slid through with little opposition led by committee chairperson and Dallas City Councilman, David Newman. The main point of discussion lingered on three points (1) the process of changing the name of a street and (2) whether or not the motion to rename Ross Avenue was a quidpro-quo deal set between the council members prior to the meeting and (3) whether or not the tenants of the Central Business district that have offices on Ross have implied any measure of agreement to the name change to reprethe increasing Hispanic population in Dallas.

"For the last month Mr. Salazar, Ms. Medrano and myself have been working with other Hispanic leaders to find another street to name after our American hero," Garcia began as she introduced the alternative to Industrial Boulevard option. "We wanted something prominent, significant and that would represent our hero and make us proud of the city of Dallas.

Ross Avenue came up."

Garcia proceeded to elaborate on the reason for the choice, citing the various areas of Hispanic influence that is present on the 3.1-mile prominent stretch of road. Specifically, she mentioned its close proximity to 'Little Mexico' (Ross Avenue is currently mapped to be about 6 miles from the community located on the northwest corner of Downtown). "This was the heart of the Latino community many years ago. It was where the Mexican-American political movement started."

There are other more visible landmarks that Garcia mentioned including The Arts District and the Cathedral Shrine of the Virgin of Guadalupe located at 2215 Ross Avenue, a place were thousands of Hispanics, Latinos and Mexican-Americans are said to attend mass everyday. The Dallas Independent School District (DISD) Central Administration office is located at 3700 Ross Avenue which houses the personnel that oversees the area public schools of which 65 percent of students are Hispanic according to the fact sheet released during the 2007-2008 school year.

Per Garcia, about sixty percent of Ross Avenue is Hispanic Americans. Recalling recent history, she added, "It is also the place where 500, 000 people came to our city in 2006 in a nonviolent way for fair immigration reform to be passed in this country." In addition, she highlighted the Cesar Chavez Elementary School presently located the Carroll and Ross Avenue intersections.

"We want to be sure that Caesar Chavez is represented," concluded Garcia as she touted Chavez as a great person, an environmentalist, an American cit-

izen.

The introduction of this behind the scenes work regarding the re-naming of Ross Avenue showed that the grass-root initiative is already in motion. However, before a name change application is filed with the City of Dallas, agreement must obtained from 51% of the street's business and property owners.

Alberto Ruiz, the president of the Caesar Chavez Task Force and a member of the League of United Latino American Citizens (LULAC) was asked by Garcia to explain to the committee, the current progress on the quest to rename Ross Avenue.

"We have already talked the West Association, Stephan Pyles restaurant, Chase Bank, the Cathedral of Guadalupe, the Dallas Independent School District superintendent, many members of the school board and other local businesses on Ross Avenue. We have done as much as we can to educate people on who Caesar was. He served in the U.S. Navy and in 1994, a year after his death; he was awarded a medal of honor President Clinton."

Councilwoman Carolyn Davis, asked for clarity during the committee meeting on more than one occasion and was obliged by Neumann which ultimately led to her successfully pinning down Ruiz on whether or not he had already obtained the required percentage of agreement and contacted the larger buildings in the downtown Dallas Central Business District." Ruiz assured the committee that they were confident in reaching the goal.

As if the conflict over the renaming issue was not enough, tensions heightened as Garcia gave her formal recommendation to the board. "As a compromise in our last meeting, Mr. Salazar, Ms. Medrano and myself said that we will support the naming of Industrial Boulevard to Riverfront Boulevard, if this committee will support the naming of another street after Caesar Chavez and the task force has chosen Ross Avenue."

This spewed a strong point of order from Councilman Ranstansky, suggesting that the motion process was not being done as two separate motions and that Garcia was in violation of an employee city code that forbids reciprocal favors between two city officials. Ranstansky eventually left the room due to this conflict of interest. Garcia withdrew the original motion at the suggesof Councilman Carraway and restated it to the committee as it was written and the committee marched to accept the recommendation to begin the application for renaming Ross Avenue. It was a unanimous agreement of all committees members that were still present.

The decisions to recommend the renaming of the streets Industrial and Ross has passed the committee unanimously, now it is up to the city council members to accept the recommendation and send it to the subdivision of the City Planning Commission. It was a day of small victories in the Hispanic community's war for respect and representation in the city of Dallas that is far from over.

While most of the groups in attendance rejoiced at this motion not all of the Hispanic community is accepting of the committee's detour from the public opinion polls and surveys sent out previously. Michael Gonzales of the Hispanic Leadership Forum (HLF), felt disrespected by committee's detour. "The HLF is not comfortable with the shift from the public survey to the Trinity River Corridor Committee. We represented the 10,000+ individuals that voted to support the renaming of Industrial to Cesar Chavez Blvd and whose voices were not respected." Regarding the support and appropriateness of the alternate, he continued. "The HLF has always supported additional public streets and buildings to be named after Latinos, African-Americans and other minorities. It is our view that Ross Avenue does not appropriately reflect the stature that Industrial does because it is the biggest public works project in 20 years."

Jaime Cortes, Dallas County Constable Precinct 5, stated "It is a victory in the point that we are getting the process started, but the real victory comes when we get the street name changed." Regarding the loss of the renaming of Industrial Boulevard, Cortes added,"It was a poll and there was nothing binding about it. We have to move on and we are willing to do that".

In a press conference, immediately following the street name discussion, Ruiz along with Rey de la Santos, the director of LULAC District 3 and about 30 Latino young adults accepted and showed their support of the Trinity River Corridor Planning Committee's decision.

"We saw a spirit of cooperation in this committee and we accept this as an alternative. We are very proud of this committee for showing unity, taking the leadership role and allowing us to move forward together instead of splintering the community even further," began Ruiz. "I believe that renaming Ross Avenue is very appropriate because of the legacy that it has within the Hispanic community. With the time and dedication that we have put into this effort, Ross Avenue has a strong chance of being renamed in honor of Caesar Chavez. It can be and will be a change that the community can be proud of. If the people would work with the heart and the spirit of Caesar Chavez, this can be a great sign and symbol of progress within the City of Dallas."



Morgan Freeman recovering after surgery

Oscar winner Morgan Freeman said he was feeling "real good" on Thursday after his release from a Memphis, Tennessee, hospital where he was treated for broken bones and other injuries from a weekend car crash.

Freeman, 71, lost control of the car he was driving late on Sunday night near a home he keeps in Charleston, Mississippi, and was airlifted to the trauma cen-

ter of the Regional Medical Center in Memphis, about 100 miles (160 km) away.

"I left the hospital today, just after 12 noon, Memphis time," the costar of the blockbuster Batman movie "The Dark Knight" said in a brief statement.

"I'm doing very well. I feel real good."


He concluded by thanking hospital staff and well-wishers, saying, "It's great to know people care about you."

Freeman's publicist,

Donna Lee, said on Monday the actor suffered a broken arm and elbow and "minor shoulder damage" but was expected to make a full recovery after undergoing surgery.

The celebrity news TV show "Entertainment Tonight" reported on its website that Freeman underwent surgery on Monday to reconnect nerves and repair damage to his left arm and hand.

female friend identified as Demaris Meyer, was also injured, but no information has been released regarding her condition.

Lee said Freeman and his wife of 24 years are in the midst of a divorce and had been estranged for some time.

Police ruled out alcohol as a factor in the crash and said it was possible Freeman had fallen asleep at the wheel when the car careened off the highway and rolled over several times.

No other vehicle was involved and no citation was issued in connection with the accident.

Part 1: Business Survival Tips

You may be in Mail Order, Direct Mail, or you may be a local merchant with 150 employees; whichever, however or whatever - you've got to know how to keep your business alive during economic recessions. Anytime the cash flow in a business, large or small, starts to tighten up, the money management of that business has to be run as a "tight ship."

Some of the things you can and should do include protecting yourself from expenditures made on sudden impulse. We've all bought merchandise or services we really didn't need simply because we were in the mood, or perhaps in response to the flamboyancy of the advertising or the persuasiveness of the salesperson. Then we sort of "wake up" a couple of days later and find that we've committed hundreds of dollars of business funds for an item or service that's not essential to the success of our own business, when really pressing items had been waiting for those dollars.

If you are incorporated, you can eliminate these "impulse purchases chases" by including in your by-laws a clause that states: "All purchasing decisions over (a certain amount) are contingent upon approval by the board of directors." This will force you to consider any "impulse purchases" of considerable cost, and may even be a reminder in the case of smaller purchases.

If your business is a partnership, you can state, when faced with a buying decision, that all purchases are contingent upon the approval of a third party. In reality, the third party can be your partner, one of your department heads, or even one of your suppliers.

If your business is a sole proprietorship, you

don't have much to worry about really, because as an individual you have three days to think about your purchase, and then to nullify that purchase if you think you don't really need it or can't afford it.

While you may think you cannot afford it, be sure that you don't "shortchange" your self on professional services. This would apply especially during a time of emergency. Anytime you commit yourself and move ahead without completely investigating all the angles, and preparing yourself for all the contingencies that may arise, you're skating on thin ice. Regardless of the costs involved, it always pays off in the long run to seek out the advice of experiprofessionals before embarking on a plan that could ruin you.

Particularly when sales are down, you must be "hard-nosed" with people trying to sell you luxuries for your business. When business is booming, you undoubtedly will allow sales people to show you new models of equipment or a new line of supplies; but when your business is down, skip the entertaining frills and concentrate

on the basics. Great care must be taken however, to maintain courtesy and allow these sellers to consider you a friend and call back at another time.

Your company's books should reflect your way of thinking, and whoever maintains them should generate information according to your policies. Thus, you should hire an outside accountant or accounting firm to figure your return on your

investment, as well as the turnover on accounts receivable and inventory. Such an audit or survey should focus in depth on any or every item within your financial statement that merits special attention. In this way, you'll probably uncover any potential financial problems before they become readily apparent, and certainly before they could get out of hand.



today feeling no small amount of gratitude. Because I know that my story, and so many other improbable stories, would not be possible without all that the Urban League has done to put opportunity within reach of every American, Obama said in his opening statement to the cheering and applauding crowd. "It's because of the doors you've opened, because of the battles you've fought and won, because of people in this room and all those who came before you, that I come here today as a candidate for President of the United States of America."

It was two days of raw political campaigning by both candidates for the Black audience thirsting to hear perspectives on socio-economic issues. Marc Morial, NUL president and CEO, sat on a stool close to the podium

as both candidates spoke. Morial then asked them questions based on issues included in the NUL's "Opportunity Compact", a comprehensive report on the state of Black America, which includes extensive research data and policy recommendations.

"This election is about the 47 million people who don't have health care – including 1 in 5 African-Americans – people for whom one accident, one illness could mean financial ruin," said Obama, promising to "guarantee health care for anyone who needs it."

On the 2.5 million people facing foreclosure, Obama said he would support tax credits to help low and medium-income families as well as establish easier ways to refinance mortgage loans.

McCain, who received several strong applause

during his speech, appeared more comfortable with NUL than he did before the NAACP audience a month ago.

"Equal access to public education has been gained. But, what is the value of access to a failing school? Equal employment opportunity is set firmly down in law. But with jobs becoming scarcer – and 400,000 Americans thrown out of work just this year – that can amount to an equal share of diminished opportunity," McCain said.

But, McCain talked more about education reform than anything, again pitching his support for charter school vouchers, which fell on a silent audience. Most historic African-American groups oppose vouchers because they take money that could go to public schools and give it to private

schools. "Some parents may choose a better public school. Some may choose a private school. Many will choose a charter school. No entrenched bureaucracy or union should deny parents that choice and children that opportunity," he told the quiet audience.

The most enthusiastic applause during the McCain speech was for his promise to reform school budgets "to put the money and the responsibilities where they belong - in the office of the school principle."

Still, it was Obama who drew obvious awe from onlookers.

It was amazing, everything I thought it was going to be – inspirational and really hopeful," said a beaming Latoya Hoflin, who will be "15 in two weeks."

Hoflin, from Atlanta, says since she's not old enough to vote, she will " and try to get other people to vote for him."

The Obama enthusiasm crossed the age spectrum. Dennis Rahiim Watson, president and CEO of the National Black Leadership Council and the chairman of the National Youth & Gang Violence Task Force, left the speech with a broad smile, saying he too has a new level of hope.

"Young Black children can be what they see. He has raised the level of our expectations of what we can be. So, I am touched. He felt the pulse of the people, very down to earth, very clear," he said.

It was Obama's ability to deliver a clear message that was first on the attack list for McCain.

"If there's one thing he always delivers, it's a great speech. But, I hpe you'll listen carefully, because his ideas are not always as impressive as his rhetoric," said McCain.

The quips about each other will no doubt escalate as both candidates get closer to the Nov. 4 election that could make Obama the first Black president in America's history.

How are you blessing





Think about it now, while you have the time, what will be your legacy when you have left this world for the next? With the help of God, it can be discovering how you might make a positive difference in




