Payday lending reform picks up steam

(NDG Wire) Cities and towns across Texas are urging legislative leaders in Austin to close a loophole in state law that allows payday lenders and auto title lenders to charge exorbitant rates for short-term loans, fostering a cycle of dependency that often leads to financial ruin.

Recently, the El Paso City Council unanimously adopted a resolution by Councilmember Susie Byrd calling on the Texas Legislature and the Governor to stop usurious lending and require these operations to comply with the same standards as licensed consumer lenders in Texas.

Meanwhile, a group of consumer and public interest organizations, including AARP, launched a new Web site – www.stoppaydayabuse.org – with information, a call to action and opportunities for consumers who have been victimized by these practices to share their stories.

In December, the City of Brownsville placed a six-month moratorium prohibiting these lenders from opening any new “money stores” in town. Other cities have gotten into the act as well, most of them adopting zoning laws that prevent the expansion of these opera-

Fighting childhood obesity

(NNPA) When First Lady Michelle Obama decided to launch the “Let's Move” campaign to fight childhood obesity, she brought much needed attention to a crisis facing millions of children. It's a special concern for children of color because new research shows Black and Hispanic children are disproportionately at risk for nearly a dozen factors that increase their chances to

be obese. But children of color are far from the only ones in danger. Experts estimate one-third of American children are currently overweight or obese, and these rates have tripled among children ages 12 to 19 since 1980. Some adults may see a heavy child as a sign of a healthy eater, or think that for children, extra weight is mainly just a cosmetic issue. But seri-

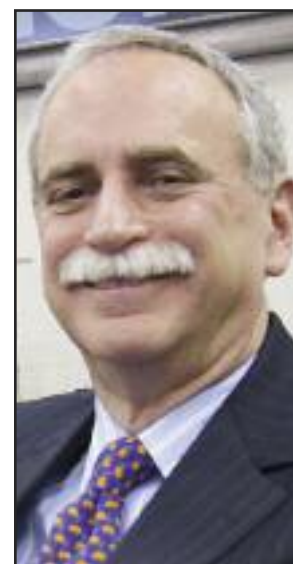
A member of the Conference of Southwest Foundations, Bob has served as Chair of the Legislative Network Committee and

Health care: Finally a semblance of justice

(NNPA) It was the second annual convention of the Medical Committee for Human Rights in 1965. And during this conference in Chicago, our great civil rights leader, the Rev. Dr. Martin Luther King Jr., delivered a speech that till this day resonates with those who see disparity in our health care system.

It was on March 25 – precisely 44 years ago – that MLK said: "Of all the forms of inequality, injustice in health is the most shocking and the most inhuman." To the 220 members of Congress who voted yes for health care reform on Sunday, the citizens of the United States at long last say thank you for representing our desires, thank you for representing our needs and thank you for representing the will of the people.

For decades, Presidents have tried and failed to push through health care legislation that would begin to rectify the unfair practices of health care providers and the egregious monopoly of the insurance industry.

There were efforts by Harry Truman after the Second World War, a push by Lyndon B. Johnson and who can forget the unyielding work of Bill and Hillary Clinton in the 1990s. But it wasn't until Sunday, into the late hours of the night, that the U.S. Congress effectively passed this historic health care legislation. Following a year of fierce debate and town hall meetings that ended in shouting matches, the Democrats and President Obama solidified their pledge that change would indeed come to Washington.

No one can deny that the road to health care re-

form was embedded with hurdles and difficulties beyond comprehension. Nor is anyone avowing that all problems within our health care system will be immediately resolved.

But for the first time in our nation's history, American children cannot be denied coverage because they have pre-existing conditions, small businesses will receive a tax credit for providing health care, young adults can stay on their parent's insurance until the age of 27 and insurance companies cannot cut someone when he or she gets sick.

And by 2014, annual caps will be eliminated, health care exchanges will be available, adults with pre-existing conditions will no longer be discriminated against and much much more. Let us not forget, all progressive legislation – including the Voting Rights

Act of 1965 – did not grant everything all at once. Instead, it was amendments and other additions to the initial law that created the equality we know and enjoy today. This health care reform bill therefore is the first step in finally achieving a semblance of justice in an area that has shocked and outraged everyone concerned with the betterment of humanity.

President Obama clearly outlined his plan for health care overhaul early on during his campaign for the Presidency. And after winning the election, he spent the first year in office not only fighting for this legislation, but also reaching across the aisle.

Incorporating both Democratic and Republican concepts into this bill, and making changes along the

ous risks for overweight children go far beyond appearance.

Diseases once associated only with adults, like type 2 diabetes, high cholesterol, and high blood pressure, are on the rise at younger and younger ages. Overweight children are at greatly increased risk of being overweight adults, so for many children, this may be more than just a "chubby" phase they'll someday outgrow.

As many as 80 percent of overweight children may be set up for a lifetime of increased health risks that come with being overweight. The most pressing risk, cardiovascular disease, remains the leading killer in America.

If childhood obesity trends continue, experts predict they could cut two to five years off the lifespan of the average child in America—making this the first generation to have a shorter life expectancy than their parents. Right now our country spends \$150 billion a year treating obe-

sity-related diseases, nearly 10 percent of all medical spending. Many experts label the current level of childhood obesity an epidemic that threatens our future national health, productivity, and security unless something can be done to stop and reverse the trend.

There are many reasons childhood obesity is on the rise. American children have been immersed in the same "supersized" culture that snares adults, surrounded by high-calorie, high-fat food that's plentiful, cheap, and often served in unrealistically big portions.

Today's children and teenagers are much less likely than past generations to spend free time running around outdoors and much more likely to spend it on the couch watching TV, playing video games, or surfing the Web, often with snacks and sodas right next to them. Very few children get the 60 minutes of moderate physical activity most days of the week recom-

mended by the Surgeon General.

Even schools have become part of the problem. Many districts have cut back on gym time and recess, often as a tradeoff for more instructional time to prepare for state testing. The quality of school meals and easy availability of snacks and sugary drinks in many school vending machines were some of the first targets in the war on child obesity, and there's been progress.

Some major school food suppliers are making improvements in response to Mrs. Obama's campaign. Advocates for better nutrition hope that as more people become aware of the risks to children's health, more industries, schools, restaurants, and communities will make a big difference for America's children.

As these kinds of changes occur in a range of child environments, Mrs. Obama and others stress the biggest influence in children's eating habits will come from home. It has

been parents who have told their children to eat their vegetables or go outside and get some fresh air.

Mrs. Obama has shared some of the simple changes she and the President have made in their own family's lifestyle, including watching portion sizes, packing more fruits and water in their daughters' lunches, limiting TV time, and, famously, starting a vegetable garden at home.

We know our beautiful children come in all shapes and sizes. But by being aware of the serious health risks many overweight children face and of the long-term value of a balanced diet, and of regular exercise for all children, we can help make sure all our children grow up to be as healthy as possible. Making healthy food and exercise part of family life is the right place to start, and will be good for many adults too! Teaching good habits to children early can have lifelong consequences, and someday our children—and grandchildren—will thank us

nated.

The blood drives will focus on the need for minority donors - especially African Americans. According to America's Blood Centers, the need for African American blood donors is very high.

"African American donors provide blood with unique antigens, which can mean life-saving treatments for people battling sickle cell, leukemia and other dis-

eases," said Tom Schallert, America's Blood Centers president. "The best blood match for a chronically ill patient requiring multiple blood transfusions throughout his or her lifetime will likely come from a donor of the same ethnic background."

African American donors also benefit people battling sickle cell disease.

"Many people with sickle cell disease require

frequent blood transfusions, and it's best for them to receive blood that closely matches their own," said Elizabeth Simpson, Interim President/COO of the Sickle Cell Disease Association of America. "African American donors provide blood with unique antigens that is vital for people with sickle cell disease."

While the focus is on recruiting minority donors, everyone is encouraged to

attend the drive and donate blood. All the blood collected will be used to help people in the Dallas and Fort Worth area.

delayed by bad weather. Drivers will soon be transporting meals in new thermoelectric containers that will keep food as hot as if it had just came out of the oven.

The thermoelectric containers operate by being plugged into a vehicle's cigarette lighter. This can be a tremendous help for the drivers who deliver more than 3,600 meals on 210 routes each weekday for the Visiting Nurse Association.

Purchase of the heated thermoelectric containers by the Visiting Nurse Association was made possible in part by a Walmart Foun-

dation Impact Grant. "We're glad to receive funding for this," notes Katherine Krause, managing director of community nutrition programs for the Visiting Nurse Association. "And so are the homebound elderly, sick, and disabled individuals who receive Meals on Wheels in Dallas County," she adds.

Census Week in McKinney includes free events for residents

2010 Census forms mailed this week

McKINNEY, TEXAS (March 19, 2010) – This week, every residence in McKinney should receive the 2010 Census form. By filling out the shortest form in Census history, residents can make a lasting impact on the future of the city.

To ensure that McKinney has full participation in the Census, City Council named March 21 – 27, 2010, officially Census Week in McKinney, and the Complete Count Committee has planned a week of activities and events.

Volunteers will be at various community events during Census Week reaching out to the community and encourage participation with the Census. From Census Sunday on March 21 to a free cook-out at Old Settler's Recreation Center, all activities center on stress-

ing the importance of the Census to the city.

The Census estimates that every family of four that does not fill out the census costs McKinney around \$50,000.

In McKinney, census data is used to determine how much funding we receive from the federal government for programs that improve quality of life and help assess the needs of the community. It helps determine where to build roads, hospitals, schools and more.

In March, every household should receive the 2010 Census form to fill out along with a postage-paid return envelope. Census workers will visit households that do not return the forms to take a count in person after April 15.

Answers are protected

by law and are strictly confidential. By law, the Census Bureau cannot share an individual's answers with anyone, including welfare and immigration agencies, and even the White House.

Stephen's advice for students looking for awards? "Apply for as many scholarships as possible, in addition to providing money, scholarships are also excellent resume builders," he said. "They can change your life."

In his own words...

What did you have to do to be considered for the scholarship?

New D.C. Internships offered to graduate students

The UT System's Archer Center will launch a new internship program this summer in Washington, D.C., offering graduate students a chance to live and work alongside our nation's most important decision-makers.

Dr. Donald Arbuckle, clinical professor of public administration in the School of Economic, Political and Policy Sciences at UT Dallas, helped organize the program. The new Summer Graduate Program in Public Policy is largely modeled after Archer's prestigious Bill Archer Fellowship Program for undergraduates, which takes place during the fall and spring semesters. The center was founded to provide professional and academic experiences for UT

System students in Washington, D.C.

Any graduate student in the UT System is eligible, and the 17 competitively selected participants will come from UT Dallas, UT Austin, UT El Paso and UT San Antonio. While the program is likely to appeal most to political science and public affairs students, students from different disciplines – such as education policy, journalism, international relations, communication and economics – will participate this year and in the future.

The Archer Center will assist the graduate fellows in finding internships related to their field of study and help with finding housing.

"This is a great opportunity for students to work in

Congress or the executive branch and see how Washington really works," Arbuckle said. "There's really no way to truly understand how everything gets done, or sometimes fails to get done, in Washington until you experience it on a daily basis and spend time with people as they do their jobs."

Arbuckle speaks from longtime experience. He came to UT Dallas in 2006 after spending 25 years in the White House's Office of Management and Budget. He was the senior civil servant in charge of presidential review of new regulations.

"I'm an evangelist for public service," Arbuckle said. "I think it's incredibly

important to have smart, well-trained people going into government. We have a lot of smart people here at UT Dallas, so I'm glad we are offering them the chance to better prepare to become effective civil servants and leaders."

Kaela Smith is one of the UT Dallas graduate students planning to participate as an intern this summer. She is seeking her master's degree in public affairs.

"This program offers a 'chance of a lifetime' opportunity to gain experience and connections across the DC area," she said. "I am considering moving to D.C. in the future, and this program will help me decide if it is the place for me and if there is a career for me

there."

The program will run from the beginning of June until the last week in August. Students will earn nine credit hours for their work. Some jobs will provide a salary, though most are unpaid. Students pay their own way, though Arbuckle and Archer Center Director Katie Romano are working to arrange some scholarship opportunities to defray the costs.

Students must fulfill certain requirements to be accepted into the program and be selected by a panel of faculty, administrators and Archer Center staff. For example, they must be currently enrolled at a UT System institution, have at least nine credit hours and main-

tain a GPA of 3.3 or higher.

Michael Carriaga, who is seeking her PhD in criminology, said she expects the internship to help her achieve her career goal of working for the FBI.

"Having the opportunity to see what it's all about and to network with the people who are currently working in the federal government will help me to better prepare myself for my future career," she said. "I think opportunities like this are great because they allow students to experience the practical side their studies. It not only gives students insight about their future careers, but it also provides them with invaluable experiences that they will carry with them for a lifetime."

Gift to boost ranks of math and science teachers

(NDG Wire) UTeach Dallas has received a gift of \$500,000 from the O'Donnell Foundation to help increase the number of middle and high school teachers certified to teach math or science.

The gift will help support the UTeach Dallas endowment and provides flexibility to support scholarships, internships and other aspects of the program.

"We are very pleased that the Foundation has provided support to the UTeach Dallas effort to encourage science and mathematics majors at UT Dallas to prepare for teaching careers," said Dr. Myron Salamon, dean of the School of Natural Sciences and Mathematics.

NMSI is a broad public-private partnership formed to reverse the decay of national math and science education and prepare students for the rigors of collegiate science classes.

NSMI has helped replicate UT Austin's original UTeach program in 15 universities across the country, including UT Dallas, the University of Florida, the University of California, Berkeley, Louisiana State University and others.

President Barack Obama announced in early January that NMSI would receive support to expand to 20 universities nationwide. The new replication sites for UTeach include, among others, UT Arlington and UT Tyler, bringing the number

of UTeach sites in the UT System to four.

UTeach Dallas launched in 2008 and expanded rapidly to include 150 students. Sixty percent of UTeach Dallas students are seeking certification to teach science, and 40 percent are seeking certification in math.

Although nearly 50 percent of the nation's teachers walk away from the profession within five years, about 80 percent of UTeach graduates are still teaching five years after graduation.

"The generous support from the O'Donnell Foundation allows us to target areas essential to the continued success of UTeach Dallas," said Dr. Mary Urquhart, co-director of UTeach Dallas.

The church was recently assumed by new management who decided that the group must pay a steep monthly charge to use the facility. Run on a shoestring budget, they had no choice but to find another space.

GiCOP President Leroy Quigg was interviewed on a

newscast in January and the story was seen by Minnie and Bill Caruth. Mrs. Caruth contacted Leroy and, when she learned the full story, she was determined to help the group find another facility. She met with City Manager Mary Suhm, asking if there was a vacant building or other facility that could be used. Within a few weeks, Suhm found that Turner Courts in Pleasant Grove had the space and time slots needed to continue the program.

The organization was started in 1998 by Leroy Quigg, a Dallas policeman in gang unit, and Donnell

Hayden who is a Dallas County Probation Officer. To engage and keep these at risk youth out of gangs, the group encourages them to participate in their basketball program and then they provide other needed services such as counseling and tutoring. Many lives have been turned around through this innovative program, educating the parents as well as the students. Currently 150 youth from ages 8-18 are participating. The group has no steady funding and many expenses have come from the pockets of the two founders.

DART hopes rally boosts census participation

Health care finally passes: What will it mean?

(NNPA) It finally passed. The health care bill for which President Barack Obama has vehemently fought almost since Day One at the White House has finally passed both houses of Congress and was headed to his desk for his signature this week.

As Congressional Black Caucus Members celebrated the 219-212 vote, the President put the historic moment in perspective on Sunday evening:

"Tonight, after nearly 100 years of talk and frustration, after decades of trying, and a year of sustained effort and debate, the United States Congress finally declared that America's workers and America's families and America's small businesses deserve the security of knowing that here, in this country, neither illness nor accident should endanger the dreams they've worked a lifetime to achieve."

He explained, "If you have health insurance, this reform just gave you more control by reining in the worst excesses and abuses of the insurance industry with some of the toughest consumer protections this country has ever known - so that you are actually getting what you pay for."

"If you don't have insurance, this reform gives you a chance to be a part of a big purchasing pool that will give you choice and competition and cheaper prices for insurance. And it includes the largest health care tax cut for working families and small businesses in history - so that if you lose your job and you change jobs, start that new business, you'll finally be able to purchase quality, affordable care and the security and peace of mind that comes with it."

President Obama has

fought long for the bill, escalating the battle after the death of his friend and former colleague Sen. Ted Kennedy last year. Kennedy was considered the Senate's champion for health care. The bill passed the Senate on Christmas Eve.

Still, many will now wonder what it all means for African-Americans who

document, other key provisions in the legislation that CBC members fought to have included are:

- Expanded support for community health centers, which play a vital role in expanding access to preventive and other care in our

nation's most vulnerable communities.

- Greater support for programs that will increase the racial and ethnic diversity in the nation's health workforce, as well as improved data collection so that we can better measure health inequities and develop solutions to end all health disparities.

- Strengthening the existing Office of Minority Health at HHS, creating new Offices of Minority Health across HHS agencies, and establishes the National Center on Minority Health and Health Disparities at NIH an Institute.

- Inclusion of coverage for resident of the U.S. territories, including a significant infusion of new Medicaid dollars, as well as access to the Exchange so that Americans in the territories will have access to affordable, high-quality health insurance plans.

- Guarantees transparency on rates and enables state insurance commissioners to recommend to the National Insurance Commissioner whether a particular insurer should participate in the Health Insurance Exchange, taking into account excessive or unjustified premium increases in making that decision.

termination. This will hold private insurers accountable, ensure affordability and help provide quality coverage for American families.

In addition to significant health care provisions, the CBC also fought for the inclusion of many very important education provisions including:

- Invests \$35 billion over 10 years to increase the maximum annual Pell Grant to \$5,550 in 2010 and to \$5,975 by 2017.

- Invests \$2.55 billion in Historically Black Colleges and Universities and Minority-Serving Institution

- Invests \$2 billion in a competitive grant program for community colleges to develop and improve educational or career training programs.

- Saves taxpayers \$61 billion over by switching to the less expensive Direct Loan program.

House Majority Whip Jim Clyburn (D-S.C.) also applauded the long-awaited passage. "Despite deafening protests from the other side, the nonpartisan Congressional Budget Office said the reforms included in this bill will reduce our deficit by \$143 billion in the first 10 years and \$1.2 trillion in the second 10 years. This bill will also create jobs, 400,000 good-paying jobs, reliable jobs, for every year and for small businesses. Small businesses will get a tax break on their health care premiums that will free up money for them to hire 80,000 more employees," he said in his floor speech. "Mr. Speaker, we have debated this issue for several generations. The time has come to act. This is the Civil Rights Act of the 21st Century. Tonight, we will take a significant step to move our country forward."

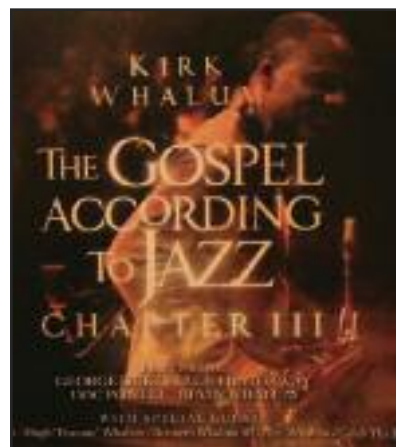

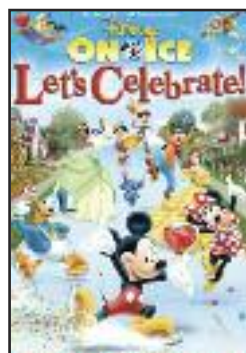

More than 180 local IRS offices open this Saturday to help taxpayer

WASHINGTON — The Internal Revenue Service announced today that IRS offices will be open nationwide on Saturday, March 27 from 9 a.m. to 2 p.m., local time, to help taxpayers. The location of participating offices is listed on IRS.gov.

"We are holding these special open houses to give taxpayers who are struggling in these difficult economic times more opportunity to work directly with IRS employees to resolve their tax issues," said IRS Commissioner Doug Shul-

man. "We will host more than 180 open houses this Saturday."

During the expanded open-house hours on Saturday, taxpayers will be able to address economic hardship issues, make payment arrangements or get help claiming any of the special tax breaks in last year's American Recovery and Reinvestment Act, including the:

Homebuyer tax credit - a refundable credit equal to 10 percent of the purchase price up to a maximum of

\$8,000 (\$4,000 if married filing separately). A first-time homebuyer is an individual who, with his or her spouse if married, has not owned any other principal residence for three years prior to the date of purchase of the new principal residence for which the credit is being claimed.

American Opportunity Credit - a federal education credit to offset part of the cost of college under the new American Opportunity Credit. This credit modifies the existing Hope credit for

tax years 2009 and 2010, making it available to a broader range of taxpayers. Income guidelines are expanded and required course materials are added to the list of qualified expenses. Many of those eligible will qualify for the maximum annual credit of \$2,500 per student.

Making Work Pay credit - In 2009 and 2010, the Making Work Pay provision of the American Recovery and Reinvestment Act will provide a refundable tax credit of up to \$400

for working individuals and up to \$800 for married taxpayers filing joint returns.

Expanded Earned Income Tax Credit - There is now a new tax classification for EITC recipients who have three or more children and a higher credit amount – up to \$5,657.

In addition to IRS help, community organizations partner with the IRS. Volunteer Income Tax Assistance (VITA) programs assist people who earned \$49,000 or less, and Tax Counseling for the Elderly

(TCE) programs assist individuals 60 and over with their 2009 income tax return preparation and electronic filing. Many of these sites have Saturday hours while others offer assistance at various times during the week. To locate the partner sites in this area call 1-800-906-9887.

In addition to the open houses this Saturday, the IRS will open many of its offices on three additional Saturdays in the spring and early summer.

"Private Eyes" can increase profitability

Private investigators can read deeper into the retrieved data by recognizing potential "red flags" that inexperienced researchers may overlook. A red flag can range from anything like an invalid Social Security Number to finding no record of an individual's degree or certification. A red flag may even be an active

warrant. As a matter of fact, one company had a high price to pay for neglecting to conduct a thorough background check.

Case in point: Two employees of a cleaning company were cleaning a home in California. While working in the home, the two apparently roamed around, casing the alarm systems, doors and windows. The pair had previously spent hours in the home as carpet cleaners before they devised their scam.

They left the home, only to return several months later to rob the place. The armed robbers were caught ran-

sacking the home and wound up shooting the homeowner.

As it turns out, both men had criminal records and felony convictions before they were hired. Needless to say, the company who hired them was charged with negligent hiring and was ordered to pay \$11 million in damages. (www.microsoft.com/smallbusiness/resources/management/recruiting-staffing/you-cant-skip-on-employee-background-checks.aspx) Having a private investigator discover and address those

tions without a special permit. Among them are Irving, Mesquite, Sachse, Richardson, Garland and Little Elm.

Bob Jackson, director of AARP Texas, noted that AARP will continue working with local officials in every corner of the state to urge similar actions.

"The abusive lending practices of these largely unaccountable operations drain community wealth and trap consumers into a destructive

cycle of debt," Jackson said. "We hope that these efforts at the local level will spread like wildfire in 2010 and signal to the Texas Legislature that Texans are serious about ending these abuses."

Payday loans are cash advances due by the borrower's next payday. Auto-title loans are similar but secured with car titles. Borrowers of these two types of loans can incur fees from both their lenders and their

banks. They can lose their vehicles, even if they've paid hundreds or thousands of dollars in interest and fees.

Payday and auto title lenders use a loophole in state law to charge Texans an annual percentage rate (APR) of more than 500% for loans by operating as "credit service organizations." This allows them to escape any regulatory oversight and consumer protections that apply to other

lenders. They operate a multi-billion dollar lending business in this state, yet, unlike most other lenders, are not licensed, regulated or subject to any meaningful consumer protections.

Texas has more than 2,800 payday lenders and auto title lenders. Among the key characteristics are:

- Average payday loan borrower pays \$840 for a \$300 loan.
- Women make up the

majority of payday loan borrowers.

- Payday and auto-title loans do not generate sales tax revenue for local governments.

- Concentrations of payday and auto-title locations give neighborhoods a look of economic decline and hinder other, more beneficial businesses, from locating in those neighborhoods.

Fifteen states and the District of Columbia have

adopted an annual percentage rate limit of 36% or lower for these small loans. The federal government has adopted a similar rate cap for payday and auto title loans to the military based on a Department of Defense finding that the loans "undermine military readiness, harm the morale of troops and their families, and add to the cost of fielding an all-volunteer fighting force."

Synthia Saint James, a world renowned and celebrated artist, author and architectural designer was honored with the History Maker Award for designing the first Kwanzaa Stamp for the U.S. Postal Service; a 37¢ stamp, it was issued on October 16, 2004. She was also the first painter to receive the prestigious Trumpet Award on January 30, 2010 at their 18th Annual Awards Ceremony.

Saint James serves as an ambassador for the Susan G. Komen for the Cure Foundation.

Barnes & Noble celebrated Black History Month 2009 and will do so in 2010 by featuring her art on merchandise in their 800 stores nationwide and on their website. She will also be inducted into the Hall of Fame of the National Association of Women Business Owners.

At an interview, Saint James said of herself, "Modest and proud, sincere and strong, hardworking and light-hearted, warm and witty, audiences love her! She is the consummate professional." --Synthia Saint James.

Ida B. Wells, was a journalist, anti-lynching cr-

usader And a women's rights advocate. She was born into slavery in Holly Springs, Mississippi in 1862. Her parents died of yellow fever when she was 14, and Wells, though minimally educated, began teaching to support her seven younger siblings. She later graduated from Rust College and got a teaching position in Memphis, TN in 1888.

In 1889 she became co-owner of a Memphis newspaper, *The Free Speech and Highlight*. Her editorials protesting the lynching of three Black friends led to a boycott of White businesses, the destruction of her newspaper office and threats against her life.

Undeterred, she carried her anti-lynching crusade to Chicago and published *Southern Horrors: Lynch Law in All Its Phases*, which documented racial lynching in America.

In 1895 she married Ferdinand L. Barnett, attorney and owner of the *Conservator*, Chicago's first black newspaper, and hyphenated her name to Wells-Barnett.

She was a founder of the National Association of Colored People (NAACP), marched in the parade for universal suffrage in Washington, D.C. (1913) and es-

tablished the Negro Fellowship League for Black men and the first kindergarten for Black children in Chicago.

She once said: "One had better die fighting against injustice than die like a dog or a rat in a trap." She also said, "I'd rather go down in history as one lone Negro who dared to tell the government that it had done a dastardly thing than to save my skin by taking back what I said."

The U.S. Postal Service honored her with a 25¢ on February 1, 1990.

Ethel L. Payne was an inspiration among her peers and a voice of her people. She dedicated her career to topics that touched her heart. Dubbed 'the first lady of the Black press,' many of her writings revolved around civil rights and international politics. Payne dedicated her life to a journalism career and even forfeited marriage and children so that she could further her craft. Unafraid to expose injustices, she became known for her hard-nose tactics and her ability to cover all angles of a story. Such traits won her many praises, but she found that everyone was not a fan of her mission.

Payne was born on August 14, 1911 and raised in

Chicago. She was the granddaughter of slaves and the daughter of William Payne and Bessie Austin Payne. Her interest in writing arose from nightly sessions where her mother read the Bible and literature to her and her siblings. Originally, Payne wanted to be a civil rights lawyer, but when she was not accepted into law school, she had to find a new career ambition. She left the city in 1948 to work as director of an army club in Tokyo, where her journalism talents were discovered. The U.S. Postal Service honored her with a 37¢ on September 14, 1990.

types of red flags and hidden issues before employment begins is much easier and less costly than attempting to correct a problem uncovered after employment begins.
