## Hispanic Caucus Responds to Calls for Boycott of Census

(NDG Wire) The Congressional Hispanic Caucus (CHC) is responding to statements from several organizations urging some immigrants to boycott the 2010 Census. Congresswoman Nydia Velazquez, Chairwoman of the CHC, stated the fol-

lowing in response to those statements:

"The CHC has been working since the last census wrapped up nearly 9 years ago to ensure a fair and equal count in 2010. The next decade will be dictated by these numbers, and they must provide an

accurate portrait of our nation and the needs of its diverse communities. To not be counted would have political implications and jeopardize vital resources, including federal funding for schools, health care, job training and infrastruc-

ture." Congressman Charles A. Gonzalez, 1st Vice Chair of the CHC and Chair of the group's Civil Rights, Veterans and Worker Protections Task Force, offered the following response to calls for a boycott:

## NAACP Centennial Celebration History of Texas Branches

(TPA) America's history is an inspirational story of pioneers who gambled their lives and those of their families in search of liberty and freedom. But that remarkable history bears the taint of a history that challenged these lofty goals with years of denying freedom and lib-

erties to many of its people. Spanning centuries, America has persecuted racial and ethnic groups, women, children and those of sexual orientation. Amidst these abuses, those heaped upon the African immigrant have been the most long lasting and cru-

eldest. From its inception, slavery in America established and institutionalized the denial of civil and human rights to people brought forcibly onto American soil.

In 1909, a group of sixty citizens, Black & White banned together to establish

## Fifty-five Years Later: American Education Separate and Unequal

In the case of *Brown vs. the Board of Education* on May 17th 1954, the Supreme Court decided that the Constitution of the United States must guarantee equal education for all American citizens.

In this landmark case, schools were desegregated across the South and the breath and width of the United States. Fifty-

five years later, however, we find American education is still sporadically separate and unquestionably unequal.

The number of government and private sector studies confirms that the achievement gap between African Americans and Whites is astounding and almost identical to the gap in 1955.

The struggle of this

## Alishia Givens

Devoted Mix 102.9 listeners might have noticed a new talent on the radio recently. Was she a hip, young Hollywood star? A famous radio personality on her way through town? It was Alishia Givens, a Grand Prairie high school student pursuing her dreams on Dallas' airwaves.

Givens, a participant in the Dallas Elevators Powered by Coca-Cola program, received the opportunity to shadow working radio professionals and explore broadcasting oppor-

tunities for her future. She had experiences at both Movin' 107.5 and Mix 102.9 FM.

"I didn't want to leave because I was having so much fun!" said Givens.

"The staff made me feel so welcome that I soon forgot we were on the radio; I felt like we were hanging out, talking. I've been looking forward to going back since the day I left - I can't wait!"

On Mix 102.9, Givens bantered on the air with Victoria Snee, who hosts the

Morning Mix show.

"Watching Alishia light up and show her fun, unique personality on air was rewarding for me," said Snee, who is a role model in the Dallas Elevators Powered by Coca-Cola program. "Anyone who gets involved with these dynamic young people gets way more out of it than you ever put in. I am proud to know Alishia and be a part of her success."

Givens, a senior at South Grand Prairie High School, is the captain of the track team, president of DECA (business marketing club), and serves on the stu-

dent council. She volunteers on Saturdays, helping elementary students prepare for the TAKS test. Givens will attend Texas A&M University in the fall.

Dallas Elevators Powered by Coca-Cola is a program that brings extra enrichment and opportunities to a select group of high school juniors and seniors who are also members of one of the many Boys & Girls Clubs of Greater Dallas. The mission of the program is to encourage students to elevate their skills in the classroom, at home, in extra-curricular activities, and wherever their interests

lie.

"These kids deserve an opportunity to be excited about their future," said Ben Lawson, director of Bottler Sales & Marketing with Coca-Cola of North America. "We encourage the community to get involved

in offering experiences. It takes so little time -- often as little as two or three hours -- but it can significantly impact a teen's

## Annette Gordon-Reed

Annette Gordon-Reed's "The Hemingses of Monticello: An American Family," which received the National Book Award last fall, won for history. Gordon-Reed's book documents the life and family of Sally Hemings, the slave girl who many believe had an intimate relationship with Thomas Jefferson.

"Race is something that people are quite focused upon," said Gordon-Reed, currently in Sydney, Australia

for a conference of Thomas Jefferson scholars and scheduled to give a talk on President Obama. "It's an internationally interesting subject. People here are fascinated by our history."

Annette Gordon-Reed, earned a place in history with her first book, *Thomas Jefferson and Sally Hemings: An American Controversy* (University Press of Virginia, 1997), which had an acclaimed but stormy recep-



tion when published in 1997, and which *The New Yorker* described as "brilliant." She is recognized as one of our country's most distinguished presidential scholars.

Gordon-Reed did not take a

definitive position on whether Jefferson had a liaison of nearly 40 years with Hemings, or whether Hemings bore him several children. Instead, in the scrupulously researched book, Professor Gordon-Reed brought her lawyerly instincts and a lifelong fascination with Jefferson to the question of how the issue had been presented by Jefferson's many distinguished biographers. In particular, it was the vehemence of their denials that such a relationship might have existed that piqued her interest. She felt that history

should be able to record both Jefferson's enormous contributions, and the lives and voices of the blacks who were part of his life and that society.

News published in 1998 described DNA tests showing a near-certain confirmation of a genetic link between Jefferson and Hemings' youngest child, Eston. Professor Gordon-Reed subsequently rewrote her introduction for the paperback edition to reflect this news.

Gordon-Reed, who grew up in still-segregated east Texas,

became interested in Jefferson in elementary school after reading a children's biography of him, narrated by a fictional slave boy. At 14, she joined the Book-of-the-Month Club (concealing her status as a minor) to receive Fawn Brodie's biography, *Thomas Jefferson: An Intimate Portrait*. She continued her study of Jefferson's life at Dartmouth College, where she majored in History, graduating in 1981. She attended Harvard Law School, where she was a member of the Law Review.

## Eugene Robinson



Eugene Robinson is an Associate Editor and twice-weekly columnist for *The Washington Post*. His column appears on Tuesdays and Fridays. His columns are syndicated by *The Washington*

Post Writers Group. Robinson is a member of the National Association of Black Journalists. In a 25-year career at *The Post*, Robinson has been city hall reporter, city editor, foreign correspondent in Buenos Aires and London, foreign editor, and assistant managing editor in charge of the paper's award-winning Style section. In 2005, he started writing a column for the Op-Ed page. He is the

author of "Coal to Cream: A Black Man's Journey Beyond Color to an Affirmation of Race" (1999) and "Last Dance in Havana" (2004).

Robinson was born in Orangeburg, South Carolina where he attended Orangeburg High School. He attended the University of Michigan, where, in his senior year, he wrote for the school newspaper, the *Michigan Daily*.

In 1976, he began his journalism career at the *San Francisco Chronicle*, where he covered the trial of publishing heiress Patty Hearst. He joined the *Washington Post* in 1980 and worked his way up through the ranks, starting as a city hall reporter. He then became assistant city editor, city

editor, South America correspondent, London bureau chief, foreign editor, and, most recently, assistant managing editor. He began writing opinion columns for the paper in 2005.

Robinson appears frequently on MSNBC as a political analyst on shows such as *Race for the White House*, *Countdown with Keith Olbermann*, and *Hardball with Chris Matthews*.

On Monday April 20 Robinson was awarded the 2009 Pulitzer Prize for Commentary in recognition of his columns during the 2008 presidential campaign. Robinson is a member of the National Association of Black Journalists and has received numerous journalism awards.

# The Truth Behind The Tax Protest Rallies

On April 15, the deadline to file income taxes, demonstrators protested at more than 750 Tax Day tea parties across the country. Capitalizing on the symbolism of the anti-tax Boston Tea Party of 1773 the events were touted as protests against government spending with particular focus on the Obama administration's \$787 billion stimulus package and the proposed \$3.5 trillion budget.

The Wall Street Journal and other media pundits would have us believe that these tax 'revolutionaries' had no political or organizational basis but were merely ordinary people who were simultaneously influenced to protest by the hypnotic power emanating from the mysterious Information Superhighway.

While this plot line, if true, would have all the makings of a TV movie it does not take a CSI expert to surmise that the well organized rallies weren't simply spontaneous grass-roots outpourings of citizens disgruntled with government fiscal irresponsibility.

A cursory tracking of Facebook, Twitter, and other blog internet sites used to generate support for the tea party rallies uncovers the depth of the organization and funding behind the so called non-partisan grass-roots movement.

The sites show conclusively that the tax rallies were created, financed and fueled by the financial, political, and media support of current and former GOP advocates.

Conservatives Sean Hannity and Neil Cavuto hosted events in major cities and Fox News provided day long coverage of the rallies. The fact that the movement attracted potential 2012 Republican presidential candidates such as former House Speaker Newt Gingrich,

Louisiana Gov. Bobby Jindal, and South Carolina Gov. Mark Sanford validates the conclusion that the rallies were politically motivated and anti-Obama.

According to the Associated Press a primary promoter of the tea parties was FreedomWorks, a conservative nonprofit advocacy group based in Washington, D.C., led by former Republican House Majority Leader Dick Armey of Texas.

Additionally, the Tea Party Movement's own web site lists four sponsoring organizations: The New American Tea Party, the ReTeaParty, the Tea Party Revolution and the Free Pocket Constitution.

our founding fathers intended."

Lastly, the fourth, the Free Pocket Constitution, which offers free, pocket-sized copies of the US Constitution, is sponsored by the Heritage Foundation, this country's leading - and very well-funded - right-wing think tank.

Do the tax protest rallies have any merit beyond the obvious conservative politicizing?

All Americans should be deeply concerned over the enormous deficit spending this year and the increasing deficit spending planned for the next decade - spending that will more than double our entire national debt.

Property taxes and taxes on investment profits are also. State tax revenue fell 4% in the last quarter of 2008, the first decline in six years and the largest in over 50. Preliminary numbers suggest the first quarter of 2009 will be three times. Average state tax collections in January and February were down 12.8% compared to the same time in 2008. The states will be looking to the federal government for more support which adds more debt.

As the economy worsens, it's inevitable that the working poor will get more and more angry about the declining financial crisis. From bailouts to bonuses to complex tax codes it is obvious that most of our hard-earned tax dollars aren't being used to provide jobs, schools, housing, health care or taking care of the disadvantaged but are being used to primarily support the very wealthy and to pay for past, present and future wars.

The working poor will blame the rich for the increasing deficits. The rich will exercise their options to abandon ship and take their wealth offshore. In the ensuing financial chaos those without options will suffer the consequences as the purchasing power of their dollars disappear. The question is: Can Obama turn the economic ship around before the dollar is rejected as the global currency?

In the face of this growing financial crisis the minority GOP has jumped on the tea tax bandwagon in the hopes of regaining political momentum. Even as America begins to show signs of potential death convulsions partisan politics takes priority over saving the country.

A recent Congressional Budget Office report compares the deficits of the 1980s and 1990s to the current and future budgets. The CBO estimates that the administration's proposed budget will add more than \$10 trillion to the total federal debt by 2019 - approximately as much total debt as was outstanding at the beginning of 2007.

## Local High School JROTC Team to Compete in National Academic Bowl in Washington, DC

After two phases of competition, the Plano East Senior High JROTC academic team, Plano, TX, will compete in the final Championship round of The College Options Foundation's 2009 JROTC Leadership and Academic Bowl in Washington, D.C., on the campus of George Mason

University, June 26 - 30, 2009.

## Grants Combat Teen Smoking

Tighter budgets may mean less money for schools and local police to enforce laws against teen smoking, but grants available from the Texas Comptroller's office can help keep tobacco away from underage users.

"Texas teens illegally buy or smoke more than 67 million packs of cigarettes each year," Comptroller Susan Combs said. "Combating this threat to our children's health is crit-

ical, even during budget-conscious times."

Grants ranging from \$1,000 to \$150,000 can be used for specific activities such as tobacco education, keeping schools and school events tobacco free and sting operations to catch retailers selling tobacco products to minors.

The deadline to apply for 2009-10 grants is May 4 for schools with on-campus law enforcement and May 11 for police depart-

ments, sheriffs, constables and district attorneys. The grant amount depends on the number of local tobacco retailers or the number of students who will receive education about smoking risks and the law against teen smoking.

The Fort Bend County sheriff's office says the numbers prove the grant program works. They sent underage decoys to buy cigarettes 377 times last year, and 10 retailers sold

tobacco to the minor, a buy rate of 2.7 percent. The sheriff's office says that is a dramatic improvement since the first sting operations in 2001, when decoys were able to purchase cigarettes on 28.6 percent of their attempts.

## GISD Exceeds All State Marks on TAKS Reading

Garland ISD students surpassed every statewide mark on the recently administered TAKS Reading section according to scores received by the district's Planning, Research and Evaluation Department.

More than 12,000 GISD students in grades 3, 5 and 8 were tested during last month's Reading portion. The Texas

Education Agency monitored their performances by grade level, divided into five student groups: All students, African American, Hispanic, White and Economically Disadvantaged.

Each of those student groups in third, fifth and eighth grade bested state averages in both the "standard" and "commended" categories.

issue was addressed at our recent National Action Network convention, among educators, clergy, elected officials, civil rights leaders and activists, by Vice President Joseph Biden, HUD Secretary Shaun Donovan, and Education Secretary Arne Duncan.

We struggled with the fact that even with a well-educated African-American President and First Lady living in the White House seeking a similar education for their two beautiful daughters, only 55 percent of African-Americans earned a

high school diploma nationally.

Given the technological advancements in the world and the weak economy, to allow this gap to continue unchallenged is to render African-Americans dysfunctional and permanently captive to an underclass.

We must challenge for equal funding for all public schools.

We must challenge accountability of teachers and administrators. We must inspire more parental and community involvement in the education of our chil-

dren. And we must give incentives for good productive teachers to go into troubled areas and confront this crisis on the ground.

To ignore this problem is to plant the seeds of economic and social despair to African-Americans for generations to come. This is no more of a compelling issue in our community and a greater threat to our future than not completing the task started by the Brown vs. Board decision pushed for equal education for all.

That is why on May 16th, thousands will join

NAN at the White House Ellipse in Washington D.C. to commemorate the anniversary of Brown vs. Board of Education and recommit to finishing the journey that the case started.

It was a long journey from the Outhouse to the White House. Now we must democratize the school house.

## Senate Passes 70th Bill of Session to House Accepting Federal Stimulus Money

It was another short week in Austin for the Legislators last week, but again they were very productive.

The Texas House of Representatives' Criminal Jurisprudence Committee passed House Bill (HB) 498 by Representative Ruth Jones McClendon on Tuesday, April 14. HB 498 creates a commission to investigate and overturn wrongful convictions in Texas.

The Commission, named the Timothy Cole Innocence Commission, after Timothy Cole, an Army veteran wrongly imprisoned for over 25 years and died shortly before his conviction was overturned due to a false eye witness statement, would study various types of evidence, procedures for evidence collection and processing, and develop policies to ensure evidence is not contaminated or false.

Governor Rick Perry designated the overseeing and review of convictions an emergency issue for the lawmakers earlier this session and Timothy Cole's family has been to the Capitol several times to meet with lawmakers. The bill, which is not yet scheduled to be voted on by the whole House, is expected to pass soon.

Also on Tuesday, the Senate Health and Human

Services Committee heard Senate Bill (SB) 544 by Rodney Ellis. SB 544 institutes a state wide smoking ban in all establishments except for smoking rooms in lodging facilities, veteran or fraternal halls, or registered smoking bars and tobacco shops.

Ellis said, "Our state and our state's employers need to embrace policies and programs that will truly clear the air, improve health for every Texan, and make a positive contribution to managing rising health care costs in Texas."

As of Friday, April 17, the bill was still pending in committee; if passed into law, Texas would become the 25th state in the nation to outlaw smoking. Currently 28 Texas cities have a smoking ban.

While most of the general public was finishing their taxes or attending TEA Parties on Wednesday, April 15, the Senate passed two bills.

First was Carlos Uresti's SB1049. This bill changes the minimum legal age of people who can buy cigarettes from 18 to 19. If passed, it is estimated there would be a 20 percent drop in cigarette smokers who are 18 or younger. The state is also estimated to lose \$12 million in revenue from tobacco sales, but would save more in state paid medical expenses to people who suffer from a smoking related sickness.

The second bill passed

was SB 1175 by Dan Patrick. If passed, SB 1175 would make it a crime for people to refuse to give correct identifying information about themselves to a police officer if arrested or lawfully detained.

As of Friday, April 17, neither Senate Bill is scheduled for review by the House.

On Thursday, April 16, Governor Perry signed this session's first bill into law. SB 769, by Senator Tommy Williams, would cut costs and speed up electricity restoration after a natural disaster. The new law would allow utility companies to use secure financing to quickly attain funds to repair and reconnect the power infrastructure in damaged areas. Allowing utility companies to finance repairs will make restoration quicker and lower the cost to consumers after the disaster.

"I don't want to rain on anyone's parade, but Hurricane Ike isn't the last storm that'll ever hit Texas. The bill I'm signing today will help us prepare even better for the next storm and recover more quickly when it has gone," Governor Perry said. He later added, "With every storm, we examine our approaches to do better next time. This legislation is part of that process and it will better prepare Texas to recover from Mother Nature's next big show."

Also on Thursday, The

House passed HB 2113 to the Senate.

Armondo Walle's bill would create a paid holiday on September 11 for firefighters and police in recognition of efforts on September 11, 2001. The House passed the bill unanimously and it was received for review by the Senate's Intergovernmental Relations Committee but as of Friday, April 17, not yet on their calendar.

On Friday, the Senate passed their 70th bill to the House this session. SB 1569, by Kevin Eltife, would allow Texas to accept federal stimulus money for unemployment benefits despite the Governor's disapproval. Doing so would also change the way the State calculates benefits paid to citizens. The bill would also allow part timers who quit their jobs due to family obligations to receive unemployment benefits. The House has not scheduled SB 1569 for review as of Friday, April 17.

Saturday, April 18, the House announced they have passed their version of the state's budget. The House's version reduces spending by 2.5 percent, uses \$11 billion of federal stimulus money on one time expenditures, and allots \$8 billion for general revenue, totaling \$178 billion for the next two years. It will be received by the Senate on Monday, April 20, for review.

# Upgrade Your Portfolio in 2009

It's no secret that 2008 was rough on most investors. And 2009 didn't get off to a particularly good start, either. Yet there's still plenty of time left this year to upgrade your investment portfolio in a way that can help you stay on track toward your long-term goals.

But what exactly does it mean to "upgrade" your portfolio? Do you have to systematically go through your investments and eliminate all those that performed poorly last

year? Or should you just sell of any investments that you think are risky?

Neither one of these ideas are good solutions. In the first place, a bear market such as we've experienced tends to drag everything down, even quality investments. Furthermore, you can't get rid of all investments that carry some risk — because all investments carry some risk. So instead of taking either of these two approaches, consider the following moves:

- Review your portfolio objectives. Your investment objectives are based in large part on your risk tolerance and

stage of life. If these factors have changed, you may need to rebalance your portfolio. In fact, it's a good idea to rebalance your holdings at least once a year, regardless of the markets or your life situation.

- Increase your portfolio's quality. Right now, you can find many quality investments that are attractively priced. In past market recoveries, these types of investments usually have recovered faster than lower-quality ones. Although past performance is not an indication of future results, the biggest gains usually occur early in market rallies. You don't want to

wait too long to explore these opportunities.

- Don't overload on a single investment. In general, it's not a good idea for a single stock to total more than 5% of your portfolio. In recent months, many investors have learned the hard way about the dangers of holding too much stock in a single company — even one that once appeared to be a blue chip firm. And the same principle applies to your employer's stock: If it's offered as an option in your 401(k), don't go overboard on it.

- Own a sufficient number of stocks. How many stocks should you own to diversify the equi-

ty portion of your portfolio? There's no one right answer for everyone, but to really attain proper diversification, you may need to own at least 20 to 25 stocks, spread out among all the major industry sectors. Of course, diversification by itself cannot guarantee a profit or protect against loss, but it can give you more chances for success while helping to reduce the effects of volatility on your portfolio.

- Invest in a range of fixed-income securities. Just as you need to own a reasonable amount of stocks, you should also own a number of fixed-income vehicles — per-

haps 10 to 20, depending on your situation. You can diversify these holdings by purchasing different types of bonds — corporate, municipal and Treasury — and certificates of deposit. To further diversify, buy fixed-income vehicles with varying maturities.

You can't control the economy or the financial markets. But by following the proven techniques described above, you can help control your own financial destiny. Consider taking action soon.

lives of all Hispanics throughout the next ten years; we must not let this important opportunity for representation pass us by."

"It is vital for all people, especially minorities, to be counted. Census numbers help decide the number of U.S. House members each state is entitled to have and provide the private sector with necessary data to make business investments in

specific communities, both of which, will have a dramatic impact on our nations future.

The Obama administration continues to move forward on immigration reform and we must have patience as we develop comprehensive solutions. It will continue to take time, but in the meanwhile we should encourage everyone to be counted in the 2010 census."

an organization that remains the single organization linked to civil rights advocacy throughout the world; the National Association for the Advancement of Colored People. Known internationally as the NAACP, this organization quickly established branches throughout the United States of America.

The first branch of the NAACP in Texas was established in El Paso in 1915. The founding of this unit cannot be told without the relating of the life of its most noted chartering member, Dr. Lawrence Aaron Nixon, Black physician and voting-rights advocate, was born in Marshall, on Feb. 7 or 9, 1884, the son of Charles and Jennie (Engledow) Nixon. He attended Wiley College in Marshall and received his M.D. degree in 1906 from Meharry Medical College, Nashville, Tenn.

He began practice in Cameron, Milam County, Texas. In 1909 there were ten lynchings of Black men in Texas, one of which occurred in Cameron on Nov. 4 and influenced Nixon to become a civil-rights advocate. In December he moved to El Paso. There he established a successful medical practice, helped organize a Methodist congregation, voted in Democratic primary and general elections, and in 1910 helped to organize the local chapter of the National Association for the Advancement of Colored

People.

In 1924 NAACP Field Secretary William Pickens visited El Paso and announced that the NAACP intended to test the constitutionality of the Terrell Law. The Terrell Law was passed in 1923 by the Texas Legislature, which stated "In no event shall a Negro be eligible to participate in a Democratic primary election...in...Texas." On July 26, 1924, with the sponsorship of the NAACP, Nixon took his poll-tax receipt to a Democratic primary polling place and was refused a bal-

lot. Thus began a twenty-year struggle in which Nixon and his El Paso attorney, Fred C. Knollenberg, twice carried their case to the United States Supreme Court.

In 1927 Nixon v. Herndon, Justice Oliver Wendell Holmes wrote the decision that Nixon had been unlawfully deprived of his rights under the Fourteenth Amendment. In 1932 Justice Benjamin Cardozo ruled for Nixon again, in Nixon v. Condon, holding that political parties are "custodians of official

experience advisor. Joe was a member of Alpha Phi Alpha Fraternity.

Funeral services were held on April 22 at Crenshaw United Methodist Church in Los Angeles.

power...the instruments by which government becomes a living thing." The Nixon cases were major steps toward voting rights, but there were legal loopholes under which the state and the Democratic party continued to deny primary votes to Blacks. It was not until the decision in Smith v. Allwright ended the White

primary that the way was cleared, and on July 22, 1944, Dr. and Mrs. Nixon walked into the same El Paso voting place and voted in a Democratic primary. Nixon was married first to Esther Calvin, who died in 1918, then in 1935 to Drusilla Tandy Porter, who survived him. He had four children. Nixon died on

March 6, 1966, as a result of an automobile accident.






## PROPOSITION NO. 1

Shall Chapter XI of the Charter of the City of Dallas be amended by adding Section 15 to: (1) prohibit the city from, directly or indirectly, using, lending, or transferring city money or property, or lending the city's credit, for the purpose of siting, financing, constructing, acquiring, leasing, or operating a hotel or other lodging facility; (2) prohibit the city from creating, authorizing, or sponsoring any special-purpose governmental entity or any non-profit corporation (including a local government corporation or a public facility corporation), or authorizing the issuance of bonds, notes, or other debt instruments by such special-purpose governmental entity or non-profit corporation, for the purpose of siting, financing, constructing, acquiring, leasing, or operating a hotel or other lodging facility; (3) require the city to assume the powers and duties of any existing local government corporation previously created or authorized by the city for the purpose of siting, financing, constructing, acquiring, leasing, or operating a hotel or other lodging facility; (4) require the city to alter the structure, organization, programs, and activities of any existing public facility corporation sponsored by the city and to prohibit such corporation from siting, financing, constructing, acquiring, leasing, or operating a hotel or other lodging facility; and (5) provide certain exceptions?

### (PROPOSICIÓN NÚM. 1)

## PROPOSITION NO. 2

Shall Chapter XI of the Charter of the City of Dallas be amended by adding Section 16 to: (1) prohibit the city of Dallas (including any special-purpose governmental entity, nonprofit corporation, and any other entity created or controlled by the city) from providing more than a total of \$1,000,000 in financial assistance (including any grant of tax concessions or relief, any authorization of debt or debt instruments; any expenditure of public funds; and any exchange, grant, or below-market sale or lease of city-owned land) to any private development project (the primary purpose of which is to construct or aid in the construction, renovation, repair, alteration, or remodeling of any hotel, convention center, luxury residential condominium, or retail facility, or the infrastructure of any such facility), unless the city gives at least 65 days' public notice (including posting the notice on the city's website for the entire 65-day notice period) before approving the financial assistance and obtains voter approval for the financial assistance at a regular or special election when voter approval is required by a petition that is signed by at least 500 residents of the city and filed with the city secretary within 60 days after the public notice is posted; (2) exempt from the financial assistance restrictions any retail development of less than 50,000 square feet that serves a subsidized residential development; and (3) provide a severability clause?
