Coppell Mayor's suspected murder

The Dallas County medical examiner's preliminary report on Wednesday indicates Coppell Mayor Jayne Peters, 55, shot and killed her 19-year-old daughter and then fatally shot herself in the head.

Their bodies were discovered in their home Tuesday night.

City spokeswoman Sharon Logan reported there was no sign of forced entry at their home located at 700 block of Greenway Drive.

Peters was appointed the mayor of Coppell in May 2009. Professionally she was a software developer.

When Peters did not arrive at a regularly scheduled

city council meeting on Tuesday night, the city manager requested the police visit her home where they discovered the bodies.

In a press release the city stated, "The Coppell Police Department's investigation is still on-going and will not be completed until any/all investigative leads have been exhausted."

Racial Discrimination in the Gulf Reconstruction

(NNPA) The big story about the NAACP convention meeting in Kansas City was whether President Barack Obama would come or not. But I think that Ben Jealous hit the right nerve in his opening speech to the Convention when he delivered a report that organization had put together from a series of meetings in affected communities in the Gulf area where the oil spill oc-

curred.

The Report found that minorities have been locked out of contracts for clean-up and other kinds of work and are routinely given the lowest-paying jobs; people are at risk of losing their houses and businesses because work has dried up; many of these communities were hit by Katrina and Rita and have not recovered; fumes and pollution are a

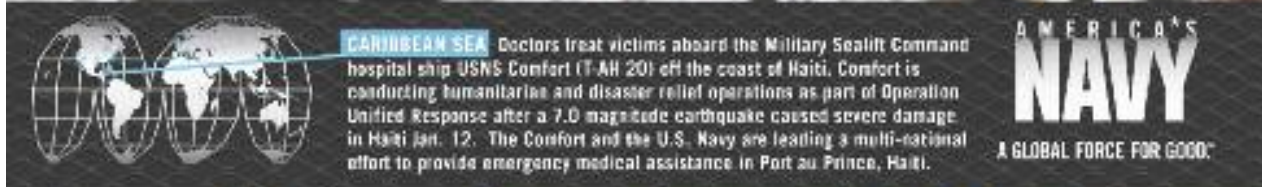

Restoring Balance Between Wall Street and Main Street

The South Carolina Small Business Chamber of Commerce, the U.S. Women's Chamber of Commerce and small business organizations and owners across this country want Wall Street Reform. But you wouldn't know that from the attention the media gives to the U.S. Chamber of Commerce, which is the mouthpiece for the big financial institutions that oppose reform.

The U.S. Chamber purports to represent small businesses. However, the reality is quite different. The July/August edition of the Washington Monthly features an eye-opening story on Tom Donohue, the CEO of the U.S. Chamber, who has a plaque on his desk that reads, "SHOW

ME THE MONEY." In 2008, a third of the Chamber's revenues came from just 19 big companies.

When big oil, insurance and other companies are out of favor because of their greed, they turn to the U.S. Chamber to convince Congress and the public that the needed reforms are bad for business in general and small business in particular. This is exactly what is going on regarding Wall Street reform.

It's clear that the U.S. Chamber does not represent the interests of small businesses that have suffered because of the irresponsible actions of the nation's biggest banks. The greed of these financial institutions collapsed our economy and shut down loans and credit lines to our small busi-

nesses. We hear macro and micro stories every day about small businesses not getting access to the money they need. And every economist acknowledges that small businesses must hire the employees we need to lead us out of this recession just as they have in the last three economic recoveries.

But ironically, the only business sector that's apparently hiring is Wall Street, as the New York Times explains in a recent piece. Greed is still alive and well on Wall Street. And we all know that without Wall Street reform, greed will bring our economy down again and tear apart our small businesses -- if we can ever get them back on their feet.

Yet, the U.S. Chamber still wants Congress and the

public to be afraid -- very afraid. Wall Street reform will dry up loans to small business, the U.S. Chamber warns. That's wrong. Their big bank donors are doing pretty well right now and they aren't doing that by making small business loans and investing in our communities. They're making money gambling on Wall Street.

The U.S. Chamber pretends to be a friend to Main Street worried that Sam the Butcher, Joe the Orthodontist and your local car dealer will be regulated out of business. That's not in the Wall Street reform proposal.

What the butcher, orthodontist and car dealer want are customers -- the cus-

serious problem and workers are often not given the correct protective clothing. Lisa Jackson, head of the Environmental Protection Agency also spoke at the Convention and backed up the findings in the report and vowed to work with communities to produce clean water, clean land.

However, it seems to me that a civil rights operation needs to move into the oil clean-up operation that bring about a strong element of fairness to that situation. When Katrina hit, we heard that the companies involved in the clean-up were importing workers from Korea, Mexico and Vietnam at the lowest wages to work the reconstruction. Many of them are still there and they provide competition with many workers who actually live in the area and have been deprived not just of a job, but of their entire livelihood if things don't improve. They have the most stake in the outcome of the reconstruction.

I was listening to Na-

tional Public Radio station the other day and John Boyd, President of the National Association of Black Farmers was being interviewed. It seems that many of his members are farmers whose land has been desecrated by the oil spill and fishermen whose livelihood was made on the water. But their complaint is that BP has bypassed them in looking for other farmers and fishermen whose land and waters have been polluted.

This important because black farmers and fishermen have a claim to the same kind of financial reparations that are being made available to whites in the area and they want and deserve a big piece of the clean-up work that is going on. However, Boyd says that Black fishermen seeking jobs with the clean-up crew have been brushed off.

Again Lisa Jackson's agency seems to be the only one that has an SBA participation program with respect to soil and water, chemistry, waste disposal but Black owned public re-

lations firms like Bright Moments in New Orleans are awaiting proposals to community outreach messaging, but none have come from BP. Apparently, they believe that national adds showing an Africa American male who lives in the area and is "in charge" of claims will suffice to show that they are sensitive to the problem. This, together with what appears to be a national media blackout of this problem hides a monumental race issue with respect to the oil spill.

Ken Feinberg has been placed in charge of processing the claims associated with the oil spill, since the President has wrested \$20 Billion from BP. But Feinberg was recently on CNN discussing the claims process but said nothing about the safeguards placed on the money would allow it to be distributed fairly, not just to selected individuals but to communities as well. The Nation Congress of American Indians has called for a meeting in New Orleans to discuss why the

Native American community in the Gulf has been overlooked with respect their access to resources in the clean-up. The black community interest is not just vested in workers, one black fisherman stands to loose more than \$100,000 from his shrimp business, but he can't get remediation contracts for the destruction of their fishing grounds.

What's happening here is old style racism and cudos to the NAACP, but the Justice Department needs to get involved and not just leave the EPA down there to fend off blacks seeking distributive justice for the damage to their lives. This is another racial issue for the administration and it will be interesting to see how they handle it.

Cowboys' Bradie James and Methodist create new cancer resource center

(NDG Wire) Breast cancer patients and their loved ones have a new resource in their support system, thanks to a partnership between Dallas Cowboys Linebacker (#56) Bradie James and Methodist Health System Foundation. James joined Methodist leaders on July 7 to unveil the new Bradie James Breast Cancer

Resource Center at the Methodist Dallas Medical Center campus, and to present a check for \$71,000 from his Foundation 56 to the Methodist Foundation. James' contribution provides key funding for the new center and other ongoing breast cancer outreach services in his partnership with Methodist.

The new center provides breast cancer patients with access to on-site and online educational information and resources, including a private setting for one-on-one consultation services. Resource center services includes staffing by an American Cancer Society volunteer who can also provide personalized assistance with fitting wigs, scarves, and prosthetics.

The pledge from James' foundation for creation of the resource center within the Women's Imaging Center at Methodist Dallas, 1441 N. Beckley, was announced in May when renovation work began. Through his foundation and an expanding partnership with Methodist, the project also includes a breast cancer support group, and other outreach initiatives to expand screening, education, and detection services. One of the funded activities includes purchase of new digital mammography equipment for Methodist's existing mobile mammography unit to expand outreach efforts into the community.

The well-known Cowboys linebacker lost his mother to breast cancer while he was a student at Louisiana State University. He has since become a passionate advocate in the fight against breast cancer through the foundation he established to honor her life.

"We are tremendously thankful for Mr. James' heartfelt dedication to advocating on behalf of breast cancer detection and treatment," said April Box Chamberlain, president and CEO of Methodist Health System Foundation. "Methodist is also grateful and proud to be part of an active partnership with his Foundation 56 to create this resource center and provide other ongoing services for our community."

In discussing his foundation's work and the role of the new resource center, and other ongoing projects with Methodist, James commented that he wanted to help provide more resources to both the patients going through breast cancer treatment, and to their fam-

ily and friends. He noted that he and his family faced the disease and treatment mostly on their own during his mother's illness and he wished to help other families have more ready opportunities for support.

James and Methodist also partnered last October

in a luncheon education event and mammogram sessions in which services were provided for 27 women who needed financial aid to obtain the potentially lifesaving screenings. The event is under development into a potentially annual project.

DART receives \$4.9 million federal grant for downtown streetcar connector

(NDG Wire) Dallas Area Rapid Transit (DART) is scheduled to receive \$4.9 million from the US Department of Transportation (DOT) as part of the \$130 million Urban Circulator Grant Program.

The grant is one of 53 proposals totaling nearly \$300 million in federal funding for both the Urban Circulator Program and the Bus

and Bus Livability Program. DOT officials say winning projects were selected from a 281 applicants totaling more than \$2 billion in funding requests. The DART grant will have a local match of \$5 million from the North Central Texas Council of Governments.

The project creates a new connection between Uptown and Downtown Dallas. It is a

rail track loop, just under three-quarters of a mile long, connecting the M-line Olive Street extension to the current M-line track on St. Paul Street. It will provide a direct connection to DART's St. Paul Station and improve connections to popular destinations like the Dallas Museum of Art and the Nasher Sculpture Garden. The M-line's heritage vehicle fleet

will still be used. Ultimately the line will connect with the planned Downtown Dallas streetcar project and will be built to accommodate a modern streetcar.

"The support of the Department of Transportation and Federal Transit Administration is critical," DART President/Executive Director Gary Thomas said. "It's also important to note this would

not have been possible without the sustained efforts of Representative Eddie Ber-

nice Johnson. We appreciate all she does to help keep our region moving."

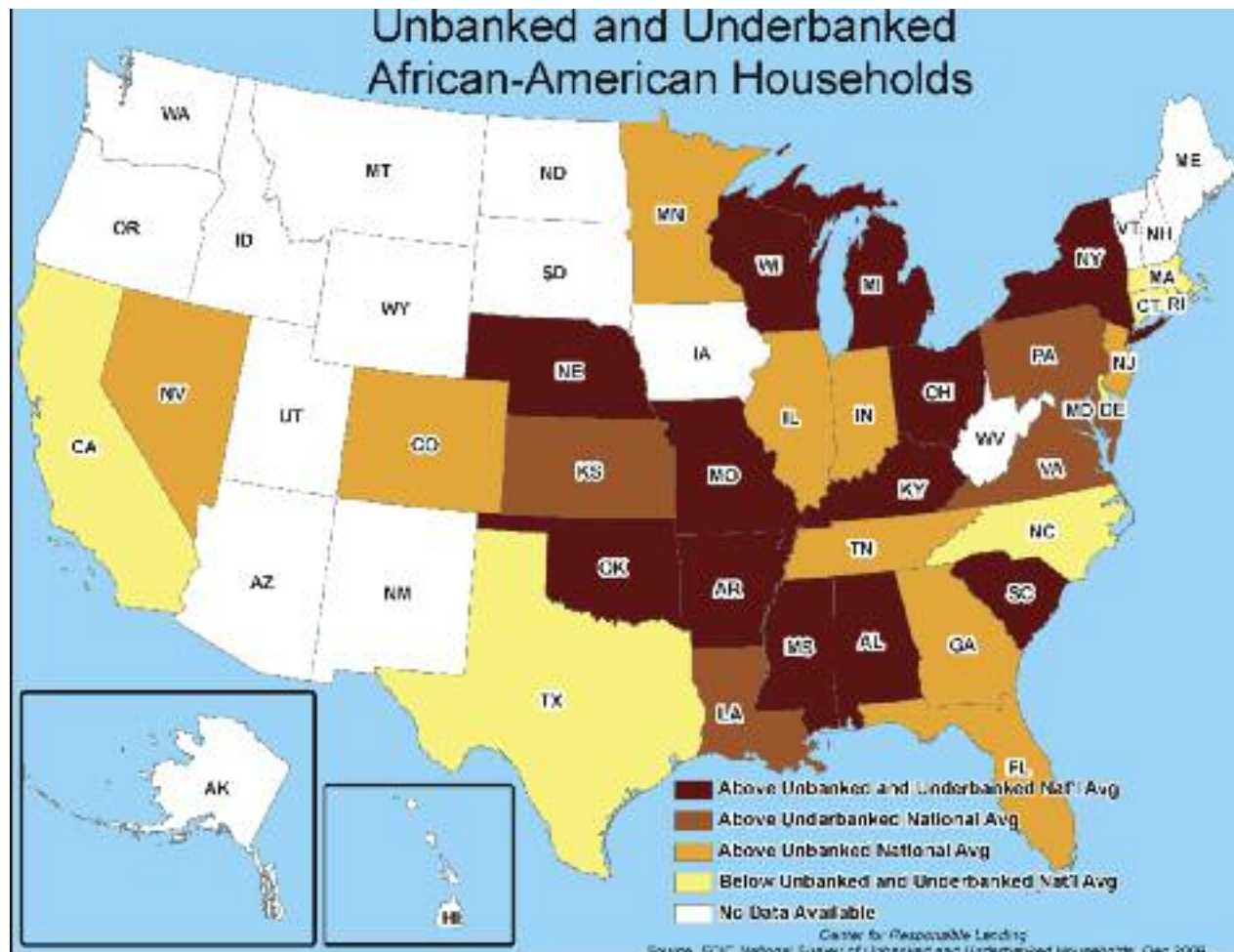
Even with Wall Street reform, the quest for financial fairness continues

(NNPA) As Capitol Hill works to complete historic Wall Street reforms, most of the public debate has focused on mainstream lending such as bank practices, loans and credit cards. Yet according to one of the nation's Federal Reserve Banks, 30 million American households -- nearly one in four -- are either unbanked or under-banked. These families instead turn to alternative financial services for their monetary mainstays.

According to the Federal Reserve Bank of Kansas City, unbanked or under-banked residents operate in a subculture that eschews traditional lenders and instead patronizes non-bank operations such as pre-paid cards, check-cashing and/or convenience stores and pawn shops. Many households with unpredictable cash flow and few savings were found to experience difficulty maintaining minimum balances or managing limits on availability of funds as many traditional lenders require. Additionally, overdraft fees, unexpected charges to accounts and account disputes together have led many households to adopt a combination of cash, money orders and prepaid debit cards for their personal financial transactions.

Sadly, these recent 2010 findings mirror those of a December 2009 report from the Federal Deposit Insurance Corporation (FDIC). Although Black and Hispanic households respectively account for 13.1 and 11.1 percent of all U.S. households, FDIC found that Latino and African-American communities together represent more than 60 percent of the nation's unbanked households. Among the nation's unbanked households, 36.9 percent are African-Americans.

FDIC defines a household as "unbanked" if no one



in the family has a checking or savings account. "Under-banked" households are those that have a checking or savings account but rely on alternative financial services that use non-bank money orders, payday loans, rent-to-own agreements, or pawn shops at least once or twice a year.

a Detroit Free Press columnist, the nation's largest poor city -- Detroit -- nearly half of all Motor City households lack traditional bank accounts.

"Convenience plays a part" wrote Gerritt, "especially for the nearly one-third of Detroit households that don't have vehicles. In

ment. Recent written remarks to the FDIC from a wide range of organizations addressed many of the underlying issues surrounding unbanked and under-banked consumers and the inherent problems with building financial assets.

For example, Heidi Goldberg with the National

the few assets they do have are vulnerable to loss from theft or natural disaster. Neighborhoods also suffer from the consequences of a cash economy, which can erode public safety and increase theft and related crimes."

"Perhaps most importantly" Ms. Goldberg contin-

to alternative financial services, Dory Rand, president of the Chicago-based Woodstock Institute in part wrote to FDIC, "Products such as money orders are important because many landlord and small business owners in LMI [Low-to-Moderate Income] areas do not accept checks. The 'competitive market rates' charged for these services should be less than the rates charged by non-bank providers in order to entice customers into mainstream banking. To avoid gouging customers, rates for cashing checks and wire transfers should be capped and not based solely on a percentage of the check or wire transfer/remittance amount."

So although the Dodd-Frank Wall Street Reform Act represents a major step forward for consumers, it is equally true that much yet remains to be accomplished before full, equal and competitive access to lending reaches all of America and its people.

According to Mike Calhoun, president of the Center for Responsible Lending, "Auto dealers--whose lending record is rife with unfair, deceptive practices, especially for people of color and military personnel--should not have been exempted from oversight by the new consumer protection agency. Also, payday or other unscrupulous lenders should not be allowed to sabotage the consumer protection agency's proposed new rules before they even see the light of day"

In other words, the quest for fairness in financial transactions continues.

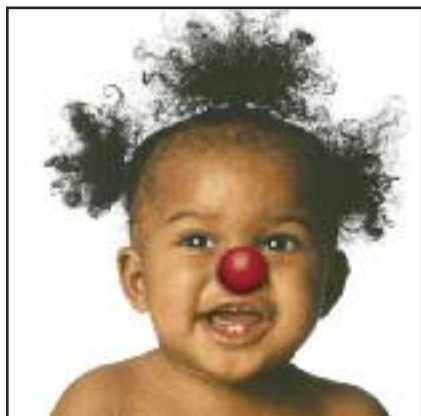

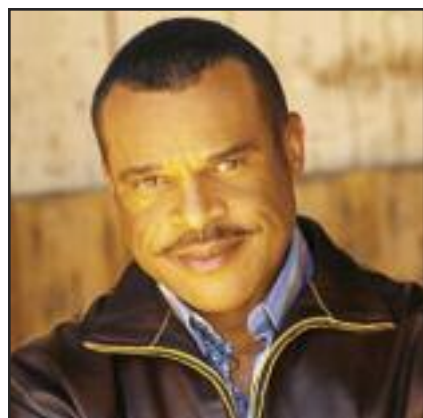

United States, reflecting a 2.5 percent increase between 2008-2009. The United States are part of a global trend, as store brands dominate in countries like Switzerland, the U.K. and Germany. Brand names, however, still rule in America, and sales even grew .4 percent in 2009.

Supersavers are likely not who you might think, either. The fastest-growing segment is families earning \$100K annually. They tend to be middle-income families earning \$30K to \$70K annually. Supersavers live in rural or comfortable country areas with three or more residents. They have younger female heads of household. They tend to be

white.

Where the super savers are:

- Supermarket deli
- Frozen food
- Dry grocery goods
- Dairy
- Health & beauty

Opportunities to become supersavers exist for African-American and Hispanic households who do use coupons but not to the extent of white coupon clippers (75 percent of coupon clippers). Asian Americans, on the other hand, don't shop in the categories supersavers like: With a penchant for home-cooking, Asians tend to stick to fresh fruit and meat products, Nielsen research reveals.

Despite what you see on the news on a daily basis, you can be at peace.

Fear isn't just a reaction to external circumstances. It is a spiritual force. It begins inside a person, and it's totally destructive. In fact, fear is Satan's primary weapon against Christians. He moves in response to fear, the same way God moves in response to faith. He challenges the promises of God with it.

An excellent example of this is found in Matthew 14 when Jesus invited Peter to come to Him on the water. "But when Peter saw the wind boisterous, he was afraid; and beginning to sink, he cried saying Lord, save me" (verse 30). Peter's faith in the Word of Jesus enabled him to walk on the water; and the fear of the wind defeated him. Peter looked at his circumstances and the result was defeat. If Peter had kept his focus on Jesus, his faith would never have wavered.

All the blustering and blowing in the world couldn't have drawn him off course.

Mediating on God's Word develops faith. Mediating on Satan's lies on the

other hand develops fear. Such fearful mediation is called worrying. Don't do it!

The Word of God is the sword of the Spirit. Use it to fight Satan every time he comes against you. Hold up your shield of faith and quench all of his fiery darts. Speak and live words of faith and fear will depart.

HEALTHY DOSE OF LOVE: Medical science has proven that walking in love is good for your health. Researchers have discovered that hostility produces stress that causes ulcers, tension headaches and a host of other ills. When you think of hostility, you may think of the type of anger you feel when something serious happens. According to the experts, that kind of thing isn't what causes the worst problems. It's the little things (when the dry cleaners ruin your favorite outfit, for example, or when the cafeteria lady puts gravy on your mashed potatoes after you've specifically told her not to.)

Think how much stress you could avoid by being quick to forgive, by living your life according to 1 Corinthians 13, "Though I speak with the tongues of men and of angels, and have not charity (love), I am become as sounding

brass, or a tinkling cymbal. And though I have the gift of prophecy, and understand all mysteries, and all knowledge; and though I have all faith, so that I could remove mountains, and have not charity, I am nothing. And though I bestow all my goods to feed the poor, and though I give my body to be burned, and have not charity, it profited me nothing." Don't count the evils done to you but imagine the physical and emotional benefits of living according to God's word.

Don't allow yourself to be habitually bound by hostility. As a Christian you have the love of God inside

of you. If you will yield to that love, it will set you free. Remember when Jesus called Lazarus forth from the grave, Lazarus was alive but still bound in the grave clothes. Jesus commanded the bindings to be loosed so that Lazarus could be free to walk.

Jesus wants that same kind of freedom for you. So get into agreement with Him. Pray first then say to those deadly habits that have you bound. "In the name of Jesus, loose me and let me go." "I'm putting hostility, un-forgiveness and selfishness behind me. I'm going on with God. I'm going to live the

Noted North Texas professor warns of K2 dangers

(NDG Wire) Several years ago, the world was fixated on what became known as Y2K---a belief that computers would self-destruct and send the world into utter chaos. Twelve years later and with billions of dollars spent to save civilization from destruction, we now must deal with "K2." What? K2, a combination of herbs and spices sprayed with synthetic residue similar to that of THC (delta-9 tetrahydrocannabinol), is a legal drug that goes by many names: skunk, knock off weed, genie, spice, and fake weed-



- just to name a few.

Dr. M. Lavelle Hendricks, Assistant Professor of Counseling at Texas A&M-Commerce warns that the public should take

this drug, though legal, more seriously. "Since K2 has been found to be more potent than marijuana, using it gives them a higher feeling than regular mari-

juana. Yet, studies continue to show that regular use of K2 will produce in individuals many symptoms including but not limited to paranoia, increased heart rate, loss of consciousness, difficulty in thinking and problem solving, problem with learning and memory, and brain damage as reported by the National Institute on Drug Abuse (NIDA)," says Hendricks.

So much is unknown about this drug that can be purchased legally at incense and smoke shops, over the internet, and some health

stores. Hendricks believes that the more attention is given to the dangers of K2, the greater chance that young adults and others will choose to avoid this drug. He is also finalizing a book ("It's Not Y2K...Just K2) for educators, mental health workers,

law enforcement and community officials on the dangers of K2 usage.

Dr. Hendricks is a Texas Licensed Chemical Dependency Counselor, Certified Advanced Alcohol and Drug Counselor, and Certified Anger Resolution Therapist.
