## Plano Dealership & Jaguar File Opposing Lawsuits

(NDG Wire) One of the nation's top performing Jaguar dealerships has asked a court to settle a dispute with Jaguar Land Rover over disputed manufacturer charges for the Plano, Texas, dealership.

Attorneys from the Dallas law firm of Shackelford, Melton & McKin-

ley, who represent Millennium Jaguar of Texas Inc., dba Millennium Motor Cars, filed suit last month against Jaguar Land Rover North America LLC and three of the dealership's former employees. The Millennium lawsuit claims the former employees concealed information and

misstated performance statistics. The employees involved were either terminated or resigned.

Jaguar Land Rover ordered a full audit of Millennium's warranty and sales-incentive records and subsequently made demands that Millennium pay Jaguar Land Rover

more than \$600,000.

Following Millennium's internal investigation of Jaguar Land Rover's claims, they made a good faith payment of nearly \$100,000 related to paperwork errors, along with a request for further investigation into the re-

## Consumer Alert Issued by FBI Online Rental Ads Could be Phony

(NDG Wire) You can't believe your good fortune - you've found a rental home in a good area through a Craigslist classified ad at an unbelievably low rate. The landlord had to travel to Nigeria, and asked you to wire him two months worth of rent. But when you arrive at the home,

ready to move in, there's one small problem - the house is not for rent and its owners know nothing about your agreement.

This is the latest scam being perpetrated by Nigerian criminals, and has been seen in a number of U.S. states. But it's not a new scam, just a variation

of an old one. The so called 419 scheme - named after the Nigerian penal code section under which this particular kind of fraud is prosecuted - has been around since the early 1980s. The common thread is the victims are solicited by Nigerian criminals to transfer money out of the

## Who Will Give Voice to the Voiceless?

(NNPA) Senator Edward M. Kennedy was a voice for the voiceless. He was passionate about health care, about children, about education. He understood poverty and often spoke of it. The fact that he touched so many lives was evidenced by the thousands that lined the streets of Boston simply to watch his casket drive by, or the lines that snaked toward his gravesite at Arlington Cemetery just a day after he

was buried. It begs a cliché to say that he will be missed. More importantly, who in the senate will give voice to the voiceless?

Though Senator Kennedy was tremendously popular among democrats and republicans, his kind of liberalism was rare. Too often, now, when people speak of social programs, they are prepared to blame the poor, at least somewhat, for their plight. You hear

## Tamara Nichole Harris

Tamara (Tammy) Nichole Harris is a talented lyricist and vocalist from Chicago, Illinois, and is also earning her cap as a producer. Harris's music is a smooth blend of traditional R&B soul fused with elements of Jazz & Funk. Her style has been described by many as reminiscent of the timing of Phyllis Hyman, the vibrato of Stephanie Mills and Randy Crawford, a waver like Denise Williams and the class of Nancy Wilson.

Harris's debut album,



# Where is Your 401K?

(NNPA) The past twelve months have been like a roller coaster ride through an economic horror show. On the downhill slope, we have seen brokerage and bank failures, a contentious presidential election, an \$800 billion dollar stimulus package and we hit the bottom in March when GM and Chrysler filed for bankruptcy. On the uphill slope, we have been teased by "glimmers of light," heard screams about "cash for clunkers" and are in the middle of an onboard brawl over health care reform.

Like most people you have probably been holding your head down while the economic roller coaster has been twisting, turning and going through its gyrations. You may have missed the fact that the stock market, as measured by the S&P 500 index, is up 52% from its low in March, but is still down 20 percent from a year ago. (In-

vestors cannot invest directly in an index) This has been a gut wrenching trip, but like most good roller coaster rides, we may be close to getting back to the station. No wonder you've had neither the time nor the inclination to look at your 401k statements.

### *Where is your 401K?*

If your 401k retirement account is like most, it is probably down about 20 percent from a year ago. Go online or look at your last statement and answer a few questions:

- How does the total value compare to a year ago?
- What are your percentages of equities/stocks, bonds and cash?
- How do these percentages compare with your desired percentages of each?
- What percentage of the total is in your company's stock?

Are you satisfied with the overall performance of your account and the allocation of

your investments? If not, you may be ready for a 401k makeover.

### *401K Makeover*

If your company uses one of the large 401k service providers, such as Fidelity or Vanguard, then the process is fairly straight forward, using the portfolio review systems available on their websites. If your 401k plan does not have a portfolio review system, then you may want to meet with your financial advisor or use the review system on websites such as: [moneycentral.msn.com](http://moneycentral.msn.com); [quicken.com](http://quicken.com); and [mint.com](http://mint.com). Most of the portfolio review systems have three basic steps and may take you about an hour to complete.

First you provide some basic financial information about yourself, next you fill out a risk tolerance questionnaire and finally the system recommends a target asset allocation. The target allocations can range from very ag-

gressive to very conservative based on your age, financial situation and risk tolerance.

Your current investments are then compared to your target allocation and you are asked if you want your account rebalanced to the target allocation. In the future, your portfolio would be rebalanced each year to the prescribed percentages.

### *Life Cycle Funds*

Using Life Cycle Funds is a simpler way to manage your 401k retirement fund. To select a life cycle fund all that is required is your age, planned retirement age and the current year. In the early years, the life cycle funds invest more aggressively. As the individual approaches retirement age, the fund invests more conservatively.

Completing your 401K Makeover

To complete your 401k makeover, you may want to

the "hand up, not hand out" type of rhetoric coming from the lips of so-called liberals who have jumped on the "what's wrong with poor people" bandwagon. In a recession, the same thing is wrong with poor people as rich ones, but poor folks just have fewer reinforcements - jobs are disappearing, people are not spending, and if the economy is recovering it is doing so at a snail's pace.

And we are leaving people behind. Senator Kennedy was buried on the same day that a group of New Orleans activists put "hands around the dome" to commemorate the people who died in the Superdome as Hurricane Katrina raged in 2005.

The commemoration, led by the African American Leadership Project and Mtangulizi Sanyika, is one way of reminding us that nearly 1900 people died in Hurricanes Katrina and Rita and that the city is still not back to normal. Thousands are still living in FEMA trailers, many have not received

their "road home" money, and few have really been made whole. We spent \$700 billion to bail out bankers last year, but we have yet to fully assist New Orleans. Indeed, some say they have "Katrina fatigue" and don't want to hear about the event that took place four years ago. Move on, they say, stuff happens.

President Barack Obama and his disaster recovery chief, Craig Fugate, have been instrumental in moving recovery along in New Orleans, approving as many as 75 projects - including libraries and schools - that had been bogged down in red tape because of complicated intergovernmental relationships, where boards, commissions, and elected bodies all have overlapping authority.

In his Saturday radio address, the president said that red tape should not get in the way of progress in New Orleans. Eleven Cabinet officers have visited New Orleans to learn how they can help the city move to full re-

covery.

What does full recovery look like? What about those who were left behind? Through Hurricane Katrina and the broken levees (let's not forget that the levees did not have to break) we began to have a conversation about race, poverty and politics, a rather painful conversation that was fraught with denial, even as former President George Bush promised Senator Trent Lott a new home, and delivered far more dollars per capita to Mississippi than to Louisiana. We are still having uncomfortable conversations about race, conversations that may be less, not more comfortable since President Obama's election.

Full recovery in New Orleans might include the rebuilding of Charity Hospital (maybe even the renaming of it), the hospital that was destroyed during Hurricane Katrina. Where do poor people go for health care now? Are they better off or worse off without the hospital they

once relied on? Would they be assisted by the national health care plan the Obama administration has developed? A voice like Senator Edward Kennedy's is missing in this conversation. Who will replace him and, more importantly, who will speak out for the voiceless?

The Congressional Black Caucus will hold its annual Legislative Forum just a few weeks from now. There are sessions, I know, on the economy and the environment, on the status of women, and on the economic stimulus package. It would be a tragedy if there were not planned sessions on the status of the recovery in New Orleans, with reporting from some of the voices on the ground that we so rarely hear from. The CBC can be an effective voice for the voiceless, and they can also offer the Katrina voiceless a platform.

# For Inactive Kids, Play Can Be Just What the Doctor Ordered

A stock conversational topic in any middle-agers' social gathering is "How Things Were Better When We Were Kids." Once this discussion starts, it's just a matter of time until some exasperated parent serves up their own video-addicted, couch potato kids as Exhibit A: "You never see kids just playing in sprinklers, riding bikes or throwing frisbees anymore!"

This trend is blamed for many negative outcomes including, almost invariably, childhood obesity. But is that really true? And, if so, how can parents encourage their children to pull out the iPod earbuds, lay down the Wii controller and go outside for some healthy physical activity?

To answer the first question, scientific opinion is divided as to how the

growing percentage of overweight kids relates to their perceived lack of physical activity. Researchers agree that diet is a key factor, but opinion diverges on the role of physical activity levels.

Smart parents will ignore the controversy and focus on two clear facts: Weight gain happens when more calories are consumed than burned, and active kids with healthy diets tend to be physically healthier than their less active, junk food eating peers.

Since most moms and dads find it easier to influence what pre-teen children eat (by purchasing healthier foods and monitoring how much is consumed at home) than to get them up and moving, we'll focus on the exercise side of the equation.

Here are a few practical tips from the Mayo Clinic

and National Association of Sport and Physical Education:

**1. Start 'em Early** — Children between one and three need at least 90 minutes of physical activity every day. This should include a mix of structured activity (holding your child's hands while he or she jumps, exploring the backyard together, climbing stairs) and unsupervised play (crawling, exploring or playing with toys).

Toddlers shouldn't be inactive for more than an hour at a time, except when sleeping. One way to discourage inactivity is to limit TV and DVD-viewing from an early age. This not only encourages independent physical activity, but also reduces the "cold turkey" effect of weaning older kids off established video habits.

**2. Be the Example** — As passionately as kids may

deny it, parents are major influences on their thought and behavior. Parents who "reward" themselves after work by ripping open a party-sized bag of Tostitos and settling in for a Law and Order marathon have little credibility when they urge their children to be more active. So set the tone by making physical activity a standard feature of your daily life.

Ride your bike or rollerblade around the neighborhood. Walk the dog. Jog or walk to the drugstore instead of driving. Organize a game of pickup basketball or softball. What you do isn't so important. What matters from your children's standpoint is seeing that you believe in what you're selling to them.

**3. Sell it as Activity, Not Exercise** — Although it may not always be obvious, kids

are drawn to physical activity as long as it looks like fun, not work. With smart planning, the fun factor can be added in many ways. If you're hosting a birthday party, hold it at a bowling alley, batting cage, paintball field or indoor climbing wall. Or make it a *So You Think You Can Dance* party, with your child as the deejay.

To encourage daily activity, fill your home (and yard, if you have one) with opportunities for spontaneous play: basketball goals, "beach volleyball" pits, badminton nets or treehouses, just to name a few.

If your child looks bored, throw down a basketball or touch football challenge. Games between kids and parents not only promote health but also encourage closeness and may inspire conversations that wouldn't naturally occur in other settings.

**4. Don't Push Too Hard** — Some children enjoy organized team or club sports such as soccer, baseball, swimming and gymnastics. Others, however, chafe under mom and dad's efforts to schedule their lives and may come to think of physical activity as a chore to be abandoned at the first opportunity. Watch and listen to your kids to learn their preferences. Then, respect and work with those preferences. A boy or girl who dislikes team sports may take readily to hiking, skateboarding, bicycling, martial arts or dancing.

Be open-minded and focus on the bottom line. Games that you cherished as a child may not have the same appeal or relevance to your kids. Activity is activity. After all, when was the last time you saw an overweight skateboarder?

This popular festival will also feature local social, service, civic, arts and educational organizations



# Winners Camp Introduces At-Risk Teens to New Opportunities

(NDG Wire) Winners Camp in Dallas County proved that all teens can be winners when given the chance. With a mixture of fun and tuition, approximately 20 at-risk teens in Dallas County improved their reading and social skills.

For six weeks of their summer vacation, the students spent weekday mornings in an intensive reading curriculum, with a 5:1 student-to-teacher ratio. Learning continued in the afternoons, but it was informal

and fun. The teens took tours of the wax museum, had lessons about hurricanes at the IMAX theater, trips to nature spots, cultural centers, hospital and sports centers, and office buildings.

The students, ages 12 to 17, are in or on the fringes of the juvenile justice system. Some are on probation, have had truancy issues, or are in the Dallas County Youth Village.

"These teens have had unique opportunities this summer to which they may

have never been exposed," said Rhonda Hunter, former president of the Dallas Bar Association. "In the morning, they received the equivalent of a private school education. In the afternoon, they met with professionals and shared experiences that opened their minds to new horizons."

Students were tested by Shelton School staff at the beginning of the Winners Camp. They were tested at the conclusion of the program, and they all showed some improvement, with

most making dramatic increases in reading and writing ability. Shelton School is a private nonprofit accredited school for learning-different students.

Most students in Winners Camp were two or more grade levels behind in reading, but showed the potential to learn. The program was created by a think tank led by

Dallas lawyers Rhonda Hunter and Paula Miller, co-chair of the DBA Juvenile Justice Committee and a sponsor of the program.

## Collin County Home Sales Continue to Show Improvement

maining amount Jaguar Land Rover claims is owed.

The problems were limited to internal warranty and sales-incentive paperwork and invoices, and at no time were customers charged for unnecessary or unperformed warranty repairs or service.

However, the lawsuit states Jaguar Land Rover refused to provide the deal-

ership with all information that it uncovered in the course of its audit.

According to Millennium Jaguar of Texas Inc., despite repeated requests, Jaguar Land Rover senior management has refused to reveal all the facts on which the audit was based.

"Millennium owner David Stephens has made a career out of doing the right

thing, and as a result has been recognized for his ethics and business practices alike. He has proven this again by taking the remedial action of voluntarily refunding the money believed to be rightfully owed to the manufacturer," says Millennium's attorney Brian Melton, a partner in Shackelford Melton & McKinley.

"Based on what Jaguar

Land Rover has provided to us, most of their findings are related to superficial paperwork problems. We are extremely confident that a complete examination of the facts will vindicate David Stephens and the Millennium dealership."

Jaguar Land Rover filed its own lawsuit in response to the matter. That case is pending in U.S. District

Court for the Eastern District of Texas.

Millennium was the first African American-owned Jaguar dealership in the United States, and ranked in the top four for new car sales of all U.S. Jaguar dealerships in July

2009.

The dealership also ranked number one in customer satisfaction in 2006 and has been a consistent award-winning sales and service performer during its more than 10 years in business.

consider two other areas:

· Contribution rate - Invest as much as possible in your 401k retirement account, since the contributions are made pre-tax and the gains accrue tax deferred. At retirement, withdrawals will be taxed at ordinary income tax rates. The minimum contribution should be at the level that will trigger the maximum employer match.

· Company Stock- Many financial advisors encourage clients to limit their investment in their employer stock to no more than 5-10% of their net worth. If the company has financial difficulties, your job may be at risk,

as well as your retirement funds.

Many of the economic indicators are pointing to an end of the recession, either later this year or in early 2010. Review your 401k to make sure it is in line with your financial objectives.

U.S. and into the criminals' pockets. And these schemes are profitable, costing victims millions of dollars annually.

In South Carolina, the rental scam problem has become so prevalent that Columbia FBI Special Agent in Charge, David Thomas, recently issued a warning about it to homeowners and prospective renters, particularly in the Charleston, Co-

lumbia and Hilton Head areas.

The scam has also ensnared victims in Rhode Island, Illinois, Colorado, and California, among other states.

How exactly does the rental housing scam work? The criminals search websites that list homes for sale. They take the information in those ads, and post it with their own e-mail address in

a Craigslist ad (without Craigslist's consent or knowledge). To sweeten the pot, the houses are almost always listed at below-market rental rates.

When a prospective renter responds to the ad, they are told the "homeowner" had to leave the U.S. quickly because of some missionary or contract work in Africa. Victims are instructed to send the first

and last month's rent to Nigeria via a wire transfer service, because the crooks know it can't be traced once it gets picked up on the other end.

Renters also fill out credit applications asking for personal information such as credit history, social security numbers and work history.

This information can be used to commit identity

fraud and steal even more money from their victims.

How to avoid being victimized:

Only deal with landlords or renters who are local. Be suspicious if you're asked to only use a wire transfer service. Beware of e-mail correspondence from the "landlord" that's written in poor or broken English.

Research the average

rental rates in that area and be suspicious if the rate is significantly lower.

Don't give out personal information such as social security, bank account or credit card numbers.

If you suspect a scam, have already been victimized, or know someone who has fallen victim to a scam, please report it to the FBI's Internet Crime Complaint Center.

## Tips for Cleaning Hot Tools ProSilk offers tips on how to keep your styling tools in good condition

(NDG Wire) Does your flat iron have a grimy layer of excess product, hair color, hairspray or other sticky finishing products? Debris on a flat iron will cause hot spots on the plates and snags that can pull and break hair, causing ragged split ends.

Clean tools last longer and work more efficiently. Following a simple cleaning regimen will protect your professional styling tools and yield better styling results.

**Cleaning Supplies**  
Cotton balls  
Wooden cuticle stick  
Soft clothe  
Dish soap  
Warm water

**Rubbing alcohol Cleaning Instructions**  
Prepare a small dish of warm soapy water (a drop or two of common liquid dish soap).

Unplug tools (never immerse any electric tool in water, plugged or unplugged).

Proceed to clean tools while they are still warm. It will be easier to clean excess product before the iron has had time to cool, dry and solidify.

Dip the edge of your cotton ball in the soapy water solution and rub the plates or surfaces in a circular motion to distribute the warm water evenly on the build-up. Wait for a few

minutes and let the water and soap solution loosen and dislodge stubborn build-up.

While you are waiting, carefully take the wooden cuticle stick and gently remove particles that have been packed into grooves and crevices of the tool. Do not force or jam the stick into any openings, as it may cause damage to the tool.

**NOTE:** Do not submerge tools in water.

Do not use abrasive cleaners, as it will scratch and damage the surface.

Do not use metal or sharp utencils.



After cleaning your tools you may find that there is a slight film left from the water and soap solution. Take a cotton ball and a tiny amount of rubbing alcohol, wipe the film off the surface and finish it with a swipe of the soft cotton cloth.

Following these simple tips will protect your tools and improve your finished styles.

# Want to give your home a facelift without spending a fortune?

(NDG Wire) In the current economic climate, home-owners are looking for ways to fix up their current home versus upgrading to a newer property. Consumer ratings service Angie's List talked to home improvement experts nationwide to find three cheaper alternatives to big budget projects.

**Big bucks project:** New bathtub

**Small bucks fix:** Reglaze the old tub.

An old, worn out bathtub can make any bathroom look dull and dated. But the cost of a new bathtub can

start anywhere from \$200 to \$600, and some tubs can cost thousands, depending on the size and features, such as jets. Replacing a bathtub usually involves more than just buying a new tub. You may have to move or replace plumbing.

Consider a less expensive option, such as reglazing the bathtub - a new enamel finish in a color you choose. Price typically ranges from \$300-\$600, and you don't have to factor in the expense of ripping out the old tub.

**Big bucks project:** New kitchen or bathroom cabinets

nets

**Small bucks fix:** Cabinet re-facing

Looking for a new, fresh look for your kitchen, but can't afford a total remodel? Consider re-facing your cabinets. That way you can re-work an already adequate kitchen/bath with a facelift, without interrupting your busy life.

Re-facing consists of installing new cabinet doors and drawer fronts, and covering the exposed frames of the cabinets with new matching wood or plastic veneer. No cabinets are ripped out, and the layout re-

mains the same. Add some new hardware, and your kitchen has a new look. Cabinet re-facing typically costs 25-30 percent less than replacing existing cabinets. Most companies price per unit (count each door, drawer, etc. as a unit). Price per unit can range as low as \$100 to as high as \$250, depending on materials.

**Big bucks project:** New deck

**Small bucks fix:** Clean and seal

A deck will last up to 20 years if you take care of it. Considering it costs anywhere from \$10-20 a square

foot to build a new deck, a little maintenance is the best bang for your buck.

Decks take a good amount of beating from the weather and catch a lot of dirt, grime and mold. A good cleaning once a year with a pressure washer will keep the deck looking nice, and is

also essential before sealing or staining. After a thorough cleaning, seal the deck or the wood will splinter, crack and warp. Finally, keep the deck free from debris build-up between boards. This area collects moisture and can cause dry rot.






