## Lulu Belle Madison White (1907-1957) Houston NAACP Leader

(NDG Wire) Lulu Belle Madison White, civil rights activist in the 1940s and 1950s, devoted most of her adult life to the struggle against Jim Crow in Texas. She campaigned for the right to vote, for equal pay for equal work, and for desegre-

gation of public facilities.

Lulu was one of twelve children born to Henry and Easter Madison in East Texas at the turn of the twentieth century. Her father, Henry Madison, a former Mississippi slave had moved to East Texas and later pur-

chased 120 acres of farmland. When Lulu Madison was born in Elmo, Texas in August 1900, she was born into a community that was thirty-five percent African American and sixty-five

## Seatbelts and School Zones Tops New Laws Passed This Year

According to the Texas State Constitution, bills passed in the year's State Legislative Session, but not signed or vetoed by the Governor, become law on September 1 of the Legislative

year.

As a result, numerous new laws became law at the beginning of this month after this summer's Legislative Session.

The new laws most affecting the general public are transportation laws, and this

year both passengers and drivers should be aware of about thirty new laws.

One of the largest transportation bills, House Bill (HB) 2730, took affect on September 1; some of the new laws under HB 2730 are:

- All persons under 18 who apply for a driver's license must take the driver's exam, and learner's permits expire when a driver reaches 18 years old.

- Drivers under 18 are prohibited from using a

# President Obama's Socialist Message of Personal Responsibility to American Students

Over the last week a controversy erupted over the desire of the President of the United States to encourage students across the country to stay in school and give their best effort. Many right wing conservatives were quick to throw out words like indoctrination and label it a socialist message.

How disappointing to see those seeking to win political battles, were unwilling to consider American school-rooms a war-free zone – dragging students, parents and administrators into their pettiness.

Former First Lady Laura Bush said it best when she told CNN: "I think there is a place for the president of the

United States to talk to school children and encourage school children."

Below is a transcript released by the White House of President Barack Obama's prepared remarks to students on September 8, 2009:

"Hello everyone - how's everybody doing today? I'm here with students at Wakefield High School in Arlington, Virginia. And we've got students tuning in from all across America, kindergarten through twelfth grade. I'm glad you all could join us today.

I know that for many of you, today is the first day of school. And for those of you in kindergarten, or starting middle or high school, it's your first day in a new school, so it's understandable

if you're a little nervous. I imagine there are some seniors out there who are feeling pretty good right now, with just one more year to go. And no matter what grade you're in, some of you are probably wishing it were still Summer, and you could've stayed in bed just a little longer this morning.

I know that feeling. When I was young, my family lived in Indonesia for a few years, and my mother didn't have the money to send me where all the American kids went to school. So she decided to teach me extra lessons herself, Monday through Friday - at 4:30 in the morning.

Now I wasn't too happy about getting up that early. A lot of times, I'd fall asleep

right there at the kitchen table. But whenever I'd complain, my mother would just give me one of those looks and say, "This is no picnic for me either, buster."

So I know some of you are still adjusting to being back at school. But I'm here today because I have something important to discuss with you. I'm here because I want to talk with you about your education and what's expected of all of you in this new school year.

Now I've given a lot of speeches about education. And I've talked a lot about responsibility.

I've talked about your teachers' responsibility for inspiring you, and pushing you

(65) percent white. It was also a community where cotton and Jim Crow was "King." Segregation and 'separate but equal' were enshrined in the state's constitution. Furthermore, the white citizenry enforced this oppression by lynching and threats of lynching. In 1908, East Texas had the dubious distinction of leading the state with twenty-four recorded lynchings [6].

The Jim Crow regime denied African Americans basic human rights to health care, jobs, education, and criminal justice. Black males were expected to tip their hats in the presence of whites. The poll tax, whites-only primary, and voter declaration regime suppressed African Americans' right to vote. But Henry and Easter Madison ensured that their children escaped much of the day-to-day indignities of Jim Crow. When most African American children had to leave elementary school to assist their share cropping parents; Lulu remained in school when the crops were harvested. Even so, some indignities remained. At Old Terrell Colored High School, the library books were those previously

used by the white high school students [3-9].

It was at Prairie View A&M University that Lulu honed her leadership skills. Recognizing that the college had the responsibility of developing a cadre of college-educated African American leaders, Prairie View College emphasized the development of intellectual skill, rigor, and discipline in debate through the L & D society, the excelsior Literary Society, and the Aristo Club. Lulu learned these lessons well and emerged as a leader while graduating magna cum laude from the college in June 1928.

Shortly after graduation, Lulu married Julius White, a successful business owner who financed some of the race discrimination lawsuits in Houston. Despite her superior grades at Prairie View, Lulu was denied a teaching position in Houston. She commuted to her teaching position in Lufkin, Texas for two years before becoming involved in the struggle against Jim Crow [13-16].

Lulu began as an organizer to help support the Grovey lawsuit. She organized women groups such as

the YWCA, Metropolitan Council of Negro Women, The Eastern Star and Grand Court of Calan.

Lulu's hard work earned her a new job as Executive Secretary of the Houston Branch of the NAACP. Her job was created to free up the president from some of the day-to-day tasks so she could work on fulfilling the objectives of the NAACP. As executive Secretary, Lulu became involved in the following causes: protests against discrimination in the Houston shipyard; protests against discrimination in Atlas Dress Manufacturing Industry; protests against discrimination in Beaumont, Texas that lead to 2,000 whites rioting and destroying an African American section of Beaumont; protests for the establishment of Reserve Officer Training corps Units in African American schools; protests that lead to African Americans being able to attend the Houston Music Hall and be seated alongside whites; protests against the Texas white Democratic primary; protests to change or modify the city manager system of government; protests opposing candidates running

for city offices that were against African American interest; efforts to get the vote out on election day; protests against Houston's City Council to end protest police brutality; protest which increased the number of African American police officers from six to thirteen; protests by letter which attacked President Johnson for allowing the Anti-Poll Tax Bill to die on the floor of the Senate; protest efforts to raise teacher pay; protests against setting up an Office of Price Administration. Lulu was involved in these causes and many others that are too numerous to mention. She continued her efforts as she was selected by the National NAACP to be Director of Branches for the Southwest Region. While continuing in both positions, Lulu continued to oppose discrimination, unfair treatment of African Americans, and Jim Crow. She was at case with the local leaders of the NAACP as with Thurgood Marshall and the leaders of the national NAACP. She was unafraid working with labor groups to enable African American

The Expo will offer exhibitor booths, free services, demonstrations and entertainment, all focused on helping citizens make positive changes to their daily lives.

Healthy You will provide health screenings and immunizations, plus information on prevention services, stress reduction methods, fitness activities, and much more. Five hundred free cholesterol screenings will be available, on a first come first served basis, beginning at 10 a.m. Seasonal flu shots will be administered by the Garland Health Department from 10 a.m. to 2 p.m. only. The cost of flu shots for children

6 months to 18 years old will be \$10; 19 years and older \$20. Medicaid and Medicare Part B participants should bring current paperwork.

A limited supply of the pneumococcal vaccine is available for \$40. This vaccine is usually given to adults 65 years and older and is covered by Medicare Part B or those individuals younger than 65 with chronic health conditions. A limited supply of the tetanus booster, Tdap, for adolescents and adults 11 years and older will be available. The cost is \$10 for children age 11-18 and \$20 for adults 19-64 years old.

Learn about Healthy Earth topics, such as recycling, conservation, energy efficiency, gardening and alternative fuels. The first 1,000 attendees will receive a microfiber, reusable shopping bag containing a variety of goodies and information (one per family, please). Radio Disney will rock the Expo with music, prizes and eco-friendly" competitions for kids and parents.

Showerhead Exchange The City of Garland Water Utilities Department will have 1,000 low-flow showerheads available. Bring your old showerhead to exchange, along with a

City of Garland utility bill and identification verifying that you are the utility subscriber. (Limit one showerhead per household, please.) The City will make sure the old devices are disposed of in an environmentally-appropriate way!

Electronic Recycling by the Environmental Co-op You can drive up and drop off a wide range of electronic equipment such as computers, telephones, circuit boards, DVD/CD players, copiers, printers, video equipment from 10 a.m. to 2 p.m., or until their trucks are full. A fee is associated with properly disposing of these items: \$5 per computer monitor and \$10 - \$30 per television, based on screen size. You can also drop off microwaves, air conditioners, batteries, and small household appliances, as well as eyeglasses that will be donated to the Lions Club.

The Expo will also feature a document shredding service for outdated or sensitive records, provided by Greenstar Northamerica, LLC. The shred truck will be onsite from 10 a.m. to 2 p.m., or until the truck is full.

## Pulitzer Prize Nominee Yvonne Thornton to Serve as Keynote Dpeaker at TWU's *The Power of a Healthy Woman Symposium* Sept. 19

(NDG Wire) Dr. Yvonne Thornton, the first African-American woman in the U.S. to be board certified in high-

risk obstetrics and a Pulitzer Prize nominee for her family's biography *The Ditchdigger's Daughters* will serve as the keynote speaker during Texas Woman's University's annual *The Power of a Healthy Woman Symposium* Sept. 19.

Adult women are encouraged to attend the half-day event that shines the spotlight on women's health. The symposium will be held from 8:30 a.m. until 12:15 p.m. Saturday, Sept. 19, in


Dr. Thornton is a double-board certified specialist in obstetrics, gynecology and

wireless device while driving.

- Drivers under 18 can only have one person less than 21 years of age in the car that is a non-family member.

- Driving is prohibited from midnight to 5 a.m. for drivers under 18 except when going to school, work, or for an emergency.

- Persons new to the state now have 90 days to change their address and get a Texas driver's license instead of 30 days.

- All persons wanting to gain a Texas driver's license must prove residency, PO boxes are no longer a proof of residency, and there are new requirements for driver's licenses being delivered to PO boxes.

- Anyone arrested of a DWI with a child in the vehicle will have their license automatically suspended.

- If a CDL Class license driver is caught harboring or transporting an illegal alien, the driver can lose their CDL rating for life.

HB 55 also became a law on the first of the month prohibiting the use of all cell phone and wireless devices in school zones except when used with a head set or for emergency (911) calls.

Highland Park was the first city to pass the ordinance in the beginning of the

year, and the State Legislature quickly adopted it to make a state wide law. The law also states school zones must to have this policy clearly marked by signs placed under school zone signs; however, some cities have not been able to install those signs by September 1. Cities that do not have the signs posted will not be enforcing or writing tickets for violators until the signs are in place.

HB 537 now mandates all passengers in a vehicle, no matter if they are front or back seat passengers, must wear a seat belt and children less than five years old can only ride in the side car of a motorcycle.

Also, according to Senate Bill (SB) 61, all children under eight years old or four feet nine inches in height must be restrained in a proper safety seat.

After the first, SB 328 now allows DPS officers to suspend a minor's driver's license if they fail a blood alcohol test when operating a boat, jet ski, or other water craft. Additionally, the fee for reinstating a suspended license was raised from \$50 to \$100.

Minors can also be charged and arrested with public intoxication under the new law from HB 558.

Bills defining or updating

criminal offenses also took affect this month. For example, stealing a driver's license or any person's identification is now a Class B misdemeanor according to HB 1282.

SB 554 now makes it illegal to own dog fighting equipment. In addition, if equipment is found or evidence of dog fighting is found on your property, the state can seize your property and the contraband. The new law also stipulates dog fighting is a type of organized crime which carries harsher penalties if convicted.

According to HB 1813, it is now a third degree felony to tamper with evidence.

Under SB 689, registered sex offenders who used the internet to find or abuse their victims now have restricted access to the internet and have to provide all of their digital information, including their email address(es), when they register as a sex offender.

And finally, to be more current with federal laws, SB 1188 allows Texans to buy firearms, accessories, and ammunition in all states, not just those neighboring Texas.



# Former Dallas Cowboys Football Player Eugene Lockhart and Eight Others Charged in Mortgage Fraud Scheme

*Federal Indictment Charges Conspiracy, Bank Fraud, and Wire Fraud*

(AP) A federal grand jury has indicted Eugene Lockhart, Jr., 48, a former player with the Dallas Cowboys, and eight others on various charges related to a mortgage fraud scheme he and the others allegedly ran in the Dallas area from 2001 through 2005, announced U.S. Attorney James T. Jacks of the Northern District of Texas. Lockhart, of Carrollton, Texas, and co-defendant Lendell Beacham, 50, of DeSoto, Texas, were arrested this morning by FBI agents, and will appear this afternoon at 1:00 p.m. before U.S. Magistrate Judge Jeff Kaplan for their initial appearance.

All nine defendants are charged in the indictment, returned by a federal grand

jury earlier this week and unsealed this morning, with various offenses related to the scheme, including conspiracy, bank fraud, and wire fraud.

In addition to Lockhart and Beacham, the following defendants are named in the indictment: William Randolph Tisdale, Jr., 45, formerly of Dallas, but currently serving a federal sentence on unrelated charges; Hubert Jones, III, 39, of Garland, Texas; Patricia Ortega Suarez, 55, of Dallas; Suzette Switzer Hinds, 45, of Dallas; Michael Anthony Caldwell, 49, of Arlington, Texas; Donna Lois Kneeland, 45, of Grand Prairie, Texas; and Bryan J. Moorman, 67, of Mesquite, Texas. These defendants,

with the exception of Tisdale, are expected to surrender to the FBI tomorrow morning, September 4, 2009.

All nine defendants are charged with one count of conspiracy to commit bank fraud and wire fraud. In addition, Lockhart, Beacham and Moorman are each charged with one count of wire fraud; Tisdale is also charged with two counts of bank fraud; Jones is also charged with two counts of bank fraud and one count of wire fraud; Suarez is also charged with one count each of bank fraud and wire fraud; and Hinds is also charged with one count of bank fraud.

According to the indictment, Lockhart was in-

involved with several real estate entities, including America's Team Mortgage; America's Team Realty; America's Team Funding Group; Ace Mortgage; Cowboys Realty; Cowboys Mortgage and KLT Properties. Tisdale was involved with Pinnacle Development and Realty Corporation; Atilla Capital Corporation; and KLT Properties. Jones was the President of Pinnacle Development and Realty Corporation and Director of Atilla Capital Corporation. Beacham was the owner of Cowboys Mortgage and was involved with Ace Mortgage.

Defendants Suarez, Hinds and Kneeland were escrow officers at various title companies. Caldwell was the general manager at New Land National Title and Moorman was an appraiser.


The indictment alleges that the defendants ran a scheme in which they located single-family residences for sale in the Dallas area, including distressed and pre-foreclosure properties, and negotiated a sales price with the seller. They created surplus loan proceeds by inflating the sales price to an arbitrary amount substantially more than the fair market value of the residence.

They recruited individuals to act as nominee or "straw purchasers" or "straw borrowers," promising to pay them a bonus or commission of between \$10,000 and \$20,000 for their participation in a particular real estate transaction.

The conspirators caused the loan applications for each straw borrower to include false financial infor-

mation, often including inflated false income figures to conceal the borrower's true financial condition so that the lender would more likely approve the loan.

The conspirators concealed from the lenders the true status, financial condition and intentions of the named borrowers, knowing that loans would not likely be approved if the lender knew the true role, credit worthiness, and risk of each straw borrower.

The conspirators falsely represented in loan documents that the straw purchaser intended to use the property as their primary residence, intentionally concealing from lender that each straw borrower, viewed himself as an "investor," who never intended to occupy the home.

The indictment also alleges that the conspirators caused bogus and fraudulent "marketing fees" to be listed on loan closing documents to provide a means for the conspirators to re-

ceive surplus/excess loan proceeds.

The scope of the conspiracy involved approximately 54 fraudulent residential property loan closings resulting in the funding of approximately \$20.5 million in fraudulent loans.

An indictment is an accusation by a federal grand jury and a defendant is entitled to the presumption of innocence unless proven guilty. If convicted however, the conspiracy and each bank fraud counts carries a maximum statutory sentence of 30 years in prison, a \$1 million fine and restitution.

Each of the wire fraud counts, upon conviction, carries a maximum statutory sentence of 20 years in prison, a \$250,000 fine and restitution. In addition, the indictment includes a forfeiture allegation which would require the defendants, upon conviction, to forfeit various sums of money, totaling up to \$20.4 million.

## Chargers LB says He Did Not Harm Reality TV Star

(AP) San Diego Chargers star outside linebacker Shawne Merriman said he did not harm reality TV star Tila Tequila at his home early Sunday and added he was concerned for her safety because she appeared to be intoxicated.

Merriman was arrested and accused of choking and throwing Tequila to the ground as she tried to leave his home in suburban Poway. Tequila signed a citizen's arrest warrant charging Merriman with battery and false imprisonment. Both are felonies.

Merriman spent about 2 1/2 hours in the downtown jail before posting bail.

Merriman practiced Monday, then said he's convinced he'll be cleared. It will ultimately be up to the District Attorney's office to decide if he'll be charged.

"I think when it all surfaces, it will be a different situation. Period," said Merriman, who described Tequila as an acquaintance.

Tequila, whose real name is Tila Nguyen, is best known for "A Shot at Love with Tila Tequila," which ran for two seasons on MTV. The bisexual dating show featured men and women vying for Tequila's affections. She has also modeled for Playboy and other men's magazines.

Merriman said he was limited in what he could

say. He kept referring to a statement issued through his attorney Sunday night.

"At the time, I was concerned about her welfare given the intoxicated state she appeared to be in and I encouraged her to stay until safe transportation could be provided," Merriman said in the statement. "We would all do our best to help a friend if we considered their actions to be detrimental to their personal safety."

"I in no way caused any harm to Ms. Nguyen, however, paramedics were called and she was examined but no injuries were reported," the statement continued.

"It's kind of a tough situation where you think you're doing the right thing," Merriman said Monday. "I'm glad that everyone was safe at the end of the day. I don't think I will regret that part."

Asked if he threw Tequila to the ground, the 6-foot-4, 265-pound Merriman said: "No. I can't talk about any of that stuff."

Scott E. Leemon, an attorney for Tequila, didn't respond to an e-mail asking for comment on Merriman's statement.

Also Monday, the owner of a downtown club where Merriman and Tequila attended a party

Saturday night said his staff told him Tequila had been drinking and it appeared Merriman had ordered only bottled water.

"I feel sorry for the guy and I think the truth needs to be told," said James Brennan, who owns Stingaree, one of the city's top hangouts for celebrities.

Brennan said he normally wouldn't comment, but felt he should after seeing Tequila's tweet in which

she said she's allergic to alcohol.

"It sounds like she's allergic to the truth," Brennan told The Associated Press.

Brennan said he was not at the club Saturday night, but had spoken with every employee who dealt with Tequila and Merriman. Brennan said he was told she had shots of tequila and drank from a bottle of vodka. Brennan said Tequila requested that his

brother, Shane, a manager at Stingaree, have a shot of tequila with her.

"She wasn't like falling down or anything of that nature, but she was visibly intoxicated," Brennan said.

In a tweet Sunday, Tequila said: "I am allergic to alcohol. It has been publicly known for years. That is how I got the name Tila "Tequila" cuz the irony. I cant drink."

and choose what photos they developed, and if they didn't think it was a good photo they wouldn't develop it," said Pruitt.

She was looking for that particular print, and she noticed it never got developed. Going back through the negatives, she saw that although it was over exposed, it was a great photo, and also realized she didn't want anyone else choosing her memories.

"After that, I learned how to develop my own film because I wanted to be able to control which photos got developed," Pruitt said. "I didn't want someone else picking my photos for me. Everyone shoots a decent picture."

Pruitt honed her skills in digital photography at Collin County Community College and is partially self-taught. She started her career taking

photos of fine art for reprints.

"Taking a photo for a reprint gives the piece another life. When you sell a piece of art, that's the end of its life. But with reprints, it's like you have children of the original piece, and its life continues in another medium," she said.

Her love for art and photography inspired her to open 14th Street Gallery as a way for herself and other artistic photographers to showcase their work. It is also a studio space for shoots. Sunny and bright with plenty of windows, the 14th Street Gallery is a hidden jewel that boasts more than pretty artwork and occasional events.

The gallery also functions as a business space where Pruitt offers her customers a chance to turn ragged, well-loved photo-

graphs into showpieces through photo restoration and decorative framing.

"I had a man come in with a wallet-sized photo of himself as a kid, and he wanted to show his girlfriend that he was cute when he was a kid, so I was able to restore it for him," she laughed. "People also come in with old family pictures that have faded and want them restored."

Pruitt is passionate about helping people restore photos, believing that photos are memories.

"People have sentimental pieces they're attached to," she said. "What we think of as only snapshots are really moments in history."

She said she wants to help people get their photos out of the box, onto paper and into frames for display in the

home. She said the everyday person can afford to take a snapshot and have it cropped and color balanced into a work of art, and feel good about their work.

Pruitt said she can bring photos back to life by erasing fold lines, enlarging wallet sizes and adding color.

"There is so much detail that gets lost in an old or small photo," she said. "And sometimes you don't see it. I had a lady come in with tubs of photos that were wet and stuck together. We were able to restore some of them, which meant a lot to her."

Because preserving memories is important to the gallery staff, all of who are photographers, another service offered is helping family-tree enthusiasts self-publish an anthology of their family history and other information

into genealogy books for family distribution.

Another way Pruitt preserves memories is by taking artistic shots of flowers, as they remind her of her mother and of growing up in Chickasha, OK. "My mother would always give us flowers when we accomplished something like graduation," she said with a smile. "So my favorite things to shoot are flowers because I never want them to die."

The 14th Street Gallery also has a satellite store in the heart of downtown Plano, called 14th on 15th. It is a mini gallery and gift shop that sells jewelry, frames, pottery and art cards, and is

located at 15th Street and K Avenue inside the Art Centre of Plano building.

Pruitt specializes in large format printing, photo reprinting and restoration, fine art reproductions, framing, matting, portrait sittings, product photography, event photography, website design, dry-mounting, scanning and photo archival. Pruitt said she is also available for event photography and family portraits.

# The King of Infidelity

## How Web Mogul Noel Biderman Cashed In With Online Adultery

Meet Jennifer, a 36 year-old loving wife and mother of two who lived in the perfect little house, in the perfect little neighborhood. On the outside, it appeared that Jennifer was living the American dream but in reality she was dying inside. Jennifer, like 20 million other Americans was trapped in a sexless marriage.

As a stay-at-home mom, Jennifer had a lot of free time, and she started spending it on AshleyMadison.com, a website specifically for married people looking to cheat. How did she end up here? It started a few months earlier and according to her “completely by accident.” One January morning, Jennifer was running some errands in her husband’s car and the radio was tuned to his favorite radio station. She was about to switch the channel until she realized they had a special guest on that day. And it wasn’t just any guest, it was Noel Biderman, creator of the most controversial website on the internet - AshleyMadison.com

Biderman was invited to appear on the popular station that Ashley Madison advertised on much to the chagrin of even the hosts themselves. As Jennifer listened intently Biderman calmly fielded calls from listeners explaining to them why millions of Americans turn to his service. Up to this point, Jennifer had never heard of AshleyMadison.com or even knew a site existed that catered to people like her. From that moment she knew her life was never going to be the same.

Before Biderman’s interview, Jennifer had already been getting restless. She was feeling sexual in a way that she hadn’t since college. She was in the

best shape of her life, and she’d been playing around with cyber-sex, exchanging pictures with a few lucky friends. But in the annals of horny housewives fooling around on their spouses, Ashley Madison was a different order of magnitude. “It was more

exciting to do it with people I don’t know,” she says. “It’s not something I’m proud of, just something I was interested in.”

Within a few days, one of the guys she had been chatting with asked her out for coffee. She thought his pictures were cute. Their chats had been hot. How would it hurt her to say yes? The chemistry was even better in person. Conversation turned into gentle caressing. Gentle caressing turned into playful fondling. Playful fondling turned into oral sex in the back of her minivan. Jennifer was now having an affair, and it was easier than she had ever imagined. “I never thought I’d cheat on my husband,” she says “But there I was.”

With more than 4.5 million members, and tens of millions spent on advertising, the 7-year-old Ashley Madison is the first, biggest and most profitable infidelity site on the internet. Noel Biderman, the site’s 38-year-old founder, describes himself as a busi-

nessman and nothing more.

A former sports agent, Biderman, didn’t start Ashley Madison to subvert the institution of marriage (he’s happily married with two children). In 2001, he read an article that said Internet dating sites were the only content sector thriving

after the dot-com bust. “The article went on to suggest that as many as 30% of the people on these dating services were attached,” he says. “They were using the anonymity of the Internet to cloak their true intentions. I thought, I’m gonna offer up a service to these folks.”

On February 14, 2002, AshleyMadison.com was officially born - taking its moniker from the previous year’s two most popular girl’s names. “The reality was that people who were going to cheat were going to cheat anyway, and people who weren’t going to cheat were going to ignore Ashley Madison, just like they would any service,” says Biderman. “But since people will cheat, it’s a recession-proof business.”

As word got out, membership grew “exponentially” according to Biderman and by the start of 2008 Ashley Madison had over 2 million members and Biderman had made tens of millions in profits. To the general public, Ash-

ley Madison’s meteoric rise was a shock but Biderman wasn’t surprised. “20 million Americans are in sexless marriages,” he says, citing a recent report from ABC News. “Some can accept this fact and live the rest of their lives celibate, but most of us can’t.”

His detractors offer up divorce as the solution, but as Biderman explains, “That would mean that marriage is only about sex when, in fact, that’s only one component. There are many reasons why divorce simply isn’t an option: family, finances, religion even love. Most of our members deeply love their spouse but they didn’t sign up to be celibate for the rest of their adult lives. So they turn to AshleyMadison.com where they can satisfy their sexual needs while keeping their marriages intact.”

Biderman adds, “It seems like every week we hear of another celebrity, athlete or politician caught

in an affair and although the media is quick to judge more often than not their partner stands by them.” That being said, Biderman is quick to point out that the best way not to get caught is to use a discreet service like his.

So why do people turn to AshleyMadison.com to have an Affair? According to Biderman, it’s because they can meet other married people in the exact

same situation as them which is much safer in his opinion. “The men and women on Ashley Madison, understand what you’re going through and will respect your discretion because they’re in the same position as you.”

As of September 2009, AshleyMadison.com has over 4.5 million members with someone new joining the service every 15 seconds. And when you look at areas like Dallas / Fort Worth the numbers are even more staggering with memberships increasing 200% in just the past year alone!

The rapid rise of his controversial site has not gone unnoticed by the National Media. In just the past year alone, Biderman has appeared on Larry King, Nightline, Good Morning America, Fox News and The View - defending the right for his service to exist. “Ashley Madison didn’t invent infidelity.” He explains “It’s

site is 100% secure, completely anonymous and free to join.”

The types of men and women on the site vary as much as the real world. The only common denominator is that they’re willing to cheat. “Steven”, 39-year-old accountant from Dallas, has discovered this. Though he has met lovers in more conventional ways, he says he likes Ashley Madison because, for the most part, it gets rid of guess-work. “You don’t have to worry about whether or not someone wants to have an affair,” he says. “It’s why everyone’s there.”

“Sara,” 27, says that when she signed on, she had no plans to get into a relationship and was looking for something with “no strings attached.” She met a guy who was able to fill her sexual needs and because he was in the exact same situation as her wasn’t looking for anything more.

“It was by far the most satisfying experience I’ve ever had,” she say, and it also changed her perception of infidelity: “It’s wrong for somebody to go years without sex because their spouse doesn’t want to.”

For every piece of negative press Biderman receives, he claims to have gotten ten times as many “Thank You” letters from members who swear that he’s saved their marriages. Thanks to Ashley Madison, they’ve stopped resenting their spouses and have become better partners themselves.

As if the site wasn’t controversial enough, Biderman has introduced an Affair Guarantee. If you don’t have an Affair using his service he’ll personally give you your money back. No questions asked.

To date, he hasn’t had to yet.

# Change Has Indeed Come to America

workers, even at the risk of being called a communist

But Lulu White possessed the ideal background for NAACP activism. As the daughter of a middle class farmer, the wife of a middle class businessman, and a college educated professional, Lulu White believed in and fought for African American first class citizenship for persons who possessed this level of professional skills and background.

She did not disappoint the NAACP national headquarters. In six short years, she raised membership in the Houston branch from 2,000

to 10,000 -- the second highest in the nation.

Lulu left an indelible mark on the civil rights movement in Texas, especially Houston during the 1940's through the 1960's. Although she was involved in many court cases and protests to gain the equal rights for African American, Lulu's greatest achievement was her contribution to the Sweatt v. Painter case, which desegregated the University of Texas.

Lulu, in fact, found and convinced Herman Sweatt to register for law school at the University of Texas. She

knew that even though Sweatt was qualified that he would not be permitted to attend UT's law program without a fight. With Lulu and other help, the Sweatt case was taken all the way to the Supreme Court. Based on the Supreme Court's decision, this case led to the desegregation of the University of Texas.

The Sweatt case was also used as a precedent for *Brown v. Board of Education* [9, 47]. The Supreme Court in *Brown* declared the doctrine of "separate but equal" null and void. This decision not only dismantled dis-

crimination in education in Texas, but also limited discrimination in education all across the United States. Additionally, the decision also led the decline in Jim Crow laws.

White's friendships with Walter White, Daisy Lampkin, Thurgood Marshall, and Roy Wilkins enabled her to exert influence on the NAACP nationally. She was a field worker in the national NAACP office between 1949 and 1951. Afterward, Lulu White returned to Houston and devoted full time to her position as director of state branches Lulu White died on

July 6, 1957 and was buried in Houston, Texas. The week before her death, the National NAACP established the Lulu White Freedom Fund in her honor.




