## Black Newspaper Publishers Cancel Mid-Winter Conference in South Carolina

(NNPA) The National Newspaper Publisher's Association (NNPA) announced Wednesday it will not hold its mid-winter conference in South Carolina scheduled for January 2010 and is joining the NAACP economic boycott of the state that has been in effect

since July 1999 when the South Carolina NAACP called for it as a protest of the flag atop the State House and inside the House and Senate chambers. The boycott, still in effect, calls on groups and individuals to avoid traveling to the state for business or pleasure and

discouraged residents from visiting South Carolina beaches or patronizing restaurants and motels. This announcement comes on the heels of South Carolina Republican Representative Joe Wilson's outburst of "you

## Tracking Registered Sex Offenders Use of Technology

In an age when criminals are employing mobile and Internet technology to commit crime, law enforcement officers cannot afford to get behind the technological curve. Authorities are getting new tools that will help them protect Tex-

ans more effectively and prevent more crime.

During the last Legislative session, I worked with legislators to improve law enforcement's ability to monitor registered sex offenders. Thanks to a newly enacted law, keeping track of convicted sex offenders will be a little easier.

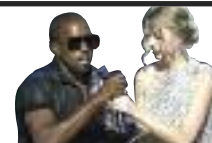
Under Senate Bill 689,

which was authored by Sen. Florence Shapiro, Plano and Rep. Aaron Peña, Edinburg sex offenders must provide their on-line identifiers and mobile phone numbers to the state's sex offender database. The newly required information includes profiles on social networking Web sites like MySpace or

Facebook, where many sex offenders create accounts so they can interact with children.

Before SB 689 took effect on Sept. 1, registered sex offenders were only statutorily required to provide traditional information, such as home addresses, land-line phone

## The Health Reform Debate and Prostate Cancer

Prostate cancer is the most common form of cancer in men, striking approximately 200,000 men each year.

African-American men are at the highest risk.

Every year, over 27,000 men die of the disease, making it second only to lung cancer as the deadliest cancer in men. Caught early, prostate cancer can be treated, usually successfully. But because many men experience no symp-

toms, it is often identified only by an abnormal result on a basic prostate cancer screening.

For the last 20 years, doctors have had a powerful weapon in their arsenal for detecting prostate cancer. In addition to the DRE (a physical exam allowing the doctor to feel the prostate), patients can also have a simple blood test called a PSA, which will detect a majority of prostate

# Counting What Counts

New Census Bureau data shows that for the 10th year in a row Texas has the highest rate of uninsured children in the country, with one of every six kids uninsured. Nearly one of every four Texas kids lived in poverty in 2008 (e.g., \$17,600 for a family of three).

As troubling as these numbers are, this data likely under represents the extent of the current problem for two important reasons.

First, the latest Census data does not cover 2009, and unemployment has been rising sharply in Texas this year, from 6.4 percent in January to 7.0 percent in July (the most recent month available). Economists tell us that poverty rises with rising joblessness and that increase is sharper for vulnerable groups like children.

Second, even once the data catches up to the recession, child poverty is likely even deeper than shown in these figures. The federal poverty measure is badly outdated and excludes many families struggling to cover basic expenses, effectively disqualifying them from re-

ceiving available food or housing assistance.

The Measuring American Poverty Act would update the poverty measure to include more realistic expenses (including health care and child care) and help us to accurately measure the effectiveness of our poverty reduction programs, such as Food Stamps (now known as the Supplemental Nutrition Assistance Program).

Shouldn't we know how many people really need help and whether our help does any good?

Decision makers need reliable, relevant information to get the best results from public programs, but our policymakers and administrators use antiquated measurements and data to make decisions and assess performance. To ensure our public structures reach the people who need them most, we need an accurate measure of poverty in America, and we need Americans to fill out their 2010 Census forms in the spring.

That is why we must plan early for the upcoming 2010 Census. Most people

do not realize that the accuracy of data personally affects them. Most major federal funding decisions (and many state and local ones) rely at least in part on Census data, including funding for early childhood education, schools, roads, environmental protection, health care, and nutrition. And the number of representatives we have in Congress is directly related to an accurate count of our fast-growing population.

If you belong to a business or community service organization, you can partner with the 2010 Census to help increase participation, which will give your organization better data on customers or clients in your area.

If you are an educator, elected official, part of a faith-based organization, or are simply a proud member of your community, you will be crucial in spreading the word about the importance of filling out the census forms next spring, ensuring Texas kids and families are accurately represented when decisions are made in Washington.

Most people understand

the need for reliable, relevant data. Everyone from hospitals to businesses to sports teams rely on data collection and analysis to measure and improve their performance. None of these groups would be satisfied with outdated or incomplete measures of performance.

Improving the quality of data - counting what counts - helps ensure our public programs work and gives us the ability to evaluate them, continue to support them if they are effective, adjust them if needed, or eliminate them if they are ineffective. In short, good data leads to better decisions. Without them, decision makers are left in a vacuum, forced to either ignore growing problems or make changes based on assumption and anecdote.

Only by counting yourself in can you make sure that kids count too.

"Over 46 million Americans are without health insurance, 8 million children are without health insurance and 880,000 African Americans would be alive today if we had enacted health care reform in the past decade. problems early. In the two decades that the PSA has been used, prostate cancer deaths have declined, and the number of successfully treated prostate cancer cases has risen.

During September, Prostate Cancer Awareness Month, the Men's Health Network is urging men to talk to their doctors about prostate cancer, and to consider screening at age 50, and at age 40 for African Americans and men with a family history of prostate cancer. The group also encourages and urge their husbands to request prostate screening, including a PSA test, from their doctor.

Men's Health Network is not alone in urging prostate cancer screening for men. They are joined by, among others, Women Against Prostate Cancer, the American Cancer Society, American Urological Association, and countless physicians treating patients nationwide.

In fact, the American Urological Association has recently issued guidelines recommending that men receive a baseline PSA test at age 40.

And, in a recent Town Hall meeting, President

Barack Obama endorsed routine checkups so we can, "...be catching diseases like breast cancer and prostate cancer on the front end. That makes sense, it saves lives; it also saves money."

If you are on Medicare, prostate cancer screening is a part of your Welcome to Medicare physical, the free comprehensive physical exam you receive in your first year of eligibility. For younger men, 37 states require that insurance companies offering health insurance provide coverage for prostate cancer tests. Insurance companies may offer prostate cancer screening in the remaining states, but are not required to do so.

But in the rush to save money, and "reduce...unnecessary tests and services," a goal we all agree is necessary, Congress may take away that benefit. While President Obama has stated, "...we will require insurance companies to cover routine checkups and preventive care (to catch) diseases like breast cancer and prostate cancer on the front end," his message is being lost in the halls of Congress.

The health care bills currently being debated in Con-

gress contain a number of health insurance options, and it looks like none of those options will cover prostate cancer tests. Instead, the health insurance system established by those bills will rely on the opinions of a government-sponsored committee, the U.S. Preventive Services Task Force, that does not recommend prostate cancer screening.

The bottom line? Having

an annual prostate exam, including a PSA test, just might save your life. No matter what age you are, that annual PSA test creates a benchmark against which to judge future tests.

When you receive your PSA test results, ask the doctor what your PSA number is, write it down, and compare it against future tests. If the number goes up in future tests, talk to your doctor.

September is Prostate Cancer Awareness Month. It's the perfect time to call your doctor, schedule an appointment, and get your prostate cancer test done. Then, talk to your doctor and determine what screening and treatment options are best for you and your family.

If you want to express your opinion about health reform, call your members of Congress and let them know what you think. Use the

Capitol switchboard, 202-224-3121, to call both senators and your representative. If you do not know their names, give your Zip code to the operator who answers, and they will connect you.

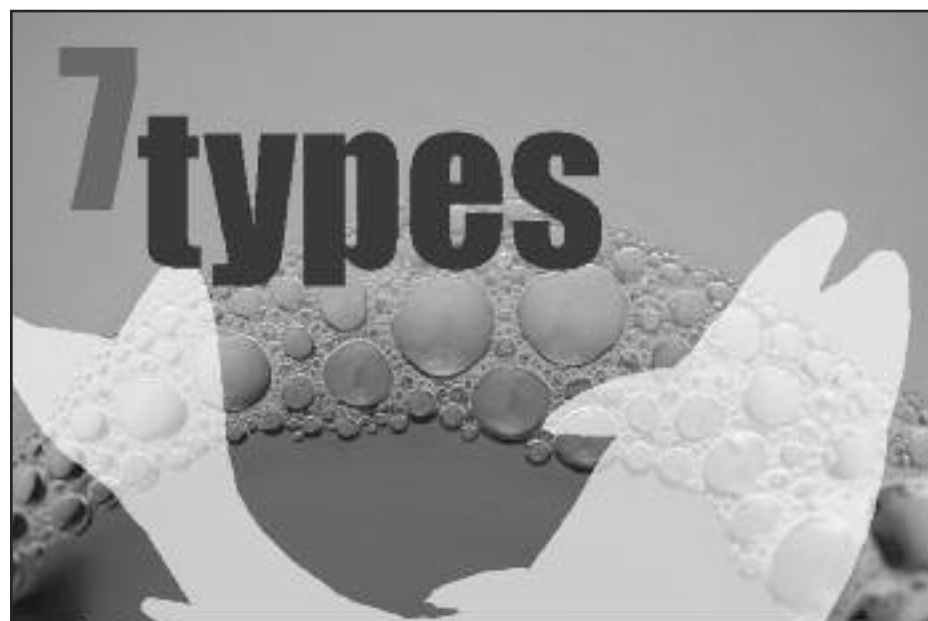

## Sickle Cell Center Hosts Research Diversity Program

(UTD) The Sickle Cell Disease Research Center helped visiting scholars hone their research skills and knowledge over the summer as part of a program to increase diversity in the nation's academic ranks.

The Summer Institute Program to Increase Diversity brought 16 researchers to campus, where they drew on the interdisciplinary expertise



of UT Dallas faculty members.

The institute is sponsored by the National Heart, Lung and Blood Institute (NHLBI). Mentors include Dr. Betty Pace, director of the UT Dal-

las Sickle Cell Disease Research Center and a professor of molecular and cell biology.

UT Dallas is one of three universities awarded a four-year grant from the NHLBI to host the diversity program. Titled "Functional Genomics of Blood Disorders," the UT Dallas program encourages collaborations to seek new treatments and cures for

blood-related illnesses.

The two-year expense-paid program equips underrepresented junior faculty with the knowledge to develop independent research by establishing mentoring partnerships with nationally established researchers. One of the program's goals is to have participants receive and serve as principal investigators on major grants.

## TWC Issues Cease and Desist Order to Dallas Health Career School

(NDG Wire) The Texas Workforce Commission (TWC) has issued a final cease and desist order against a Dallas-area career school that has been operating without a certificate of approval. Career Academy of Texas Inc. (CATI) in Grapevine was training students to work as nurse's aides, medication aides and medical assistants. CATI was issued the order for failure to obtain a certificate of approval or exemption as required by the Texas Education Code.

"These operations ex-

plot vulnerable individuals with false promises of careers at a time when health care workers are in such high demand," said TWC Chairman Tom Pauken. "This will serve as a warning to any other schools considering offering unlicensed, unapproved programs."

Health care professions top the fastest-growing occupations in Texas, with an estimated growth rate of more than 33 percent over the next eight years.

"Career schools must obtain a TWC certificate of approval," said TWC Commis-

sioner Representing Labor Ronny Congleton. "We want to make sure these types of schools do not take advantage of students looking to join the workforce in the health care industry."

A career school traditionally trains students for a career in a business, trade, technical or industrial occupation, or for avocational or personal improvement. An order to cease and desist operating is issued to a business only after a hearing and a written decision finds that the business is not in compliance with the Texas Edu-

cation Code requirements. If TWC has reason to believe that a school has violated the order, TWC may refer the matter to the Attorney General's Office for enforcement.

"The great need for health care workers in Texas and around the country has led to some unscrupulous owners operating uncertified schools," said TWC Commissioner Representing the Public Andres Alcantar. "These schools take advantage of students who are paying large sums of money."

# Irving City Council Approves A Single-Member District System

After almost two years, Manuel Benavidez has light at the end of his tunnel.

In November 2007, Benavidez sued both the Irving City Council and the Irving Independent School District (IISD) after two unsuccessful attempts at getting elected to the IISD school board. He claimed Irving's at-large election process denied representation of Hispanics.

And on Thursday, September 3, 2009, Benavidez witnessed victory when Irving City Council members voted 6-3 to approve the 6-2-1 City Council single-member district plan. The proposed plan makes Places one, three, four, five, six and seven to be elected on a single-member voting system, with Places two and eight and the mayoral post remaining at-large.

"I continued to pursue this case because I was doing this not only for my family, but for all families of every race. My hope is the future generation will get involved to help make this world better for everyone," said Benavidez.

This vote came after U.S. District Judge Jorge Solis ruled in favor of Benavidez on July 15, 2009, and found the City of Irving in violation of section two of the Voters Right Act of 1965. Solis ordered the defendants (City of Irving and Irving City Council Members) and the plaintiff (Manuel Benavidez) to

separately or jointly create and implement a redistricting and election plan within 90 days, or the Federal Court

would devise a plan to address the disparity of minority representation within Irving City Council.

"After several meetings of negotiations with the defendant, we were able to compromise and agree to a six single-member district in the effort to avoid an appeal," said Michael Veaser, legal counsel in the Benavidez case.

Awaiting Solis' final approval, the City of Irving has agreed to pay a settlement of \$200,000 to cover the plaintiff's legal fees, and voted not to pursue an appeal contingent upon the proposed 6-2-1 single member district plan being accepted by the court.

City Council members Tom Spink (Place one) and Beth Van Duyne (Place two) had overwhelming representation of their constituents at the September 3 meeting who voiced their opposition

to the proposed agreement. The proposed 6-2-1 single-member district plan would require Spink and Van Duyne

to run against each other in next May's elections. Their terms end in 2010, and Spink will no longer hold his current Place one seat under the new redistricting plan.

"I feel the decision is a result of gerrymandering, and we were not given adequate time to comprise a plan that would be inclusive for all groups involved. It was totally fractured," said Spink.

"Beth and I have consistently voted based on what our constituents wanted and not for our own personal interest. I do feel there were members within the council, including the Mayor, who possibly wanted to see one of us replaced in the hopes of eliminate discontented votes," added Spink.

According to a 2006 American Community Survey (ACS), Hispanics make up over 40 percent of the population in Irving. To have a City Council with no Hispanic or other minority representation eventually would have forced Irving to face this issue, the same issue Dallas City Council faced in 1988 in a lawsuit similar to Benavidez'. That lawsuit led the city to implement a 14 member single-district system with an at-large mayoral post.

"All cities go through this process when they continue to grow. Irving has become a very diverse community, and

this is a natural progression for cities like Irving to transition to a single-member district type system. Sometimes the process is messy and we have a strike against us in that the Federal Court has ruled against us and our system," said Mayor Herbert Gears at the September 3 meeting.

In 2004, the Irving City Council attempted to address this issue by forming a Charter Review Committee. The committee consisted of appointed citizens selected to recommend changes to the current at-large electoral process. The Irving Hispanic Chamber of Commerce presented its own report to the committee, recommending a single-member voting system for Places one through five. This recommendation was not passed to the Council by the committee, and was not placed on the election ballot. Ultimately, no resolution was adopted to address the demographic change.

Attorneys for Benavidez were able to get a favorable ruling due in part to the testimony of one of their expert witnesses, David Ely of Compass Demographics, a consulting and database management firm specializing in projects involving Census and election data. They hope the evidence presented in this case will render a favorable ruling in the lawsuit filed by their client Benavidez against IISD, set to go to court in October.

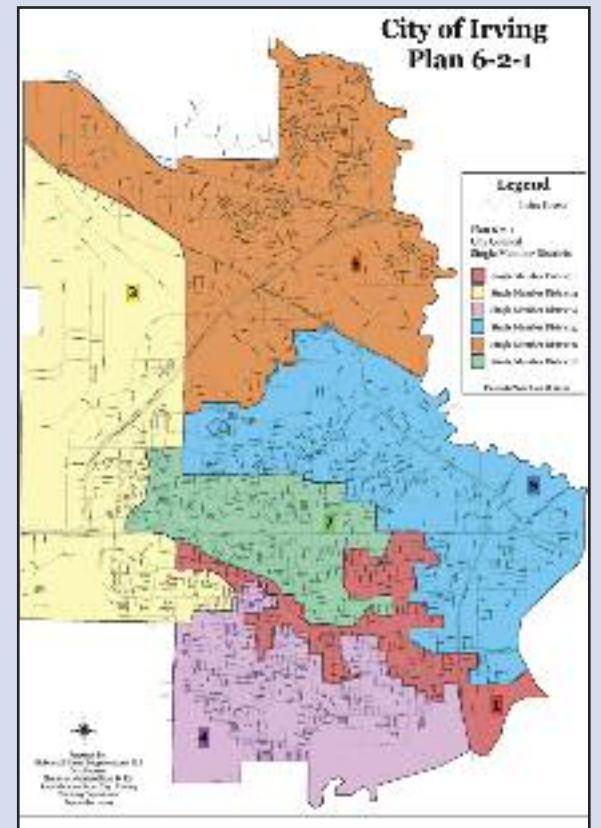
"The fact we were able to use innovative Census Bureau Estimation data to support the idea that we could create a district that was minority-majority, as opposed to using data from a census countdown is what makes this case extraordinary. Utilizing the Census Bureau Interim Estimation Data, ACS provided us the ability to prove rapid demographic change, specifically as it relates to Place one (southern sector of Irving)," said Veaser.

The opposing argument presented by the City of Irving testified the illustrative districts created by the plaintiff results in vote dilution by relying on total population for district size, rather than considering citizen-voting-age-population (CVAP). Arguments made by the public

opposing a single-member voting district range from how a voting system of this nature can distort the purpose of government to serve all the people and not just one particular group, to lending itself to opportunities for corruption, which leads to ineffective government.

On Tuesday, President Barack Obama inadvertently joined the fire storm surrounding Kanye West bum-rushing Taylor Swift Sunday night when his off the record comments were shared via Twitter.

Kanye West received much deserved criticism after interrupting country star Taylor Swift during her acceptance speech at the *MTV Video Music Awards* Sunday.

West walked on stage and took the mic away from Swift and proceeded to pro-

claim that Beyonce deserved the award for best female video.

West issued two apologies on his blog Monday before appearing on Jay Leno's debut of his new show for a more extensive apology.

"I'm just ashamed that my hurt caused someone else's hurt -- and I don't try to justify it because I was just in the wrong. That's period," he says. "But I need to, after this, take some time off and just analyze how I'm going to make it through the rest of this life, how I'm going to improve. Because

I am a celebrity, and that's something I have to deal with."

After Swift appeared on *The View* on Tuesday morning and stated she would be willing to speak with West, he called Swift and finally apologized to her personally.

Obama's 'jackass' comment about Kanye West was off the record, claimed John Harwood, CNBC's chief Washington correspondent.

"The custom in television, as I understand it, is that when you have an interview of this kind, the little chit-chat when you are

getting ready to sit down to do the real interview is off the record," Harwood told Politico.

"It's one of those things that's like an understanding, as people have understandings with sources," he continued. "And if you have a relationship of trust with someone, as I feel I do with the White House and the president, specifically, I felt like I should honor it."

However, the remarks quickly became public after ABC News reporter Terry Moran tweeted the comment.

## UT Dallas Launches Top-Level Sustainability Center

(UTD) Labels describing furniture made with "all natural fiber," "reclaimed teakwood" and "water hyacinth fiber" are common in showrooms and catalogs. Manufacturers and retailers are (UTD) seeking sustainable alternatives to traditional hardwood product lines.

Crafting furniture using ecologically sound practices - including recycling, sustainable forestry, conservation and reclamation - has become more than a fleeting fad. There's a booming market trend in the U.S. home furnishings industry to create products that not only add beauty but also help protect the environment.

"Businesses in all industries today must be concerned about the impact that

products and services are having on the planet and future generations," said Francisco Szekely, a UT Dallas School of Management professor. "More and more, consumers are asking: 'Who made this product?' and 'Where did it come from?'"

An expert on environmental and corporate sustainability, Szekely is the director of the School of Management's new Center for Responsible Business and Sustainability (CRBS).

Launched this past spring by Szekely and the center's associate director, Dr. Usman Ghani, the CRBS strives to help business leaders adopt business practices that are sustainable as well as competitive.

Helping develop a business model in the U.S. fur-

niture industry is one of several initial projects the center has undertaken in its quest to position UT Dallas at the forefront of universities working on sustainability issues.

Overpopulation has strained the Earth's natural resources, posing a worldwide challenge that demands action from governments, corporations, universities, organizations and consumers, Szekely said. Business can play a central role in helping build a sustainable society by creating corporate culture that is mindful of the environment across its business practices.

"If we sacrifice our environment, we limit the ability of the next generation to do well," said Szekely. He also has served

as director of and professor at the International Academy of the Environment in Geneva, as well as deputy minister of environment and natural resources in Mexico.

"Sustainability is about keeping a balance between environmental, economic and social objectives. We help companies come up with a business model that keeps these things in balance," Szekely said. "Business has to adopt a new approach to value creation. Instead of the traditional and narrower approach of focusing mainly on creating 'shareholder value,' now companies must figure out how to create 'stakeholder value,' where managers, employees, customers, communities and society benefit from its activities,"

he said.

Combining the research and teaching strengths of UT Dallas with the center's forward-looking approaches, the CRBS plans to offer "learning platforms" and "sustainability forums" to discuss the business and social implications of adopting options in response to sustainability challenges such as global warming, new energy sources and risk management.

Some of the areas the center will focus on include innovation, work processes, leadership methods, organizational models, competitive strategies, and supplier

and customer relations. The center will also explore the pros and cons of various policy options to curb global warming, such as cap and trade, carbon taxes, alternative energy, and product and service labeling. It will also organize multi-stakeholder forums to address how business can better respond to global challenges.

Since joining the School of Management a year ago, Szekely has been in demand as a keynote speaker at events hosted by local civic and professional groups, community colleges, and industry and business associations.

lie!" that broke decorum during President Barack Obama's address to the Joint Houses of Congress on health care reform Wednesday (September 9, 2009) evening.

"As African-American newspaper publishers we stand in solidarity with the NAACP and fully support the economic boycott of South Carolina," stated NNPA Chairman Danny J. Bakewell

Sr. "Rep. Wilson's remarks were racist, disrespectful, and a disingenuous violation--not only of President Obama--but to the institution of the presidency and only solidified our position and the im-

portance in not spending Black dollars where Black people are not respected. The continued public and blatant disrespect of President Barack Obama by members of Congress will not be

rewarded with our dollars nor will a state that continues to uphold America's shameful past by flying the Confederate flag."

The NNPA is currently considering North Carolina

numbers and places of employment. The absence of e-mail addresses, mobile phone numbers or Internet identifiers meant the Office of the Attorney General (OAG) and other law enforcement agencies often had to rely on low-tech methods to track down convicted sex offenders who accessed the Internet in violation of their parole.

Paroled criminals in the state attempt to use the anonymity of the Internet to

disguise their identities, arrange meetings with children or maintain social networking profiles. Recently, the OAG's Fugitive Unit arrested Gary Dee Gause, of Fort Worth, after he maintained a MySpace account in violation of his parole. He was paroled after serving 25 years in prison for sexually assaulting two women in 1982 – one in Harris County and the other in Tarrant County.

The Fugitive Unit also

arrested Michael Jermain Harris, of Houston, for maintaining a MySpace account and Facebook account in violation of his parole. After Harris 2004 conviction for attempted sexual assault a 14-year-old girl, he was paroled and prohibited from using the Internet.

Fugitive Unit investigators also arrested a third suspect, Brian William Yoas, of Austin, for violating his parole by logging onto the Internet and maintaining a

MySpace account. In 2005, Yoas was convicted in Williamson County of possessing and intending to distribute child pornography.

To date, our office has arrested more than 30 sex offenders who violated their parole by logging onto MySpace, which recently revealed that 90,000 of its members were registered sex offenders.

At least 5,000 sex offenders have also been discovered on Facebook's

membership lists.

The new law's mobile phone requirement is equally important – not just because it helps track down parole violators, but also because many predators use mobile phones to prey on children. Unfortunately, mobile phones are being used to send text messages to potential victims, transmit explicit photos and access the Internet, where children can fall victim to other types of exploitation.

When criminals are exploiting technology as fast as it is developed, authorities cannot be bound to low-tech law enforcement techniques. SB 689 gives the long arm of law enforcement the maximum possible reach in order to hold registered sex offenders accountable.

As history has shown, cooperative, creative law enforcement can and we will overcome even the most cutting edge criminals.

group needs a seat at the outdoor table.

Now they will find out how to take full advantage of what belongs to us all. Environmentalists Audrey and Frank Peterman, organizers of the First Biannual Conference & Expo: *Breaking the Color Barrier in the Great American Outdoors* at the Atlanta Airport Hilton in Atlanta, September 23-26, have been working for the past 14 years to draw attention to this hidden segment of American life.

The conference will feature people of color engaged in sports such as mountain climbing, skiing, sailing, scuba diving, bird watching, falconry and other sports.

And it will highlight the efforts of black and brown Americans to protect the environment and the scenic treasures in the nation's public parks, forests and wildlife refuges.

"The National Park System has a budget of around \$3 billion," said Audrey Peterman, during a television interview on August 16th about the First Family's visit to Yellowstone National Park and the Grand Canyon. "Many of the parks are bigger than entire cities - Yellowstone, for example, is 10 times the size of New York City. Parks have jobs consistent with those in cities - from the mayor (called a Superintendent in the parks) to

street cleaners to IT and Human Resource professionals. It's time to open up that revenue stream to the full American population. Right now, the park system's workforce is close to 80-percent white," Peterman said.

Peterman noted that the changing demographics of our country demand participation from all ethnic groups if the parks and the environment are going to thrive.

"Some African Americans, Latinos and Asians have not seen themselves reflected in outdoor sports and in the environmental movement; but that has got to change," she said.

The Petermans have worked with a wide range of outdoor recreation proponents of color and notables in government and business who want to see more diversity in the environmental movement. Many of them will be available at the conference to inspire young people, provide little-known information about the public lands system, and offer advice about career and business opportunities, contracts, education and recreation.

The conference will introduce people of color actively engaged in fields not typically associated with their race. For example, Hermes Castro is a 30-year-old Latino outdoor enthusiast who lost his legs when a drunk driver hit his bicycle in 2006.

Yet Hermes has continued to be an avid sportsman in San Diego and just returned from an expedition to Antarctica, where he became the first wheelchair visitor ever.

And there's Jerry Bransford, a 62-year-old guide at Kentucky's Mammoth Cave, whose great-great-grandfather began exploring and guiding in those same caves as a 15-year-old slave. Savannah Williams, a 25-year-old marine scientist in Nashville, was the first person in her African-American family to learn how to swim when she joined a teen aquatic club and became a certified scuba diver.

The conference coincides with National Public Lands Day on September 26, with participants having an opportunity to work on improving a house in the

historic Martin Luther King district. It also is timed to the release of Ken Burns' documentary, *The National Parks: America's Best Idea*, which will air on PBS stations on September 27, and highlights the roles of African Americans, Latinos, Asians and Native Americans in the creation and expansion of the park system. The Petermans have collaborated with Burns. His co-

producer, Dayton Duncan, credits Audrey Peterman with introducing him to one of the subjects profiled in the documentary, The Jones Family of Biscayne National Park.

The Petermans' new book, *Legacy on the Land: A Black Couple Discovers our National Inheritance and Tells Why Every American Should Care*, will be released at the conference.

# Improve Our Air in Less Than Sixty Seconds

(NDG Wire) To decrease ozone-forming emissions from a high-polluting vehicle as soon as possible, North Texans who see smoke pouring from a vehicle tailpipe are encouraged to report it by dialing #SMOKE on a cell phone or visit [www.smokingvehicle.net](http://www.smokingvehicle.net).

To protect our air, North Texas vehicles by law must annually pass an emissions test, but a lot can happen the 364 days between State inspections. Alerting vehicle owners to potential emissions-related problems, sooner rather than later, helps improve the region's air quality.

Additionally, Texas law prohibits visible motor vehicle exhaust for 10 consecutive seconds.

To assist vehicle owners and improve air quality, the Regional Smoking Vehicle Program allows residents to report high-emitting smoking vehicles by calling #SMOKE from a cell phone—it is a free call with most wireless providers. Callers are asked to report the Texas license plate number and where and when they saw the vehicle. Drivers can also report vehicles by dialing 817-704-2522 or entering information online at [www.smokingvehicle.net](http://www.smokingvehicle.net).

Since the program launched in March 2007, about 15,350 vehicles have been reported.

Owners of reported vehicles receive a letter explaining the importance and benefits of regular vehicle maintenance. The letter also provides information about local solutions like the AirCheck-Texas Drive a Clean Machine Program which offers financial assistance for eligible vehicle owners to pay for emissions-related repairs. A follow-up survey is sent after the initial notice. More than 1,500 surveys have been returned, and 431 respondents

have repaired the reported vehicle. About 100 others said the reported vehicle was no longer in operation.

The program is implemented through a partnership between the North Central Texas Council of Governments and the Texas Commission on Environmental Quality.

Aside from reporting smoking vehicles, there are 14 other clean air choices encouraged through Air North Texas, a regional public awareness campaign and partnership to educate residents and motivate them to commit to clean air choices.

Other things to do: carpool, avoid idling and maintain vehicles.

Keeping tires properly inflated and rotated regularly, replacing air filters annually and changing oil and oil filters according to the owner's manual all help a vehicle run more efficiently, which re-

duces pollution. More clean air choices are online at [www.airnorthtexas.org](http://www.airnorthtexas.org).

Reducing ozone-forming pollution and improving air quality are important to protecting the health and welfare of North Texans today and sustaining the quality of life for tomorrow.
