

The ink is all but dry on Texas Voter ID law

By Sen. Royce West A routine by comic Bill Cosby weaves the tale of a daily walk to school in telling kids how hard he had it growing up. It was five miles each way, Cosby said, "uphill, both ways." Such is the task facing Texas Democrats' attempt to block potentially harmful revisions to Texas' election laws that are so important to Republicans, that Gov. Rick Perry declared it an "emergency" item, putting it on a fast-track through legislative timelines.

Former President Bill Clinton once said that elections have consequences and Democrats will soon pay the price for staying home for the midterm elections. Passing what will be the country's toughest voter ID law was made easier when more than 20 Democrats were ousted on the way to Republicans gaining a 101-member super-majority in the Texas House. This means Republicans can convene and pass legislation without a single

Where did all the Haiti money go?

By Nicole C. Lee, Esq. When a 7.0 magnitude earthquake hit Haiti on January 12, 2010 the world community came to its aid. Millions of private citizens in this country and around the world reached into their household budgets and gave generously to the Haitian people who were grappling with the devastation.

We sat in front of our televisions and watched men digging for their families. We gave more. We heard doctors lament the lack of supplies. We gave more. In March, the United Nations member states and international partners met in New York and passionately pledged more than \$5 billion over the next 18 months to help Haiti recover.

Despite the billions of dollars pledged from private citizens and world governments, a serious health scare has arisen. With poor sanitation, malnutrition, little safe drinking water and no sewage systems, the over-crowded temporary housing tent communities provide an ideal breeding ground for cholera.

One independent report has conservatively estimated that there is one toilet

for every 273 people in the Port-au-Prince metropolitan area. Throughout Haiti, a year after we opened our hearts and wallets, the latrines are not cleaned on a regular basis and human waste spreads into the streams by the frequent rains. Now, a year later, limited water distribution continues, with little development of sustainable, municipal water-filtration systems.

In the face of these conditions. Haiti remains the non-governmental organization (NGO) capital of the world. Before the earthquake, there were more than 5,000 organizations on the ground in Haiti. From the International Red Cross to Save The Children to any number of church and civic organizations, Haiti is replete with people of good will who are there to make it a better place to live. Each of these organizations conducted their own fundraising campaigns after the earthquake and collected millions of dollars.

With millions of dollars at our disposal do we really lack the ability to support basic sanitation and clean water? Do we lack the ability to stop a preventable, deadly water-borne disease right off our coast? What happened to all of the money?

Many of the charities on the ground have reported they are setting aside a portion of their donations (sometimes up to 70 percent) for the "reconstruction" period. It's clear from the outpouring of support many of those who donated from their own scarce family budgets believed they were giving to save lives immediately. In the face of a preventable public health emergency, like cholera, many will be surprised that more than half of their donations continue to sit in US banks

My organization has attempted for nearly a year to get the Red Cross to account for the money they collected for Haiti. In a recent meeting, I was told that 70 percent of their donations remain in "reserve" to be used for longer-term reconstruction.

Long-term development to secure transitional and permanent housing, build infrastructure outside of Port-au-Prince and promote public health campaigns are all extremely important issues. But if the Red Cross, whose mandate and expertise lie in emergency and crises management, is not responding to continued immediate emergencies on the ground, then who is? Who is responsible for the deteriorating quality of life and preventable suffering faced by those most affected by the earthquake?

We have asked the House oversight Committee, to hold a hearing on large private NGOs and USAID partner organizations to ask one simple question: "What happened to all of the money?' Though significant promises of donations have been made, many communities of earthquake survivors continue to face challenges in accessing even the most basic of services. Our repeated requests to determine where the money went have fallen on deaf ears.

We need to know who is responsible for coordinating the money donated to Haiti? Who is holding the thousands of NGO's on the ground accountable for the money they collected from U.S. families and families around the world? Moreover, who is pressuring the

Democrat's "yea" vote.

Others will also feel the repercussions. Republicans are pushing through a bill for which testimony provided no projections on actual implementation costs. Analysts say this unfunded mandate will pass along costs to county governments. And while we mull the reality of laying off thousands of teachers, our colleagues don't mind diverting resources to solve a problem that doesn't exist

On the new session's second day, Senate Republicans passed a rule to bypass the longstanding tradition requiring 2/3 of members' approval for bills to come up for a vote. Less than a week later, Senate Bill 14 cleared committee in an evening-long hearing. The next evening, the bill passed the full senate on a party-line vote.

SB14 will require Texas voters to display a current government-issued photo ID to cast a ballot. Republicans claim a new law is needed to prevent election day fraud by those who show up at polling sites bearing fake voter registration cards. No evidence exists that validates claims of massive voter fraud of this type. Democrats support laws that insure the integrity of the ballot. But SB14 does not address known improprieties surrounding mail-in ballots.

Evidence does exist that minorities, the elderly and disabled are more likely to be without a driver license or state-issued photo ID. And throughout debate, Senate Democrats foretold the hardships that SB14 could cause would-be voters.

In parts of Texas, citi-

zens must drive more than 100 miles to a Department of Public Safety (DPS) location to obtain a state ID. There's no DPS office in 77 of Texas' 254 counties. Newly-married or recentlydivorced women could have problems with names on voter registration cards that don't match those on state IDs. And missing accepted forms of identification can deny or delay the issuance of state-issued ID to applicants.

Eight states require voters to present photo identification. None are as restrictive as SB14 looks to be. Neither Indiana nor Georgia laws, both highprofile cases, repel voters like SB14 will. Georgia allows use of an expired state-issued driver license and any valid photo ID issued by the federal government, state agency, county

or municipality. Indiana permits use of a photo ID issued by any state or federal agency or a photo ID issued by a state university. Michigan law says voters without a state photo ID can use a current out-of-state license or ID, or a college or high school picture ID.

Democrats may have to depend on the U.S. Justice Department to reject a photo ID law they view as unfair. Any changes to voting laws must pass federal pre-clearance due to Texas' history of voter suppression.

Call some Texans un-American and you may have a fight on your hands. But on the night of the State of the Union Address when the president sought to rally the nation around a theme of unity, Texas' leadership treaded down a path that would only further divide.

Our kids are getting fatter...and hungrier?

(NDG Wire) If the war against childhood obesity was a race, America would still be at the starting line.

Childhood obesity has tripled in the past 30 years. About one out of every three children or teens is overweight or at risk of being overweight. Because children's bodies are still developing, the damage to organs triggers medical problems extending throughout their lifetimes, according to a report issued by First Lady Michelle Obama's Task Force on Childhood Obe-

Nearly 75 percent of Americans will be overweight or obese by 2019, and that condition will drag

down the economy and impoverish the nation. What's worse is that our nation is growing fatter at the same time it is growing hungrier. Another study by New York's Food Research and Action Center describes another dilemma -- a new definition of hunger that actually describes how families can become obese at the same time they are going hungry.

DART approves agency's first CNG bus order


(NDG Wire) In the latest phase of its clean transit fuels program, the Dallas Area Rapid Transit (DART) board has approved one of the nation's largest compressed natural gas (CNG) bus orders.

The \$210 million contract with North American Bus Industries, Inc. of Anniston, Alabama will allow the agency to purchase up to 452 new 30-foot and 40-foot heavy duty, low floor buses to replace the current fleet of liquefied natural gas (LNG) and clean diesel buses which began service



in 1998. The new buses are scheduled to be in service in 2013. The full fleet conversion should be complete in 2015.

DART plans to award a contract in April for the construction of four CNG fueling stations. The stations will be located at its bus and Paratransit maintenance facilities.

Educators urge lawmakers to support the Make Education a Priority resolution

(NDG Wire) Members of the Texas Association of School Boards and the Texas Association of School Administrators visited Austin on Monday together to ask Texas lawmakers to Make Education a Priority while building the state's budget.

Superintendents and trustees specifically dis-

(NDG Wire) Members cussed the devastating impact proposed cuts would have on Texas schools and the state's future.

About half of all Texas public school districts have adopted the Make Education a Priority resolution, which urges law-makers to hold education as the highest priority when developing the

state's budget for the next biennium. The Make Education a Priority campaign was started by the Aledo Independent School District as a way to increase public awareness about the problems with the way public schools are funded in Texas.

The initial drafts of the state budget proposed by

the House and the Senate include approximately \$10 billion reductions to Texas public schools over the next two years. This reduction comes after years of district belt-tightening, since the target revenue froze revenue for schools at 2005-06 levels. In light of the proposed state funding cuts, local

school districts across the state are facing crippling choices such as teacher layoffs and school closures.

A world-class public education system is critical to Texas' economic success. Such severe funding cuts for the public schools charged with preparing our future

workforce and state leaders is shortsighted. TASB and TASA members recognize the challenges awaiting lawmakers, but we urge them to Make Education a Priority when considering budget decisions: please do not balance the state's budget on the backs of Texas students.





Agitation over the removal of the n-word from *Huck Finn*

The removal of the n-word from Mark Twain's *Huckleberry Finn* has caused complete outrage, shock, and outcries of sorts all across the American landscape. If the term is removed from historical texts,

which were written during and work to convey the reality of the times - depicting the distorted face and broken planes of America's overall past psyche, how can we expect children to learn real history, and hence, the meaning and importance of societal progress, if it is sanitized or veiled...resonates from the voices of the malcontent.

I agree with those who are concerned about history being distorted and sanitized, but my concerns extend far beyond Huckleberry Finn. As belated scholar Dr. Asa Hilliard would constantly say about present day historical literature, "We have a truth problem." Indeed we do! in the past, not erasing them.

The effort should be to show our current generations the ignorance that was acted out in the past, the sickness the use of the nword bores in all, and how to effectively proceed today

> by eradicating n-word from their use. The truth in history is suppose to make stronger and serve as a fundamental building block for improvement, however, when one looks at Hip Hop culture, the opposite is manifested.

The truth of the matter is that when it comes to slavery and the nword, history has ALWAYS

been sanitized and distorted in efforts to lighten the deliberate blows of hate, hostility and genocide that were carried out against blacks. It's as if the historians are saying slavery was bad, but not that bad. Honestly, it is somewhat an irreverence to be sanctimonious about the removal of the n-word from *Huck Finn* and fail to exhibit the same concerns about American history overall.

In the time when Mark Twain wrote the classic, slaves were not perceived as having the same human qualities as whites. Even though "n**ger" has always been used as a derogatory term, it became so commonly accepted that it was used synonymously with the word "slave" or just common reference to blacks. As such, it rolled just as easily off the tongue

of Jim as it did of Huck and society in general.

Just as with today's contemporary blacks, the nword rolls off the tongues of someone who hates him. And I repeat - a TRULY free person - which is very significant. A point seemingly lost upon today's sanitization of history. Much about the n-word's sinister history has been suppressed and erased from the academic approved his-

many rather easily and effortlessly. However, the problem is that blacks tend to forget or downplay the original meaning of the nword as it applied to their ancestors. A "n**ger" was looked upon as lacking human qualities, 3/5 of a person, sub-human and a bestial savage beast who needed to be tamed. N**ger was symbolized as something inferior to the rest of humankind, a place where anyone of black origin belonged. Hence the phrase, don't forget your place, n**ger. Black African Americans who embraces the term makes a mockery of the sacred memories, struggles and sacrifices of their dearly beloved ances-

To be succinct, mentally and emotionally scarred descendants of slavery are so severely psychologically disturbed that they have become immune to the idea of debasing themselves and think nothing of defining themselves with a word that is drenched in ignorance, death, terror and bloodshed. Excuses that are being tendered, otherwise, serves as testimony of a lack of intestinal fortitude to deal with reality.

As irony would have it, Mark Twain illustrates a point that a truly free person would never want to wear the name given to him by black users of the pejorative term and those who condone such use.

Many rap artists like Jay-Z, Lil Wayne, Soulja Boy and a host of others use the word in their music to supposedly entertain their audiences. Their songs may seem harmless because they use the word in a context of camaraderie and friendship. However, there are inherent and chilling similarities to the self-destructive messages in gangsta rap and the indoctrination techniques used in the days of chattel slavery to corrupt the minds of an enslaved race of peo-

The founder of BET made a fortune by spreading a culture of gangster rap, with its glorification of violence, denigration of women, saggin' pants, use of the n-word and the perpetuation of a dysfunctional vocabulary that all but ensured that countless young Black people will never be able to get through a job interview. Not a murmur of concern erupted from the Black community; the nword is removed from Huck Finn and the floodgate opens up denouncing the dismissal of the incorrigible term; this goes beyond the comprehension of logic.

The *Huckleberry Finn*"n- word" episode pales in comparison to perhaps the most blatant distortion and

tory books limiting at least 95% of contemporary Americans' knowledge of the word as being nothing more than a racial slur, to demean, degrade and insult. N**ga which is a ghetto vernacular for n**ger is so stigmatized that trying to redefine it suggests that all the death, terror, bloodshed and mental abuse associated with it never happened. But the fact is it did. Hip hop culture serves as a shining example of what happens when one is left in the dark about their history, a history that has been sanitized and



distorted

He who forgets the past is doomed to repeat it. There was not only a physical enslavement of a people, but the aspect regarding the barbaric and brutal methods used to MENTALLY enslave them as well, has been whitewashed, sanitized and virtually expunged from the teachings of American his-

tory. Where is the outcry and concern? Does it need to be pointed out that mental enslavement is the worst form of slavery?

Millions of Black African Americans - men, women, AND children were viciously beaten, raped, castrated and/or murdered and categorizing them as n**gers in some twisted way was suppose to make all committed acts okay. Clearly, a 300-year African-American Holocaust took place and yet the term is not being used anywhere in American History; there has been no out break of hysteria, remove the nword from Huck Finn and you would think the sky is falling. The hypocrisy of it all is asphyxiating.

There is a blanket of sorts enveloping certain aspects of slavery and the nword with the blessings of both black and white America simply because they can't handle the pain of it all. This quandary makes it even more paramount to understand the pain that black children, whenever grossly outnumbered in a classroom, are experiencing having to suffer through a reading of Huck Finn, and how unfair it is to subject them to such an ordeal. Why is it that so many Black African Americans are willing to sacrifice their very own in their anxiety to preserve and protect their use of the scurrilous n-word (n**ga)?

CRL: Wall Street created toxic mortgage market

As the 112th Congress begins and new committees are formed, our nation's marathon housing crisis seems far from over and no sure cures to its billion-dollar economic effects have been identified. In the meantime, agencies and laws intended to expand affordable housing nationwide have now come under attack. So-called 'risky borrowers', the Community Reinvestment Act and two government-sponsored enterprises, Fannie Mae and Freddie Mac, have all been accused of creating the lengthy downtown in housing and more than 2.5 million foreclosures.

Even a long-awaited report from the Financial Crisis Inquiry Commission, presidential appoint-ees charged to provide an objective and thorough review of the still-unfolding dilemma sharply split along partisan lines as to the causes and effects of the economic crisis.

But according to the Center for Responsible Lending (CRL), an independent and nonpartisan research and policy organization, the culprits and leaders in the still-unfolding foreclosure crisis were clearly Wall Street firms that "securitized" subprime mortgages. A CRL Capitol Hill brief summarizes the findings. As Wall Street securitizers expanded the subprime market, Fannie Mae and Freddie Mac's market share diminished substantially. GSE losses were caused not by risky borrowers but by risky loans, frequently loans that went to borrowers with relatively higher incomes

In part, the new brief advises, "It's well known that toxic subprime loans started the foreclosure crisis, and the disaster spread to other mortgages approved without properly qualifying borrowers. The facts show that Fannie Mae and Freddie Mac were followers, not leaders in the events leading up to today's foreclosure epidemic."

'Securitization', process of bundling thousands of mortgage loans into investment pools and then re-selling pieces to investors enabled loosely-regulated lenders, says CRL, to make loans and then quickly sell them to private firms that created mortgagebacked securities.

CRL also refutes widespread charges of risky borrowers and Community Reinvestment Act loans as causes for the still-unfolding housing crisis. The truth is that 94 percent of subprime mortgage loans were made by institutions not covered by CRA.

"Mortgage loans purchased by Fannie Mae and Freddie Mac - including loans to lower-income borrowers - are performing better than the private market. As of June 2010, 13.35 percent of GSE loans to borrowers with credit scores

under 660 were 90+ days delinquent or in foreclosure. By comparison, the Mortgage Bankers Association reports that the serious delinquency rate for subprime loans was over 28 percent", says CRL.

Lawmakers would be well-advised to focus on the facts and to seek sustainable answers instead of new villains. Before the housing hubble burst modest increases in African-American homeownership were

achieved. Now, the effects of the extended housing crisis have erased those same

According to the Center for American Progress, in the third quarter of 2010, the homeownership rate for African Americans was 45.0 percent. The homeownership rate for Latinos was 47.0 percent, and the homeownership rate for whites was 74.7 percent.

Further, as the national unemployment rate hovers near 10 percent, communities of color are suffering more. The unemployment rate for African Americans was 15.8 percent in the fourth quarter of 2010, compared to 12.9 percent for Latinos, 7.3 percent for Asian Americans, and 8.7 percent for whites, also according to the Center for American Progress.

What all Americans need – regardless of race or ethnicity – are solutions to shared problems, access to fair lending, and reasonable, transparent terms for all lending products.

Somebody should deliver that message to Con-

269-2401 may have the passes shipped via FedEx or pick them up at will call at QuickTrip Park.

To ride the TRE to the game on Sunday, February 6, 2011, only, the regional transit pass will cost \$20 (lanyard and pass holder not included) and must be purchased at the TRE Centre-Port Station the day of the game. The regional transit pass will be required to board the bus at CentrePort Station to the stadium. DART and T passes will not be accepted as fare payment for the bus from CentrePort to the stadium.

The pass allows customers unlimited rides on Dallas Area Rapid Transit light rail (Red, Blue and Green rail lines), all DART buses, the Trinity Railway Express commuter line, and all services from the Fort Worth Transportation Authority (The T) and the Denton County Transportation Authority.

The pass also includes transit service to Cowboys Stadium for the big game. On game day, customers can ride the TRE to TRE's CentrePort/DFW Airport Station, where they will transfer to one of The T's shuttle buses to ride to the stadium.

The special regional transit pass can be purchased in beginning SBXLV.ClickandPark.com. The pass will also be sold at the DART Store, 1401 Pacific Ave. in Dallas, and the Worth Intermodal Transportation Center, 1001 Jones St. beginning Tuesday, February 1 through Friday, February 4. The pass will be on sale at QuickTrip Park starting January 24.

Passengers who wish to ride TRE and The T's buses to the game only on Sunday, Feb. 6, but haven't already purchased the special fourday regional pass, may ride TRE free to the TRE Centre-Port Station, and purchase the pass for \$20 at the station

prior to boarding the bus to the stadium. This game-day only special regional transit pass will not include the lanyard and pass holder. A special regional transit pass will be required to board the bus at CentrePort to the stadium.

TRE passengers returning to Dallas from the Super Bowl on Sunday, February 6 are advised to plan carefully the time of their return trip from Cowboys Stadium since the last DART light rail trains depart downtown Dallas around midnight. Passengers destined only to downtown Dallas will have Green Line service from Victory to Pearl as late as 1:27 a.m.

For TRE passengers returning to Fort Worth on game day, The T's trolleys will run from the downtown Intermodal Transportation Center until the last TRE train arrives, and make passenger stops at the downtown hotels. The T's other trolley service will end at midnight.

and declared for "Emancipation or Extermination". Yes, there were Black newspapers during slavery - since March 16, 1827.

Classifieds

The Weekly Anglo-African, April 13th, 1861 heralded: "Better be a DEAD MAN, than a live slave! Better to die fighting, than to live to breed children for the shambles! Death slays only the body; the spirit, [disenthralled], will pass on, working out its immortal destiny. Rather say we, 'Ten Reigns of Terror' than one year of bondage! Better a thousand guillotines, than one fugitive returned. 'let the Union go to pieces, if the slaves go free"

Black leaders faced the reality and inevitability of the consequence of the coming sectional conflict with resolution, while white leaders were in denial of the unions transformation and the certain demise in the preservation of slavery. Frederick Douglass editorialized in his Douglass Monthly on May, 1861, just one month after the start of the war: "God be praised! That it has come at last. We should have been glad if the North, of its own proper virtue, had given this quietis to doubt and vacillation. She [the Union], did not do it, and perhaps it is best that she [the Union]. did not. What her negative wisdom withheld, has now come to us through the vengeance and rashness of slaveholders. Another instance of the wrath of man working out the purposes in praise of eternal goodness!"

Free and Enslaved

Blacks transformed a Civil War for reunion into a war for liberation. It would take five years of fratricidal conflict for White America to arrive at the meaning of the war that was clear to Black America at its beginning the reaffirmation of the founding universal human principle of America that all men are created equal. "This [the Civil War] is but another step in the drama of American progress. We say progress, for we know that no matter what may be the desires of the men of Expediency who rule, or seem to, the affairs of the North, the tendencies are for Liberty. God speed the conflict. The strife will be deadly, but the end is certain. It matters not whether the government is successful, whether the union is preserved, the ideas underlying the struggle will triumph", Weekly Anglo-African, April 20th, 1861.

April 12, 2011 will mark the 150th Anniversary of the firing on Ft. Sumter and the start of the American Civil War. The African American Civil War Memorial Foundation will commemorate the beginning Civil War with celebrities reading from Civil War newspapers, period speeches, and other documents announcing the coming of the war and its profound effect on the ending of slavery in America. We will also have celebrities read from selected press responses to the election of President Lincoln and the anti-slavery platform of the Republican party of 1860.

The African American Civil War Memorial lists the names of 209,145 Black union soldiers who joined President Lincoln to save the Union and keep it united under one flag. The monument, located at the corner of 10th and U Streets NW Washington, D. C., was built by a private foundation that operates a museum. On July 18, 2011 the museum will host a Grand Opening for its newly renovated 5,000 sq.

ft. space with new exhibits, artifacts, and state of the art educational programs adjacent to the monument.

Five years had gone by, and other than a few freelance jobs writing advertising copy, I had not made a penny from writing. I was beginning to re-think my life, when I recalled the encouraging words from my ninth grade English teacher.

She had assigned my class with several essays to write. I remembered the glowing paragraphs of praise she wrote in bright red ink at the top of all my papers. There must have been a dozen of those compositions, and just recalling them gave me hope. I thought, "At least one person in the world believes in my writing."

It was just the encouragement I needed, and I doubled my efforts to find work. Soon I was getting a great deal more freelance work. Enough that I was able to quit working in restaurants. Enough to make a down payment on a house. Then whenever I needed a boost in confidence, I would think again of those dozen glowing paragraphs of praise written in bright red ink at the top of my essay papers.

Suddenly everything seemed to gel. I sold my first book; I won several very important advertising awards; and three colleges were asking me to teach a class in copywriting. I was feeling very grateful and once again thought of my ninth grade English teacher and those glowing paragraphs of praise written in bright red ink. I decided to look her up and give her a call.

When I got her on the phone my first shock was that she did not remember me. I was certain I had been one of her favorites My second was when she told me that she never wrote paragraphs of praise. "There were simply too many papers to grade to write more than a word or two," She said. "I would write 'Nice Work' or 'Good Job,' but never anything more."

Unconvinced, when I got off the phone, I went up to the attic and dug out the box that held my old school work (yes, it's true - I'm a total pack rat – especially when it comes to things I've written!). It took a while, but I finally found those old papers. She was right; there were no paragraphs. And, there was far less than a dozen – only two. About the only thing I remembered correctly was the bright red ink. I did, however, rate more than one or two words. On the first one she wrote. "Nicely written - well thought out." On the other, "Good Sense of Humor!"

Nine words. Nine little words that were so heartening that over the next 15 years they grew into hundreds in my mind. Nine words that motivated me to stick to my dreams. My

point? Even the least bit of praise can be powerfully motivating. So, don't keep it in – use your power!



This is the start of Black History Month; again I will highlight some facts and accomplishments of African Americans. Some will be ones that are most requested and talked about from past years. Some readers have mentioned that they had learned a lot of Black History facts from reading my columns during the month of February.

It is my strong belief that as we honor the accomplishments of African Americans world-wide, we honor God and our ancestors. Too many of our Black children have forgotten or have never been taught that they are where they are in life because of our ancestors. Our ancestors suffered, prayed, honored God, endured many hardships and died so that future generations' lives would be better. Many young Black children (and, I am sad to say, some older Black people also)

have the misconception that it is not necessary to honor the accomplishments of Black Americans that have made a huge difference world-wide. They wrongly believe and have said so, we have gotten over that part of history in America, and we have overcome. Let us not forget to honor and thank older Black Americans, especially this time of the year. Listen to what they have to say (over the years they have learned many things that will be helpful to young Black children, if they are willing to learn).

Little Known Black **History Facts**

Since the "Entertainment World" is all a buzzed about The Oscars, and how many nominations there are in each category, and speculating who will win what, I thought that it is good to know that Maya Angelou was the first Black woman to have a screenplay produced, "Georgia, Georgia," which she also directed. In 1970, she was the first Black woman to have a non-fiction book on The New York Times Best Seller List; it was the first volume of her autobiography, I Know Why the Caged Bird Sings. And she was the first Black woman to be a conductor on a San Francisco streetcar. The Harlem Renaissance was a flowering of African American creativity that exploded in America in the 1920's. Langston Hughes (a postal stamp was made to honor Hughes) and Countee Cullen wrote poems, Nella Larsen and Jean Toomer wrote novels, and Zora Neale Hurston wrote about Black folk life. Aaron Douglas painted extraordinary pictures, and sculptor Augusta Savage turned

was open to Black musical theater with zestful singing, dancing, and comedy. The whole country was moving to the rhythm of a Black dance called the "Charleston." In politics, Marcus Garvey was calling for Black self-reliance and identification with African heritage. W.E.B. Du Bois was fighting against segregation and for civil rights for people of color. This much energy, talent, and creativity infused the whole nation with a unique new vigor and originality.

Reading this column today, it is good to know that The Stone Churches of Lali**bela** in Ethiopia are **one of the** architectural wonders of the world. A group of eleven buildings, they are hewn from volcanic rock. But they are not carved from stone standing above ground. Astonishingly, they were cut into the earth, so that what one first sees is their roofs—level to the ground. It is said that the churches date from the twelfth century. Their
