Texas leads the nation in child heat-related fatalities

You're a good parent. Your family is your top priority. Your children are healthy, cared for, nurtured, and loved. You would never forget to drop your infant at daycare on the way to work. You would never allow your toddler to play in your vehicle in the driveway. A tragedy like the death of a child from being

forgotten or trapped in the car couldn't possibly happen to you. Think again!

An average of 38 children in the USA die every year as a result of Hyperthermia, commonly known as heat exhaustion or heat stroke, after being left unattended in a vehicle. Sadly, Texas consistently reports the highest numbers of

these tragic incidents.

That's why the McKinney Fire Department (MFD) has joined with the National Highway Traffic Safety Administration (NHTSA) in an effort to reduce these deaths by reminding parents and caregivers about the dangers of heatstroke in young children.

An open letter to Governor Rick Perry

of Dallas Municipal Court No. 4 judge, who was voted out of her seat after she refused to relinquish it when she ran for the 162nd seat.

Lister Brown, 50, has served on several prominent boards within the Dallas community. She also has a solid educational background to bolster her current position as judge in the municipal court. Unfortunately, she stopped practicing law in 1994 when she began her career as a judge. Lister Brown's extensive knowledge of business, civil and other commercial laws and issues do not stack up to Moore's current successful track record.

Moore, 36, has an impeccable education, including being magna cum laude when she earned her Bachelor of

Science degree from Boston College Carroll School of Management and her Juris Doctorate from George Washington University Law School. She is also either currently affiliated, a board member or a recipient of awards and accolades of more than 10 organizations including being the first Hispanic to ever serve as a Trustee on the Dallas County Schools Board of Trustees.

Diversity is important to Moore as she has been a longtime member of the J. L. Turner Legal Association, the African American Bar Association of Dallas and other minority organizations. Moore believes in staying involved in her field and understands what it takes to be successful as an attorney and as the future

judge for the 162nd civil court.

Moore has expansive knowledge of today's civil law practices. She is board certified in labor and employment law by the Texas Board of Legal Specialization, whereas Lister Brown is not board certified. In her current law practice, Moore continuously demonstrates knowledge and application of the law. Her reputation for high ethics and professionalism has landed her more than 400 endorsements including one from *The Right Wing Leaning Daily* in Dallas and high profile and prominent African Americans in the community.

"Because of my active practice in the courts and understanding of the most complex matters, I am ready to

step into the role of judge from day one," Moore told *The Right Wing Leaning Daily* for their candidate comparison feature.

Moore's experience in civil and business litigations make her more than qualified to transition from practicing attorney to judge. quickly before they could be exonerated.

Texas leads the way in gun ownership as well as homicides resulting from gun abuse, yet the policy of Texas is not to try to control or issue common sense regulations for the licensing of firearms, the state had turned its back on protecting the law abiding citizen from harm by increasing the numbers of guns on the street. By promoting the possession of guns on college campuses, I thought the plan was to quickly liquidate those educated college snobs, who are considered the root of all the evils in this state. And by adopting a policy that anyone should be able to shoot to kill to protect their television set, they have clearly elevated property above the value of human life. I foolishly thought that by cutting funding for the Women's Health Program in an attempt to put Planned Parenthood out of business, the number of deaths caused by undiagnosed breast cancer, cervical cancer, ovarian cancer and the deaths of infants due to lack of pre-natal care would rise dramatically. Further, the number of unplanned pregnancies due to the lack of access to contraception would

actually increase the number of abortions sought by poor women. Thank you Governor Perry, for clarifying this for me.

Plans to cut Medicaid funding for the poor will put these people in life threatening positions because they cannot afford proper health care. My concern about the mortality rates for these people was obviously wrong

however, because you made it clear that Texas has a 'long history of protecting life.'

I similarly felt that the huge cuts in the educational programs in Texas would result in ever increasing numbers of under-educated workers, doomed to toil in minimum wage jobs. I really feel foolish about this one.

So thank you Governor, for setting me straight. Texas

does have a long history of protecting life. I now believe this because contrary to all the evidence, your single statement of this 'long history of protecting life' has convinced me. Now as to the quality of life, well I guess that is a different question.

House Republican Budget Reconciliation Vote a Threat to Seniors' Well-Being

On last Thursday, the House passed H.R. 5652, the Sequester Replacement Reconciliation Act, by a vote of 218-199. No Democrats voted for the bill, and 16 Republicans voted against it. For a tally of the vote, go to <http://clerk.house.gov/evs/2012/roll247.xml>. Most seriously, the vote eliminated

the \$1.7 billion Social Services Block Grant (SSBG) and cut Medicare and Medicaid for seniors.

"Preserving the SSBG would provide Meals on Wheels to seniors unable to prepare their own food; adult day care services, which enable seniors to remain in their own homes; and fund-

ing for programs such as adult foster care and adult protective services, which address the abuse and exploitation of older adults," said Edward F. Coyle, Executive Director of the Alliance.

Senior vaccinations

Things wear down as we get older including our vaccinations. But Dr. Andrew Kroger of the Centers for Disease Control and Prevention says many older people don't realize this:

"Adult immunizations are an excellent way to prevent many diseases that can be deadly. Vaccines aren't just for kids. Some of the protection you got from

childhood vaccines may have worn off."

Consider the chickenpox vaccination you got as a kid. Chickenpox and shingles are caused by the same virus, but shingles is more common among people over 60. If you're over 60,

you may need a shingles vaccination.

And you might want the vaccination against tetanus, diphtheria and pertussis – known as Tdap. The parts about diphtheria and pertussis could keep you from infecting the grandkids.

"More than half of all vehicle-related heatstroke deaths in children are caused by a child accidentally being left in the car, and more than 30 percent are from a child getting into a hot car on their own," said Stacie Durham, Public Information Officer for MFD. "In an effort to prevent these needless tragedies, we want to urge all parents and caregivers to do three things: 1) NEVER leave a child in a vehicle unattended; 2) Make it a habit to look in the backseat EVERY time you exit the car; and, 3) ALWAYS lock the car and put the keys out of reach.

And, if you ever see a child left alone in a hot vehicle, call 911 right away!"

According to NHTSA, heatstroke is the leading cause of non-crash vehicle fatalities for children 14 and under. In fact, one child dies from heatstroke nearly every 10 days from being left in a hot vehicle.

Warning signs of heatstroke include: red, hot, and moist or dry skin, no sweating, a strong rapid pulse or a slow weak pulse, nausea, confusion or acting strangely. If a child exhibits any of these signs after being in a hot vehicle, cool the child by spraying them with

cool water or with a garden hose. Call 911 immediately.

"Children's body temperatures can rise up to five times faster than that of an adult, and heatstroke can occur in temperatures as low as 57 degrees," said MFD's Emergency Medical Services Chief, Kyle Easley. "On an 80 degree day, a car can reach deadly levels in just 10 minutes."

NHTSA and MFD want to remind everyone of a few key safety tips to prevent deadly accidents and to prevent vehicular heatstroke:

- * Never leave an infant or

child unattended in a vehicle, even if the windows are partly open, or the engine is running and the air conditioning is on.

- * Don't let children play in an unattended vehicle. Teach them a vehicle is not a play area.

- * Make a habit of looking in the vehicle - front and back - before locking the door and walking away. Take steps to remember not to leave a child in a vehicle:

- * Write yourself a note and place it where you'll see it when you leave the vehicle.

- * Place your purse, briefcase, or something else you're

sure to need in the back seat so you'll be sure to see a child left in the vehicle.

- * Keep an object in the car seat, such as a stuffed toy. Once the child is buckled in, place the object where the driver will notice it when he or she leaves the vehicle.

- * Always lock vehicle doors and trunks and keep keys out of children's reach. If a child is missing, check the vehicle first, including the trunk.

- * Ask your childcare provider to call you if your child doesn't arrive on time.

- * If you see a child alone

in a hot vehicle, call 911. If they are in distress due to heat, get them out as quickly as possible. Cool the child rapidly by spraying them with cool water or with a garden hose.

The McKinney Fire Department wants everyone to have a safe and enjoyable summer. If you have children, transport, work with or provide care for children, make it a policy to always "Look Before You Lock."

Just as James Brown passed on, so did many of the banking practices of yesterday. Today's bank customers often harbor a deep and broad resentment as to how these institutions operate. Perhaps a new research report on credit cards from the Center for Responsible Lending will enlighten and encourage those now leading our financial institutions to change their ways again. Predatory Credit Card Lending, the latest research from CRL, finds that bank practices that benefited consumers also enhanced financial stability. Conversely, financial institutions focused on maximizing short-term gains through deceptive terms and penalty fees wound up being more financially at-risk.

The report states in part, "Predatory products seemed profitable in the short term and seemed to help fuel eco-

nomic growth; but led to a disproportionate escalation in losses when housing markets slowed and the economy soured. Our new research shows this has also been true in the credit card arena."

CRL examined prevalent marketing and pricing practices before the Credit Card Accountability, Responsibility and Disclosure Act (CARD Act) took effect. The analysis of the connection between credit card practices and actual company performance during the recent economic downturn was based on data from the top 100 credit card issuers. After tracking credit losses beginning in 2006 and continuing through 2010, CRL found:

- Credit card issuers that engaged in a deceptive or abusive tactic tended to engage in several;

- The larger the financial

institution was that was engaged in these misleading practices, the worse their practices tended to be.

- In general, regional or smaller banks and credit unions tended to have clearer and fairer pricing; and

- Common sense curbs on abusive lending benefit everyone -- customers, investors, shareholders and ultimately taxpayers.

These findings also suggest that despite current efforts

to weaken or dismantle the Consumer Financial Protection Bureau, the public and private sectors would be well-served by more and better policing of credit cards and other forms of predatory lending such as overdraft and payday loans.

High-cost penalty fees and rising interest rates became the risk, instead of mitigating it, according to CRL. As the report concludes, "This study shows that measures to stop

deceptive and unfair lending practices promote market transparency and enhance the health of lenders --and the economy -- in the long term."

There was a time when bankers understood that taking care of its customers was just good business. Here's hoping

that banks will remember that time and change again -- for the better.

John Wiley Price facing three challengers for Dallas County Commissioner Court District 3

Three African American Democrats are among the five challengers seeking to unseat veteran District 3 Dallas County Commissioner, John Wiley Price, in the upcoming Dallas County Democratic Primary set for May 29. The *North Dallas Gazette* spoke with Commissioner Price and three of challengers in the race. The winner of the May 29 election will face Republican nominee Charles Lingerfelt, who was unopposed in the primary.

Bennie Brown, a former government contract manager; Betty Culbreath, a retired Dallas county employee; and Micah B. Phillips, a community development leader, are all vying to change the nameplate on this district's commissioner court seat. Though they bring their own set of ideas to the table, all of their campaigns are knitted with the common thread of change.

Price, who is facing the largest group of political challengers in his county career for a seat that he has held since 1985, is seeking re-election and questioned the cries for change.

"I have been the lone Democrat most of the time

and have made substantial gains. South of I-30 is 48-percent of the 2.4 million people, but only 15-percent of the tax base. My cities are amongst the poorest in the district," shared Price by phone with the *North Dallas Gazette*.

He also explained the district includes cities which still buy water through a mud district and some are still pumping sewage. "They have land, but no budget to fund the infrastructure and you can not do economic development without water."

Amid the challenges, Price also shared signs of progress. "For the first time, I now have a majority on the court and a court that embraces the idea of advancing infrastructure in the Southern Sector."

Price spotlighted the expansion of Home Depot into areas like Wilmer and the Whirlpool Distribution center which brought 300 jobs that he equates to about \$60 million dollars to the county's bottom line.

Recounting his tenure, he concluded. "I have survived and thrived." Price asked his challengers, "What would you change?"

Micah Phillips and Bennie Brown point to the need for a fresh start and new vision for the district and the citizens in their campaigns.

"The current commissioner has set the tone that you do not want to deal [with him]. The environment is like the forbidden zone," Phillips told the *North Dallas Gazette*. "I will unify the district, build collaborative networks, create sustainable communities and get rid of the bureaucracy."

He continued, "Fifteen cities should be able to pull together and not be polarized. When you can pull together, you can create a bid-friendly environment, were investors are biting at the bit."

Desoto business owner, Bennie Brown, is tagged as the Accountable Commissioner and highlights integrity and trust as two points of change needed in this district.

According to Brown, "In order to achieve optimal results and unlock growth potential in this County, it is going to require that we establish full accountability and trust of our leaders."

Brown is the founder and CEO of Hope Beyond Hope Foundation, a non-profit organization supporting Dallas area children summer and afterschool programs. He promotes his 25 years of results-driven executive leadership experience along with contract management and management experience.

"I pride myself on my sound judgment, decisive

leadership, high standards, integrity and effective execution of strategic vision and quality improvements," she stated. "It starts with developing an accountability system which rests on internal controls and oversight, and a decision-making process that promotes transparency and integrity."

Phillips and Brown shared thoughts on the restoration of the district's image while Culbreath took a wider perspective. "The whole court has to have the attitude that none of them can work alone and that all departments must be properly funded."

Culbreath has 20 years of county government work and years of organizational leadership experience with six of those years

Phillips is the CEO of Diamonds of Dallas, a non-profit community development corporation that provides social service resources, activities and services that support lower-income residents in displaced neighborhoods. He is also the pastor of Holy Communion Baptist Church and a Dallas firefighter. He is running a grassroots campaign, positioning himself to change the ethical image of the district one handshake or hug

These experiences along with his social service and public service education makes Phillips feel equipped for the opportunity. "With total inclusion, we can expect greatness where the citizens will have their voice back in District 3. It is a new day in Dallas County."

After 27 years, Price may somewhat agree with Phillips, Brown and Culbreath that change is eminent in Dallas County but only for the sake of the latest successes and vision of a more profitable future.

"It is coming to fruition because we now have policymakers in place that un-

actually working in a county district office. She served as the first African American woman from Dallas to lead the DFW Airport Board. Culbreath was the director of the Dallas Housing Authority and twice chaired the Dallas County Planning Commission.

Culbreath says she is running because she is disturbed about the recent decisions the court have made over the years. "They have not been good for the taxpayers, the staff, or the county," said Culbreath. "I want to restore integrity and fairness to the district. I know how to work the county system. I am a good manager and am conservative with money."

“Charity suffereth long, and is kind; charity envieth not; charity vaunteth not itself, is not puffed up,” “Doth not behave itself unseemly, seeketh not her own, is not easily provoked thinketh no evil;” I Corinthians 13:4 & 5” (KJV)

Have you ever tried to forgive someone for something they did to you and found that you simply couldn't do it? You cried about it, prayed about it and asked God to help you, but those old feelings of resentment just would not go away. You just could not let go of it.

Have you ever heard anyone say, “I may forgive but I'll never forget?” That's a second-rate kind of forgiveness that you, as a believer, are never supposed to settle for; you are to forgive supernaturally, “And be ye kind one to another, tenderhearted, forgiving one another, even as God for Christ's sake hath forgiven you.” Ephesians 4:32 (KJV)

You are to forgive as God forgives. He said that he will throw your sins in the sea of forgiveness and remember them no more. You are to release that person from guilt permanently and unconditionally, just as God does, and to operate as if nothing bad ever happened between you. You are to purposely forget as well as forgive.

As you do that, some-

What do you do when someone tells you that you can't do something you want to do?

Maybe you beg by saying, "Pleeeeeease??" Or maybe you ask again and again and again until your parents get mad. Or you might pout a little and wait to see if the answer is different later on.

Twice As Good tells a great story that needs to be shared

But when young Willie Powell was told that he couldn't do something he wanted to do, it just made him work harder to reach his goal. In the new book *Twice as Good* by Richard Michelson, illustrated by Eric Velasquez, you'll see how Willie made his dream come true.

Even though he was just in third grade, Willie Powell was a very fast runner.

He had to be fast. The Edgewater Golf Course was seven miles away and it was one of the most beautiful places Willie had ever seen. Each day after school, he ran to Edgewater, then he ran back home by nightfall.

Willie wanted to learn to

play golf on the smooth lawns at Edgewater, but the golfers told him that "his kind" wasn't welcome there. He was used to that, though. He was often the only Negro boy wherever he went and that didn't stop Willie. He went to Edgewater anyhow, every chance he got.

Eventually, one of the golfers let Willie be a caddy, which meant carrying a heavy bag filled with golf clubs. That didn't stop Willie, either; in fact, he worked twice as hard because being "good" at his job wasn't good enough. Soon, he was earning money at being a caddy.

Then one day, someone asked Willie to play a round



of golf and Willie loved it! From then on, every chance he got, he practiced. By time he entered high school, he was one of the best golfers around. He even entered competitions.

Still, lots of white golfers didn't want Willie playing on

their course. They wouldn't let him join the club or share their clubhouse. But Willie had dreams, not only for himself but for his baby daughter, too.

He knew that someday, there'd be a place where she could learn to play golf, too, and nobody would turn her away. Willie was sure there'd be a course like that, even if he had to build it himself.

Got a kid who wants to be the next Tiger on the links? Show him (or her!) that someone helped groom the course by reading *Twice as Good*.

Author Richard Michelson took the true story of a boy who refuses to take "no"

for an answer to his dreams, and makes it into a kid-friendly story of perseverance in the face of racism. I liked that Michelson gives his young hero a graceful determination with no room for discouragement (which is very inspirational), and Eric Velasquez's illustrations fit Michelson's story to a tee.

I think that if your 3-to-6-year-old loves a good read-aloud, this is one to put on the roster. For you, *Twice as Good* is a book that's hard to say "no" to.
