NAACP urge Texans to oppose confederate flag license plate design

The Texas State Conference of NAACP Branches is asking all Texans of good will to please write the Board of the Department of Motor Vehicles to let them know you oppose the proposed plates that would bear the insignia of a confederate flag on the license plate. The flag in question never flew

over the State of Texas according to our own state archives department, was never the official flag of the Confederacy and has been adopted by many hate groups around the nation. After being used by a Northern Virginia regiment during the war, it was adopted by hate groups that used it to

terrorize blacks throughout the South after the war. The flag was also used in the 1950's and 1960's as a means of sending a signal to the African-American community that the governments of the South were not in favor of the civil rights movement.

Gary Bledsoe, president of the Texas NAACP offers

a haunting analogy:

What is next? If this government-issued license plate is approved, the board should also stand ready to approve a license plate with a swastika on it. Revisionism that tries to paint the Confederacy as a symbol of

Michele Bachmann: The John Wayne of political lies

By George E. Curry (NNPA) Whether making the round of Sunday morning talk shows, giving the Tea Party response to President Obama's State of the Union address, or announcing her own presidential candidacy, Michele Bachmann does one thing consistently – lie.

The Republican congresswoman from Minnesota, who has been described as Sarah Palin with a brain, has enjoyed a dramatic rise in public opinion polls following the latest debate among GOP candidates seeking the party's

presidential nomination. But Bachmann's comments are a reminder of the adage: Figures can lie and liars can figure. Here are some of the most egregious examples:

BACHMANN [CBS "Face the Nation," June 26]: *The Congressional Budget Office estimated Obamacare will cost economy 800,000 jobs, probably the –*

HOST BOB SCHIEFFER: *Again, that is data that other people would question.*

BACHMANN: *That's –*

Keeping young Texans safe on digital playgrounds this summer

With the end of the school year and the arrival of summer, some young Texans will have more unsupervised time at home – and in an increasingly digital world, that means more

opportunities to visit potentially dangerous online playgrounds. Unfortunately, cyber predators do not take summer breaks. Texas parents are the first line of defense against criminals who use the Internet to prey upon children.

Families must stay engaged in their child's activities online, set boundaries and know the capabilities of minors' mobile phones and handheld gaming devices.

Cyber crime investigators across the state have seen firsthand the danger-

ous criminals that lurk online. Texas parents must remain vigilant and remind their children that cyber predators pose a constant and very real threat. Parents should make sure children

Cornel West Theory

The Cornel West Theory is launching their new LP, "The Shape of Hip-Hop to Come," on July 19. This record features the six-member band and chief collaborator, Princeton Professor Dr. Cornel West.

In releasing their second full-length album, the Cornel West Theory continues to evolve its Type I style, which is based in the progressive hip-hop tradition established by artists such as Public Enemy, Rage Against the Machine

and KRS-One. The album was created out of an appreciation for several music genres - hip-hop, jazz, punk, blues, go-go, rock - and takes its name from Ornette Coleman's "The Shape of Jazz to Come" and Refused's "The Shape of Punk to Come."

The Cornel West Theory has once again teamed with Dr. West. In 2009, the band recorded with its



namesake on its critically-acclaimed release "Second Rome." Back then, Dr. West commented: "I think what we have with 'Second Rome' is an instant classic of its generation. And if the

subsequent generations understand the depths of it, they will see what is at stake here in this album is the making of a new wave of new voices in a new generation that we haven't seen in decades."

"The Shape of Hip-Hop to Come" also represents the tradition of hip-hop as a rebellious art form, one that pushes creative boundaries,

champions the common man and speaks with a genuine love for humanity. This album makes a bold statement about where hip-hop has been and can go.

"Hip-hop is really one dimensional right now," says Cornel West Theory Emcee Rashad Dobbins. "Hip-Hop has four elements: Graffiti, dj'ing, rhyming and B-boying. Now the fifth element of money has taken over. ... It's a contradiction to a rebellious music from the start."

With the release of

"The Shape of Hip-Hop to Come," Dr. West says, "It builds on the best of the past. Yes, but it's something new, something novel."

The intent of "The Shape of Hip-Hop to Come" is to display traditions from hip-hop and spoken word and show how those styles can expand with the fusion of other genres. The album takes traditional elements - electronic loops and beats - and evolves them by fusing live instruments and other elements.

Calvin Spann

The Allen Public Library will feature Tuskegee Airman Lt. Calvin Spann, at 7:30 p.m., Thursday, July 14, Allen Public Library Civic Auditorium, 300 N. Allen Dr. He will discuss the rigorous training at the Tuskegee University Moton Airfield, aerial campaigns during World War II that included traversing the treacherous Alps and encountering a newly invented German weapon-jet aircraft.

Under the direction of Col. Benjamin Davis, Jr., 450

of the Tuskegee Airman, as the Tuskegee-trained pilots came to be known, flew World War II missions over North Africa and Europe in P-39, P-40, P-47 and P-50 aircraft. These men served in either the 99th Fighter Squadron or the 332nd Fighter Group. The first black West Point graduate, Col. Davis was one of the five who graduated from of a class of originally 13 men in the first nine-month training at Tuskegee. Col. Davis later earned the distinction of being the U.S. Air Force's

first African American general.

Eventually, the 332nd Fighter Group consisted of four fighter squadrons—the 99th, 100th, 301st, and 302nd. The 99th Fighter Squadron received two Presidential Unit Citations for their tactical air support and air combat in Italy in 1943 and 1944, and the 332nd Fighter Group earned a Presidential Unit Citation for their mission escorting bombers to Berlin in March of 1945. These brave airmen also distinguished themselves by achieving the singular distinction of never losing an escorted bomber to



enemy plane fire.

Juanita Posey, Commander of Armistice Memorial Post 2195, declares, "As a young, black woman from

the South in the late 80's, my future opportunities were presented to me in minimal options. As a Naval JROTC student, my exposure of heroism in the face of racism was amplified with my introduction to the Tuskegee Airmen. Their sacrifice to prove that they were capable in spite of their skin color gives a me the courage to do the same."

This is an exciting opportunity to hear an eyewitness to history's biggest war. Boy Scout Troop 328 will present

the colors to commence the program. After the program, Mr. Spann will be available for questions and photographs. A reception with refreshments will follow.

Calvin and his wife Gwenelle, reside in Allen and give talks to schools and libraries on the role of Tuskegee Airmen.

To break the NFL lockout, the fans need to get mobilized

(NNPA) After constant attention on negotiations in the National Football League and the subsequent lockout [where the employers refuse to let the employees work] by the owners, there has been something close to silence. Recent court rulings have permitted the owners to go forward with their lockout, at least for now. And, the rest of us just sit back and watch the calendar slowly approach the beginning of the next season.

The gist of the dispute, as I have discussed in earlier commentaries, has been the greed of the owners. There is really no other way to put it. They are seeking conces-

sions from the player, including an extension of the football season, in a situation where the owners cannot demonstrate any economic need for such givebacks. The only logical conclusion as to why the owners have pushed this dispute to the point of a lockout is so that they can destroy the union of the players—the NFL Players Association—and achieve total dominance over the players and the sport.

The Players Association, under its relatively new Executive Director DeMaurice Smith, has been doing a great job of fighting the good fight. In fact, sports writers and fans have expressed significant support

for the Players and have, correctly, identified the greed on the part of the owners as the major source of this conflict. Yet the owners see no particular reason to back down. Conservative court decisions in their favor, along with a national political climate that promotes the destruction of labor unions, encourages their arrogance.

What the owners seem to be counting upon is passivity on the part of the fans. The owners actually do not care whether the fans support them or not. What they are concerned with, however, is what the fans do. It is for this reason that the fans of football need to become motivated and active if we want justice to be won by the

players. Here are a few ideas:

1. There needs to be a highly visible organization of the fans, something like "We stand with the Players" or something like that. This needs to be more than a couple of people setting up a website. There need to be thousands of active members who sign up to participate.

2. This organization of fans needs to ensure that governmental bodies, particularly municipalities, that have been considering or negotiating any deals that concern new stadiums, put such talks on hold. Not only do most sports stadiums NOT bring economic advance-

well, that's what the Congressional Budget Office, that's not Michele Bachmann, that's Congressional Budget Office figures saying that we're – we have the potential of losing 800,000 jobs.

FACTS: As Factcheck.org noted, "The CBO didn't say that. Instead the CBO said that the law would cause a reduction in the amount of labor workers choose to supply. Some Americans would decide to work fewer hours or retire earlier because their ability to get health insurance would be more secure. And low-income workers would receive subsidies to purchase insurance, putting more money into their pockets. Overall, the CBO said the impact on jobs would be 'small.'"

BACHMANN [Jan. 25 Tea Party Response to the State of the Union address]: Unfortunately, the president's strategy for recovery was to spend a trillion dollars on a failed stimulus program, fueled by borrowed money... Not only did that plan fail to deliver, but within three months the national jobless rate spiked to 9.4 percent. And sadly, it hasn't been lower for 20 straight months. While the government grew, we lost more than 2 million jobs. Let me show you a chart. Here are unemployment rates over the past 10 years. In October 2001, our national un-

employment rate was 5.3 percent. In 2008...it was just 6.6 percent. But, just eight months after President Obama promised lower unemployment, that rate spike to a staggering 10.1 percent.

FACTS: The watchdog group Media Matters, on its politicalcorrection.org site, stated: "From December 2007 to July 2009 – the last year of the Bush second term and the first six months of the Obama presidency, before his policies could affect the economy – private sector employment crashed from 115,574,000 jobs to 107,778,000 jobs. Employment continued to fall, however, for the next six months, reaching a low of 107,107,000 in December of 2009. So, out of 8,467,000 private sector jobs lost in this dismal cycle, 7,796,000 of those jobs or 92 percent were lost on the Republican watch or under their policies. Some 671,000 additional jobs were lost as the stimulus and other moves by the administration kicked in, but 630,000 jobs came back in the following six months. The tally, to date: Mr. Obama can be held accountable for the net loss of 41,000 jobs (671,000-630,000), while the Republicans should be held responsible for the net losses of 7,796,000 jobs."

BACHMANN [Tea Party State of the Union response]: But instead of cutting, we saw

an unprecedented explosion of government spending and debt, unlike anything we have seen in the history of our country. Deficits were unacceptably high under President Bush, but they exploded under President Obama's direction, growing the national debt by an astounding \$3.1 trillion dollars.

FACTS: The rising debt can be attributed to Bush-era policies and the recession that began before Obama took office. As the conservative Washington Times observed, "The Congressional Budget Office announced a projected fiscal 2009 deficit of \$1.2 trillion even if Congress doesn't enact any new programs... About the only person who was silent on the deficit projection was Mr. Bush, who took office facing a surplus but who saw spending balloon and the country notch the highest deficits on record."

BACHMANN [Tea Party response]: We need to start making things again in this country. And we can do that by reducing the tax and regulatory burden on job creators. America will have the highest corporate tax rate in the world. Think about that.

FACTS: Researchers at the Center on Budget and Policy Priorities have thought about it and what they realize is that to grasp the corporate tax burden, one needs to look beyond statutory tax rates to

the effective tax rate, which takes into account tax deductions. Judging by that standard, the Center notes, "The U.S. corporate tax burden is smaller than average for developed countries. Corporations in 19 of the member states of the Organization for Economic Cooperation and Development paid 16.1 percent of their profits in taxes between 2000 and 2005, on average, while corporations in the United States paid 13.4 percent."

Appearing on Fox News after officially declaring her candidacy for president, Bachmann said on June 27: "What I want them to know is, just like John Wayne is from Waterloo, Iowa, that's the kind of spirit that I have too."

John Wayne wasn't from Waterloo. He was born in Winterset, Iowa and grew up in California. Bachmann apparently got John Wayne mixed up with another John Wayne – John Wayne Gacy, the serial killer who was from Waterloo.

Ladies, it's not just you! globally – we're all stressed!

(NNPA) So ladies, I'm sure if you're like me and any of the women I know personally, you have been running hither and yon to keep all of your hats – home, work, parents, children, finances, and relationships – in the air all at once. And sometimes, you find yourself wondering, "Is it just me? Am I the only one feeling like I'm an exotic juggling act in the three ring circus of life trying to keep all these things balanced?" Well, shout hallelujah and signal the ringmaster to shine the spotlight on you in the center ring because the answer is a resounding No! You are not alone! Nielsen's latest comprehensive report Women of Tomorrow: a Study of Women around the World confirms women around the globe are feeling pressure like never before and are stressed!

Nielsen is known for its measurement capabilities and for analyzing consumer behavior and trends in media, online, mobile and more around the globe. We recently con-

ducted this study among nearly 6500 women in 21 countries throughout Africa, Asia Pacific, Europe, Latin America, and North America, representing 60% of the world's population and 78% of the Gross Domestic Product (GDP). We included women in both developed markets – like ours – and several emerging markets like India and Nigeria. Some of the key findings:

- 90% of women believe their role is evolving for the better from gender equality to workplace opportunities.

- Women control 12 trillion dollars in global spending of 18 trillion dollars, but want to share jointly in life responsibilities and decision making

- While women are indeed increasingly empowered, we are increasingly stressed.

Whoop! There it is! Call your girlfriends and tell them "Girl, it's official! Women everywhere around the world report being pressured for time, rarely have the time to unwind; feel stressed and overworked most of the time. And yes, want just a

tad bit of help from the fellas' time to time. It is NOT just us!"

How we cope with stress varies between developed and emerging markets. Our sisters in emerging countries are often faced with maintaining every day basics like food and clothing. The percentage of their household spend on food is staggering. In Nigeria, for example, 40% of household spending

is on food, vs. 7% in the US. So if women in emerging countries found themselves with any additional dollars it would go toward savings, clothes and education. While women in developed countries like ours are more likely to use extra cash for luxuries like vacations, savings and paying off debt.

In conducting this research, women were divided into three segments – daughters (average age 30), mothers (average age 47) and grandmothers (average age 67). The high

stress factor is universal, but it breaks down generationally. The "daughter" generation is the most stressed. This stands to reason as this woman's family is young and she has not likely achieved her full earning potential. Among "mothers" the stress is mid-level. Makes sense because by the average age of 47, income levels are (usually) higher; but finances are still cause for concern. Lastly, "grandmothers" are the least stressed segment. Perhaps not surprisingly, grandmothers are also

most likely to believe that they have successfully achieved that delicate work-life balance.

Fellas, I think the most notable take away from this study for you is that women would like to share more male/female responsibilities. We may be doing it all but would love to have a little more help from you. Umm hmm, did you hear that? Ladies, they may have missed that point, so if you want to cut this column out and post it up on the 'fridge for those times when you need a little back up, feel free. Guys

don't like arguing with you, let alone taking on women from 21 countries and arguing in multiple languages! (You should highlight the multiple languages part).

Consider this ladies: if based on our global spending power of \$12 trillion we were our own country (and lord knows there are times we wish we were don't we?) we'd be about the size of the United

States (based on GDP). That's a lot of power. So, there's no doubt that you and I and our sisters across the globe are agents of change. Can you imagine how much more powerful we'd be if we got a little more support on the home front? So, when's the last time you actually asked for the help you need? I'm just sayin'.



Apprenticeships Touted As Viable Career Route

Largely overlooked by policymakers, educators, and the public, apprenticeships offer a promising route for preparing large numbers of students for high-skilled jobs and professions, according to an article in the Summer 2011 Issues in Science and Technology.

Diane Auer Jones, a for-

mer assistant secretary of the U.S. Department of Education, argues that college is not a good fit for many students but that students often enroll because they lack other career preparation alternatives. She calls for an expansion of the options available so that each student can find the right path to success based on his

or her personal and professional goals, life circumstances, learning style, and academic preparedness.

Jones writes that in countries such as Germany and Switzerland, apprenticeships are a critical part of the secondary education system, and the majority of students complete an apprenticeship even if they

later plan to pursue postsecondary education. It is not uncommon for German or Swiss postsecondary institutions to require students to complete an apprenticeship prior to enrolling in a tertiary education program. In this way, apprenticeships are used to train engineers, nurses, teachers, finance workers and myriad other

professionals.

In the United States, however, apprenticeships generally have been considered to be labor programs for training students to work in the skilled trades or crafts. They are not viewed as education programs, so they have not become a conventional part of most secondary or postsecondary

systems or programs.

"Apprenticeships should be developed for occupations traditionally associated with a liberal arts education," she writes. "It is shortsighted to assume that only economically disadvantaged or low-achieving students can benefit from apprenticeship training."

states' rights could in the same breath repaint the Nazi regime (because after all, didn't Hitler bring Germany out of a recession?). Both symbols are inextricably linked to horrible human atrocities, and should not be dignified by the state of Texas through a prominent feature on a state-issued li-

cense plate.

Whether individuals have a right to display the flag is an entirely separate issue from whether the government should do so on state-issued property. It is important that Texas not go the way of other states like Virginia and Florida that have lost battles trying to keep this hate-filled

insignia off of their license plates.

Why Obama still says no to gay marriages

President Barack Obama thundered to the throngs at the recent LGBT Leadership Council fundraising bash in New York. "I believe that gay couples deserve the same legal rights as every couple in the country," he said. This was not hyperbole that he had to shout to one of the country's most prominent, and influential gay rights groups to get gay activists off his back about his opposition to gay marriage.

Despite the withering heat he has taken for that opposition, Obama has been the best friend that gays have ever had in the White House.

He backed gay rights in speeches and legislation more than a dozen times as an Illinois state legislator and U.S. Senator. The record number of gay appointments, and the speed with which he's made them, were just the extension of his personal and political conviction that discrimina-

ples the same as heterosexual ones, and at the same time expanded rights for gay couples who work in the federal government. He vigorously opposed Proposition 8, the California initiative that would have effectively banned gay marriage. He reversed his position on the 1996 Defense of Marriage Act and calls it abhorrent.

But he won't take the final step and flatly say 'I support gay marriage and will back every effort in

full-throated, all-out backing.

Obama may in time back gay marriage -- he's said his position is "evolving" -- but it's not going to happen just yet.

This would require Obama to reverse not his political thinking, but his fundamental and personal beliefs. He made that perfectly clear in a blog talk last October when he flatly said he wouldn't sign on to same sex marriage because of his "understandings" of

just an antiquated, bigoted, and rapidly discredited understanding that Obama refers to, and that he's still stuck on.

Obama is no different than many other fiercely liberal, tolerant and broad-minded African-American when it comes to diversity issues. But he, like many others, still can draw the line on gay marriage and that's fueled by deeply ingrained notions of family, church, and community, and the need to defend the terribly frayed and fragmented black family structure. This mix of fear, be-

defensive end Reggie White, an ordained fundamentalist minister stirred a firestorm when he took a huge swipe at gay rights and gay marriage in a speech to the Wisconsin state legislature. White became the first celebrity black evangelical to say publicly what many black religious leaders said and believed privately about gay issues. Few blacks joined in the loud chorus that condemned his remarks.

A year before White's outburst, a Pew Poll measured black attitudes toward

Pew also found that for the first time in the decade and half that it had been polling Americans on attitudes toward gay rights, and that includes gay marriage, less than half of Americans opposed same sex marriage.

It's wrong-headed and wildly inaccurate to think that President Obama opposes same sex marriage out of narrow religious belief, conservative family upbringing, or a racial herd mentality that is unyielding on the traditional defense of family values. But it's just as wrongheaded to say that none of these things have

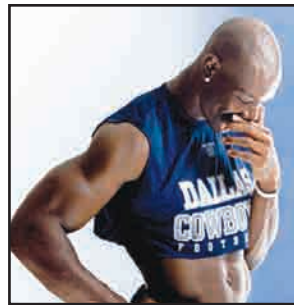

Resistance to financial reform reunites pro-consumer interests

Federal agency challenged on cutting states out of enforcement actions

Nearly a year ago, President Obama signed the Dodd-Frank Wall Street Reform and Consumer Protection Act. At the time, consumers and their advocates rejoiced in the success of the most comprehensive financial reform enacted since that of the 1930s New Deal. Now as the newly-created Consumer Finance Protection Bureau (CFPB) prepares its formal launch on July 21, anti-consumer forces have emerged again. Those who lost the battle on pro-consumer legislation are shifting gears to thwart reform through regulation and a series of legislative amendments. Sadly, a federal office is supporting those efforts.

The Office of the Comptroller of the Currency (OCC) is now proposing federal preemption that would allow national banks to side-step state regulation and resume their old practices — many of which contributed to the recession that continues to affect both businesses and citizens alike. OCC is also the federal agency charged with regulating national banks and functions as an independent bureau within the U.S. Treasury Department.

According to OCC's fiscal year 2010 annual report, the national banks represent \$8.5 trillion in assets -- 71 percent of the value of all U.S. commercial banks. It is also relevant to note that OCC's operations are funded

by assessments paid by these banks. National banks pay OCC for their respective examinations and corporate application fees.

Fortunately, many of the same advocates that fought for and won Dodd-Frank's enactment are actively opposing this OCC action. Voices opposing OCC include federal state and federal officials and reinvigorated groups representing the pro-consumer alliances of last year.

For example, on June 27, the Center for Responsible Lending (CRL) was joined by Consumers Union, the National Consumer Law Center, Public Citizen and the Sargent Shriver National Center on Poverty law in filing joint

comments in opposition to OCC's proposed regulations.

Together, the groups said in part, "The creation of the CFPB was designed to remedy some of the consumer protection failures of federal regulators; but the CFPB cannot do the work alone. . . . States also bolster the resources of the CFPB and the federal banking agencies. The states have a critical role to play and that is why Congress reaffirmed and reinvigorated the states' role as part of financial reform."

Continuing the groups observed, "States are our nation's first responders when new threats target consumers. States see abuses sooner, react more quickly, and can address local problems before

they become national ones.... The OCC's regulations are completely inconsistent with the Dodd-Frank requirements."

In a recent report by the New York Times, Paul Bland, a senior staff lawyer with Public Justice said, "In these proposals, the OCC is very close to trying to pretend that the Dodd-Frank Act never passed."

Comments filed by George Madison, the federal Treasury General Counsel, succinctly said to OCC, "In our view, this position is contrary to Dodd-Frank."

Other offices that have publicly expressed opposition to the OCC action include the National Association of Attorneys General and New

York State's Financial Services Department.

Any effort to preserve the ill-advised financial status quo is short-sighted at best. To avoid another financial crisis, we need more financial regulatory cops on the beat. To maximize real reform, consumers need regulators working in concert at both the state and federal levels. If allowed, Dodd-Frank will operate as originally intended — to correct the neglectful oversight and abusive financial practices that together have created the current financial crisis.

It would be foolish to expect old practices to bring new or different results. Perhaps OCC has yet to learn that lesson.

New IMF Leadership Ignores World Realities

Editor's note: This column was written prior to the release of Dominique Strauss-Kahn from jail following the discover of problems with the accuser's credibility.

Part of me is delighted that France's Finance Minister Christine Lagarde will replace the accused rapist Dominique Strauss-Kahn as managing director of the International Monetary Fund (IMF). She will be the first woman to hold this position, and her background makes her a good pick for this important position. That she is a Frenchwoman replacing another French national suggests no loss of power or influence for France after the national soul-searching on gender attitudes that the DSK imbroglio sparked. While gender is not likely to shape the ways that Lagarde approaches IMF business, interest in her gender and her background may motivate more women to consider international finance as a career path.

While the woman that I am is cheering at the selection of Christine Lagarde, the woman of color in me wonders when the United States and Europe will loosen their lock on key global finance position. Customarily, someone from the United States leads the World Bank, and someone from Europe the International

Monetary Fund. Last year, at the G20 Summit in Seoul, representatives from China, Brazil, and other countries balked that their economies are not only influential, but also growing. When they argued that they, too, should be considered for leadership positions, there was concurrence. The selection of Christine Lagarde suggests that concurrence was only lip service.

When one considers the growing role that China plays in the world economy, including its recent bet on the euro, it is beyond myopic that China should have such a minimal role in international finance. One might argue, too, that leadership of the IMF or the World Bank should not simply be reflective of the size of a national economy, or a regional one. What about the African continent or Latin America? How would perspective change, if financiers from these countries had the opportunity to provide global financial leadership?

To be sure, neither gender nor nationality will shape an approach to the faltering economy in Greece, nor to the world economic slowdown. Except the whole world really isn't slowing down. While Western economies are relatively stagnant, economies in developing countries are showing much more robust

growth. Leaders from these countries may have different perspective on bailouts and other ways to induce world financial stability.

The world GDP is roughly \$78 trillion; the U.S. GDP is \$14 trillion, or about 17 percent of that. The GDP of the European Union is a bit higher, at \$16 trillion. The U.S. and the EU have about 38 percent of world GDP. While the Chinese economy is growing rapidly, its GDP was just \$5.8 trillion in 2009. Though China and India's have more people than the United States, they have much smaller GDPs, with India's hovering at just \$1.5 trillion. Still, if the U.S. and the EU argue that size is the only thing that matters, then we had better enjoy our hegemony while we can. Certainly at the pace it is growing, and with the currency reserves it has on hand, China is poised to top the United States within the next two to three decades.

(By the way I am aware that the larger economies pay a larger share of the operating funds of the IMF and the World Bank, and one might argue that she who pays the band calls the tune. She might find herself at a rather unruly party, if no one gets the beat).

Instead of the "might matters" argument, we might look at other things that matter in terms of international finan-

cial leadership. What about growth rate? Educational development? Energy efficiency? These are all metrics that could be considered when

leadership is being selected. Of course, the United States might not fare well when different metrics are used, which is why we've held fast to the

notion that size is the most important things.

District Attorney to Appoint Law Firm to Collect Outstanding Bond Forfeitures

Dallas County District Attorney (DA) Craig Watkins announced that he will appoint a local law firm to collect an estimated \$35 million in outstanding bond forfeitures owed to the county. The District Attorney's Office, which is understaffed and underfunded for a jurisdiction of its size, does not have the resources to designate assistant district attorneys to focus on the collection of bond forfeitures. Thus, the DA will select and hire a law firm (as allowed by the statute) to handle the outstanding funds from default judgments that had gone uncollected for years prior to Mr. Watkins taking office in 2007. The firm hired to spearhead this effort will retain 25 percent of the total amount collected and the remaining balance will go into the county's general fund.

"A recent report stating that there are no policies

and procedures in place at the DA's office is absolutely incorrect," said Dallas County District At-



torney Craig Watkins. "We have been looking into this issue for the past two years. In 2010, we hired a bond forfeiture subject matter expert to work full-time in our Civil Division to seek forfeiture judgments in current civil cases. However, it is going to take more than one individual to proactively go after default judgments that were never collected. Therefore, we will have to bring in someone from the outside to manage the collection of these funds as our

civil attorneys are already busy representing the county on a host of other civil matters. During my first term, we focused on cleaning up the failures of the past and improving policies and procedures to operate more efficiently. This is among many issues that still need to be corrected and hiring a law firm to dedicate their time and attention to resolving this issue is the first step."

The Dallas County District Attorney's (DA) Office is located at the Frank Crowley Courts Building in Dallas, Texas, and is led by District Attorney Craig Watkins, who began his second term on January 1, 2011. The DA's Office represents the State of Texas in the prosecution of all Dallas County criminal cases. world financial table is bound to push the envelope of western hegemony in coming years. As the Chinese economy gets larger, and as China claims a larger role in the development of other countries,

including those on the African continent, it is likely that many will make the case that non-Western countries deserve more of a voice in world economic matters. Even as Christine Lagarde was being

selected to lead the IMF there were rumblings from Brazil, especially, that there ought to be alternatives. When these rumblings become a roar, and they will, then the United States had better watch out.

As we struggle to lift the debt ceiling, we might also ask who holds our debt. Are we beholden to some of the countries that we refuse to treat fairly? This isn't a question that will be resolved this

year or next, but as world demographics shift, it is a question that will have to be answered. We in the United States must examine the advantages we enjoy from our "might is right" posture, and

ask what we are prepared to give up in the interest of fairness.

know never to agree to a face-to-face meeting with a stranger they meet online and never to share their personal information with Internet acquaintances.

Informed and active parents can help protect their children from all types of online threats. By surfing the Internet with their children and fostering open conversations about the websites they visit, parents can both teach and learn from their children. Parents should give children and teenagers ground rules for their Internet usage — including the hours they can access the Web and the types of websites children can visit.

Texas parents should also establish boundaries for children's mobile phone

usage. Cyber Crimes Unit investigators with the Attorney General's Office have arrested several sexual predators who used wireless devices to call or text children. These communications often include sexually explicit language or images and are intended to lure children into a sexual encounter. Wireless devices that allow users to surf the Internet may also give children an opportunity to go online and access sexually explicit content, chat rooms and social networking sites.

Parents should monitor their children's mobile phone Web usage and teach them to avoid calling or texting people they do not actually know. Young Texans should also avoid giving out personal information via

their wireless device. Any child who receives a communication — including a photo or video — that is inappropriate, hurtful or otherwise makes them feel uncomfortable should immediately notify their parents. If parents suspect criminal activity or believe that their child is in danger, they should save the image or message and immediately contact law enforcement authorities.

Fortunately, many wireless carriers offer controls that allow parents to monitor and manage their child's cell phone usage. These controls allow parents to set limits on incoming and outgoing text messages and phone calls. For example, parents can restrict specific phone numbers, limit the

quantity of text messages and prohibit communications during certain hours. Depending on the provider, parents can also filter or completely block websites from being accessed by their child's wireless device. Increasingly, wireless devices are also equipped with global positioning system (GPS) features that give parents the ability to track their child's whereabouts.

Finally, Texas parents should be aware that video game systems now have many of the same capabilities as home computers. In particular, these gaming devices allow users to interact with other players through typed messages, voice communication or even online video chats. Parents should be cognizant of the fact that

child predators can use these game systems to prey upon and contact children.

Although children may enjoy playing video games with their friends online, parents should carefully consider whether to enable a gaming system's online chat feature. During online conversations, predators may look for clues that reveal a child's physical location. Parents who choose to allow online chatting should strongly caution their children not to discuss anything personal while playing online games with players they do not know.

Video game systems typically have parental control features that can be used to restrict game features that pose increased risks. These controls allow a parent to:

- Enable or disable a game console's chat features or manage with whom and how a user can communicate and play;
- Enable or disable Web browsing;
- Permit or block access to online games; and
- Restrict games based on maturity ratings.

Parental control features on a wireless phone or game system are designed to give parents peace of mind. While these tools are important, actual parental supervision offers the best level of control. To keep young Texans safe while they enjoy their summer break, parents should communicate openly with their kids and set clear limits on Internet, wireless device and gaming system usage.

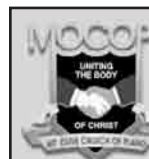

ments from industrial, jazz, gospel, go-go, reggae and rock music. Hard, thoughtful, introspective, literary-esque lyrics are a mainstay of the Cornel West Theory. The group's lyrical range and depth are placed on display in this record.

Tim Hicks rhymes on the song, "The Contradiction." "This is exercise, bench pressing, soul weapons, fortified live/Christ died and my mom's still praying/And this is what I'm saying/That this time it's no more contradictions, platinum changes or chrome benzes."

The Cornel West Theory (www.thecornelwest-theory.com) is a Washington, DC-based ensemble, proudly born from the hip-hop aesthetic, but not bound by limitations of any genre. It's an eclectic amalgam of spoken word, lyricism, instruments, electronics and vocals, which draw from genres ranging from home-grown go-go to jazz to rock to hip-hop. This

"musical theory" hits you aesthetically, emotionally and intellectually.
