## Plano Church Seeks Historic LEED Status

(NDG Wire) Plano's Christ United Methodist Church (CUMC) has been a leader in the community for 30 years, with unique cross-cultural missions projects reaching across town and around the world.

Now the church is at the forefront of another movement - CUMC is going green. Not just the recycle-

your-trash green, but a multi-million-dollar building effort that, by summer 2010, will result in the church seeking to own the first LEED-certified sanctuary in Texas.

CUMC and its partners at HH Architects and Rentenbach Constructors are building a 60,000-square-foot building at the corner of

Coit and Parker roads.

LEED, an acronym used by the U.S. Green Building Council, stands for Leadership in Energy and Environmental Design. It is a point-based system that rates a building's performance in five areas: sustainable site design, water efficiency, energy efficiency, materials selection and indoor environ-

mental quality.

By using high-efficiency irrigation and native plantings, the church expects to use 57 percent less exterior water. Efficient plumbing will cut internal water usage by 42 percent. Improved insulation, with efficient lighting, and heating and cooling



## Testing Obama's Fortitude

(NNPA) It is time for testing on several fronts as the health care debate becomes the platform for a general uprising over President Barack Obama's governing program.

His very life is being tested, as people like William Kostric, show up to a New Hampshire Town Hall meeting with a gun strapped to his leg.

In an interview with Kostric, he claimed his right under New Hampshire law to carry a weapon openly, but he

also had a sign with him carrying the words saying that "it is time to water the tree of liberty."

This was a Thomas Jefferson quote that inferred that liberty often required the shedding of blood, and it had been the same phrase carried by Timothy McVeigh when he blew up the federal court house in Oklahoma City several year ago.

The strange thing about this is that there are no news reports of the Se-

## Concerts To Help Single Moms Offset The Impact Of Recession

(NDG Wire) Households headed by single mothers are one of the hardest hit segments in the economic troubles. Unemployment during this recession has been especially steep for female heads of household, and the impact has been mind numbing for mothers trying to raise children with-

out a support system and adequate income.

Theresa Green, a Plano mother of two, said, "I have no idea what to do next. The bottom has fallen out of my life, and I am afraid of what might happen to my family."

Green's story is echoed by a flood of single mothers who are struggling to keep

food on the table and a roof over their heads. Last year, a group of women formed The Single Mothers Outreach Project (SMOP) to provide relief and support for women raising children alone.

The SMOP has announced a series of jazz concerts to raise awareness and money to help single moth-

ers during this challenging time. The Jazz Friday Series is a monthly event, where local visual artists, jazz musicians and a sommelier come together to create a night filled with entertainment and enrichment.

## Evelyn Palfrey

Evelyn Palfrey is a native Texan and a lawyer who writes romantic suspense for the 'marvelously mature' because romance is just as sweet with a little gray at the temple. She is the author of four novels: *Three Perfect Men*, *The Price of Passion*, *Dangerous Dilemmas* and *Everything In Its Place*. Her novels deal with issues com-

mon to the middle passage of life, and reflect her 25 years' practice of criminal and family law - and her love of RV travel.

Palfrey began writing fiction in 1995, driven by the realization that although many romance readers were like her-at middle age and starting a new phase of life-they weren't represented as romance heroines. *Three Perfect Men* was born as the first book in a trilogy about three women who had been college roommates in the 60s. *The Price of Passion*, a

novel about marriage and betrayal, followed the next year. Her sister's remark about the absence of full-figured women as romance heroines propelled her to write *Dangerous Dilemmas*. Her fourth novel, *Everything In Its Place*, grew out of recognition that many women who thought they had finished raising children, are now raising grandchildren.

Her next venture is a story in the anthology *Cougar Tales*, with Sandra Kitt and Laura Parker.

Palfrey's novels have been on the *Essence Magazine* bestseller list, the

*BookSense '76* list, and have been *Black Expressions* selections. *The Price of Passion* was awarded Best Multicultural Book by *Romantic Times Magazine*.

Palfrey's story *The Lady at the Bus Stop* was published in *Chicken Soup for the African-American Soul*, and her story *Mama's Hands* was published in *Chicken Soup for the African American Woman's Soul*. She has also been a contributor to *Black Issues Book Review*.

Palfrey was nominated for a Career Achievement Award by *Romantic Times*. She has served on the Board

of Directors of the Austin Public Library Foundation, Travis County Lawyer Referral Service, Austin Community Radio, Inc., Texas Municipal Courts Education Center and the State Bar of Texas. She is currently on the Board of the Writers League of Texas and is active with Austin Romance Writers of America.

## Thurbert Baker

(NDG Wire) The National Bar Association (NBA) presented Georgia Attorney General Thurbert Baker, with its first annual Barack Obama Political Leadership Award at its 84th annual meeting in San Diego, California on Friday. The award recognizes Baker's pioneering achievements as a public servant and elected official.

Baker, a Democrat from Stone Mountain, is Georgia's first African-American

Attorney General, having served in the office since 1997. During this time, he has been the only elected African-American Attorney General in the nation. He is also the only African American to be elected by his colleagues to serve as the president of the 102-year-old National Association of Attorneys General.

As Attorney General, Baker has successfully man-



aged the state's legal affairs for more than a decade. He has always made protecting families and children a top priority. He promoted tough new laws against sexual predators who target chil-

dren via the Internet, and has aggressively worked with local prosecutors and police to bring those who target children online to justice. Baker has also been a leading voice against domestic violence. He fought to make it a crime to commit an act of domestic violence in the presence of a child, and he's worked with local law enforcement to fight family violence.

Prior to his service as Attorney General, Baker served for five terms in the Georgia House of Represent-

tatives, including several years as the Floor Leader for then-Governor Zell Miller. As Floor Leader, Baker led the fight to pass some of the most significant legislation in modern Georgia history, including the institution of the state lottery and the lottery-funded HOPE Scholarship program.

He was the lead sponsor of the largest tax cut in Georgia's history - the removal of the state sales tax on groceries. He also led the fight to pass tough new laws against drunk driving, stre-

ngthening the state's notoriously weak, outdated drunk driving laws, and helped bring Georgia to the forefront in the battle against DUI.

Baker, now a Democratic candidate for Governor of Georgia, said, "I am humbled and honored to be the first person to receive the National Bar Association's Barack Obama Award. I hope to live up to the honor by continuing to bring people together to solve the tough problems facing Georgia."

## Dr. Winfred Parnell

Winfred Parnell, MD is not only committed to providing his patients the best health care as a local obstetrician and gynecologist, but he is also an advocate for healthcare reform. Speaking Monday as a member of the Community Panel on Proposed Healthcare Reform, Parnell dismissed the notion reform would lead to

socialized medicine with assurance. "We will put together a uniquely American program," he said. He also reminded the audience of the importance of getting the right information out to allow citizens to make a more informed decision regarding which proposal they support.

Parnell's concern is the debate derails the reform process and "we do nothing." He challenges those who do not want a public option - fine - bring a solution for the public to consider. Simply saying no is not a solution.

In recent days the idea proposed by Sen. Kent Conrad (R-ND) described as a "nonprofit health care cooperative as an alternative to a new government insurance plan," commonly referred

to as co-ops, has gained momentum in the debate. However, Parnell stated the only successful version of a medical co-op worked well because it operated like an insurance program. Many feel the same issues would persist under a co-op without addressing the underlying problems of affordable access for everyone.

The Community Panel included representatives from Baylor and Parkland hospitals, the business community and Aetna insurance. They all agreed there was a need for health care reform. Parnell said, "Doctors want it, patients want it - who is between it?" He feels critical political rhetoric be removed from the debate.

Key elements for successful reform will include providing doctors and hospitals incentives to work together, said Parnell. Stating

that what we have now is "sick care," Parnell advocates providing pay-for-performance incentives. Many have argued that by making the public aware of the quality of services provided in the medical community, an informed medical consumer will receive better care.

Parnell is one of the founding physicians of Carlos Parnell, Jones & Diaz in Dallas. He is an active member of the medical staff at Medical City Hospital, serving in leadership positions on numerous hospital committees, and was Chief of Staff during the 1995-1996 term.

Receiving his Bachelor of Science from Florida A&M University, Doctor of Medicine from the University of Florida, he completed his internship and residency at Parkland Memorial Hospital and UT

Southwestern Medical Center. Parnell is a member of North Dallas Community Bible Fellowship. He and

his wife, Debra, are the proud parents of twins (Winfred and Wendy). He enjoys traveling and skiing.

# Twenty Companies Have Pulled Advertising from Fox's Glenn Beck

(NDG Wire) Eight more of Glenn Beck's advertisers, including Wal-Mart have confirmed to ColorOfChange.org their ads were pulled from the controversial Fox News Channel broadcaster's eponymous show. Allergan (maker of Restasis), Ally Bank (a unit of GMAC Financial Services), Best Buy, Broadview Security, CVS, Re-Bath, Travelocity and Wal-Mart join the dozen other companies who previously distanced themselves from Beck.

Twenty companies have pulled their ads from Beck's show in just the last two weeks. The moves come after the Fox News host called President Barack Obama a "racist" who "has a deep-seated hatred for white people" during an appearance on *Fox & Friends*. Previous companies who pulled their ads include ConAgra, GEICO, Lawyers.com, Men's Warehouse, Procter & Gamble, Progressive Insurance, RadioShack, Roche, SC Johnson, Sanofi-Aventis, Sargento

and State Farm Insurance.

"We are heartened to see so many corporate citizens step up in support of our campaign against Glenn Beck," said James Rucker, executive director of ColorOfChange.org. "Their action sends a clear message to Glenn Beck: broadcasters shouldn't abuse the privilege they enjoy by spewing dangerous and racially charged hate language over the air. No matter their political affiliation, hate language doesn't belong in our national dialogue."

David Tovar, a spokesperson for Wal-Mart, in an email to ColorOfChange.org said "Walmart [sic] today confirmed the retailer pulled ads from the Glenn Beck show on August 3rd."

"While advertising on Fox is part of our communication plan, we had not requested time on Glenn Beck's show specifically," said Carolyn Castel, vice president of Corporate Communications for CVS Caremark, in an email to ColorOfChange.org. "We have instructed our ad-

vertising agency to inform Fox to ensure Glenn Beck's program is not part of our advertising plan."

Our position is simple," Castel continued. "We support vigorous debate, especially around policy issues that affect millions of Americans, but we expect it to be informed, inclusive and respectful, in keeping with our company's core values and commitment to diversity."

In an email to ColorOfChange.org, Lisa Svach-Hawks, director of public relations for Best Buy, stated that any advertisements for Best Buy placed on Glenn Beck's show were done so in error. Svach-Hawks pledged that Best Buy will correct any mistakes made.

"We did not specifically place our ad on the show," said Amanda Borichevsky, a spokesperson for Travelocity in an email to ColorOfChange.org. "We buy ads in bulk and then they are placed somewhat randomly. However, we have now specifically asked that our

ads do not appear during this show."

"We reviewed our commercial schedule, and based on your feedback, we've put any programming featuring Glenn Beck on our "do not air" list," said Aziz Mottiwala, senior marketing manager for Allergan, in an email to ColorOfChange.org. "This means that you will no longer see any Restasis ads during programming featuring Glenn Beck. Thanks again for bringing this to our attention."

"Ally advertises on a broad spectrum of programs to reach our potential customers," said a customer care representative for Ally Bank. "Our advertising is not an endorsement of editorial content on any program. We have ceased to advertise on the Glenn Beck program."

In a phone conversation with Dwayne Sigler, Senior Vice President of Marketing for Broadview Security Systems, Sigler told Color

cret Service securing this individual quickly, given that the President of the United States was there. Federal law, which should taken precedent in that case, prohibits any citizens from threatening the President of the United States, and Kostic most certainly would have seemed threatening having a loaded weapon on his person.

Rather than the media denouncing such practices and the vitriol that has accompanied these town hall meetings, they appear to want more drama, following the president out to town hall meetings in the Mid-West in anticipation he will be confronted personally.

He has done well in those settings, but you could not tell it from the subsequent reportage.

Rather than praising him for his clarity in explaining difficult concepts of health care that are on the table, he is being chastised for not having said this or that, done this or that, and taking little leadership. Where have these people been? What guides their conclusions?

But it is more difficult to handle a debate where fear-mongering is the most potent resource and where the confusion around the lack of a settled piece of legislation feeds into the fear and indecision.

The insurance industry is a master at this. They have fielded television ads that appear to support reform, but are larded with subtle questions that propose to support a "bi-partisan" solution, meaning a solution that is favored by Re-

publicans as well as Democrats.

That is increasingly unlikely as one can see by the leadership in the Senate of Grassley of Iowa, the minority leader on the Senate Finance Committee who is working with the Chair, Max Baucus.

Baucus is already compromised because he received more money from the health care industry than any other senator except for Grassley, but his deference to Grassley makes it all the worse.

So, the issue is whether Obama will have the guts to stand up to them or negotiate reform away, seeking to get anything to set him up for re-election in 2012.

Already, the wheels of the "government option" seem to be coming off. This measure had been sold as a

mechanism to provide competition to the 1,300 health insurance companies to bring down costs.

Now his secretary of health is saying that if the same thing can be achieved without this option, it might be done.

Obama needs to not be intimidated, but to understand the raucous town hall meetings as nothing more than the massive rant of those who lost the election, that things will clarify when there is a bill and the American people will most probably swing behind it and him.



# Health Care Reform Debate Takes Center Stage in Dallas

Monday's healthcare reform town hall meeting in Dallas was moved to accommodate overwhelming public demand for free tickets, the crowd inside was much tamer than it was outside.

In a low-key panel discussion, U.S. Representatives Eddie Bernice Johnson (D-TX) and Pete Sessions (R-TX) presented opposing ideas on healthcare reform and fielded audience questions. Each reiterated their parties' positions on the subject and, at times, gave their emotionally charged opinions.

In her opening remarks Johnson described the need for healthcare reform as a "moral obligation to ensure universal access." She said Texas has the highest rate of uninsured people in the United States, with some at risk of bankruptcy due to healthcare costs.

Johnson said she has read each of the three bills currently under consideration in the U.S. House of Representatives, and she favors the public option, which she described as an opportunity for the uninsured to go into a pool and

purchase affordable coverage.

Sessions said the public option is a form of "socialized medicine," to which Johnson immediately responded "better than nothing," to the applause of many in the audience.

Johnson, who is a registered nurse, previously worked in psychiatric services at the Veterans Administration Hospital in Dallas. She is the 30th Congressional District of Texas representative. This includes Downtown Dallas, Fair Park, Oak Lawn, East

is lacking for many because they do not seek medical attention until they are very sick and show up in the emergency room, said Johnson. She stated this results in several tests - at a cost to the public - because emergency room professionals have no prior medical history for the patient.

Johnson said she wants health care reform to address quality care and stability for patients despite their income level. Johnson would like to eliminate pre-existing clauses and ensure coverage when there are

corporations receive.

Sessions advocates patient controlled coverage, which he said would give insurance portability, allowing them to keep the same insurance provider year to year. He also called for national tort reform to eliminate the \$150 billion per year spent in lawsuits.

Sessions believes the current proposals are too ambitious, as they tackle 220 million who have good insurance, rather than simply addressing the 46 million who lack coverage. He said everyone will be heavily taxed, and about 120 million people will be shifted to the public option by their employer, not by choice.

Sessions stated care will suffer because patients will not be able to choose their doctor as they will be placed in a pool. And he said they will have difficulty seeing a physician because there are not enough doctors in place to handle the influx of patients to universal coverage.

Sessions said the Republicans support associated plans offering people the opportunity to band together and buy as a group across state lines, and he cited realtors as an example. Sessions agrees with Johnson that insurance companies must move toward eliminating the pre-existing condition clause.

Sessions and Johnson disagreed on the cost effectiveness of the public option. Sessions said it would "tax the stuffings out of business."

When he asked who would pay for it, Johnson said Parkland hospital provided \$520 million of uncompensated care last year. She said people visit Park-

Dallas, Pleasant Grove, South Oak Cliff, and other areas. Johnson said there are over 220,000 uninsured within her district.

For the uninsured, preventative and primary care

changes in employment. She said people should not be forced to stay in undesirable jobs just to maintain insurance coverage.

Sessions agreed there is a healthcare problem, but said he is concerned that the current proposals will provide a huge cost shift to the federal government. Instead of a public option, he proposed actions such as doubling the funding for the National Institute of Health, whose research in recent years has paved the way for significant decreases in deaths due to cancer, heart attacks and high cholesterol.

Citing what he considered Republican healthcare success, Sessions said Medicare prescription reform has led to \$4 prescription co-pays. He also said the health savings account, which allows participants to deposit pre-tax monies is a Republican success. And he repeatedly referred to expanding the program by allowing individuals to enjoy the same tax benefits all

land because other hospitals will require \$500 before you get any care. Johnson said this cost is coming out of taxpayers' pockets.

Sessions changed the tone of the discussion when he dismissed the co-op proposal because he said there is no need to create a new entity. He even suggested many problems are a result of a lack of personal responsibility, citing knifings and drug usage as examples.

"When someone is paying for something in America, they treat it differently,"

Sessions said.

A stunned Johnson replied, "I don't even know how to respond to that," which was greeted with applause.

She added, "With insurance coverage for everyone at a reasonable cost, we would not have a problem." Johnson pointed out insurance companies charge about the same as each other, eliminating competition in the marketplace.

Johnson closed by saying, "Anything that is for the people is hard to come by."

Nearly a million single

moms are out of work, and their families are suffering, according to a report entitled *Women in the Recession: Working Mothers Face High Rate of Unemployment*. Congresswoman Carolyn B. Maloney, Chair of the Joint Economic Committee, said. "The fact that they (single mothers) are receiving pink slips in greater numbers than in prior recessions has serious implications for family economic well-being. Working mothers are having a tough time sheltering their families for the current economic storm, with women of color fairsing the worst."

Ward she has noticed the

same thing in recent months "It is scary," she said. Ward is asking those not interested in attending the concert series to make a donation.

"Just today I got a call about a young woman who is 9 months pregnant with three small children ages, 1, 2 and 3 years old. Her husband left and is no longer supporting the family. She can't find work and needs money to keep her utilities on, to buy shoes for her children and gas for the car. I am tired of saying there is no money to help. We all have a responsibility to help each other during these tough times."

# Get Educated About Investing

systems will help cut energy costs up to 14 to 18 percent. And with 35 percent of the new building's electricity coming from renewable West Texas wind power, the church will reduce carbon dioxide emissions associated with its electrical needs.

"We are doing this because we believe it will benefit others," says Rev. Alexandra Robinson, associ-

ate pastor at CUMC. "Building green is not just about this current generation, or even our grandchildren. It is also about providing a better life for our neighbors, particularly those who are not able to provide a better life for themselves."

A green building is a healthy building, said Blake Atkins, the church's LEED awareness project leader and

a regional chief with the Environmental Protection Agency.

Paint and carpeting made of low-odor compounds will improve indoor air quality. By diverting 75 percent of construction waste from local landfills, the project will reduce resources and energy necessary for producing new paper, metal, plastic, glass, concrete and lumber

that will be recycled. Use of alternative refrigerants and refrigerant management of the new cooling system will minimize ozone layer depletion, thereby minimizing UV radiation from penetrating the atmosphere. And by using a light-reflecting roofing material and maintaining vegetation around the sanctuary, CUMC will help minimize the heat-island effect.

OfChange.org that Broadview's advertising is bought based on network, not particular programs, but that "given the considerations, we have requested of Fox News not to include us in the rotation that would have our commercials running on Glenn Beck's show."

"We are continuously impressed with the response we are getting and the amount of companies who have stepped forward to pull their ads from Glenn Beck," said James Rucker, executive director of ColorOfChange.org.

"We have the backing of a number of major companies in this country and we're still going to continue our fight to see that as many of Beck's advertisers pull their

support as possible."

Three weeks ago, ColorOfChange.org called on its 600,000-plus members to sign a petition urging companies who advertise on Glenn Beck to cut off their advertising support of his work. Since then, more than 145,000 members have responded to the call by signing a petition directed at advertisers.

With more than 600,000 members, ColorOfChange.org is the largest African-American online political organization in the country.

providing information and referrals in a timely and cost-effective manner for both the caller and community service organization.

The Alliance database system is managed and maintained through Community Council of Greater Dallas (CCGD).

CCGD has committed two full-time employees to research, update and maintain the database. The resource database system, Alliance allows the call specialist to effectively provide referrals that deliver the appropriate solution for the callers' problems and/or needs.

"CCGD works with nine other community agencies within one or more of 2-1-1 Texas AIC coverage

areas to ensure they have the most up-to-date information available," said Thornton.

What this means for a caller is timesaving. A Texas resident can call from anywhere in the state to get

the service they need without being transferred to another 2-1-1 Texas call center. Each call center can ac-

cess a state-wide database, eliminating time and hassle.

2-1-1 Texas follows AIRS Inclusion Standards when considering adding to the 130 existing social service agencies that are a part of their database of refer-

als. An organization such as a church, nursing home or educational facility would have to meet the quality indicator requirements (i.e. diversity, financial practices, etc) and professional standards to register with 2-1-1 Texas AIC, which follows the state and AIRS national standards.

According to a 2004 University of Texas cost-benefit study of eleven call centers nationwide, the net value of a national 2-1-1 system would approach \$160 million in the first year and \$1.1 billion over 10 years. Savings would come in such areas as re-

duced 911 calling, reduced toll-free lines funded by government, decreased need for public assistance because of timely links to needed services and time saved by callers searching for the right agency to call.

A service of both cost and time best sums up the

benefits of the 2-1-1 info-line service.






