Pledge: "A Trick Bag For America"

Lyfe Jennings

(NDG Wire) On September 22, 2010, just a few weeks after releasing what he has called his "final" stu-



dio album, I Still Believe, platinum-R&B-soulcrooner Lyfe Jennings was sentenced by Cobb County Superior Court Judge, Lark Ingram, in Marietta, Georgia to serve 3½ years in jail for his role in a 2008 domestic dispute.

In court, Lyfe spoke to the judge, accepting full responsibility for his actions and apologized for what he had done. After serving a 10 year prison sentence for arson from 1992-2002, Lyfe has not had any trouble with the law except on this one occasion. Lyfe is eligible for parole and according to his attorney, Don Samuel, will most likely serve about one-third of his 31/2 year sentence. Mr. Samuel also stated that "Although it had been reported otherwise, there were no allegations of physical abuse or violence whatsoever against my client in this case". He also added, "Lyfe wants his family, friends and fans to know that he is a changed man, but all it takes is one misyour freedom."

He is currently in the Cobb County jail, where he will remain for approximately 30 days. Then will be moved to what is known as the Diagnostic Center where he will serve about two months, and then he will be designated to a minimum security prison for the remainder of his sentence

After being handed down his sentence, Lyfe sent this message via Twitter:

"This will be my last take and one bad day to lose post. To everyone who gave me a chance I am forever in your debt. I have had a fabulous career because of you. All I can say in parting is that I have been honest with [y'all]. I didn't sugarcoat a word didn't hold back a single [syllable] of my life from [y'all]. I've lived a hundred lives in these 6 [years] so I not only won't, [I] don't have the right to complain. I would like to think that I've changed lives by changing my own, [though] I can't be sure. But one thing I am sure of is God gives and takes away in measure. He is fair, just

and forever. Amen from [a man]... Smile, its [contagious]:)"

As a result of this news, all remaining shows left on Lyfe's current National tour have all been canceled. On his latest LP, Lyfe touches on the incident that has now sent him to jail in the song If Tomorrow Never Comes. Lyfe addresses his mother, his aunt, his ex-girlfriend and his kids singing, "If tomorrow never comes/ And you never see me again/ I don't want your last memories of me/ To be filled with negativity."

John Dabiri

John Dabiri is a biophysicist whose work draws on a wide range of fields-including theoretical fluid dynamics, evolutionary biology, and biomechanics-to unravel the secrets of one of the earliest means of animal locomotion.

On Tuesday September 28 he was named by the John D. and Catherine T. MacArthur Foundation a winner of the 2010 Mac-Arthur Fellowship, more commonly known as the

MacArthur Genius Award. Dabiri studies some of the simplest multicellular organisms, jellyfish, which propel themselves by contracting cells in their bellshaped outer skin and generating jet forces in the tail end, with tentacles trailing behind. From a theoretical engineering perspective, he has shown that elucidating the mechanisms of locomotion depends on detailed mathematical analysis of the fluid vortex rings that jellyfish form in the surrounding water by contracting their bell; his results significantly increase our knowledge of the impact of size and speed on the formation of optimal vortex rings. Because the relative impact of viscosity on propulsion decreases with greater size, fluid dynamics theory implies that rowing becomes a more efficient means of locomotion as animals grow larger.

Dabiri and colleagues confirmed this experimentally by examining propulsion during maturation and in adult specimens of varying size across hundreds of

species, and they also found that a hybrid jet-paddling motion brings the advantage of drawing nearby prey into the bell, where the tentacles can capture them. Dabiri has invented a method that allows divers to use tiny reflective particles to visualize, with high speed and fine spatial resolution, the fluid dynamics of propulsion by jellyfish in their native habitats; this technique provides a wealth of new data that can be used to test and refine models of vortex behavior.

Annette Gordon-Reed

(NDG Wire) The John D. and Catherine T. MacArthur Foundation announced Tuesday that Annette Gordon-Reed, an award-winning historian, is one of 23 recipients of the 2010 MacArthur Fellowship, more commonly known as the MacArthur "Genius Award." Gordon-Reed-the recipient of the National Humanities Medal, the Pulitzer Prize and the National Book Award-was recognized for dramatically changing the course of Jeffersonian scholarship.

Gordon-Reed joined the Harvard faculty in July 2010 as a professor of law at Harvard Law School, a professor of history in the Faculty of Arts and Sciences, and the Carol K. Pforzheimer Professor at the Radcliffe Institute for Advanced Study.

and humbled to be given this award," said Gordon-Reed. "Of course I've known about MacArthur fellowships for many years and wondered what it would be like to have someone call out of the blue and tell you you've won something like that. Now I know, and I have to say it's a very good feeling.'

Said Harvard Law School Dean Martha Minow: "Professor Gordon-Reed's remarkable work will be read for generations because of its originality, scrupulousness, rigor, and imagination. We are thrilled that she has joined the Harvard faculty, where she has already brought the Law School, history department, and Radcliffe Institute into happy collaboration."

According to the Mac-Arthur Foundation, the Mac-Arthur fellows program is in-



tended "to encourage people of outstanding talent to pursue their own creative, intellectual, and professional inclinations." The foundation awards fellowships directly to individuals rather than through institutions. Gordon-Reed will receive a five-year grant worth \$500,000.


Those who yearn for a return to George W. Bush's philosophy will cheer the Pledge's promises of tax cuts for the rich and lax regulation of Wall Street. They will applaud the Republican call to repeal universal health insurance and to hand the Social Security Trust Fund over to Wall Street.

But for African-Americans, this retrograde Pledge is a recipe for disaster.

Our communities were hit hard by the Great Recession, and the economic crisis continues. African-American unemployment now stands at 16.3%. Working families are struggling to pay the rent and keep food on the table. And the situation is critical for our youngest generation: am-African-Americans ong ages 16 to 19, the unemployment rate is 26.2% -and that doesn't include those with low-paying parttime jobs or those who have given up looking. For these youth, the American Dream is turning into a nightmare.

President Obama and this Democratic Congress led by Speaker Nancy Pelosi and Majority Whip James Clyburn (the highestranking African American in Congress) inherited this dire recession from Bush and the Republicans, and they've directed help toward those who need it most -despite stiff opposition from Republicans in Congress. If the "Party of No" had gotten its way, the Great Re-

worse than the Great Depression - an economic hurricane instead of a bad storm. They opposed the Recovery Act. They opposed healthcare reform. They opposed ending tax breaks for companies that ship jobs overseas. They even opposed 7 of the 8 tax cuts Congress has passed to help small business owners.

We don't need to imagine what would have happened if Republicans ran Congress. We know their record – and now we can read their Pledge: to restore the immoral policies of Presidents Reagan, Bush and Bush II: tax cuts for millionaires and billionaires and benefit cuts for everyone else and of course, nothing special for Blacks. It is unconscionable that

at a time of our nation's highest unemployment in more than 60 years, the Republicans propose a \$4 trillion tax cut for the rich. They're trotting out the same tired argument they've recycled for 30 years: cut taxes for billionaires, and some of their wealth will trickle down to the rest of us. Meanwhile, the Republicans promise to repeal President Obama's Recovery Act, which cut taxes for 110 million families who don't happen to be rich.

We already know the harmful impact of trickledown economics – nothing ever trickles down for Blacks, minorities and the poor. Under Presidents Reagan and Bush, the economic divide widened to historic proportions due to huge tax cuts for millionaires while workers' wages stagnated. President Clinton made a dent in pervasive inequality by raising taxes on the wealthiest Americans and investing in education, healthcare, jobs and tax breaks for working families.

Bush pulled a 180 degree turnaround, cutting taxes for the richest of the rich, letting Wall Street run wild, and slashing federal aid to working families. ConAgra Foods' Healthy Choice brand reduces sodium in top-selling soups

Consumers cite sodium as most important health-related factor when selecting soup

(NDG Wire) ConAgra Foods has announced a 15 percent sodium reduction, from 460 milligrams to 390 milligrams per one-cup serving, for its top two varieties of Healthy Choice(R) soup -Chicken Noodle and Chicken with Rice. Additionally, Healthy Choice is introducing three varieties of All Natural soups with 390 milligrams of sodium per one-cup serving, including Cheese Tortellini, Red Beans & Rice, and a reformulated Tomato Basil.

"The entire line of Heal-

thy Choice soup has always met the government guideline for 'healthy' sodium levels, which is a maximum of 480 milligrams per serving, and the five new soups contain about 20 percent less than this amount," said Jane Anders, vice president, Research, Quality & Innovation, ConAgra Foods.

In a recent independent study from market research firm Mintel, nearly 70 percent of consumers rated sodium as the most important health-related factor when selecting soup and 42



percent indicated that all natural ingredients are important. The market for natural and organic food and beverages remains strong with the category growing 11 percent in 2008 to \$34

"Healthy Choice is all about making great food with healthy ingredients. Now, we're making our soup line even more healthful by reducing sodium in two varieties and introducing three new All Natural soups that are also lower in sodium," said Laura Flanagan, president, Consumer Foods, ConAgra Foods. "This reflects ConAgra Foods' ongoing commitment to sodium reduction and builds upon the tremendous success of the Healthy Choice All Natural Entrées line introduced last year."

The suggested retail price for a 15-ounce can of Healthy Choice soup is \$2.19 and a 14-ounce microwaveable bowl is \$2.49. Both contain two servings.

In October 2009, ConAgra Foods pledged to reduce sodium across its portfolio of food products by 20 percent by 2015. In total, as many as 20 brands and 160 product varieties will be impacted by the sodium reduction initiative. The company will ultimately eliminate approximately 10 million pounds of salt each year from the American diet.

Texas receives more than \$3.3 million from the Affordable Care Act to help people navigate health and long-term care options

Across US, \$68 million in grants to support community living for seniors and individuals with disabilities

(NDG Wire) HHS Secretary Kathleen Sebelius announced Monday \$68 million in grants to help seniors, individuals with disabilities, and caregivers better understand and navigate their health and long-term care options. A total of more than \$3.3 million in grants has been awarded in Texas.

"We know how difficult it can be for individuals and caregivers to deal with a sudden illness or chronic disease while at the same time trying to navigate through a complex health care system to figure out where to go to get appropriate help. The Affordable Care Act seeks to give people more control over their own care, while lowering health care costs and improving quality," said Secretary Sebelius.

These grants, made possible by the Affordable Care Act, are going to states, territories, tribal and communitybased organizations. The funds will be used to help seniors and individuals with disabilities and their caregivers make more informed decisions about their health and long-term care. Specifically, the funds will be used to help families: understand their Medicare and Medicaid benefits, including coverage for preventive services; navigate options for long term care including communitybased services that can help individuals remain in their homes; and assist those transitioning from nursing or re-

habilitation facilities back home to put the supports in place to make that transition successful.

These grants are being administered collaboratively by HHS' Administration on Aging (AoA) and the Centers for Medicare & Medicaid Services (CMS). AoA and CMS have provided grants to states for several years to develop person-centered, integrated systems of information and counseling to help services and support programs in the community such as those provided by AoA, CMS and other HHS agencies.

Funds were available for states, area agencies on aging, State Health Insurance Assistance Programs; Aging and Disability Resource Centers (ADRCs) and tribal organizations through a competitive as well as formula process. Grantees will focus on four areas to support seniors, individuals with disabilities and family caregivers: • Medicare Outreach

and Assistance in Low Income Programs and Prevention Grants: 50 states and territories and 125 tribal organizations have been funded to provide outreach and assistance to Medicare beneficiaries on their benefits, including coverage for preventive services. Additionally, \$5 million goes to the National Center for Benefits Outreach and Enrollment for technical assistance. (http://www.centerforbenefits.org/)

• ADRC Options Counseling Grants: 20 states funded to strengthen Aging and Disability Resource Centers (ADRCs) Options Counseling and Assistance Programs for community-based health and long-term care services. Options counseling programs help people understand, evaluate, and manage the full range of services and supports available in their community.

• ADRC Nursing Home Transition through Money Follows the Person Grants: 24 states funded to strengthen the ADRCs role in the CMS Money Follows the Person program and support state Medicaid agencies as they transition individuals from nursing homes to community-based care.



TXU Energy to Install Electric Vehicle Charging Stations

(NDG Wire) TXU Energy is jump-starting electric vehicle programs in the cities of Dallas and Fort Worth with its gift of key electric vehicle charging infrastructure.

The TXU Energy Accelerator program will invest in at least a dozen charging stations spread across the two cities at various locations.

The locations and type of charging station equipment will be selected by each city. TXU Energy will fund the cost of the charging station equipment and installation.

Filling up' an electric ve-

hicle should be cheaper than gasoline - comparable to paying about 75 cents per gallon of gasoline.

To emphasize this point, TXU Energy has also offered to reimburse the cities for the cost of the electricity at the charging stations for city vehicles for three years, and for the public's vehicles for the first year.

"This is an important step in developing the kind of infrastructure needed to provide cleaner transportation options for North Texans," said Dallas Mayor Tom Leppert. "Almost three-fourths of air pollution can be attributed to mobile sources, and electric vehicles have an important role to play in helping us reduce it."

"The auto manufacturers are providing consumers with a cleaner and affordable transportation solution, but electric vehicles are no use without the charging stations to support them" said Fort Worth Mayor Mike Moncrief.

"It's vital that companies, like TXU Energy, step forward to provide the tools necessary to help realize the full potential of zero-emission vehicles. A cleaner environment means a more prosperous future; and the nation that leads on energy will be the nation that leads the world in the 21st Century. I believe America can be that leader, and I believe that can start with us right here in North Texas."

"We want to play a leading role in jump-starting adoption of electric vehicles," said Jim Burke, chief executive officer, TXU Energy.

"We're seeing great interest from customers, including several cities throughout North Texas, who want to incorporate electric vehicles and other energy saving solutions into their daily operations. 





Bishop Eddie Long: "I Am Not Perfect"

(NNPA) More young Black men are expected to step forward this week to follow in the footsteps of four former members of the New Birth Missionary Baptist Church who claim to have been "coerced" into sexual relationships with Bishop Eddie L. Long, the megachurch's well-known 55 year-old pastor. Vowing to "vigorously fight the charges" against him, Long stood in the pulpit as nearly 10,000 members of the church applauded, promising to support him.

In September 21, 2010 court filings, in DeKalb County State Court, two of the plaintiffs alleged sexual harassment against Bishop Long, New Birth, Inc., and the church's male youth ministry - Longfellows Youth Academy, Inc. Maurice Robinson and Anthony Flagg, both students in the youth academy at the time of the alleged incident, stated in civil litigation documents that Bishop Long exerted his influence as pastor and spiritual advisor over the 14 yearolds, to engage in sexual relationships for (Long's) own personal sexual gratification. It was also alleged that Bishop Long furnished the plaintiffs with cars, cash, jewelry and other gifts, allegedly purchased with church funds. In addition, the plaintiffs were allegedly put on the church's payroll. The other gifts were described as -- airplane trips within the U.S. and abroad, luxury hotel stays, and access to numerous celebrities, including entertainment stars and politicians.

In separate 23-page filings by Robinson and Flagg, the Longfellows Youth Academy, Inc "purported to train young men, from 13 to 18, to love, live and lead as they proceed on their masculine journey." Bishop Long was the Academy's "pastor / counselor / confidant" to the teens in the program. The plaintiffs allege the academy is Bishop Long's method to influence and exploit vulnerable teenage males who, in the case of Flagg, have no father, or father-figure.

Court documents state that after the then-teenagers were pronounced as Long's "spiritual sons" within the program and church congregation, "defendant Long has a pattern and practice of singling out a select group of young male church members, and (uses) his authority as Bishop over them to ultimately bring them to a point of engaging in a sexual relationship."

Shortly after Robinson and Flagg, now both 21, joint lawsuit became public, a third plaintiff, 23 year-old Colorado resident Jamal Parris filed a sexual harassment lawsuit, alleging similar charges. However, in his lawsuit, Parris is claiming that while he was occupying nouncing the accusations. "I am going to fight this thing. I am not a perfect man, but I am not the man being portrayed" as a "sexual predator." Although Long did not definitively deny the allegations to his congregation, he spoke to all people having to "face painful situations". "This is the worse time of my life," the pastor proclaimed at the morning service, dressed in beige-tan garments with New Birth insignia.

Following the service, Long addressed local and national news media at a press conference in New Birth's chapel. Bishop Long cancelled all media interviews prior to the church press conference and taking no questions from reporters, he said the civil lawsuits "would not be fought in the media, but within a court of law." After

Bishop Long's guest house in DeKalb County, the pastor would regularly request Parris be nude for pastoral visits. All three men are being represented by Brenda Joy (B.J.) Bernstein a lawyer in Atlanta, Georgia.

At press time, a fourth male, Spencer LeGrande filed a sexual harassment lawsuit against Long, alleging similar charges occurred when he was a member of New Birth-Charlotte, a satellite church based in North Carolina. The then-17 year old LeGrande, in the lawsuit, claims to have engaged in sex with Long in 2005, after being given a sleeping pill and continued the relationship until 2009, according to Associated Press reports. Attorney Bernstein was unavailable for comment.

Bishop Long is denying the allegations. The first Sunday after the allegations came to light, Long stood before his congregation, dethe brief press conference, Bishop Long left with his wife, Vanessa, and his attorneys; Craig Gillen and Dwight Thomas, of Atlanta. In statements to the radio media, attorney Gillen, said, "It is unfortunate these young men have chosen to take this course of action." Gillen "Bishop added. Long adamantly denies these allegations. We're reviewing the complaints... and will respond in the proper venue." Gillen announced Bishop Long, the father of four, wanted to "be clear. The charges against me and New Birth are false. I have been through storms, and my faith has always sustained me. I have devoted my life to helping others and these false allegations hurt me deeply."

The plaintiffs' attorney who is remembered for successfully defending Genarlow Wilson in a sexual sodomy case brought by Douglas County and the state of Georgia told The Atlanta Inquirer, "the courage of these young men to stand up is testimony to (obliterate) Bishop Long's great influence, as well as they trying to get to the truth of the betrayal ...for a productive life." She also warned, "There are kids right now at risk (at New Birth)." Bernstein refused a request by a reporter to speak with the plaintiffs last week, indicating, "They've relocated for the moment... To (initiate litigation) was very emotional for them," stating that e-mails, text messages, and pictures provided to the young men "will speak for the cases against the Bishop." Bernstein stated she had no comment after Bishop Long's sermon.

Bishop Long, a native North Carolinian, arrived in Atlanta in the mid-1980s, prepared to brandish his small-town reputation for the big city and suburbs of Atlanta. From 1987, after being appointed New Birth's pastor, membership grew from hundreds to nearly 30,000. Primarily teaching God's promise of prosperity, Long's popularity has made him a sought-after counselor among the rich and powerful, including former Georgia governors, U.S. presidents, and local county leaders.

Particularly during the out-of-town trips, the plaintiffs allege Long shared a bedroom to "engage in sexual touching, and other sex acts" with Robinson. "Defendant Long would use Holy Scripture to discuss and justify the intimate relationship between himself and friend," thereby, "causing Robinson great anger and anguish." With both plaintiffs Flagg and Robinson, character could become a key issue, if the lawsuit goes to court. In 2007, Flagg was arrested for simple assault, and later, his mother agreed for him to live in New Birth's "Golod House," a residence for troubled teens, as suggested by Long.

The living arrangement was "to provide stability and an opportunity to learn and



grow with an important spiritual mentor." Flagg also alleges Bishop Long was "situated to exercise a controlling influence over the will, conduct, and interest" of Flagg, and shared the same bed "to engage in sexual massages, where increased sexual contact included oral sodomy, kissing, masturbation, and oral sexual contact."

As a result of Robinson and an accomplice, being arrested last June for breaking into Long's personal office on the New Birth campus the plaintiffs are seeking multiple damages. Specifically, the plaintiffs are seeking punitive and compensatory damages for; "breach of fiduciary," various counts of fraud and negligence, "intentional infliction of emotional distress," "negligent failure to protect," "negligent failure to warn" and "negligent failure to intervene supervise" against youth academy officials, all under the auspices of New Birth, Inc., and its registered agents.

While attorneys debate Bishop Long's intent to allegedly "coerce" the thenteens into sex, New Birth members, past and present, are "shocked" and "in disbelief" of the salacious accusations. "It's nothing but a setup," said a former member. "Big money, power, and success attract devilish acts." Nevertheless, the irony of a popular Pentecostal/Baptiststyle preacher leading an anti-gay ministry... has rocked New Birth, along with the local and national black clergy.

Sources indicated to The Atlanta Inquirer that several church administrators recently resigned from New Birth, stating "their pay and benefits were good, but they didn't want to go out like that."

The Rev. Bernice King, youngest offspring of Dr. Martin Luther King, Jr. and a New Birth elder, helped lead the anti-gay march. According to the church's website, counseling services for members "struggling with homosexuality" are offered by Long, "a man of vision, revered locally, nationally and internationally as a dynamic man of leadership, integrity and compassion." Repeated requests for comment from Rev. King went unanswered.

Also, local ministers gathered at a local restaurant to organize a "lock-in" -- an initiative where pastors will sit and pray with Bishop Long for seven days to respond to the church and "to show and provide open arms," as rendered in scripture, according to coordinator Rev. Jasper W. Williams, Sr., senior pastor of Salem Bible Church of Atlanta and Lithonia. "We are all sinners...



Sunday, Oct. 3 is Deadline to Qualify for 2010 Tax Deduction for Vehicle Business Use

(NDG Wire) Taxpayers who use their personal vehicles for business purposes in 2010, may claim 50-cents per business-mile tax deduction, but only if they keep proper records, according to-Home Business Tax Savings, Inc. (HBTS), specialists in home-business tax law.

"If a home-based business owner drives 8,000 miles in 2010 for business purposes, that's a \$4,000 tax deduction," says HTBS president Dr. Ronald R. Mueller. "If that taxpayer is in the 25 percent tax bracket, the deduction will add \$1,000 to their Tax Refund." To document the deduc-



tion, the Tax Code says the taxpayer must maintain proper records for "a typical 90 consecutive day period." [IRS Regulation 1.274-5T(c)(3)(ii)]

After Sunday, Oct. 3, there no longer will be 90 days remaining in 2010. Therefore, any taxpayer who has not begun a vehicle-use log by Oct. 3, will not qualify to use the IRS "90 day rule," which can cost them \$4,000 or more in lost tax deductions.

What constitutes 'proper records' for tax purposes? "Each time the driver starts the ignition - even if the trip will be for a non-business purpose - he or she must record four pieces of data -date, destination, primary purpose, and number of miles traveled," Dr. Mueller says.

"Then what? First, you add up all business-miles for your 90 day period, and the IRS will accept that number as an accurate sampling of your business-use for the entire year. Since 90 days is 25

percent of a full year, the taxpayer may then multiply that number times four, and the IRS will let you to deduct that number of business miles for 2010," according to Dr. Mueller.

The above example applies only to taxpayers who operated an active homebased business for the entire year of 2010. If the business was established during the year, the numbers would be prorated.

whether the application was for a home purchase or a refinance loan.

An analysis by the Center for Responsible Lending (CRL) termed the new HMDA report as one indicator of a "national tragedy" for its "far-reaching and highly disturbing mortgage trends".

Beyond the higher rate of mortgage loan denials, African-American and Latino borrowers who do get mortgages are also likely to pay more for them once approved. They also face a higher share of foreclosures.

According to CRL, "A superficial look at the mortgage situation today might make it tempting to conclude that low and moderate-income borrowers and borrowers of color simply had too much access to credit before the housing bubble burst. However, research indicates that the problem went deeper, extending to systemic risks that originated in the mortgage market itself."

"If there had been high access to sustainable mortgages, the subprime market would have behaved quite differently", continued CRL. "In fact, empirical research shows that high foreclosures have largely been driven by defective mortgage products and pushmarketing families into bad loans."

The HMDA report covers mortgage lending transactions at 8,124 financial institutions across the country and includes information from banks, savings associations, credit unions and mortgage companies. The specific data available through the report covers applications, originations, purchases of loans, denials, and other actions such as incomplete or withdrawn applications. Most importantly, the report includes information on applicant race, ethnicity, sex, household income and census tract composition.

HMDA, which was enacted by Congress in 1975, requires most mortgage lenders located in metropolitan areas to collect data about their housing-related lending activity, report the data annually to the government, and make the data publicly available. In 1989, Congress expanded HMDA data to include information about denied home loan applications and the race, sex, and income of applicants and borrowers. In 2002, the Federal Reserve Board amended the HMDA regulations to require lenders to report price data for certain higher-priced home mortgage loans, and other new

s data.

For 2009, about 15 million applications resulted in nearly nine million loan originations and 4.3 million loan purchases. Additionally, 210,000 requests for pre-approvals did not result in a loan.

The report also revealed a growing reliance on loans backed by government insurance such as the Federal Housing Administration (FHA) and/or Veterans Administration (VA). For home purchases, FHA's share of first-lien loans grew from only seven percent in 2007 to 26 percent in 2008 and 37 percent in 2009. Although VA lending represented a smaller market percentage, increases were also evident, growing from 2.7 percent in 2007, to 4.9 percent in 2008 and 6.7 percent in 2009.

With more than 2.5 million foreclosures in recent years and several million more projected in the continuing crisis, CRL is focused on what can be done to avoid another subprime fiasco. For example, CRL has testified before Congress on the effects of credit scoring and its relation to loan decisions, and in turn, HMDA results. Currently, lenders do not report credit scoring data.

While the implementation of the new Dodd-Frank Wall Street Reform Act is an important first step towards systematic change. The new Consumer Finance Protection Agency, also authorized by Dodd-Frank is expected to become operational and of service to the public by next year.

Even so, CRL believes much more remains to be accomplished:

• GSE reforms that tie government guarantees

on mortgage securities to responsible and sustainable loans;

• Vigilance in ensuring that FHA continues to focus on its key mission of supporting homeownership opportunities for under-served communities

• Safeguards to ensure that all banks – but especially those that receive access to low-lending rates through the Federal Reserve - have a commitment to fair lending practices.

he said.

In an effort to increase interest in the vote, and to allow for maximum dialogue and discussion of the proposed amendments as well as what they could mean to the city, the local government has scheduled two Town Hall Meetings; one on the evening of Thursday, Oct. 14, before the early voting period begins, and the other on Sunday. Oct. 24. closer to the general election. Both meetings will be held in the city's municipal chambers, 206 North Murphy Road.

Presentations on the proposed revisions will be made by the city manager and staff, and while the staff cannot advocate for or against any proposed amendment, they can answer questions and clarify issues as needed. Changes to the language on the ballots, adding to or deleting from the number of proposed amendments, or pressing for reconsideration of the Council's decisions relating to any of the proposed amendments cannot be made. The meetings are designed for informational purposes only.

Over the last nine months, a Charter Review Commission, made up of cit-

izens appointed by the City Council, has been at work reviewing the charter, testing the relevance of its contents and making recommendations, where appropriate, for improvements, changes, updates and clarifications. The Council acknowledged the commission's report and has accepted most of the commission's recommendations while making further adjustments to some sections, and is now sending the proposed amendments to the voters for final adoption.

"Our home rule system of municipal government calls for the citizens of the city to decide through the election process any and all changes to the charter, and so the Council has called for the election to ratify or reject 37 distinct changes to the charter," added Fisher.

The 37 amendments on the Nov. 2 ballot must be considered separately, but a look at the changes reveals that some of the amendments are relatively minor and address specific changes that make the charter line up with state and federal statutes.

Other sections deal with administrative matters and procedures that have become

necessary as the city has grown both in population and in organizational responsibility.

"As we mature as a city, we must ensure that our government keeps pace with that maturation process. Murphy is entering a new era of growth and development that the original charter commission may not have foreseen even as recently as seven vears ago. Keeping pace with the advancements in managerial, executive, organizational, fiduciary and administrative changes is a necessary aspect of municipal government, and the Council is determined to do so," he concluded.

Early voting on the proposed charter amendments begins on Monday, Oct. 18 and ends on Friday, Oct. 29. During early voting, registered Collin County voters can vote at the City of Murphy Municipal Building and at any Collin County early voting location. The deadline for registering to vote in the Nov. 2 election is 5 p.m., Oct. 4, 2010.

and we are all the body of Christ, including Bishop Eddie Long," said Williams.

Declaring he has "no opinion, either way" of Long's innocence or guilt, Rev. Williams, said he has known Long "since he's been in Atlanta." He expressed "mixed emotions" upon viewing the cell phone pictures, allegedly transmitted by Long to Robinson and Flagg, in one photo Long was dressed in a red skintight muscle shirt, and in another, Long was posing in a black form-fitting gym suit. As Williams calls on the nation's pastors to come to Atlanta "to pray with and for Bishop Long", saying a rush to judgment is premature, and to remember Long's admirable community service in Atlanta. "He's done tremendous works here. This negativity has had a tremendous affect on him and on New Birth, but the church will sustain itself."

"I feel like David against Goliath, but I have 5 rocks, and I haven't thrown one yet," Long concluded. Although Concerned Black Clergy of Metro Atlanta president Rev. William Cobble chose "to reserve comments until later", former president Rev. Dr. Gerald Durley said he felt, "It was mostly shock and disappointment" when he learned of the allegations against his friend of 20 years. Nevertheless, "we should be extremely prayerful for him, his family, and New Birth. This is a precarious time." Durley also commended Long's "tremendous amount of work" within Atlanta and beyond. "We must look at the good he's done, too," as well

as comment on the allegations

Regional Council of Churches co-chair Durley added that "whether they (allegations) are true or false, they will have an impact. As clergy (members), we need to continue lifting up the flock, as well as move forward toward healing and redemption. Overall, the black churches will not be negatively impacted. We'll come out of this stronger."

Although Bishop Long is not speaking to media about the allegations, his children are defending their father on the social network Twitter. "We are doing great; keep my pops lifted up in prayer!" exclaimed Edward Long. Daughter Taylor Long declared, "Man, my dad does NOT deserve this!"

In 1907, during a major league baseball game, second base was stolen 13 times by the winning team. The catcher for the losing team, Branch Rickey, was unable to pick off even a single runner. That record stands to this day. It also spelled the end of Rickey's career as a baseball player after just two short seasons. With nothing else to do, he went to college and law school.

Six years later, he returned to major league baseball. This time as a manager - and what a manager he turned out to be! He created the modern baseball farm system which enables major league teams to nurture and develop future stars through their minor league teams. He was the first to establish a permanent spring training facility in Florida. He changed the way statistical analysis is used in baseball by proving that on-base percentage is more important than batting average. Branch Rickey is best known, however, for breaking the color barrier by bringing African-American Jackie Robinson into the major leagues. It earned him a spot in the Baseball Hall of Fame.

Rickey offers this as his recipe for success, "Success is where preparation meets opportunity." A simple formula that reminds me of the old joke: "How do you get to Carnegie Hall?" The answer: "Practice. Practice. Practice." Obviously, you can't take advantage of an opportunity if you don't have the skills. It's a good recipe for success, but it doesn't reveal the secret main ingredient.

A funny old song from Frank Sinatra gets us little closer to the answer. Do you remember these lyrics from *High Hopes* ?

Just what makes that little old ant. Think he'll move that rubber tree plant. Anyone knows an ant, can't.

covering the sanctuary, and all the vessels of the sanctuary, as the camp is to set forward; after that, the sons of Kohath shall come to bear it: but they shall not touch any holy thing, lest they die. These things are the burden of the sons of Kohath in the tabernacle of the congregation." Numbers 4:15 (KJV).

When the sons of Kohath were transporting the ark, Uzza innocently reached to steady the ark but was immediately stricken dead when his hands touched the ark of God. Did David know this law or did he simply forget? Did Uzza know this law? If so, did he really believe it? David thought it was okay to carry the ark the way Uzza did. A man lost his life for his presumption and Christians will lose their spiritual life and perhaps their nature life if they fail to know and follow the Word of God.



models which help older persons or persons with disabilities remain in their own homes after a hospital, rehabilitation or skilled nursing facility stay. These grants will help break the cycle of readmission to the hospital that occurs when an individual is discharged into the community without the social services and supports they need.

"When it comes to long-term health care, each patient has a unique mix of medical and social needs that must be considered," said Dr. Donald Berwick, CMS Administrator. "Our health care system can offer many options to meeting those needs from traditional nursing home care to home and community-based services. Helping patients and their families understand these options will help them

make informed decisions about long-term care that are in the patient's best interests. These grants will help families make informed decisions and make sure patients have more control over their own care."

demic."

What's up with that? "Too much blame is being placed on the kids," says Anytime Fitness club Manager Kevin Edward. "Adults need to step up and be better role models if we want our kids to be healthy. That's what this is all about."

The campaign will feature an organization called COAK – the Coalition of Angry Kids.

The kids are "angry" because adults aren't doing enough to help children lead healthy lifestyles. (For a preview of the COAK TV commercials, visit www.coak.org.)

The timing of the campaign is no accident. September was the first "National Childhood Obesity Awareness Month." Edwards predicts politicians and the media will suggest that kids need to put away their video games and cell phones and get outside and play.

They'll also declare war on school lunches, fast food and vending machines.

"But nobody will be

offering any real solutions," Edwards says.

"Somebody needs the courage to stand up and say, "The primary reason we have so many overweight kids is because they have poor role models: overweight adults.""

Edwards points to recent research as evidence:

• "If one parent is obese, there is a 50 percent chance that the children will also be obese. However, when both parents are obese, the children have an 80 percent chance of being obese." - American Academy of Child & Adolescent Psychiatry.

• "The Factor that puts children at greatest risk of being overweight is having obese parents." -Stanford University of Medicine researchers.

• More than twothirds of states (38 out of 50) now have adult obesity rates above 25 percent. In 1991, no state had an obesity rate above 20 percent Edwards says Anytime


"It's our way of saying it's time to stop blaming the kids," Edwards says. "It's time to lead by ex-
