## Scott Sisters Suffering a sign of criminal justice failures

By Saeed Shabazz (NNPA) "After we are pardoned we want to go out across the country and speak out about abuse of Blacks in prison," Jamie Scott, 38, told a gathering of supporters who braved strong winds and a constant downpour to hear from her and her sister.

In January, the Scott Sisters from Mississippi were granted "indefinite suspen-

sion" of 1993 life sentences for an alleged \$11 robbery. The women served 16 years before a strong grassroots effort won attention of mainstream groups and their freedom.

"We are grateful for all of the letters that were sent in our behalf, and all of the support," said Gladys Scott, 36, adding, "I can say we are grateful to Black folks."

A diverse crowd gathered in a basement conference room in Restoration Plaza in Brooklyn to talk to and listen to the sisters via Skype. "Free the Land!" shouted Jamie Scott. "We dedicate our lives to all prisoners—we are their voice," she said.

The event was sponsored by the National Conference of Black Lawyers and the Malcolm X Grassroots Coal-


ition, and moderated by April R. Silver, founder and president of Akila Worksongs, Inc., a Brooklyn-based public relations firm.

A panel comprised of Rukia Lumumba, of the Center for Community Alternatives for Women, who also specializes in helping Black women with reentry issues;

## Following the death of her baby son, mother joins campaign against 'co-sleeping'

In Marisa Huerta Lehmann's videos and snapshots of her infant son, Tyler, the first things you notice are his heart-melting smile and penetrating "old soul" gaze. Those images still flood Marisa's mind each time she recalls her final moment with Tyler before his death on January

22, 2010.

That was the night the 3 month old suffocated while sleeping next to his mother — one of 177 such deaths last year in Texas. Lehmann hasn't fully overcome her grief, nor does she ever expect to. But she's chosen to share her story as part of the Texas Department of Fam-

ily and Protective Services' Room to Breathe campaign that informs parents and caregivers about ways to protect sleeping babies from accidental strangulation, suffocation and sudden infant death syndrome (SIDS).

"Before we went to sleep, he looked me right in

the eyes," Lehmann remembers. "In that moment I just knew that he knew who I was. It was the best moment I ever had with my son. And it was also the last moment I had with him."

Lehmann, a state employee in La Grange, admits that she knew she was going

## NFL player disses all black women

By Yasmeen Muqtasid "I didn't touch her. I don't even like black girls. I know what this is about, she is just upset I have a white girlfriend. I couldn't tell you the last time I dated a black girl. She was trying to get with me."

I had to do a double take when I read this in the Washington Post's recent article about sexual abuse charges against NFL player Albert Haynesworth. He is no stranger to controversy, and was recently indicted for assaulting a black waitress. In his defense he states that there's no way he could

have assaulted the woman because as he put it, "I don't even like black girls..."

Whether Haynesworth sexually assaulted the waitress or not is up to the courts to decide. However, what is crystal clear is that Haynesworth did indeed attack and assault the black waitress and every other black woman with his hateful spew of words when he said "I don't even like black girls," and used this as his defense against sexual abuse charges. Haynesworth's public outburst about his disdain for black women



The decision three years ago by UT Dallas researchers to bolster their efforts in the field of cloud computing is paying dividends: Not only do they



now have \$5 million in cloud-related research, but their graduate students find they have their choice of internships and job offers.

Indeed, two recent PhD graduates have been hired

by leading corporate players in the field, Amazon.com and IBM's T.J. Watson Research Center.

Cloud computing is a model for providing on-demand Internet-based access to a shared pool of computing resources, including networks, storage and applications. It's meant to make it as simple to obtain an array of electronic data resources as it is to get electricity itself.

One key to the UT Dallas group's success has been the breadth of its approach.

"We have established a reputation for conducting interdisciplinary research among computer scientists, management scientists, social scientists, behavioral economists and risk ana-

lysts," said Dr. Bhavani Thuraisingham, director of the University's Cyber Security Research Center and a Louis A. Beecherl Jr. Distinguished Professor in the Erik Jonsson School of Engineering and Computer Science. Her team includes associate professors Latifur Khan and Kamil Sarac and assistant professors Murat Kantarcioglu and Kevin Hamlen.

Another key has been the research group's focus on data security.

When incorporating security, you must carefully consider both the risks and costs involved as well as the tradeoffs between privacy and security," she added. "We started focusing on interdisciplinary research in cyber-security in 2007 by working with our colleagues at UT Dallas and

with researchers at Purdue University, the University of Illinois, the University of Minnesota, the University of Michigan, the University of Texas at San Antonio and the University of Maryland, Baltimore County."

Discussions are now also under way regarding additional collaborative work with researchers at the University of Southern California's Information Sciences Institute and with scientists at Telcordia Technologies Inc.'s Austin Research Center.

The growing demand for cloud computing stems from the need to securely store, manage, share and analyze immense amounts of complex data in many areas, including health care, national security and alternative energy. And although several companies have launched commercially

available cloud systems, two areas still need significant improvements, Thuraisingham said: the secu-

rity mechanisms needed to protect sensitive data as well as the capability to process huge amounts of

## Federal regulatory actions focus on foreclosure faults

In recent days, courts have issued encouraging rulings on cases involving discriminatory lending. In lawsuits filed by the cities of Baltimore and Memphis against Wells Fargo Bank, two federal judges declined Wells' bid to get those cases dismissed. As a result, each city will have its day in court to argue that Wells violated fair lending laws, resulting in a high number of unnecessary foreclosures in their respec-

tive locales. Both cities allege that disproportionate foreclosures and resulting economic losses were caused by steering black consumers into high-cost, unsustainable mortgage loans.

In a third action, two Michigan lenders, Citizens Republic Bancorp Inc and Citizens Bank of Flint, Michigan accepted a \$3.6 million settlement to end a lawsuit that alleged the banks engaged in discriminatory mortgage lending practices on the

basis of race and color. As part of the settlement, the banks will now open a loan office in a Detroit African-American neighborhood and invest approximately \$3.6 million in Wayne County.

In separate developments, federal banking regulators have issued consent orders to 14 of the nation's largest lenders, including Ally Bank, Bank of America, GMAC Mortgage, JPMorgan Chase, SunTrust and Wells Fargo. These orders are the result of

a rapid review of foreclosure practices that the agencies began in late 2010. The investigating regulators included the Office of Thrift Supervision, Office of the Comptroller of the Currency and the Federal Deposit Insurance Corporation.

The regulators' review determined that many institutions failed to commit resources sufficient to manage responsibly the rapidly grow-

and his use of it as a legal shield is unacceptable.

Black women just want an equal opportunity to find love - so all you Haynesworth - types, keep your smear campaign about black women to yourself. At a minimum, have some self respect for the sake of your own black mother, black sisters, and above all - your black daughters. After all, you are black and came from a black woman. Like it or not.

Haynesworth and Ocho Cinco must have forgotten about the collective buying power of women and that we make 85% of all purchase decisions.

In 2006, when Albert Haynesworth kicked fellow NFL player Andre Gurode in the face during a game, he publicly said "I apologize to Andre. What I did was disgusting. It's something that should never happen. I mean, I'm not a dirty player. I don't play dirty. I have respect for the game. What I feel like is I disgraced the game, disgraced my team and disgraced my last name." Haynesworth's comments about black women show just how much of a dirty player he still is. His tirade against black women was equally "disgusting and something that should have never happened." And yes, we deserve a public apology too.

## Dry mouth? Don't ignore it

Almost everyone's mouth is dry sometimes. But if you feel like you have cotton in your mouth constantly, it may be time for treatment.

Dry mouth, known medically as xerostomia, occurs when you don't have enough saliva, or spit, in your mouth.

Feeling stressed can trigger dry mouth temporarily. But a persistently dry mouth may signal an underlying disease or condition, so it's important to see your doctor, says the Food and Drug Administration (FDA), which regulates products that relieve dry mouth.

And because dry mouth can lead to tooth decay, you should see your dentist, too, says John V. Kelsey, D.D.S., of FDA's Division of Dermatology and Dental Products.

Dry mouth may make it difficult to speak, chew, and swallow, and may alter the taste of your food. It can also cause a sore throat, hoarseness, and bad breath.

Dry mouth can affect people of any age, but older people are especially vulnerable. "It's not a normal consequence of aging," says Kelsey. "Older people may take multiple medications that can cause dry mouth."

According to the Surgeon General's Report on Oral Health in America, dry mouth is a side effect of

more than 400 prescription and over-the-counter drugs, such as antidepressants, antihistamines, muscle relaxants, and high blood pressure medicines.

Other causes of dry mouth include:

- cancer treatments, such as chemotherapy and radiation of the head or neck

- hormone changes, such as those that occur during pregnancy or menopause

- health problems, such as HIV/AIDS, diabetes, and Sjögren's syndrome, a disease in which a person's immune system attacks the body's tissues, including moisture-producing glands

- snoring or breathing open-mouthed

### The Role of Saliva

Saliva is produced by three major glands in the mouth (salivary glands) and plays a key role in

- chewing, swallowing, and digesting food

- preventing infection in the mouth by controlling bacteria

- preventing tooth decay

"Saliva is mostly water, but it also contains enzymes and lubricants," says Kelsey. "The enzymes help digest food and the lubricants make speaking, chewing, and swallowing more comfortable."

Saliva helps control bacteria, which cling to the

surface of teeth. They feed on sugar in the food we eat and break down and use (metabolize) the sugar to grow.

"A by-product of the metabolized sugar is acid, which starts to eat away at a tooth's surface," says Kelsey. Saliva neutralizes the acid and helps wash away food particles. If there is not enough saliva, cavities may occur.

### Dry Mouth Treatments

Your doctor or dentist may recommend oral rinses and moisturizers, or prescribe an artificial saliva.

Also called saliva substitutes, artificial salivas are regulated by FDA as medical devices. "Unlike drugs, artificial salivas have no chemical action," says Susan Runner, D.D.S., chief of FDA's dental de-

vices branch. "Their action is mechanical. They moisten and lubricate the mouth but do not stimulate the salivary glands to make saliva."

While not a cure, artificial salivas can provide short-term relief of the symptoms of dry mouth. "They can also help minimize discomfort after an oral procedure," says Runner.

Artificial salivas come in a variety of forms, including rinses, sprays, swabs, gels, and tablets that dissolve in the mouth. Some are available by prescription only; others can be bought over-the-counter.

FDA has also approved several prescription drugs to relieve dry mouth caused by certain medical treatments or conditions, such as Sjögren's syndrome and radiation for head or neck cancer.

If you have persistent dry mouth:

- Talk to your doctor,

who may change your medications or adjust the doses.

- Talk to your dentist and provide a list of the medicines you take as well as any medical conditions or treatments you've had. The American Dental Association recommends seeing your dentist at least twice a year.

### Tips for Relieving Dry Mouth

- Sip water or sugarless drinks, or suck on ice chips.


- Avoid irritants, such as alcohol, tobacco, and caffeine. Remember that caffeine is found in many sodas as well as in coffee and tea.

- Chew sugar-free gum or suck on sugar-free candy.

- Avoid salty or spicy foods, which may irritate the mouth.

- Use a humidifier in your bedroom at night.

- Consider using saliva substitutes.



### Tips for Relieving Dry Mouth

- Sip water or sugarless drinks, or suck on ice chips.
- Avoid irritants, such as alcohol, tobacco, and caffeine.
- Chew sugar-free gum or suck on sugar-free candy.
- Avoid salty or spicy foods.
- Use a humidifier at night.

both geospatial data and what's known as semantic Web data.

"To address the limitations of current cloud-computing platforms," she said, "we are using state-of-the-

art hardware, software and data components combined with a secure cloud-computing framework we are developing for multiple agencies, including the U.S. Air Force Office of Scien-

tific Research, as well as corporations such as Tektronix and Raytheon. We're confident our progress will help significantly advance the field of cloud computing as a whole."

## Kids battle it out on a mathematical playing field

Nearly 450 students from 25 area schools converged on UT Dallas Wednesday for a competition capable of bolstering your appreciation of grade-school teachers, their students and the appeal of difficult mathematical problems.

The second annual E2 Brainiacs Mathematics Competition was sponsored by the Electrical Engineering Department (hence the E2) of the Uni-

versity's Erik Jonsson School of Engineering and Computer Science.

"Mathematics serves as the foundation for electrical engineering, and our goal is to promote an interest in mathematics to inspire the next generation of great electrical engineers," said Dr. Jung Lee, who organized the competition with her husband, Dr. Gil Lee. "We hope some of our students will grow up to be the next

Thomas Edison, Alexander Graham Bell, Nikola Tesla or Nobel Prize winner Jack Kilby."

Students competed in several categories, including algebra, geometry and pre-calculus, with trophies awarded to the top three students in each area.

The students' sophistication in math and science was particularly evident when a seventh-grader explained binary pulsars to lunchtime speaker and

Nobel laureate Russell Hulse, the co-discoverer of binary pulsars.

"Why do I enjoy doing this?" Jung Lee asked. "I like to see young minds being challenged. I like to see many local students visit UT Dallas and feel some of the flavor of college life. Not everyone can win at the competition, but they can enjoy being at a university and dreaming and planning for their future."

## Americas High School places fifth at national competition

Americas High School of El Paso, Texas, won fifth place in the 2011 National High School Mock Trial Competition. Out of 48 teams, including several from Guam, the Northern Mariana Islands, South Korea and Australia, the Texas team finished fifth—marking the first top-10 finish for a Texas team since 2007.

On May 4-8, high schools teams competed in Phoenix,

Arizona, arguing a hypothetical court case. In March, Americas High School team beat out 24 high school teams from across Texas, including defending State Champions Booker T. Washington High School of Dallas, to earn their place in the national competition.

Team captain, Zach Fields, who will attend Harvard University next year, was selected as one of the Out-

standing Advocates at the competition.

The Dallas Bar Association has sponsored and coordinated the statewide program since its inception in the 1970s to teach high school students how the justice system works and how the law is applied in everyday life, and to expose them to critical thinking exercises and quick analysis through preparation and presentation.

ing volume of mortgage loans in default or at risk of default. Weak governance and controls increased legal, reputational, operational and financial risk created unnecessary confusion for borrowers.

Among the list of specific examples of lender failings were missing documents, execution of documents by unauthorized persons, failure to notarize documents in accordance with local law, inaccurate affidavits, and affidavits signed by persons lacking sufficient knowledge of the underlying mortgage loan transaction.

The consent orders also require best practices that in part call for:

- Avoidance of unnecessary foreclosures and consider

workout strategies that are affordable and sustainable;

- Early and frequent customer contact to increase successful foreclosure mitigation;

- A single point of contact to manage the bank's relationship and communications with the borrower; and

- Discontinuation of paying law firms, servicers, and employee bonus incentives to process high volumes of foreclosures.

For many consumer advocates, however, these federal actions are simply not enough to fully or fairly address the hurt borne by consumers from ill-advised lending practices.

More than 50 organizations jointly issued a letter that advised these regulators

to withdraw the consent orders and instead work with state Attorneys General and the U.S. Department of Justice.

The Center for Responsible Lending joined with the NAACP, National Urban League, National Consumer Law Center, National Council of LaRaza, Service Employees International Union (SEIU), National People's Action and others in a call for a joint settlement that addresses illegal servicing practices in a meaningful way.

The letter advised in part, "The proposed consent orders do not provide the accountability and rigor required to right this foreclosure crisis. They are clearly not intended to do so."

It is time for the banks that were rescued from financial ruin by the nation's taxpayers, to return in full measure the goodwill that has now led to the industry's returned prosperity. American families should have a fair chance to recover from the harmful lending practices that led us to today's recession.

# Black America's survival: Hinging on group success vs. individual success


In spite of the numerous blatant and subliminal social obstacles that the Black community has faced in the past and continues to face, a remarkable number of African Americans have risen to highly-esteemed statuses in the professions, arts, letters, professional sports and the entertainment field in the last 100 years. Within the past 10 years, two Black Secretary's of State have held office, a few Black U.S. Senators and governors have been elected to serve, and the first Black president has even earned a seat in the oval office. Each of these individuals' accomplishments and many more by other African Americans has helped Black America to progress significantly since the 1960's.

However, when Black America is placed under a microscope, a malignant picture emerges. Though much individual success has occurred sporadically among blacks, virtually no group achievement exists. Black America—as a group—is divided and fragmented, and comes in last place in relation to other races. Minority groups such as Asians, Hispanics, and Jews are far more productive. Their communal success can be attributed to their “greater good” mentality and their willingness to stand united; re-distribute their income within their communities to build and strengthen their communities; as well as assist one another in their individual plights toward success by sharing knowledge, skills, and access to resources, which will ultimately uplift their entire community.

Seemingly, the concept of unity and community is foreign to Black African Americans; seemingly, the thinking that prevails within the Black community is the “crabs in a bucket” mental-

ity. Rather than linking hands with one another and building ladders to help others climb to the top (success) and take the black community to the next greatest level, every man seeks their own personal gain or wealth. They crawl over one another or outright sacrifice the lives and psyche of others to gain a dollar. This fact is most apparent in rappers degrading black women and promoting ignorance to the masses of black youth, hustlers selling drugs on the corner, entertainers constantly using the n-word for laughs, and failing participation in or creation of social movements to benefit the black race.


When will African Americans realize that until the Black community unites from within and makes strides as a group, no African American will be able to experience the true fullness of freedom and respect? Henry Louis Gates, Jr., educator, scholar, writer, editor, and

public intellectual, is a perfect example of this victimization; and most recently President Obama regarding the “Baby Monkey” email shenanigans. Until Blacks unite as one and respect one another from within the group, respect from without is never, ever going to be a reality.

Malcolm X once said, “We cannot think of becoming acceptable unto others

until we have first become acceptable to ourselves.”

When you look at the Black community, the capital income exceeds that of most third world countries. Yet only about 5% of that capital remains in the community. Everyone else benefits from African Americans' capital gains except for African Americans. There is something psychologically wrong with the way many African Americans think. If one's very own community is not important enough to one for them to invest in financially and morally, how can

Blacks really expect others to provide and care for the race?

Consider the fact that Kobe Bryant, Los Angeles Lakers NBA superstar, was recently fined \$100,000 for using the derogatory slur “faggot” towards a referee. The fine illustrates the NBA's zero tolerance for use of a derogatory term. However, when it comes to the black players' use of the n-

word, the NBA looks the other way. It does not cost one red cent for African Americans to free themselves from the psychological bondage of the n-word, inferior thinking, and self-destructive behaviors; yet, blacks—as a group—don't even want to put forth the effort to take back their rightful dignity and self-respect that so freely and eagerly awaits their pick up.

The n-word is a derogatory term no matter whose mouth it flows from, black or non-black. So why do African Americans insist on making fools of themselves by publicly degrading the black race? Public use of the n-word does absolutely nothing to elevate or uplift the image of the African-American community as a group.

The rest of the world watches in utter amazement and shock as African Americans dog and totally disrespect each other. Jewish peo-

ple would never publicly refer to one another as kike or hymie; the gay community publicly to each other as faggots; or Hispanics to one another as wetbacks. So why do Black African Americans stoop so low, disgracing, dishonoring and bringing con-

tempt upon themselves by insisting on residing in their pre-appointed place and referring to one another as a n\*\*ger?

Black America needs to

ask itself how do those who tolerate use of the n-word from within come to this acceptance? And does their tolerance for the use of the n-word serve as validation that they are a free and independent spirit? Or does it prove that they have been spoon fed by the powers-to-be to accept this demeaning categorization of self? How did they come to accept the idea that they are a n\*\*ga—and that being such a thing is okay?

Whether the “Willie Lynch Papers” are true or not, many years ago, a heinous plight was carried out against black slaves. The only purpose of this plight was to keep blacks divided, weary, and unaware of who they were and their potential. If blacks continue to remain divided and fragmented, flaunting the “me, myself, and I” mentality, as well as refusing to see the harm in use of the n-word and community-destructing behaviors, the community will remain in a state of limbo—unable to progress. Blacks must focus on group survival and partake in activities that result in the greater good, and not selling out for a dollar.

Group success over individual success [must] become paramount to each and every black person. Only then can the plight be reversed and re-gaining control of the psyche and rejuvenation of the Black community can occur.

## America's got "Flava" which tastes like pure power

The world has changed considerably since the "Leave It to Beaver" days, when the Cleaver family represented the model of the American family. My employer, the Nielsen Company, measures and analyzes consumer trends and behaviors across the globe, and recently released a comprehensive new study – *The New Digital American Family*, which details America's ever evolving society of many "flavas" (officially known as diversity) and the marketing impact of that diversity. In a nutshell, our society is more ethnically "flava-ful" than at any other point in history.

According to the report, no single cultural, social, demographic, economic or political point of view dominates the American landscape. How cool is that? The data projects that households with children under age 18 will be predominantly multi-cultural (Hispanic, African-American and Asian-American) by 2020. That's just a

short nine years away. And if that's too far out for some of ya'll to envision, consider the fact that a whopping 40 percent of the population is already multi-cultural today due in large part to immigration. You know what this means, right? Advertisers are going to be forced more and more to focus their marketing lenses on us – all of us! This means adapting and adopting new technologies for communicating with consumers who look like you and me.

The smartphone, for example, has emerged as an equalizing agent across households of every ethnic demographic and income level. Whereas before there was a "digital divide" as it related to African Americans having access to the internet, these nifty devices provide low cost, easy access Web connectivity to households of all income levels and ethnicities. Two out of three of us who are U.S. mobile subscribers use text messaging. We live in the age of any-

time, anywhere, affordable access. This too is a game changer for marketers who now must learn to leverage the unique attributes of "mobile" into their campaign strategies. Here are some



specific advertising technology realities, according to *The New Digital American Family* report:

- When surfing the net, as a group, African Americans tend to gravitate to music sites, while Hispanics tend to visit Latin-influenced sites like Univision and MSN Latino and Asians prefer technology sites.

- African-American media habits are TV- and mobile-centric. As I have

shared in previous columns, we own four or more sets per household and spend almost 40 percent more time watching TV, especially premium cable channels, than the average American viewer. That's

not necessarily a bad thing if television manufacturers, advertisers and programmers of these mediums take note of our over indexing and model more content, commercials and programs after us.

- As a group, we also apparently love to talk more than the U.S. average, running up more mobile voice minutes per month—1,261—than any other group. Again, when the mobile companies realize they can improve their

market share with such a brand loyal demographic group perhaps they'll increase the number of ads that feature people who look like those of us who use their products the most. And if they really want to be cutting edge, they might even increase their advertising buys on stations and in publications Blacks frequent the most. Now there's a novel idea, right?

Education and affluence are consistent behavior markers, regardless of ethnicity. Do you recognize any of your behavior below?

- Higher income families across the board buy fewer cell phones than the average, most likely because lower income consumers are more likely to bypass a landline in exchange for a cell phone.

- Higher income households use digital video recorders (DVRs) four times more often; purchase more video games and more DVDs than the average household. They also are huge devotees

of time-shifting, which allows them to watch more with their children.

- Higher income families also spend less time on sites like Facebook and YouTube but more time educational options like Teacherweb.com and ClassZone.com.

So let's not get it twisted: as African Americans we have power and influence through our choices of purchasing, listening, talking, surfing and viewing. If someone tries to make you feel bad because you do "too much of this or watch too much of that" please know that for every one of your actions – there is a "ching ching" cash register reaction for some business or company. So choose and act wisely and – Viva la difference!

Dr. Marc Lamont Hill, Columbia University professor and author; activist attorney Michael Tarif Warren; and attorney Chokwe Lumumba, the lawyer for the Scott Sisters, discussed the sisters' case and how it was connected to other issues.

Ms. Silver explained that each panelist, while speaking on separate subject matter, would connect to the Scott Sisters' case, and the oppression of Blacks in American society and in the criminal justice system.

Lumumba brought gasps of horror from the gathering when she noted there are 200,000 Black women in prisons or jails—an 800 percent spike during the past three decades. Two-thirds of the women were incarcerated for non-violent offenses, she added. “A 2005 study stated that 28 percent of the women were jailed for drug offenses,” Ms. Lumumba said.

Another telling statistic, according to Lumumba, came from a 2008 study that showed 45 percent of women in prison were White, 32.6 percent were Black, and 16 percent were Latino.

Many women fit the same description of the Scott Sisters as “community prisoners” who “for the rest of their lives they will have to call a parole officer,” she said.

Analysts complained that Governor Haley Barbour's decision to grant the Scott Sisters indefinite suspension, rather than grant a pardon or commutation of the sentence, has placed

extra hardship on the women. They are required to undergo constant supervision, steer clear of any associates with criminal records, pay \$52 a month to the state of Mississippi for upkeep and cannot travel without court permission.

Dr. Hill talked about the media's role in criminalizing Black women. “The media insists on using certain behaviors to criminalize Black women across the board,” he said. “There is a dominant message to the middle class in America that constructs an image that the reality for Black women is that they deserve to be caged in prisons.”

The Scott Sisters told the audience two White sisters would not have been sentenced to life for a simple robbery. “Black people don't have a chance in the state of Mississippi, we are going to all have to be willing to fight the injustice,” stated Jamie Scott.

Attorney Warren has been fighting for justice for the young Black men in New York known as the Central Park 5. The teens were convicted of the rape of a young White woman in 1990, but thanks to the work of attorneys and Black activists, the five were exonerated in 2002. A sex offender stepped forward saying he committed the rape alone.

Attorney Warren pointed to similarities in the Scott Sisters' case, such as a prosecutor who was willing to believe statements from the three Mississippi teens who actually committed the \$11 robbery at gun point. The prosecutor believed the

story, though one teen said the sisters had no hand in the crime, said Warren.

There are also questions about the trial judge, he said.

“The Central Park 5, just like the Scott Sisters, are victims of conspiratorial behavior throughout the criminal justice system,” Warren said.

The Scott Sisters ordeal is a tragedy that happens daily in America, said Lumumba. “We have to use the power of the people to stop the destabilizing of our community,” he said.

“The oppressors have created a police state, and the Scott Sisters case represents a clarion call. We must see the connectivity on the basis of the case and the situation facing all political prisoners languishing in U.S. prisons,” Attorney Lumumba said.

As tragic as the Scott Sisters' case may be, there are hundreds just like it throughout the South, he observed.

Jamie Scott told stories about daily oppression and racism the sisters witnessed while incarcerated. “If a Black woman slapped another Black woman, the prison guards would say, go sit down. You slap a White woman you are going to the hole,” she said.

Suzanne Ross, co-chairwoman of the Free Mumia Abu-Jamal Coalition-NYC, told *The Final Call* the forum made sense.

It is “so important that we were able to connect to their pain of being framed, and also their horrid living conditions and daily abuse,” she said. “I found

it very moving seeing them, and hearing from them. We must support these two sisters; and we must smash the prison/industrial complex,” Ross added.

“I am very impressed with the Scott Sisters. They

represent the many victims of the criminal justice system who have been educated by the oppression of the system,” Warren told *The Final Call*.

Lumumba stressed that activists are still working to

see the Scott Sisters pardoned. A rally for justice is planned for Sept. 30 in Jackson, Mississippi, and a two-day conference is scheduled for Sept. 14-15, he said.



**Sister Tarpley**

"They that sow in tears shall reap in joy. He that goeth forth and weepeth, bearing precious seed, shall doubtless come again with rejoicing, bringing his sheaves with him." - *Psalm 126:5 & 6 (KJV)*.

It has been said that one of the most difficult times in life is to keep moving in faith when we are in extreme pain. Extreme pain, especially emotional pain, can become immobilizing to the human spirit if we allow it to overcome us.

The psalmist in the above scriptures tells us that there is only one remedy for overcoming painful circumstances that will result in joy. We are to sow (plant) in the midst of these times. We can't do this if we live by feelings alone. It is an act of the will. This act requires that we go outside ourselves in pure faith.

We can learn this principle during one of the deepest periods of our life; especially when we lose someone in death that is dear to us. A mature Christian in the faith will tell us to reach

out to others in spite of our own pain; to invest in someone else. We can not realize what a place of healing and comfort that would become.

Pain can become a source of joy if we take the first step by planting a seed. There is a harvest that will come if we sow in the midst of our tears.

There is no doubt in my mind that we have all heard stories of individuals who have overcome extreme hardship during their childhood years. Children of alcoholics, orphans who never have parents, loss of parents to a fatal crash, childhood disease - these are all difficult circumstances to overcome.

Jephthah in the Bible was a man who planted a seed in the mist of his tears when he overcame his obstacles and refused to allow his circumstances to prevent him from becoming great in God's sight. He was born to Gilead, a result of his father's adulterous encounter with a prostitute.

Jephthah's half-brothers decided to reject him; they drove him away from their home saying, "Thou shalt

not inherit in our father's house; for thou art the son of a strange woman." *Judges 11:2b (KJV)*. Can you imagine the rejection this young man felt as he was cast away from his own family through no fault of his own?

This experience taught Jephthah to become a hardened warrior. Today he probably would have been part of a street gang. As he got older, his reputation as a warrior became known to those in his country, so much so that when the Ammonites made war on Israel, the elders of Gilead went to Jephthah and asked him to be their commander. Jephthah probably had to fight off those feelings of rejection from previous years.

"Didn't you hate me and drive me from my father's house?" He responded. However, he overcame his hurt and pain; and he responded to the call God had on his life.

It is a known fact that if we were to help the butter-


fly remove itself from the cocoon that the butterfly would not be strong enough to survive. It is the struggle that forces the fluid into the wings and prepares the butterfly to become strong enough to fly. Without the struggle in the cocoon, it

against expert advice when she put Tyler in bed with her and curled up next to him as he slept on his stomach. But she couldn't deny her natural craving for closeness with her baby.

"Around 6:30 in the morning, I woke up and squeezed his little feet and they were cold," Lehmann said. "I thought, 'Oh Baby, I'm so sorry, Mommy needs to put some socks on your feet.' But then I reached around and felt his stomach and it was cold too. When I realized what had happened, all I could think or feel was no, no, no, no."

Investigators determined that Tyler died of accidental suffocation, possibly from sleeping face down on a deeply cushioned adult mattress that blocked his air intake.

Lehmann has since learned why such sleeping arrangements can be dangerous: "Babies that age haven't developed the instinct to open their mouth if they can't breathe through

their nose. That's why you shouldn't let them sleep on an adult bed."

## Speaking Out Brings Meaning, Redemption

After several months of feeling little but emptiness and remorse, Lehmann read



about Room to Breathe. The redemptive opportunity was too obvious to pass up.

"Sometimes you just want to sit in a room and cry

and cry all day. But eventually you realize, you can't just sit there and do nothing," Lehmann said. "I got in touch with DFPS and told them I'd like to help."

Lehmann says she's never regretted her decision.

Her undeniable credibility allows her to command parents' attention, even if they don't always agree with her message.

"I know a lot of people are pro 'co-sleeping' with their babies, and I try to be clear that I'm not telling them their views are right or

wrong. I'm just sharing my own story as an example of what could happen."

Lehmann says she intends to keep on speaking

out.

"Tyler will be in my heart for the rest of my life. And though he only had a short little life he's still doing something really good. I'm on a mission, and I'm not going to stop."

## To lower the risk of infant death while sleeping, DFPS suggests:

- Always put infants to sleep alone, on their backs, and in a crib or other firm sleeping surface.

- Never put babies to sleep with soft bedding, pillows, bumper pads, or stuffed animals that may interfere with a baby's ability to breathe.

- Never sleep with infants while you are under the influence of alcohol or any drug or medication that causes drowsiness.

- Never sleep with an infant if you are obese or extremely fatigued.

- Never expose an infant to second hand smoke.
