Bishop Eddie Long settles—instead of fighting as promised Lawsuit questions left unanswered

(NNPA) The Atlanta pastor facing four civil lawsuits accusing him of sexual coercion settled the cases out-of-court, his church announced May 26, but the agreement leaves plenty of questions unanswered.

in September 2010 against Bishop Eddie Long, the leader of the 25,000 + member New Birth Missionary Baptist Church. Four plaintiffs alleged that Long gave them and others attention, money, and gifts, before and after they reached the legal age of

Former Irving City Council member Beth Van Duvne's has accused current Mayor Herbert Gears' administration of mismanagement of the proposed \$250 million entertainment center. Her repeated claims regarding the disputed entertainment center were cited as the key reason she finished first and forced a runoff in last month's hotly contested election. Van Duyne received 41 percent

of the vote and Gears received 38 percent.

According to Van Duyne, Gears' administration offers "a lot of pretty pictures but no real substance behind them," regarding economic development proposals for the city.

However, if voters take a closer look at Van Duyne's professional track record, they would likely come to the same conclusion. Her resume paints a "pretty picture" it just happens to not be true.





Sounds impressive, the only problem is according to documents from the Texas Secretary of State, BCI was slapped with a Texas Forfeiture on July 1, 2005. Her resume indicates she has served as the company's president since February 2002, which is interesting given the fact the State of Texas shows the Articles of Organization were not filed until July, 2003.

Van Duyne demands the voters hold Gears responsible for the leadership of the City of Irving. That is fair, but shouldn't the voters consider her leadership which resulted in the forfeiture of the company to the State of

However, we understand things happen, sometimes not in your control even as the leader of an organization. But perhaps voters should also consider the fact that she is listed as President of Monumentals, Inc. which started in June 2003. Yet by January 7, 2005 it was also seized by the State of Texas for Tax Forfeiture.

Is this the kind of leadership worthy of the City of Irving? Is it the type of leadership the City of Irving can afford?

She criticizes Gears for abusing his power and broken faith with the voters. What about the State of Texas taxpayers who had faith that under Van Duyne's leadership two - not one companies would pay their fair share of the taxes owed.

On the website for her campaign Van Duyne prominently promises to, "Restore accountability and fiscal responsibility to the city budget." How can voters have confidence in her ability to deliver on this promise when her track record as a business leader is a picture of failure?

Even now there remain questions regarding the companies Van Duyne claims she has an interest in: BCI Marketing Group, LLC and Coolest Energy Solutions, LLC. On her Personal Financial State Disclosure Report filed April, 2011 she listed these two companies, yet when a search for information regarding Business Personal Property Taxes paid to Dallas County (searchable

myself as a perfect man. But I am not the man that's being portrayed on the television. That's not me."

"I've been accused. I am under attack," he said. "This thing, I'm gonna fight. ... I feel like David against Goliath. Butm I've got five rocks and I haven't thrown one yet."

The settlement, which was reached after several months of mediation. doesn't look like the fight Long promised. It leaves all the questions from the lawsuits unanswered, including the basic question of his guilt or innocence, and generated new ones, including the monetary terms of the settlement, and whether Long or the church is paying the tab.

"After a series of discussions, all parties involved have decided to resolve the civil cases out of court. The decision was made to bring closure to this matter and to allow us to move forward with the plans God has for this ministry," Art Franklin, spokesman for Long and New Birth Missionary Baptist Church, said in a statement. "As is usually the case when civil lawsuits resolve out of court, we cannot discuss any details regarding the resolution or the resolution process, as they are confidential. This resolution is the most reasonable road for everyone to travel."

B.J Bernstein, the lawyer plaintiffs Maurice for Robinson, Anthony Flagg,

"never in my life portrayed Jamal Parris, and Spencer LeGrande, released a brief statement, saying only that "The matter has been resolved" and adding that neither she or her clients would make any further statements or give interviews now or in the future about the case.

> "To me it looks like a cover up," the Rev. Dr. Bar

bara Reynolds, a religious and political commentator, said. "It looks like he did what the Catholic Church has been doing for decades. I thought that [Long's initial statements] meant he would go to court and fight in court."

Reynolds added that there is no way to be sure if Long was guilty or innocent. "If that's his addiction, more people will be violated ... But, who will know for sure now, because it's been covered up."

The New Birth congregation rallied around Long, supporting his call to fight and continue to move forward. And he assured them

that he would remain their pastor, saying, "I've been called to be your shepherd and as long as you receive me as your shepherd, I'll be your shepherd."

But without a clear resolution of Long's guilt or innocence, or the cost of the settlements to the church, many are wondering what

impact this will have on Long's ability to be effective as a leader.

"I think they'll go right on with him," Reynolds said. "People have a special relationship with their preacher and they are going to believe Eddie Long and things will go on as usual."





Digital forensics Regional labs help solve local crimes



RCFL examiners—all certified by the FBI—specialize in locating encrypted, deleted, or damaged file information that could be used as evidence in an investigation.

In 2008, Illinois police received disturbing information about a Chicago woman who had taken a 3year-old to a "sex party" in Indiana where the child and an 11-year-old girl were abused by three adults. However, by the time the tip was received, the crime had already occurred, and there seemed to be no evidence to support criminal charges.

But there was evidence, buried deep within the woman's computer, and examiners from our Regional Computer Forensics Laboratory (RCFL) in Chicago found it—a deleted e-mail titled "map to the party" that contained directions to an Indiana hotel. The evidence led to charges against all three adults,

who were later convicted of aggravated sexual abuse and are currently in prison serving life sentences.

"That's just one example of what we do every day," said John Dziedzic, a Cook County Sheriff's Office forensic examiner who is the director of the Chicago RCFL. "Evidence we produce hereand testify to in court—is crucial in a variety of major investigations.'

The FBI established the first RCFL in San Diego in 2000, and today there 16 Bureau-sponsored labs located around the country, staffed by agents and other federal, state, and local law enforcement agencies (see sidebar).

Each facility is a full-

service forensics laboratory and training center devoted to examining digital evidence in support of investigations-everything from child pornography and terrorism to violent crime and economic espionage cases.

Using sophisticated tools and technology, RCFLs analyze evidence from all kinds of electronic devices, including computers, cell phones, video game consoles, and even reel-to-reel tapes.

"Anything that can store data electronically can be analyzed," said Special Agent Justin Poirier, deputy director of the Chicago RCFL.

RCFL examiners-all certified by the FBI-specialize in locating encrypted, deleted, or damcould be used as evidence in an investigation.

"Digital evidence has become part of just about every type of investigation," Poirier said, "because today everybody computers uses and portable electronics such as cell phones."

The benefit of having a regional forensic facility, he added, is that the FBI can bring its expertise and training directly to where it is needed.

"The idea is to create regional resources " Poirier explained. "We train the state and local examiners, who make a three-year commitment to the RCFL. When they return to their agencies, they have expertise and access they didn't have before. And in the process, we build lasting relationships with our regional partners.'

Dziedzic added, "Instead of sending evidence to the FBI Laboratory in Quantico, we can analyze it much faster here in our own backyard."

Chicago's RCFL was established in 2003 and consists of five FBI employees and 13 examiners from agencies including the Chicago Police Department. Cook County Sheriff's Office, and U.S. Customs and Border Protection. It is the only digital forensics lab in Illinois

> "Accreditation is the gold standard when it comes to prosecuting cases and testifying in court," Dziedzic said. "It means that we operate at the highest professional

standards."

"Criminals are using more sophisticated electronic methods to commit crimes," Poirier said. "This regional approach to digital forensics-pairing the Bureau with local law enforcement to collaborate on cases—is the future for law enforcement. It really works."

Maternal mortality rates are increasing for African-American women

By Marjorie Valbrun (America's Wire) High rates of obesity, high blood pressure and inadequate prenatal care cause death from childbirth more often for African-Americans in the United States than for whites and other ethnic groups. Worsening this trend are the increasing numbers of cesarean sections nationally. These procedures can result in deadly complications for women dangerously overweight or suffering from hypertension or other ailments.

Nationally, blacks have a four-times greater risk of pregnancy-related death than whites - a rate of 36.1

per 100,000 live births compared with 9.6 for whites and 8.5 for Hispanics, according to a 2008 report by the Centers for Disease Control and Prevention (CDC).

Maternal mortality rates have been rising in the United States since the mid-1990s. In 1997, the black maternal mortality rate was 21.5 per 100,000 live births compared with 8.0 for Hispanics and 5.2 for whites, according to the CDC. The rate for other races was 8.8.

By 2007, the black maternal mortality rate had jumped to 28.4, roughly three times the rates among whites and Hispanics at

left a legacy that others would have to deal with. His Massachusetts roots have borne strange fruit, even as race matters remain unresolved despite the election of an African American president.

What would happen if Black folk wrote the stories of our history? Would we learn about the challenges that allowed some to lay stone on the ground to build our nation's capital? Would we learn, from their own mouths, about those who served our plethora of flawed presidents, who managed their foibles? If Black folk wrote our nation's history, would we finally capture the South Carolina burial ground that was the first recorded Memorial Day, according to Yale University history professor David Blight.

What would happen if Native Americans wrote the story, wrote about the land that was taken by greedy white people whose expansion plans

collided with other people's existence. Would we learn about the men and women who grabbed belongings in the dark and fled someplace? Would we learn about the reservations that were established, a fraction of the space that one once lived in? Would young people, sitting down to read history, learn about the pain that our imperialism cost?

History belongs to she who holds the pen, and history holds us hostage to interpretation. So write. sister, write, the story of Memorial Day, of the Black folks who went to give dignity and honor to those who lost their lives. Write, sister, write, about the foundation of our nation's capital. Write it, write it, write it, boldly and bodaciously because the story will not be told unless we claim the pen as our own



Chairman Elizabeth Ames Jones begins process for first state rule to disclose frac fluid components in drilling *Rulemaking to build upon sound foundation of earlier voluntary national disclosure process created with Railroad Commission input*

Elizabeth Ames Jones, Chairman of the Texas Railroad Commission (RRC), the energy regulatory body for the U.S.'s largest oil and natural gas producing state, will begin the process to craft rules to mandate disclosure of certain chemicals in the solutions used in the hydraulic fracturing process commonly used in drilling natural gas and oil wells.

Chairman Jones said, "A common sense frac fluid disclosure policy will balance the Railroad Commission's dual mission to prevent the waste of Texas's energy resources, and to protect the environment and the public's health and safety. The policy will be built on the sound foundation that the Railroad Commission has already laid through our staff's active leadership in the crafting of Frac Focus, a disclosure website.

"I expect any rule to formalize best practices while protecting proprietary information. As more foreign companies are in-

vesting in businesses that drill here in Texas, and more wells are produced using hydraulic fracturing, it is important that our public disclosure rule does not undermine a frac company's intellectual property and trade secrets," said Jones.

"I appreciate the legislature's recent passage of HB 3328, and our rulemaking will instill confidence and allay concerns regarding the safety of hydraulic fracturing for handlers above ground. Hydraulic fracturing has been going on for over 60 years. Our actions should not be misconstrued to upend my earlier statements that it is geologically impossible for fracturing fluid or natural gas or oil to migrate upward through thousands of feet of rock, sometimes miles, to adversely affect ground water. In fact, I am committed to encouraging the development and use of technologies, across the board, like multi-stage hydraulic fracturing, that will allow for an ever shrinking

drilling footprint and enhanced recovery of energy. That is simply good for Texas and good for America," added Jones.

On Thursday, June 2, 2011, Jones will advise the Secretary of Energy, Steven Chu, and the Secretary of Energy Advisory Board's Natural Gas Subcommittee at the U.S. Department of Energy Headquarters on the state's successful oversight role of hydraulic fracturing. The Subcommittee is comprised of 7 members: John Deutch (chair), Susan Tierney, Daniel Yergin, Stephen Holditch, Ph.D, Fred Krupp, Kathleen McGinty, and Mark Zoback.

Jones recently testified with other experts and the Environmental Protection Agency before the U.S. House Committee on Science, Space and Technology's hearing regarding hydraulic fracturing. The archived hearing, including Jones' testimony, is available on the Committee website.

NTTA toll rates scheduled to increase effective July 1 Updated rates follow biennial schedule announced in 2009

The North Texas Tollway Authority wants to remind drivers that a regularly scheduled toll rate increase takes effect July 1.

To deliver regional transportation projects to relieve congestion, preserve a strong and financially viable system and maintain quality, safe and reliable roadways, the NTTA will implement a regularly scheduled toll rate increase of .8 cents (less than a cent per mile). The toll rate policy provides for a 50 percent price difference between TollTag and ZipCash rates.

"The Board understands this rate increases comes durng a challenging economic time," said NTTA Chairman Victor Vandergriff. "However, raising rates is a planned and necessary step the NTTA needs to take in order to maintain a viable financial system and to deliver the many mobility projects that bring growth to the North Texas region."

The action increases rates from 14.5 cents per mile to 15.3 cents per mile. NTTA rates are compatible with the toll rate structure recommended by the Regional Transportation Council.

This increase follows a schedule that requires toll rates be increased every other July at a compounded annual rate of 2.75 percent. This incremental change is required to meet the financial needs of the NTTA while ensur-

Preventing Bullying and Cyber Bullying

By Texas Attorney General Greg Abbott Bullying was once considered an unfortunate – but relatively harmless – schoolyard malady. Today, however, parents, educators and law enforcement officials are increasingly recognizing that bullying is anything but harmless.

Young victims of bullying can suffer long-term consequences that haunt them long into adulthood. For the perpetrators, bullying can cross the line and become a criminal violation with lifelong consequences. A recent study by Fight Crime: Invest in Kids showed that nearly 60 percent of boys who were classified as bullies in sixth to ninth grade faced criminal prosecution and conviction of at least one crime by the age of 24. Of that same population, 40 percent had three or more criminal convictions.

Bullies typically choose their victims based upon a particular vulnerability or a specific trait. Some simply choose victims randomly. For example, a bully may target a child because of the child's height or academic successes. To intimidate their victims, bullies rely upon a variety of harmful behaviors such as hitting, teasing, threatening, spreading rumors, damaging belongings and excluding others from social groups.

In an increasingly electronic world, cyber bullies rely on technology to torment others. Cyber bullying occurs when teenagers use the Internet, cell phones or other devices to send or post texts or images that are intended to hurt or embarrass their victims. Put differently, cyber bullies may attempt to destroy or smear a victim's reputation with emails,

blogs, social media posts, text messages and other electronic media.

Bullying situations often involve seemingly powerful aggressors and victims who feel helpless. Sadly, some students who suffer bullying at school may believe that violence is the only way to defend themselves – but it is not. Texas law allows bullied students' parents to request that their children be transferred to another classroom or school. The law also requires that all schools display a student code of conduct that imposes disciplinary consequences for

young bullies.

Parents and students alike should be aware that some instances of cyber bullying can cross the line and become criminal conduct. Texas law defines criminal harassment as "sending repeated electronic communications in a manner reasonably likely to harass, annoy, alarm, abuse, torment, embarrass, or offend another." Texas teenagers who suffer from cyber bullying or harassment should save all communications from a bully and report those threatening or hurtful messages to a parent, teacher, law enforcement officer or other trusted adult.

By working to prevent young Texans' bullying, harassment and intimidation, adults can help protect young people and make our communities safer. Parents and teachers are often best poised to build a child's selfconfidence and teach the student how to peacefully resolve their problems. Parents and school personnel should always take bullying seriously so that children are not embarrassed or afraid to tell adults that they have been bullied.

blacks are nearly eight times more likely to die from pregnancy-related complications than whites, and in California where pregnant blacks are four times as likely to die from childbirth.

"The magnitude of this black-white gap in maternal mortality is the greatest among all health disparities ... and that gap is growing. It's unacceptable," Michael Lu, an associate professor of obstetrics and gynecology and public health at UCLA and an expert in racial and socio-economic disparities in maternal and infant health, recently told PBS NewsHour.

The black-white gap also stubbornly persists for a variety of socio-economic reasons, including education and income levels, access to and quality of health care, and lifestyle and diet. Improved health care could reduce the maternal death rate by 40 percent to 50 percent, according to CDC estimates, but medical attention has been focused more often on reducing infant mortality during the past decades.

"When we look at some of the factors associated with maternal mortality, most of the underlying factors tend to be dominant in the African-American community, and it is manifested in the health disparities that affect our population," says Dr. Kerry M. Lewis, chairman of the Department of Obstetrics and Gynecology at Howard University's College of Medicine and chief of the Division of Maternal-Fetal Medicine.

Lewis, who specializes in high-risk pregnancies, says the mortality rate reflects lack of access to specialized health care that integrates comprehensive skills and technology. Too often, he says, patients are treated by family practitioners, nurse midwives, general obstetricians and gynecologists instead of specialists trained in high-risk pregnancies and medical problems that can cause complications during birth.

Obesity and hypertension are the major contributors to the black maternal mortality rate, leading to death from strokes, renal failure and other complications associated with obesity, Lewis says.

"We have to look at the reality of where we practice," he says. "Obesity is much greater among African-Americans. I deal with a gamut of high-risk problems, but complications from obesity are an underlying problem in all of them.

"Even young patients when they come in for prenatal visits have very elevated rates of high blood pressure. It really starts with obesity, so when they become pregnant, it places them at a higher risk for infections and other complications." To a lesser extent,

sickle-cell disease, a genetic disorder more common in people of color, also causes complications, he says. Lewis, who also chairs the District of Columbia section of the American Congress of Obstetrics and Gynecology, says the increase in Csections has compounded the problem because they can lead to hemorrhage, infections and pulmonary embolisms, or blood clots in the lungs. One-third of births in the United States are now by C-section compared with 20 percent a

decade ago. "Women who have Csections have higher rates of complications and maternal mortality than with vaginal

deliveries," Lewis says. The California study bears this out. Of the 386 women who died in the state during childbirth in 2002 and 2003, it found, 65 had undergone C-sections "and most were unplanned or emergency surgeries to try and save the life of the mother or the infant." Additionally, more than onethird of the deaths "were determined to have had a good to strong chance of being prevented and some causes of death appeared to be more preventable than others."

The study also found that:

* Blacks in California had a four-times higher risk of maternal death and were more likely to have been overweight or obese and to have risk factors identified in the prenatal period.

* High rates of obesity or excessive gestational weight gain were contributing factors in one of four deaths.

* From 2006 to 2008, the black maternal mortality rate in the state was 46.1 deaths per 100,000 live births, compared with 12.8 for Hispanics, 12.4 for whites and 9.3 for Asians.

* Although blacks account for only 6 percent of California births, they represented 22 percent of pregnancy-related deaths in 2002 and 2003. Hispanics had the largest number of pregnancy-related deaths, 44 percent, and account for 51 percent of births statewide.

* Cardiomyopathy, or heart disease, was the leading cause of death for blacks with pregnancy-related deaths and accounted for 36 percent of the 22 deaths in that group and 62 percent of all deaths due to the disease.

* Thirty-one percent of mothers who died had not

completed high school.

Conrad Chao, department chair and program director of obstetrics and gynecology at the University of California, San Francisco, who worked on the report, has said that he was surprised by "the magnitude of the disparity" and that the quality of care given these women needs further exploration.

The CDC issued a report in 2001 calling for comprehensive, broadbased public health surveillance of pregnancy-related deaths to identify factors, from pre-pregnancy through six weeks after birth, that affect a woman's chance of survival and that place minority and older women at increased risk of death. The report said surveillance must include reviewing the causes of deaths, analyzing the findings and coordinating action among public health agencies.

"Too often, surveillance stops after identifying and counting deaths," the report states. "With the resources available today, we should be able to eliminate this gap in such an important health outcome."

To help children deal with bullies, parents should work to bolster children's self-assertiveness and selfesteem. They should also teach their children to solve problems without resorting to violence. Victims of bullying should be taught to immediately report the bully or cyber bully to an adult.

Parents should also teach children that if they witness bullying, there are positive steps to end a potentially dangerous situation and help the victim. Witnesses must not watch or encourage the bully, since bullies typically desire an audience. Instead, witnesses and bystanders should go to the victim's aid if it is safe to do so and report the incident to an adult. Parents who observe any bullying should take action to stop it right away – even if their own child is responsible for the bullying.

To ensure children and teenagers know how to safely resolve a bullying incident, parents and teachers should teach students to:

• Report to an adult any type of bullying – including theft, physical attacks, online harassment, abusive text messages, etc.

• Protect themselves and others. Young Texans

should follow rules and stay out of trouble, avoid gangs, walk to school with friends, and be aware of their surroundings.

• Be cooperative and respectful. Conflict resolution exercises, parental involvement in school or summer activities, and spending time with family can help offer children opportunities to experience appropriate social interaction with their peers.

Together, parents, children, teachers and law enforcement authorities can help prevent bullying and cyber bullying, reduce crime and build a brighter future for all Texans.

Irving mayoral candidate Beth Van Duyne: A step forward or backwards for a city rich in diversity

Irving voters will go to the polls on June 18 to decide who will be the City's next mayor. Incumbent Herbert Gears and former City Council Member Beth Van Duyne will face each other again in a run-off election. According to a WFAA Channel 8 report, the results from the Irving Mayoral election held on May 14 consist of the following voter percentage breakdown: Van Duyne (41 percent); Gears (38 percent); Joe Putnam (14 percent); and Tom Spink (7 percent).

Mayoral candidate Van Duyne received the highest amount of votes with a total of 4,373, but was unable to win the majority. Gears came in second with 3,984 votes trailing by only 389 votes. Gears and Van Duyne both have a loyal voter base. With the first election being a close one, this mayoral race will most likely go till the very end.

Who will truly win or lose in this election is the bigger question minority voters must consider. Irving is a community that is as diverse as its architectural beauty. Based on 2010 U.S. Census data, Irving has a population comprised of 30.8 percent White; 11.8 percent African American; 13.9 percent Asian; 0.4 percent Native American; 0.1 percent Pacific Islander and 41.1 percent Hispanic. Electing a mayor who understands the issues important to its diverse population is critical to the vitality and progression of the city.

Van Duyne touts her professional experience as a senior corporate officer and business owner with respect to her ability to lead and create job opportunities. There have been concerns over the validity of her company, BCI Marketing and Monumentals Inc. North Dallas Gazette has learned in a document submitted by the Texas Comptroller of Public Accountants that both companies held by Van Duyne are not in "good standing as it



has not satisfied all the franchise tax requirements.,,

Transparency is one of the platforms Van Duyne continues to preach on, but has not practiced what she has preached with respect. She has not provided transparency as it relates to the complete nature of of the financial status of her businesses. Irving faces tough economic challenges and in this strained economic climate it is paramount that the next mayor has the business savvy and knowledge to manage, as well as oversee budgets while creating job growth for all residents in both the northern and southern sectors of the City.

Like the City of Dallas, the economic culture of those residents who live in the north vastly contrast to those residents living in the southern sectors of the Irving. Under the current mayoral leadership, Irving is seeing economic development through their Capital Improvement Projects (CIP), but there is a true concern with some community and business leaders that the economic gap that was once ignored in previous local governments will resurface if Van Duvne is elected.

"I have serious concerns that Beth Van Duyne would not be sensitive to the needs of the minority community. When she was on the City Council she had numerous opportunities to show all of Irving the love and she did not seize that opportunity. The current mayor [Herbert Gears] may not be perfect; however, I do believe he tries to do what is best for all of Irving regardless of race or religious background,,, said Don Herring, Jr., owner of Don Herring Mitsubishi and Board Member of the Irving Hispanic Chamber of Commerce (IHCC).

Former Chair of IHCC, Rene' Castilla shares a different view with respect to how Van Duyne would serve the Minority and Women Business Enterprise community. Castilla believes she will be as sensitive to the issues the minority business communities face because she knows firsthand the challenges that come to both minority and women-owned businesses.

"I think as a woman and a business owner she will bring that sensitivity to the office not only because she is a woman, but because the office of the mayor requires it and I think she can do that as well as anybody. To me Beth has grown from the time she was on the City Council to the time she is now seeking the position of mayor and in that growth comes maturity and understanding that we live in a diverse community and she has had to listen and serve all points of that community and I think she will do that as Mayor,,, states Castilla.

North Dallas Gazette reached out to the Van Duyne campaign to allow them the opportunity to answer the questions about the forfeited existence status deemed by the Secretary of State on the two businesses led by candidate Van Duyne, as well as answer questions on specific ways her companies has created economic growth. Unfortunately, we have been unsuccessful in getting a response from her campaign and have been unsuccessful in finding a list of business clients she has served to provide our readers with a track record of Van Duyne's business accomplishments and experience.

Minority voters will also need to take a serious look at the direction they would like to see Irving take as they address Illegal Immigration issues. Candidate Van Duyne has publicly supported the controversial Section 287 (g) under the Immigration and Nationality Act (INA). According to Wikipedia, Section 287 (g) is a Federal Act that authorizes the Federal Government to enter into agreements with state and local law enforcement agencies, permitting designated officers to perform immigration law enforcement functions, pursuant to a Memorandum of Agreement, provided that the local law enforcement officers receive appropriate training and function under the supervision of sworn U.S. Immigration and Customs Enforcement (ICE) officers. Under 287(g), ICE provides state and local law enforcement with the training and subsequent authorization to identify, process, and when appropriate, detain immigration offenders they encounter during their regular, daily law-enforcement activity.

Manuel Benavidez, Irving Civil Rights Activist who received a favorable ruling in July 2009 from Judge Jorge Solis ordering Irving to change the at-large voting system election of City Council members to a singlemember voting system for those districts with a large minority population to insure equal representation of government has concerns. He feels it will give local law enforcement the power to act as ICE agents and could be an open gate to the unfair treatment of Hispanic residents of Irving. Benavidez is concerned the 287 (g) would give local law enforcement full discretion and authority to enforce this federal law when in fact no crime has been committed.

"The police department is certainly not for that particular program and nationally 287 (g) is not producing what it thought it would produce; therefore I do not see it as something that will come before the Council or one of Van Duyne's major initiatives she would intend to do if elected as Mayor.,,

"What is in place now, the Criminal Alien Deportation Program (implemented under Gears watch) is working and is providing the City the opportunity to address the criminal aliens without causing grief to the community atlarge, " comments Castilla.

Historically the turn-out in local elections among minorities are low and it proved to be the case in the May elections. It is the hope of the various business and community leaders that minorities will get out and vote in June.

Community leaders are particularly hoping voters within the minority community will take a stand in this upcoming run-off election. This election is important because the issues that matter the most to the voters who make up the diverse population of Irving could have the power to see those issues move forward in the direction of progress.


"If minorities do not believe their vote will make a difference they will be ambivalent so it is important that they know their vote counts. In an at-large election like this, I hope they know that their vote can make a difference and that their vote could sway the entire election if there is a strong turn-out among minorities,,, added Herring.

that unless the 433 sergeantswho make up the largest percentage of managers in the Dallas Police Department-implement the leadership principles they learned in the course, "we're not going to be successful as a department.'


"Management is an assignment that can be given to anyone," Heidingsfield said. "Leadership is a burden because it carries with it the very high price of leading others, protecting others




