## Veasey's "Fair Texas Plaintiffs" call on Court to overturn GOP Partisan Congressional Map

Texas State Representative Marc Veasey (HD95 - Fort Worth) is leading a group of plaintiffs in filing a federal lawsuit to block the partisan congressional redistricting plan approved by the Texas Republican leadership earlier this summer.

The Republican plan is particularly harmful to vot-

ers in the house district that Veasey represents in Fort Worth and to minority voters across Texas. For example, in order to diminish their impact on elections, the predominately African American and Hispanic urban neighborhoods in Fort Worth have been divided into three different bizarrely contorted dis-

tricts. All of these districts are controlled by Anglo Republican voters who live in suburban neighborhoods.

Explaining why he is leading the legal battle, Representative Veasey said, "I have a duty to fight such an overt attack by the

## Minorities would suffer if Social Security cut

By Earl Ofari Hutchinson (NAM) President Barack Obama is well aware of the devastating impact that any cuts in Social Security, either through direct benefit slashes or a formula change that virtually eliminates or dampens the already abysmally low cost of living increases, would have. In a ringing statement in 2008, then-Democratic presidential candidate Obama flatly said that more than two-thirds of Social Security recipients rely on Social Security for more than half of their monthly income.

But Obama also gave a guarded hint that Social Security might not be the sacred cow that prior Democratic and even Republican presidents have regarded it as. He repeatedly said that his concern was with the long term "solvency" of Social Security. He did not spell out exactly what "solvency" meant or what steps he would take to ensure that solvency. It was apparent that Obama -- even then -- believed that Social Security was in some danger and that some steps had to be taken to shore it up.

Obama, though, left the





## Obama Budget Concessions to the Right of Republican Voters

A recent Gallup poll shows that most Americans support President Obama's plan to raise the nation debt ceiling, set to expire Aug. 2, with a mix of spending cuts and tax increases, especially on corporations and the wealthy. Republican leaders, on the other hand, are resisting any tax increases, a position not favored even by Republican voters.

In the poll, taken July 7-10, only 20 percent of Americans say deficit reduction should be achieved solely through spending cuts. Another 30 percent say it should be done mostly with spending cuts and 32 percent believe the goal should be reached equally with spending cuts and tax increases.

Among Republicans, 24 percent favor an equal split between spending reductions

and tax cuts, 26 percent favor only spending cuts and 41 percent favor reaching the target with mostly spending cuts. Among independents, 30 percent favor mostly tax increases, 28 percent support an equal share of spending cuts and tax increases and 23 percent prefer mostly spending cuts.

The largest share of Democrats – 42 percent – favor an equal split between spending cuts and additional taxes, followed by 23 percent who mostly want spending cuts and 12 percent who favor mostly tax increases.

Writing in the New York Times, Nate Silver noted: "Much to the chagrin of many Democrats, the mix of spending cuts and tax increases that Mr. Obama is offering is quite close, or perhaps to the right of, what the average Republican voter wants, let alone the average

American."

Make no mistake about it, this posturing over the deficit is directly related to the 2012 presidential election. Republicans have concluded that making a deal with a Democratic president, even one who is willing to give them most of what they want, will not help them in the next election cycle. For his part, Obama has concluded that a deal on raising the debt ceiling, even a bad deal, bodes well for his reelection campaign.

New York Times columnist Paul Krugman, an economist, said, "President Obama has made it clear that he's willing to sign on to a deficit-reduction plan that consists overwhelmingly of spending cuts, and includes draconian cuts in key social programs, up to and including a rise in the age of Medicare eligibility.

"...If a Republican president had managed to extract the kind of concessions on Medicare and Social Security that Mr. Obama is offering, it would have been considered a conservative triumph. But when those concessions come attached to minor increases in revenue, and more important, when they come from a Democratic president, the proposals become unacceptable plans to tax the life out of the U.S. economy."

Obama has public opinion on his side yet he is caving in to conservative Republican leaders who are being forced to move even more out of the mainstream by right-wing Tea Party fanatics.

A June 9 poll by Quinnipiac University found that voters will blame Republi-

matter there. However, three years later, that is no longer the case. With the GOP breathing down his neck to cut a deal to slash and burn programs that have profound effect on health, education, and infrastructure spending, nothing is out of bounds and that obviously includes Social Security. In a review of the positions on Social Security of the top three 2008 Democratic presidential candidates Hillary Clinton, John Edwards, and Obama, a summary question was "Does he or she pledge to NOT cut Social Security benefits?" The answer for Clinton and Edwards was an unequivocal "yes." Obama's answer was "no."

That "no" has now ignited alarm and anger among House Democrats at the report that Obama had put the "tweak" of Social Security on the bargaining table to get a budget deal with the GOP. It has stirred even greater panic and alarm among those who need and depend on Social Security the most -- and those are minorities.

There is good reason for their anger -- in fact several good reasons. Social Security has been the jewel in the crown of the Democratic Party's domestic program since FDR put pen to paper in

August 1935 and signed the Social Security Act into law. No Democratic president, and only one Republican president, has dared to even breathe a hint that Social Security should be changed. George W. Bush tried it with his scheme to privatize part of the program, and that failed miserably.

The success of Social Security has rested on two major pillars. It provides a financial lifeline for millions of seniors, sick and disabled, despite the GOP's con job that it is an entitlement program that must be cut. It isn't and never has been. It is self-supporting, has not added a nickel to the national debt, and has provided a major boost to the economy by pumping up spending.

The Social Security "tweak" that Obama reportedly put on the table would change the inflation measure that determines whether recipients get a cost-of-living boost or not. But the bigger reason for the Democrats' panic and horror at the thought of this or any other change to Social Security is that it would spell even greater destitution for minorities.

Two figures tell the devastating impact that any cut in Social Security would have on minorities. Nearly 40 percent

of African-American recipients rely solely on a Social Security check for their income. One out of three African-Americans and Hispanics would sink below the official poverty line without their Social Security payout.

The original idea was that Social Security would strictly be a supplement to the retirement income of older Americans. But as the figures on income and poverty show, that notion has long since been rendered moot. In 2008 only one out of four African-Americans got any income from private assets compared to nearly 60 percent of whites. While more than 40 percent of older whites received income from pensions, the figure for blacks was slightly more than 30 percent.

The massive shrink in public worker employment, the assault on labor union protections, private sector outsourcing, and relentless rises in cost of living, have all sledge-hammered health and pension programs that traditionally were the primary income source for minorities and most workers. Social Security will have to fill even more of the plunging income void for them in the coming years.

It's not just the aged

among minorities that stand to be big losers with any benefit cut or cost of living formula change in Social Security. The burden will also fall heavily on the disabled. African-Americans have higher rates of disability and are more likely to receive benefits from the Social Security Disability Insurance program. They have even less chance than able bodied retirees of supplementing their Social Security benefits with outside income.

The GOP and President Obama will battle over how to slash Social Security. And as always, the biggest casualties of that battle will be those who rely on Social security the most. And that's minorities.

## Mexican-American births outpace immigration

(New America Media) Births have surpassed immigration as the main driver of the dynamic growth of the Mexican-American population, according to a new analysis of U.S. Census Bureau data by the Pew Hispanic Center, a project of the Pew Research Center.



Between 2000 and 2010, the Mexican-American population grew by 7.2 million as a result of births and by 4.2 million as a result of new immigrant arrivals. This is a change from the previous two decades when the number of new immigrants either matched or exceeded the number of births.

The surge in births is attributable to two factors. Mexican Americans, many of whom are immigrants, are younger and have higher fertility than other groups. The median age of Mexican-Americans in the U.S. is 25, compared with 30 for non-Mexican-origin Hispanics, 32 for blacks, 35 for Asians and 41 for whites. And the typical Mexican-American woman ages 40 to 44 (at the end of her child-bearing years) has given birth to more children (2.5) than similar aged non-Mexican-Hispanic (1.9), black (2.0), white (1.8) or Asian (1.8) women.

Meanwhile, the number of Mexicans annually leaving

Mexico for the U.S. declined from more than one million in 2006 to 404,000 in 2010--a 60 percent reduction. This contributed to fewer new immigrant arrivals to the U.S. from Mexico in the 2000s (4.2 million) than in the 1990s (4.7 million). However, the Mexican-American population continued to grow rapidly, with births accounting for 63 percent of the group's population increase.

Mexican-Americans are the nation's largest Hispanic group. At 31.8 million in 2010, they comprise 63 percent of the U.S. Hispanic population and 10 percent of the total U.S. population. Among Mexican-Americans, some 39 percent---or 12.4 million---are immigrants. More than half of these immigrants (6.5 million) are in the country without authorization.

## Changes to Texas Democratic Party delegate selection plan

With the Texas legislative session over and the 2012 Primary Election date certain, the Texas Democratic Party seeks to remind voters of some basic elements of the Texas Democratic Party (TDP) Delegate Selection Plan.

The Texas Delegate Selection Plan maintains the delegate allocation process based on Primary and Convention results, as the TDP was overwhelmingly instructed to do by our State Democratic Convention delegation.

The hybrid Primary-Caucus system allocates delegates based on both the Primary Election votes candidates receive and on the number of supporters who

turn out for precinct conventions after the polls close.

Following the 2008 convention, TDP Chairman Boyd Richie appointed a Commission chaired by Senator Royce West and Representative Jessica Farrar. The Commission was tasked with studying and reporting on the Texas delegate selection process and held over a dozen meetings in all parts of the state, taking testimony from interested Democrats. The Commission recommended several reforms and concluded that the current system, which includes allocation of delegates by convention, was highly beneficial to Party growth and activism.

Under the system, 75%

of the base delegation (208 delegates) will be allocated by the Primary vote, and 25% by the Convention vote. The 29 individuals who are delegates by virtue of position will remain separate from the base delegation. Additionally, there will be 31 Party leaders and elected officials selected by delegates at the Convention, making the total delegation number 268.

The TDP will issue periodic releases on the Plan in the coming months and additionally, will hold 31 meetings (one per senate district) to ensure voters' familiarity and understanding of the Plan.

Additionally, TDP would like to restate that as

At all competitions, Jason's platform was "Stomping Out Obesity." Last year, Jason competed with men from: New Zealand, Africa, Australia, Argentina, Czech Republic, Slovakia, Canada, Albania, and Egypt. Bodybuilders from the USA came from the states of: Texas, California, Nevada, Arizona, Michigan, Florida, Indiana, Oregon, and Utah.

As a result of Jason winning "Mr. Natural Fitness" statewide, nationally, and internationally, Denny Kakos, World President and Founder of the INBA decided to do State competition in Jason's city of choice. Jason chose Mesquite, Texas the city his parents live in.

On Saturday, July 30 the first ever International Natural Bodybuilding Association's Texas State Muscle & Fitness Championships in Mesquite, Texas. It's an all day event in the Performance Hall (Building F), at Eastfield College, 3737 Motley Drive in Mesquite. Pre-judging is at 10 a.m. and the Main Show at 5 p.m. The INBA holds 125 competitions in 40 countries each year including the U.S. (Hollywood, CA and Reno, NV), Italy and Greece. The natural bodybuilding movement has grown in recent years and drug free athletes are receiving more exposure and opportunities than ever. Competitors from across the State of Texas have signed up for the Texas State Muscle & Fitness Championships in Mesquite, including natural bodybuilders from: San Antonio, Lufkin, Dallas, Allen, Henderson, Azle, Plano, Arlington, Mansfield, Richardson, and Fort Worth.

This is a history in the making INBA Competition. For the Texas State Muscle & Fitness Championships, in Mesquite on July 30, 2011, Governor Rick Perry has already sent a letter recognizing the competition and on Saturday evening at

5 p.m., the Deputy Mayor Pro Tem for the City of Mesquite will present a proclamation.

Jason lives the INBA Motto Daily – Train Hard, Train Smart, Train Natural.

"Last year, each competition was more challenging," recalls Jason. I always go in confident that I will win and I do my best. Having two international titles gives me the opportunity to do bigger and better things for myself, my clients, my students, and the State of Texas. I'm proud to be born and raised in Texas!"

This is Jason's second year to compete professionally in bodybuilding with the INBA. This year he did his first competition in Carona, California. He won the first place title for "Mr. Fitness Natural Iron Galdiator."

In addition, Justin Cole, Jason's identical twin brother was encouraged by his brother's success and for the first time competed in Carona, California. Winning first place, Jason and Justin "wowed" the crowd with a "Team Challenge Duo." The twins competed together in a spectacular routine that brought the spectators to their feet in a screaming and standing ovation.

Jason and Justin's second competition together for 2011 will be in Mesquite, Texas on Saturday, July 30, 2011 at the Texas State Muscle & Fitness Championships. In October, Jason will defend his Natural Universe Fitness title in Queensland, Australia; and in Hollywood, CA in November; Jason defends his Natural Olympia Fitness title in Reno, Nevada.

"I enjoy competing in the INBA," said Jason. "I think the INBA is a great idea because there are other athletes like myself who don't take abusive drugs and we need a safe way to participate in the sport of bodybuilding. There's no way we could compete with steroid users."

Jason and Justin became personal fitness trainers as a result of their

mother nearly dying in September 2004 from 7 stress-related diseases. They decided to step in and help save her life without prescribed medication, over-the-counter medication and surgery. Afterwards, the twins changed their college major from International Business to Kinesiology.

There's another side to Jason, an even more personal side of his story that hasn't been told, but needs to be shared. Jason was the first born of identical twins. He was born naturally and his brother Justin was born by cesarean section. This is rare. A skinny and sickly child and adolescent, Jason was diagnosed with a weak immune system, a weak respiratory system, asthma, and chronic eczema. He was hospitalized twice for pneumonia and for over 5 years had to use a nebulizer twice a day. Jason longed to be healthy, strong, and free of asthma and eczema.

At the age of 13, for Christmas, his mother surprised him with a weight set. The next year, his mother enrolled him in Martial Arts to gain discipline and balance. Jason grew stronger and his breathing better. Two years later Jason's mother gave the weight set to the Salvation Army for fear of him becoming obsessed with weight lifting and harming his body. At age 21, Jason left home and got his own apartment. He began working out with a punching bag, doing advanced martial arts, and hand-held weights. Jason reshaped his body and his muscles started developing. Within 2 years, he had the physique he had always wanted.

Jason is the President of Health Wise and Justin is Vice President of Development. Health Wise is a fitness and wellness company. Jason and Justin are 2000 graduates of Rockwall High School in Rockwall, Texas. Jason was employed at 24 Hour Fitness in Lewisville, Texas for 3 years before becoming a full-time train-the-trainer instructor for a national career institute in North Richland Hills. Justin

was employed at the same 24 Hour Fitness for 2 years and is also teaches at the same place in North Richland Hills.

Now that Jason is Mr. Fitness Natural Olympia, he feels that he is in a better position to help others throughout America become fit. He does personal fitness training for over 30 clients each week and along with his identical twin brother Justin teaches 6 to 8 weeks boot camps for the City of Denton and various groups throughout North Texas.

"Obesity is preventable," said Jason. "Exercise and nutrition are the keys to being fit, but fitness begins in the mind. Give me six weeks and I can set anybody on the path to becoming fit."

Last year, Jason's story also featuring his mother Earnestine Cole, first appeared on the Channel 8 News on August 30, 2010 by Health Reporter Janet St. James. The Dallas Morning News featured Jason in the Metro Section on November 6 and November 7. Channel 11 News did a feature on November 10. In 2010, Jason was also fea-

tured in community newspapers: The North Dallas Gazette, LaVida News, and The Dallas Weekly. Jason was quoted in the January 2011 issue of the national magazine Heart & Soul. The article, "Best Body Moves at 20s, 30s, 40s and 50s & Beyond" was written by Tamara Jenkins.

Since, 2007, through his company Health Wise, Jason has volunteered his services in South Dallas and other cities in North Texas to help adults and youth improve their health. In addition, with his mother, Jason co-hosts a weekly radio show on KHVN 970AM at 8:30 a.m. – The Health Wise Talk Show.

Denny Kakos, ABA/INBA/PNBA International President and Founder, held the first INBA natural bodybuilding competition in 1988. Today, the organization is the world's premier natural bodybuilding association and holds 125 competitions in 40 countries. The association is approved and supported for international events by the U. S. Department of State.

The INBA is the largest

drug free bodybuilding and sports organization in the world. "It has been years of integrity, spirit, dedication, and excellence to get us to this point," said Diana Kakos, Denny's wife. "The INBA is fun and positive. It's all about the athletes."

Denny Kakos said there was a need to start the ABA/INBA/PNBA because, "Thoughtful athletes realized that the drug usage associated with strength training and bodybuilding was contrary to good health, sportsmanship, and the true spirit of athletics. People are finally recognizing natural bodybuilding and fitness."

"It's not just about building a good athlete," continued Kakos. "It's about giving back and supporting natural bodybuilding. We will do whatever it takes for you to have an even playing field."



# Black unemployment through local eyes

## Dallas-area residents feel exhausted, pessimistic about employment

Emma West, Kathy Peterson and Jason Powell are all African American. And, they are all unemployed.  
While people of all

these (education and employment) should be his number one priority – and that's us."

In June, the Texas Workforce commission reported the Dallas-Plano-

West said the main reason why blacks cannot find jobs is because they don't have the connections within companies to get their feet in the door. She said while other races find

school to further his education, but he is debating his major.

"I don't want to get hired by another computer company that will turn around and decide to ship

"Outsourcing is the reason why these numbers are so high," he said. "The jobs have left America, but the workers are still here."

Coppell Kathy Peterson is in the same predicament as West. Peterson, who is in her late 50s, has been unemployed since December 2008. Before being laid off, Peterson worked in human resources and information technology. She has a bachelor's of business administration, but few opportunities have arisen.

Peterson said she has attended plenty of job fairs. When she first became unemployed, she took part in various networking groups, where she was able to meet with a resume guru and participant in interviewing classes.

"I was in a networking circle with 15 white women. They are all now employed," she said. "Some of them don't even have a college degree."

Peterson said her experience with job fairs have not been positive. For instance, she recently at-

tempted to individuals with bachelor's degrees or higher.

"Avon, Mary Kay and University of Phoenix were there. They (University of Phoenix and the other schools) were not there to highlight job opportunities; they were there to get you to go to their schools," she said. "Job fairs are a way for companies to get the word out about their business."

Peterson said she will continue to submit resumes, but she has decided to further her education.

"Companies are not hiring professionals with bachelor's degrees because they don't want to pay them what they are worth," she said. "It is especially crushing for the older African American. They would prefer to hire someone younger and pay them less."

Peterson, Powell and West agree that, in today's job market, it is all in who you know.

"You must know someone in the company to get



rates are affected by unemployment, it is astronomically high in the African American community. According to the Bureau of Labor Statistics, in June 2011, the unemployment rate for the general population was 9.1 percent. But, for African Americans the number skyrocketed to 16.2 percent. The number for African American males was 17.5 percent.

There is enough blame to go around. The Congressional Black Caucus has attempted to point fingers at President Barack Obama. U.S. Representative Eddie Bernice Johnson (D-Texas) recently questioned Obama's priorities during a CBC summit.

"Unemployment and education is a common thread among all of us. I have great respect for the president. I knew he was going to inherit a whole lot more problems. I understand all of that, but the people with the least of

Irving had one of the lowest unemployment rates in the state, at 7.9 percent. Jobs exist, but competition for jobs is fierce. During a job fair sponsored by Career Solutions, a nonprofit job-seeker organization based in Euless, at least 60 employers attended, but at least 600 individuals attended the fair.

While the state does not maintain unemployment rates by race or gender, signs show there are still numerous African Americans who are out of work in Dallas/Fort Worth area.

Take Emma West of Irving, a 50-plus-year-old former medical recruiter. West said she has attended job fair after job fair only to see little results.

"For me, I don't see big job fairs as a positive move," she said. "You are like a fish in a can of sardines. There are so many people at these job fairs that you cannot find your own space."

"Those who can extend a hand are not doing it," West said.

Garland resident Jason Powell, 30, has been unemployed since April, when he was laid off from his job with Spring Wireless. At this point, Powell said, his career is up in the air.

"For the first time in my life, I don't know what to do," the father of one said. "I have not started to look for a new job, but I really dread doing it."

Before being laid off in April from Spring Wireless, Powell said he worked for three years as a tech support contractor for the Frito Lay division of the Pepsi Corporation in Plano.

Powell has a computer certificate, and he is thinking about going back to



cans over Obama by a margin of 48 percent to 34 percent if the debt limit is not raised. Additionally, by a margin of 67-25, voters believe that the agreement to raise the debt ceiling should include tax hikes for the wealthy and corporations, not just spending cuts.

The public debate is being framed in the context of lowering the deficit, but that's a smokescreen. The real GOP goal is to shrink the size of the federal government, especially agencies with regulatory power.

Even with public opinion on his side, Obama is unlikely to force Republicans to take a stand. It is part of an increasingly disturbing pattern: President Obama makes major concessions to Republicans in hopes of reaching a bipartisan agreement, but in the end GOP leaders walk away from the table, with the administration gaining nothing in the process.

Mark my word: Republicans are not going to agree to even minor increases in taxes to accompany the draconian cuts in social spending that

Obama has put on the table. They know by now that they can always play a game of chicken with Obama and he invariably blinks.

More than likely, Obama will accept the scheme of Senate Minority Leader Mitch McConnell – the man who said his top priority is denying President Obama a second term – to empower the president to raise the debt ceiling without Republican support.

Under the so-called Plan B, which has been endorsed by Senate Majority Leader Harry M. Reid [D-NV], Congress would empower the president to raise the debt ceiling by \$2.5 trillion in three increments over the next year. Republicans in the House and Senate would seek to pass a resolution of disapproval, allowing them to blame Obama for raising the debt limit. Obama would veto resolution of disapproval, if it passes both chambers. Congress is unlikely to have the two-third votes needed to override the president's veto.

No-drama-Obama is

likely to go along with the scheme and defend it by saying America's economic health was at risk. But Republicans share that responsibility. Obama should reject the McConnell proposal and have a showdown with Republicans more interested in their political fortunes than the future of the country. They should not be given an easy way out.

If Obama walks into the political trap set by McConnell, he will give Republicans the cuts in domestic programs they wanted, no tax revenue will be added to the pot, and the GOP will be able to blame Obama in 2012 for raising the debt. That's not the change we've been waiting for.

## Consumer Financial Protection Bureau becomes official July 21

### Early efforts solicit public comment, address mortgage servicing and Predatory lending targeted to Military

For everyday people who know what it means to be snookered financially, July 21 is a day worth noting. On this date, the federal Consumer Financial Protection Bureau (CFPB) becomes the official consumer cop on the beat, fighting predatory lending in its multiple forms. The office will craft important steps and procedures that together will promote transparency on the front end of transactions and enforcement in the aftermath of alleged violations.

"Consumers deserve the peace of mind that financial companies – both banks and nonbanks – are following the rules," said Elizabeth Warren, Special Advisor to the Secretary of the Treasury. "The CFPB will be able to examine companies that have never

been subject to federal oversight to ensure that no one is gaining an unfair advantage by breaking the law. This will ultimately create fair competition, better product offerings and more transparent markets for consumers."

For the Center for Responsible Lending and other civil rights and consumer advocates, CFPB represents the best available opportunity to correct the current mismatch between the huge volume of consumer needs and borrower needs from a lack of transparency in many financial transactions as well as the lack of one-on-one contact – especially with mortgage servicers.

By the end of July, CFPB expects its staff to include more than 100 examiners operating in Washington and in satellite offices in Chicago, New

York and San Francisco. One of the early bureau efforts will be examinations of the nation's 111 depository institutions with total assets of over \$10 billion. These institutions represent more than 80 percent of the banking industry's assets. CFPB is also authorized to examine all sizes of non-bank mortgage companies, payday lenders and private education lenders; and monitor fair lending, fee structures and marketing practices.

Consumer issues with mortgage servicing were the topic of a July 7 House subcommittee hearing. Testifying in that forum was Raj Date, Associate Director for Research, Markets and Regulation at CFPB. He related the bureau's concerns with mortgage servicing and the lack

**Three Things to Understand**

When Apostle Paul wrote a letter to the Ephesians, he urged the believers to experienced three important things in their spiritual lives that he had personally experienced. As a mentor to the

Ephesians he wanted them to follow his example. He didn't just tell them to do as he said; but to follow him as he follows Christ.

First, as a believer in Christ, God wants your heart enlightened in order to know the hope to which He has called you. God has called each of us to a purpose, a future and a hope. Many people do not nor can they realize the dreams that they envision for their lives. But because Apostle Paul experienced this, he prayed that every believer will experience the joy that the eyes of their heart are enlightened to know a purpose, a future and a hope.

Second, God's desire for every believer is to know that there is an inheritance for each believer in Jesus Christ. There are spiritual riches that are laid up for every saint. If a believer is faithful to God's calling in

his/her life, there is a reward for your faithfulness and trust in God. And, there will be God's peace for the believer.

The third important thing that Apostle Paul wants every believer to experience is the power that is available to every believer. Apostle Paul often exhorted believers not to look at his persuasive words, but the demonstration of the power of God in his life. He wants every believer to know that the same power that is available to him in Christ is available to them. Remember, Jesus said that believers would do even greater things than He did, because He would send the Holy Spirit to believers.

As a believer in Christ, you should pray that God reveals your purpose, your future and the hope that exists inside you; to be encouraged that there is an inheritance

of opportunity for most consumers to even choose their mortgage servicer.

"Mortgage servicing rights can be, and quite frequently are, bought and sold among servicers irrespective of the borrowers' consent. . . I get to choose my pharmacist. I don't typically get to choose my mortgage servicer," said Date. "The current structure of servicing fees creates a strong incentive to under-invest in adequate technology, people, and processes to handle cyclical spikes in delinquencies."

At the same hearing, Mike Calhoun, President of the Center for Responsible Lending was even more direct. "For at least a decade community-based organizations, housing counselors and advocates across the country have documented a shoddy, abusive, and illegal practices by many mortgage servicers, who staffs are trained for collection activities rather than loss mitigation; whose infra-

structure cannot handle the present level of demand, and whose business records are a mess. The harm to which borrowers have been subjected cannot be overstated", Calhoun concluded.

In another recent CFPB development, an ongoing alliance with the nation's military is hoped to stem the illegal foreclosures and other predatory lending that the armed forces and their families confront.

In a joint statement, the military officials said, "Too often our Soldiers, Marines, Sailors, Airmen and Coast Guardsmen are targeted by predatory lenders and they become victims of unfair financial practices. This agreement recognizes the crucial role financial readiness plays in mission readiness and we look forward to partnering with the CFPB to vigorously protect service members and their families from unlawful acts or practices by providers of consumer financial products or serv-

ices."

With these and other activities begin implementation, the public is also being asked to provide input on a key element of the agency's non-bank oversight program. Consumers who may have wished there was an office to listen and act on their pleas for financial fairness, now is the time to speak up.

CFPB needs to know how lenders have mistreated customers or misrepresented their products. Right now is the public's chance to help shape the rules that affect a range of alternative financial services that operate in many urban neighborhoods.
