# New effort begins to identify discriminatory mortgage lending

Many times consumers question whether complaining about a financial problem will ever do any good. Now, thanks to a new initiative by the federal Consumer Financial Protection Bureau (CFPB), no one needs to wonder anymore. Beginning December 1, the consumer watchdog agency is asking consumers to tell them about unfair or illegal practices that occurred be-

fore, during or after getting a mortgage loan. The agency promises to give every complaint a fair review, and it will also use the information gathered as a guide when considering new consumer protections.

The CFPB should exnect to get an earful. A wealth of research documents how communities of color have borne the brunt of predatory lending and the foreclosures that followed. Too many African-Ameri-



## **Myrlie Evers-Williams**

In an honor bestowed on only a handful of individuals, the United States Navy selected NAACP civil and voting rights icon Medgar Evers as the namesake of their newest ship. Christened in San Diego, California on November 12 by his widow Myrlie Evers-Williams, the USNS Medgar Evers (T-AKE 13) will serve as a supply ship for the Navy starting in the first quarter of 2012.

"I am just so honored for Medgar and all of the other people who gave their lives in the civil rights movement, particularly those in Mississippi. In my humble estimation, very few of them have received rightful acknowledgment of their contributions," remarked Evers-Williams. "He was a man who did believe in this country, and he believed in his people. He wanted things to be just and fair, and he was willing to work for that."

Medgar Wiley Evers, an

Army veteran, was born and raised in Mississippi, where, after completing his military service in 1946, he returned to earn his degree from Alcorn Agricultural and Mechanical College (now Alcorn State University). After graduation, Evers began working on behalf of the NAACP in the fight to end segregation. In 1954, Evers became the first NAACP state field secretary in Mississippi.

As field secretary, Evers organized boycotts and demonstrations to bring attention to the pervasive discrimination and urge an end to racial injustice. He also led the investigation into the murder of Emmitt Till, who, at the age of 14, was killed for talking to a white woman

Evers may be best remembered for his fight to secure voting rights for all Americans. He helped lead the charge for voting rights Mississippi, organizing voter registration



forts across the state.

After returning from an NAACP meeting on June 12, 1963, Medgar Evers was assassinated outside his home by a member of the White Citizens' Council. Just two months before his murder, Evers anticipated that his work for civil rights would bring about his demise. "I expect to be shot anytime I step out of my car... if I die, it will be in a good cause."

Evers murder served as one of the catalysts for President John

# **SCLC** seeks assistance from the Justice Dept

Reprint of letter sent to the U.S. Department of Justice

Ms. Carmelita Pope Freeman Southwest Regional Director U.S. Dept. of Justice Community Relations Service

The Fort Worth Chapter of the Southern Christian Leadership Conference

(SCLC) requests federal intervention to secure relief from the City of Fort Worth, Texas Police Department's pattern of excessive use of deadly force that endangers the black and brown communities. We believe that ingrained institutional racism has allowed this egregious behavior to flourish in the police ranks.

We have reliable information from high level City

of Fort Worth officials that the mayor, city staff, police department and the overzealous Police Officers Association will continue to ignore our concerns and persist in their oppressive actions toward the minority communities. We have attempted futilely to seek remedy directly from the Fort Worth Police Chief Jeffrey Halstead through face-to-face communication. We are left with no al-

ternative but to pursue federal assistance. [2]

Since 2004, there have been six questionable deaths (five by Tasers and one by shooting) by the Fort Worth Police Department. We believe the City of Fort Worth's and police administration's failure to properly recruit, train and supervise the officers have enabled this pattern of excessive use of deadly force

can and Latino borrowers received high-cost, risky mortgages when they could have qualified for lower-cost and more sustainable loans. Now foreclosures are happening more quickly in communities of color than anywhere elsea curious phenomenon when one considers that white homeowners hold far more of troubled home loans. By one estimate, Black and Brown communities have lost \$350 billion of wealth during this Great Recession, according to the Center for Responsible Lending (CRL). Even worse -- these communities already had the least to lose.

During the subprime boom and long before the CFPB was formed, there was no shortage of mortgage-related complaints—but very few received serious consideration. Responsibility for mortgage protections was parceled out among at least half a dozen regulatory agen-

cies, some of whom were very friendly to the lenders they were supposed to be monitoring. Now, with the CFPB on the job, we can expect a much sharper focus on consumer complaints and a stronger commitment to resolving them.

For any doubting Thomas that remains cynical about progress on consumer complaints, consider what happened when the CFPB asked the public to share their problems with credit cards. Between July 21 and October 21 this year, the Bureau received 5,074 complaints. Of these complaints, 74 percent have now been resolved. Issues raised involved billing disputes, identity theft and other fraud.

We now know that 397,000 African-American families lost their homes on mortgages made between 2004 and 2008. Some opponents of reform try to blame

affordable housing programs, but the facts don't support that position. Wall Street became ravenous for the most dangerous types of loans, and lenders obliged by aggressively marketing them without bothering to underwrite. Moreover, CRL's most recent research shows that borrowers of color with higher incomes and good credit scores received riskier loans than similar white borrowers.

The result has been tragic for the families involved and also crippling to the entire economy. The CFPB represents a genuine effort to make sure this doesn't happen again. The Bureau is now open for business, and it wants to hear consumers' side of the story. Individuals may

file complaints related to any part of the mortgage process, including the wrongful denial of a loan, overcharges on lending fees, problems with the way mortgage payments are collected, and abuses related to foreclosures.

# Medicare gives employers, consumers information to make better health care choices

Consumers and employers will have the health care information they need to make more informed choices about their care, thanks to the Affordable Care Act, the Centers for Medicare & Medicaid Services (CMS) announced in a final rule today.

The rule gives qualified organizations, like employers and consumer groups, access to data that can help them identify high quality health care providers or create online tools to help consumers make educated health care choices. Information that could identify specific patients, however, will not be publicly released and strong penalties will be in place for any misuse of data.

"This is a giant step forward in making our health care system more transparent and promoting increased competition, accountability, quality and lower costs," said Marilyn

Tavenner, Acting CMS Administrator. "This provision of the health care law will ensure consumers have the access they deserve to information that will help them receive the highest quality care at the best value for their dollar."

For years, employers, consumers, and health care quality advocates have expressed frustration about the limited and piecemeal availability of Medicare data that could be used to help evaluate health care provider or supplier performance. Although many health plans have created provider and supplier performance reports, these reports are based solely on the health plans' own claims, and do not reflect information from other health plans, including Medicare.

Providers, too, have expressed frustration at receiving performance reports that are piecemeal and


produced without an opportunity for review and correction. This final rule creates a framework for providers to receive a single, actionable performance report covering all or most of their practice.


The final rule makes a number of important changes from the original proposed rule. The final rule makes this data less costly for qualified entities, gives qualified organizations more flexibility in their use of Medicare data to create performance reports for consumers, and extends the time period for health care providers to confidentially review and appeal performance reports before they become public. The rule also includes strict privacy and security requirements to protect patients, health care providers, and suppliers as well as stringent penalties for any misuse of Medicare

# The buck stops here: Santa Bucks help North Lake college students in need

lege students find their budgets cannot make ends meet, they do not always go to a local discount store They know their Blazer Bucks (and, on Nov. 30, their Santa Bucks) make a difference in their lives; at North Lake College, where they can buy food, gentlyworn clothing and toys, or necessities they might not otherwise be able to afford.

Instead of doing without, they can take their Blazer Bucks to the new, permanent Blazer Student Store where they can feed and clothe themselves and their families, provide toys for their children and even volunteer to work in the store to help pay their way. Most items in the store cost one Blazer Buck, and everything is donated by the college's faculty, staff or students – or sometimes brought in by students to trade for other items. It's a thrift store that uses Blazer Bucks for currency.

And the concept came from students themselves 10 years ago, when journalism majors for the campus newspaper, the North Lake News-Register, tried to think of ways to help students make it through the holidays.

"In fall 2002, the News-Register staff and Journalism Club members began to hear stories of hardships among students, the result of a post-9/11 economy,' recalled Kathleen Stockmier, student publications

When North Lake Col- manager at the college. "The rising unemployment rate triggered an increase in college enrollment, and many at North Lake needed help. Christmas was approaching, and it was going to be a bleak holiday season for many.

> 'So the writers and editors brainstormed and came up with an idea: send out a campus-wide e-mail; ask for donations of food, clothing, housewares and miscellaneous items; and give it all away free to students by using a play-money sysknown as Santa tem Bucks," Stockmier added.

> And that's how Santa Bucks were born. Generous donations came in from the North Lake College family, and students who signed up on the day of the event received \$20 in Santa Bucks to purchase what they needed. Nine years later, the Bucks project Santa evolved into the Blazer Student Store, which offers help to students year-round. (Canned foods and non-perishable items now are called the Blazer Food Bank sup-

run by students for students, receives money from a fund set up by the News-Register. Portions of the campus newspaper's advertising revenue is deposited into the store's account on a regular basis - money which already has paid for shelving, printing and miscellaneous supplies to get the new facility off the ground.

The sustainable store,

Students obtain their Blazer Bucks several ways: by trading items from home for bucks; by earning them in the classroom; by winning them at campus events; or by purchasing them in the cashier's office on campus. Students who are experiencing a hardship also are given Blazer Bucks for Blazer food vouchers free of charge - no questions asked

This year, on Nov. 30, students used their Santa Bucks (the holiday version of Blazer Bucks) to buy Christmas gifts and items they need to get through the holidays. Students who presented their IDs and signed in at the cashier's office received \$30 in "currency" to spend in the store. That day,

their Santa Bucks bought three food items for \$1 (usually one item for \$1). More than 200 students stopped by to get their Santa Bucks and shop in the store, in addition to service learning students who worked on set-up, signing in shoppers, bagging goodies, serving as cashiers and helping students take their purchases to their cars.

Melissa Firestone, a nursing major at the college, wrote a letter to the editor of the student newspaper about the Blazer Student Store. "I recently decided to get my associate degree in nursing, so this fall I came back to college. I had to tighten the reins on my budget so I could make this happen. (People in) the

Blazer Store told me all about this great resource offered to North Lake students. I found it a blessing since I am not able to go out and spend like I used to.

"They told me I could bring in my gently-worn clothing and exchange items for something in the store," Firestone added. "The first time, with my budget counselor in mind, I spent the bucks on grocery items. What a deal!...Thank you to the people who run the student store." She has volunteered to work in the store and also won a drawing for a gift card to use in the bookstore.

NLC student Jessenia Gutierrez has used Blazer Bucks in the past to buy a

gift or to purchase jewelry, which she likes, and she also bought this year's Christmas gifts there, too."The Blazer Store is important because sometimes I'm low on cash and, if I need a gift, I can just trade in an item instead of going shopping," she said. "The Blazer Store has helped me learn not to be such a wasteful person. I know I can trade in items instead of throwing them away. I believe it will help during the holidays - I actually already have some small gifts for my family, so I'm set for Christmas!'

The Blazer Ambassadors, a campus club whose mission is to increase participation in student life activities, are in charge of ensuring that the store's workers are on time, and they fill in for those who can't make their shifts. Service learning students work those shifts and acquire community service hours for volunteer-

Stockmier is proud of the effort started by journalism students that now has become a permanent, sustainable program on campus that helps students. "This year, when the oneday Santa Bucks event shuts down, we won't have to say: 'It's a shame the students can't be helped yearround.' Now, the Blazer Student Store is doing that every day, with no end in



# We Are Not Trash: **A ONE Dallas Movement**

# Paul Quinn College Students and Highland Hills Community Speak Out

At the center of the "We Are Not Trash" (W.A.N.T.) movement swelling on the Paul Quinn College campus and in the Highland Hills community is Dexter Evans. He is more than just an ordinary college student, Evans is a campus organizer and is quickly becoming the unifying voice of this entire southern sector

"This is an ongoing problem. The city officials

yond the walls of the college early this fall.

Evans explained, "We switched to emphasize that this is not a Paul Quinn College issue, it is a Highland Hills, Southern Sector and a ONE Dallas movement."

Paul Quinn College president, Michael Sorrell said students saw the social disparities in the area, became aware of the proposed McCommas-Bluff Landfill expansion, and used this as a dual opportunity to see how government works and to better the community.

students and representatives from the Dallas Democratic Party, LULAC, a local pastor's coalition, the Highland Hills community, Friendship West Baptist Church, Concord Missionary Baptist Church, and St. Luke Community Baptist Church.

The denial of the study prompted Sorrell to offer a long-term option that would conclude the said haphazard, piecemeal approach to developing the southern

"The college offered to pay for a full community

plan to be developed for the area instead," shared Sorrell.

His request was also denied by the city. With the ex-

pansion looming, one of the movement's points of contention with the city lies in the unanswered auestion. "Where was the study when you decided to vote and make a public-policy decision that will

impact economic development?" Evans asked..

"We want a study for our community [conducted] by the city of Dallas. The study is important to make a decision after the research has been properly conducted," said Elizabeth Wattley, director of the Food for Good Farm at Paul Quinn College and the W.A.N.T. campaign event organizer. "We do not know [the economic benefits] if we do not have a study.'

Currently, plans to expand the Mc-Commas Bluffs Landfill. Vision of the city is to devise a system to recapture discarded trash, sort those

materials which can be reused, and save the rest for later use as new technologies develop. By collecting all of Dallas' waste at Mc-Commas Bluff Landfill, Dallas will have more of its resources available for use as future resource recovery facilities. The completion of this project would make this landfill the largest dumping ground in the southwest region of the United States but still leaves obscurity regarding the economic benefit to the area.

The W.A.N.T. movement does not appear to be firm set against the landfill expansion, but wants the city to take the proper steps to truly revive this area. The Highland Hills community is about one and one-half miles away from the landfill and almost 6 miles away from full-service grocery stores and other retail establishments

"We are hoping for more economic development. The post office, library and other things are being stripped from this community," Wattley said. District Councilman

Tennille Atkins unveiled a

plan to spend \$100,000 on the conversion of an abandoned Popeye's Chicken building into a convenience store that carries fresh food and vegetables. Sorrell, Evans and Wattley agreed that this should not be seen as real means to impact the conditions of the area.

"The convenience store is a great step, but would we be celebrating this if we were north of the Trinity River? We would like to have a grocery store that has all the amenities of another community," Wattley

"It is like smoking mirrors. They are throwing a store at you to shut you up," Evans said.

W.A.N.T. has some successes such as the dramatic increase of supporters and sponsors along with seemingly shift toward the middle with the budget approval passing 8-7, as opposed to the 13-2 passing vote at the project's proposal. Yet, the group is committed to continuing the fight for equal consideration in the southern sector.

"We will continue until there is social equality," Wattley said.

Sorrell said he supports the W.A.N.T. movement and sees this experience as an academic win for the stu-

"We have ability to show people that the Quinnite method works," he began. "At Paul Quinn, we teach the students to solve the problems that matter and the students are learning the value of putting the teaching into practice.

Paul Quinn College, the 2011 HBCU of the year, also stresses service, the concept of We over Me, and the four L's – Lead from where you are, Live a life that matters, Love something greater than yourself, and Leave a place better than you found it.


Evans' actions to date seem to align with the principles and show his ability to lead in the spotlight.

"I was always a leader, and I stood up for what I believed in," said the former high school drum major and student council president. "I am motivated by standing up for those who cannot or are not speaking up for themselves." In addition to the We Are Not Trash Movement, Evans also organized Stand Up Highland Hills, a joint Paul Quinn College and Highland Hills community event held on Labor Day that served as the springboard for the movement.

# Jobs Act – a free money buzzer for small businesses?

Small business owners should be planning now for how best to invest their windfall if Congress passes all the American Jobs Act incentives, says consultant Richard B. Sanford. Otherwise, they may quickly find themselves overextended.

"The jobs act rightfully emphasizes freeing up money so small business owners can hire new workers," says Sanford, author of Success by Design (www.ssbp.biz), a guide to simplified strategic business planning.

"One of the provisions is a payroll tax holiday on up to \$50 million in wages for new workers or raises for existing ones," he says.

"Businesses need to look at juicy carrots like this with a critical eye: This is a temporary tax holiday," he says. "As proposed, it applies Jan. 1 to Dec. 31, 2012. But those payroll additions likely will be on the books long after the holiday ends."

Businesses should be analyzing their market and their company now for ways to expand sales income and increase profits. They should execute those steps before they hire the first new worker, Sanford

"If they can look ahead and see a sustainable increase in income and profits with the bigger payroll, taxed at the full 6.2 percent rate, that's a green light for hiring," he says.

Other provisions of the jobs act include up to \$4,000 in tax credits for businesses that hire people who've been out of work for at least six months. Employers would get a tax credit of up to \$5,600 for hiring a veteran who's been iobless for six months or longer, and up to \$9,600 for hiring a vet with a servicerelated disability.

"While those credits are

enticing, keep in mind hiring is much riskier for a small business than a large one. For very small businesses, one bad hire can be disastrous," Sanford says. "You should expect each hire to produce at least three times his or her salary in revenue

"So while giving a veteran or a long-term jobless person work is laudable, employers need to approach those hires with the same care and caution as they would if there were no incentive. To justify the long-term employee expense, these new hires must be able to provide productive services for their employer and customers."

Employers likely will also need to verify through unemployment claims how long the person has been out of work, he added.

Other small business incentives in the jobless

•Encourage businesses to invest in equipment by extending the current 100 percent expensing write-off into 2012

•Help for small business contractors that want to bid on infrastructure contracts and get Small Business Administration surety bonds.

•Make it easier for jobless people to start their own small businesses by allowing them to use unemployment insurance money for up to 26 weeks. Currently, only some states consider jobless entrepreneurs eligible for unemployment payments. This provision would allow all 50 states to establish Self-Employment Assistance programs.

•Raise the cap on small businesses' "mini" public offerings from \$5 million to \$50 million and reducing the costs for smaller companies to go public.

cracked, cut, torn, streaking or chattering.

An emergency road kit is something that can be easily compiled or purchased. A kit should include an ice scraper and snowbrush, jumper cables, flashlight, flares, blanket, candles/matches, bottled water and dry food snacks.




