Is the Voting Rights Act worth saving?

Forty-five years ago, displaying the courage of a true Texan, President Lyndon B. Johnson signed the historic Voting Rights Act into law. His actions signaled the end of a generation of government sanctioned discrimination and ensured that minority citizens would have legal protection to register, vote, and an opportunity to elect a candidate of their choice. Today, however, two GOP Texans – Rick Perry and Gregg Abbott - are work-

ing to turn back the clock. They want to destroy the Voting Rights Act and return to a day when governments sanctioned racial discrimination.

That's the real issue at stake in the Texas redistricting battle. When Greg Abbott asked Supreme Court to block the use of the court-ordered redistricting plans in Texas, he was stepping up as the leader of the darkest most divisive forces in our society who

The conference will be held:



Move over, Caped Crusader! Hit the cave Bat Woman! Make room for the real-life "Dynamic Duo!" Renowned entrepreneur and "Success Against the Odds" author, Vonda White is joining forces with Orrin "Checkmate" Hudson, author of "One Move At a Time" and two-time World Open Speed Chess Champion, to improve lives

Org), an organization that uses the game of chess to teach successful life skills. "He's got a way with kids that's miraculous," says actress and philanthropist Jane Fonda,

who had Hudson give lessons to young people who were in her teen pregnancy-prevention campaign.



Raised in a housing project with 12 brothers and sisters, Hudson was struggling in school and stealing tires -

until an English teacher, James Edge, took the 14year-old aside and started teaching him chess to give him focus. Soon Hudson was playing college kids. "Chess changed my life," recalls the father of five. "I learned every move you make has consequences."

As a teacher, motivational speaker, and now an author of "One Move at a Time," Hudson expertly weaves chess strategy with 20 important life lessons in a suitable read for all ages. He has taught more than

20,000 youth to have better focus and decision-making skills through the game of chess.

want to erase the US Voting Rights Act.

In a live radio interview last week, top Texas GOP operative and Rick Perry insider, Ted Delisi, removed any doubt that Perry, Greg Abbott and the Texas Republican leadership see the Texas redistricting litigation before the US Supreme Court as a chance to end the US Voting Rights Act.

During an interview on Houston radio News 92 FM, responding to a question from host Scott Braddock, Delisi bluntly said it's time for the Voting Rights Act to be "history."

If allowed, Greg Abbott, Rick Perry and the current Texas leadership will tear down every barrier in place that might stop them from destroying the voting strength of Latino and African American citizens, not just in Texas, but everywhere across our nation.

What did the Supreme Court do?

At the request of Greg Abbott, acting on behalf of Rick Perry and the Texas leadership, the Supreme Court issued an order temporarily blocking the use of the legislative and congressional plans ordered by a Federal District Court in San Antonio for the 2012 elections. However, the Supreme Court did not order that the discriminatory plans passed by the Republican Legislature be used. Instead, the Court will hear arguments from both the Republicans and plaintiff groups opposing them to determine what criteria lower Courts should use when determining the boundaries of the not yet pre-cleared redistricting plans. What will Abbott and his allies argue?

Texas Republicans and

their extremist national allies will argue for the virtual elimination of Section 5 of the US Voting Rights Act. They will claim that maps passed by state legislatures – even those like Texas that have a long history of racial discrimination – should be implemented even if they have not yet been reviewed to ensure they do not discriminate against minority voters. What will Plaintiffs supported by the Lone Star Project argue?

Lone Star Project-supported plaintiffs and our allies will argue for the preservation of the standard of law that has stood for a generation. Simply stated, any redistricting plan passed by a state covered under the Voting Rights Act must be pre-cleared to ensure against racial discrimination. If a State like Texas intentionally delays pre-clearance or seeks to avoid it altogether, a Federal District Court must step in to draw new lines and. in doing so, use the existing lines as the baseline and not the likely discriminatory lines approved by the State. (Reponses to Stay Request: MALC, Texas NAACP, LULAC, and Perez (Dutton) plaintiffs, Davis/LULAC state senate response)

The Voting Rights Act itself hangs in the balance on the Texas redistricting decision. Plaintiffs opposing Texas Republicans must have the legal resources to make the strongest argument possible before the Supreme Court and before Courts with jurisdiction to save the Voting Rights Act.

150th Anniversary of Watch Freedom Night and Jubilee Day

This year as in years past, many African-American churches will convene on December 31, 2011, New Year's Eve, for what has become known as "Watch Night Services." While traditionally observed by African-Americans, Watch Night Services originated in the 1800's with John Wesley, the founder of Methodism. It

was to be a time when members would gather and recommit their lives to the faith as they entered a new year, sometimes called Covenant Renewal service.

For enslaved Africans, however, the gathering took on different meanings. First, for plantation owners this was a time for them to take stock of their property. They also paid off debts at the beginning of the new year. Because Africans were considered property, December 31st would be the last time many of them would see their family or friends, so they gathered one last time in church before they were separated from each other for life.


Secondly, Watch Night took on another meaning during the Civil War. Frederick Douglass, Harriet Tubman, Senator Charles Sumner, Senator Thad-

deus Stevens and other abolitionists worked to encourage President Lincoln to issue the Emancipation Proclamation to free enslaved Africans in the Confederate states that rebelled against the Union. On that night, December 31, 1862, many enslaved African men and women and their families gathered to hear "the word." Then at midnight in many African-American churches, "the word" came that President Lincoln had signed the Emancipation Proclamation. After midnight, African men and women, who along with their ancestors had experienced over 244 years of slavery in America, began thanking God for the dawn of freedom.

The next day, January 1, 1863, became known as "Jubilee Day" to the newly freed African men, women and children. They enjoyed a freedom feast of collard greens, yams, black-eyed peas, roasted meats pies and cakes. They sang songs and played games of all kind as they reminisced on slavery's past and mused on freedom's future.

Today, remarkably few African-American churches and families know the history of "Watch Freedom Night" (Freedom's Eve) December 31st and "Jubilee Day" January 1st. While many celebrate June-

Sunday Pork Roast with Vegetables

Once you get this easyto-assemble dinner in the

oven, you can sit back and relax. A small amount of brown sugar and apple juice sweeten the pork, and the vegetables get a lot of flavor from the pan juices. This recipe provided by the American Heart Association is a tasty but healthy version which those suffering with diabetes can enjoy. Ingredients

Cooking spray 1 1-pound boneless center-cut pork loin roast or pork tenderloin, all visible fat

discarded

tablespoon

frozen apple juice concentrate, thawed



1 1/2 teaspoons light brown sugar

1 1/2 teaspoons garlic powder

1 1/2 teaspoons dried oregano, crumbled

1 1/2 teaspoons dried thyme, crumbled

1 1/2 teaspoons paprika 1/2 teaspoon pep-

2 small red potatoes, cut into 1/2inch cubes

1/2 cup baby car-

1/2 cup bite-size cauliflower florets

1/2 small zucchini, cut into 1/2inch cubes

1/4 small red onion, cut into 1/2-inch dice

Preheat the oven to 375°F. Lightly spray a 13x9x2-inch baking pan with cooking spray.

Brush the pork on all sides with the apple juice concentrate.


In a small bowl, stir together the brown sugar, garlic powder, oregano, thyme, paprika, and pepper. Set aside 1 teaspoon of this mixture. Spread the remaining mixture all over the pork, pressing so it adheres. Put the pork in the baking

In a medium bowl, stir together the potatoes, carrots, cauliflower, zucchini, onion, and reserved 1 teaspoon brown sugar mixture.

Place around the pork. Lightly spray the pork and vegetables with cooking

Bake for 55 minutes to 1 hour for the pork loin roast (40 to 45 minutes for the pork tenderloin), or until

the pork registers 160°F on an instant-read thermometer and the vegetables are tender when pierced with a fork. Cover loosely with aluminum foil. Let stand for 5 minutes before slicing the

• HOV - The high occupancy vehicle (HOV) lanes on I-30 (East R.L. Thornton), on I-30 West (Tom Landry Freeway), the reversible S-ramp at the southern end of the I-35E (Stemmons) HOV lane, the direct connector ramp between the US 75 and I-635 HOV lanes, and the section of the I-35E/US 67 (South R. L. Thornton/Marvin D. Love) HOV lanes from downtown Dallas to Loop 12 will all be closed. The remaining portion of the I-35 (Stemmons) HOV lanes, the I-635 (LBJ) HOV lanes, the US 75 (Central Expressway) HOV lanes, and the I-35E/US 67 HOV lanes from Loop 12 to Camp Wisdom Road will be open 24 hours a day as usual.

Forgetting the Iraq War

(New America Media) American wars used to end decisively. When Americans came back from defeating the Germans after World War II, there were ticker-tape parades. When the last U.S. helicopter lifted off from Saigon, Vietnam on April 30, 1975, the image seared deep into the American psyche; it spelled an ignominious end.

For the first time in its history, America had been defeated. Its ally, South Vietnam, fell to communist hands. Several generations grappled with their nation's foreign policies and the meaning of such "hell in a small place," reexamining their role in the war, whether as participants and supporters, or dissenters and protesters. Vietnam changed the nation's outlook on the world and its place in it. Since then we have been trying to kick the Vietnam syndrome. We have been searching for vic-

Fast forward to Dec 15, 2011.

The last of American troops made their way across the border to Kuwait from Iraq, a short trek and uneventful one. After nearly nine years, the United States declared the end of its military operations in Iraq. In a solemn note, Secretary of Defense Leon Panetta, in a low-key ceremony at Baghdad Airport, said, "The cost of war was high... blood and treasures of the Untied States and Iraqi people. But those lives have not been lost in vain — they gave birth to an independent, free and sovereign Iraq." He then flew out to Turkey to attend a more important meeting on the other war where blood and treasures continue to be spent -- the one in Afghanistan.



The war in Iraq started with Operation Shock and Awe but ended in a fizzle and, some would argue, in an epic exercise in human futility. Neither victory nor defeat was immediately clear. Instead, with the last of the American troops gone (even as thousands of mercenaries are left behind), the meaning of the war is muddled, leaving in its wake more questions than answers.

Is this the victory we had hoped for since Vietnam? Is this what we could muster nine years after we invaded, supposedly to find weapons of mass destruction? Is Iraq truly a free and sovereign nation, given the unending conflict between Shiite and Sunni Muslims? And even if it is, was it worth the squandering of American blood and treasures, not to mention the killing of Iraqi civilians in "collateral damage"? Why liberate Iraq and not, say, North Korea? Why freedom and sovereignty for Iraq, if that was truly our purpose, and not, say, Tibet or Cuba? And if our national interest

was at stake, have we protected that interest now that we have spilled precious blood and depleted our national treasury? Why Iraq?

Historians will bicker over the answers. What is certain, however, is that the war in Iraq claimed 4,487 American lives, and left 32,226 Americans wounded, according to Pentagon statistics. According to Iraqbodycount.org, the number of Iraqis who died from violence ranges between 103,000 and 114,000. The United States spent nearly \$3 trillion fighting it, and with another exorbitant war still waging in Afghanistan, the result is a bankrupt U.S. economy. After all, in 2000, the U.S. economy had a \$230 billion surplus. In 2011, U.S. debt is at \$15 trillion and growing. That's \$1.3 trillion a year going South.

We closed a chapter in Iraq but the book of the War in the Sand is still being written. One is left with an unsettling feeling, a bitterness in the mouth. We lost more than we hoped to gain. It's not defeat exactly, but in

an age of perpetual war, it's clearly no victory.

Our troops are barely out of Iraq, and we can't wait to move on. News of the war's end competed with news of the typhoon in the Philippines and the death of North Korea's Kim Jong Il, and the endless fights in Congress over whether to extend the payroll tax cut.

It's as if there is a collective will to forget in this country. Let's forget Abu Ghraib, where we tortured and sexually humiliated our captives. Let's forget about the weapons of mass destruction, since we couldn't find any. Let's forget Haditha, where a My Lai-style massacre took place by our drunken soldiers. Let's forget water torture being condoned and supported by politicians. Let's forget extraordinary rendition where we kidnapped thousands of world citizens and flew them directly to secret prisons for interrogation. Let's forget that there's a Guantánamo where political prisoners are still being kept without due process. Let's

forget the 2 million displaced Iraqi refugees. Let's forget all the lies and deceptions we've been spoonfed.

Let's just move on.

It is worth noting that as the war in Iraq drew to an end, Congress passed a defense budget at a whopping \$662 billion with flying colors. There was no fighting to speak of in a Congress known for its bickering and quarrels. There was no controversy over spending that amount of money among elected officials otherwise known for their push to cut basic services. No doubt much of the funds will go to high-tech weaponry and better drones - a remotecontrol war that is increasingly replacing ground operations.

At last month's Occupy Movement rally in San Francisco, before it too fizzled out, there was a lone placard that said "U.S. Out of Iraq and Afghanistan." It stood out among a litany of grievances against the federal government over domestic issues: "Give Us Back our Dream!" "Give Our Homes Back!" "99% against 1%." The outrage was against wealth inequalities in America, not what the empire is doing overseas.

The violent works and aggression of empires seem to depend proportionally on the complacency, and therefore tacit approval, of their citizenry. The war industrial complex needs to be fed. Victory may no longer be needed. As long as we can afford it, and even when we can't, we seem destined to wage war.

For all of the horrors committed in the name of democracy, and all of the soul searching Americans did after the Vietnam War—remember that '70s mantra, "No More Vietnams!"—we failed to alter the bellicose direction of our nation.

Years ago, the poet Robert Bly argued that Americans have yet to experience ablution over past atrocities. "We're engaged in a vast forgetting mechanism and from the point of view of psychology, we're refusing to eat our grief, refusing to really eat our dark side," Bly told Bill Moyers on national public television. "And therefore what Jung says is really terrifying -- if you do not absorb the things you have done in your life...then you will have to repeat them."

In this sense, individual karma is not so different from that of a nation. Perhaps it is our country's fate to keep repeating acts of barbarism until we come to some profound reckoning with our own heart of darkness.


Lawyer releases urban fiction novel

until a special session in June to even hold a hearing on congressional redistricting and did not pass a plan until June 25. And it wasn't until July 19 that Governor Perry got around to signing the congressional plan.

Attorney General Greg Abbott then bypassed the shorter process of seeking preclearance through the US Department of Justice and opted for the much longer process of going through the Federal District Court in Washington, DC. On two separate occasions, Abbott refused an offer by the DC District Court to conduct an early trial. Instead. Abbott filed a motion

Instead, they waited for summary judgment which delayed the process for over six weeks.

> There's been a lot of talk about the delays and why things happened the way they did- including criticism the state's handling of the case from people like Republican State Senator Carona. Did the state just mess up or do you think this is part of an overall strategy?

What's happened is exactly what Texas Attorney General Greg Abbott and the Texas Republican leadership had in mind when they planned their redistricting strategy. By carefully orchestrating a series of legislative delays, timeconsuming legal maneuvers and old-fashioned footdragging, the Texas GOP avoided the formal preclearance review required for Texas redistricting plans and have set the stage to dismantle the US Voting Rights Act.

The state's now arguing that its maps should be used on an interim basis because there isn't enough time to have the San Antonio court get guidance from the Supreme Court and draw new interim maps. Doesn't that end-run section 5 of the Voting Rights Act?

Yes. Because of the delays, the state now can attack the Voting Rights Act indirectly by arguing that the federal courts must defer to State Legislative maps even when those maps have not been reviewed and found to be free of racial discrimination. If the Supreme Court agrees with the Texas Republicans, the Voting Rights Act will no longer stand as a meaningful shield to block racial discrimination in redistricting plans.

After the 2010 Census, Texas was awarded four additional congressional seats only because the Latino and African American population in the state exploded. Almost 9 out of every ten new Texans over the last

decade are Hispanic or Black. If Texas had grown at only the rate of its Anglo population, the state would not have gained a single new congressional seat.

Texas Republicans have chosen to be the point in the spear that guts the US Voting Rights Act. Almost a year after release of the 2010 Census and stark confirmation that the Texas Anglo population is shrinking relative to Hispanic and African American Texans, Greg Abbott and the Texas Republican leadership have set the stage for the US Supreme Court to perpetuate Anglo Republican con-

The Texas Republican

redistricting strategy has exposed their shameful decision to retain power through disenfranchisement. Rather than look at the future as an opportunity to hold power by broadening their appeal to Hispanics and African Americans, the Texas leadership has chosen a much darker and more cynical path. They are asking the US Supreme Court to turn back the clock, dismantle the Voting Rights Act and shred the fabric of social justice and racial fairness essential in our diverse state and increasingly diverse nation.
