Those familiar with accounting and business practices, and even many who are not, understand what profit and loss are all about. If you have a small business and apply for a loan, they ask for your P&L statements; they want to know if you are making money or losing money. Collectively, if Black people in the United States check our P&L statement, we will reveal a startling fact. Everyone else is profiting and Blacks are talking a huge loss. If businesses conducted themselves the way we conduct ourselves, vis-à-vis reciprocity in the marketplace, they would be

out of business in a heartbeat. How long will Black folks survive if we continue in the same vein of demanding rather than supplying?

We are spending billions of dollars each year with virtually no return. Their profit; our loss. Black people are buying everything everyone else makes, no matter how ridiculous the item is and no matter how fast the item depreciates. Their profit; our loss. Our people are in love with numbers and names on athletic jerseys, rims that keep spinning when the car stops, soft drinks that embarrass us with their commercials, and fast food restaurants that sell Black history to us - with fries; of course. Their profit; our loss.

Blacks people acquiesce to the so-called "powers that be," Public Enemy notwithstanding, rather than stand up like men and women and fight against what we know is detrimental to our people, especially our children. The media messages and the control of so-called Black Entertainment Television, which has now made yet another move to dumb-down its audience by canceling the 11 pm. news, are indicative of our plight. Talk about mission creep; Viacom has it down to a fine art and a science. Their profit; our loss.

## Dallas Mayor Skips Strong Mayor Debate

For months leading up to the May 7 election, Dallas Mayor Laura Miller and her push for a Strong Mayor run city has been a heated debate, and an issue that's raised many opinions across the board. With that in mind, and with the May 7 election coming down to crunch time, hundreds of South Dallas residents packed Friendship-West Baptist Church to hear city leaders voice their respective pros and cons about the issue during a highly anticipated panel discussion. The majority of the eager and excited crowd was in attendance mainly to hear Miller debate on the Strong Mayor proposal. However, not to the liking of the majority, panel moderator Willis Johnson of KKDA-AM radio station announced during the discussion that Miller couldn't attend, citing she didn't want to miss her son's last basketball game. Taking Miller's place on the panel was Dallas lawyer Beth Ann Blackwood, who's more than 20,000-signature petition is the main reason that the Strong Mayor measure is on the May 7 ballot. James Baldwin once said: People can cry much easier than they can change. Many would say this thought was recently illustrated by campaign ads of Irving mayoral candidate Terry Waldrum. Mr. Waldrum asked residents in a newspaper advertisement if they were "tired of the neighborhood businesses that look like they belong in a third world country" or "West Dallas". The Irving Rambler ran two versions of Mr. Waldrum's ad in the February and March weekly editions. The ads supplied additional fuel to smoldering tensions between white and minority residents of Irving, with only a few days left until the May 7th election. Anthony Bond, community activist and past president of the Irving NAACP chapter, expressed both surprise and resentment at the tone of the ads. "You have to be pretty bold in 2005 to run a racist ad like that," he said. ## Blind Obedience—The Tool Of Religious And Political Dictators

Blind Obedience is receiving a fair amount of attention these days in both the religious and political circles. As with most issues that trigger emotions there are extreme viewpoints on both sides firmly embedded in the "I'm right-Your wrong" rationale. This type of environment is the perfect breeding ground for those bent on establishing dictatorial domains.

History books are rife with examples of religious and political power egotists deceitfully using Blind Obedience to induce followers to conform to the leader's self-serving dictates.

Using deceit in the quest for political power is not unique to a single religious sect or political party. All have tried at one time or another to implement Blind Obedience—often using unbelievably horrific methods.

The sadistic abominations that occurred periodically at the hands of misguided secular leaders warrant our utmost contempt but the barbaric cruelties inflicted on believers and non-believers alike in the name of the church goes beyond comprehension. The confluence of church and state in the dark ages did not bode well for those who dared to act or believe in accordance with their own conscience. The same religious doctrines that were implemented during Reformation's darkest days, that crushed human liberty and placed men of God at peril for exposing religious iniquity, stands ready to be recycled.

Perhaps that is why the Constitution of the United States guarantees liberty of conscience. The founding fathers understood that nothing is dearer or more fundamental.

This was not always the case. Pope Pius IX, in his Encyclical Letter of 1854 stated for the church, "The absurd and erroneous doctrines or ravings in defense of liberty of conscience are a most pestilential error—and to be dreaded in a state."

History seems to be repeating itself in America as movements to secure the support of the state for the usage of the church are now receiving priority attention. The President goes to war ostensibly guided by God while religious entities dictate onerous civil policies in the name of God. And both want the people to fall in line without question because the anointed leaders claim infallibility.

Religion that focuses on externals is attractive to the unsuspecting. The pomp, ceremony, and rituals of modern church worship exude a seductive, bewitching power, by which many are enticed.

Religious and political groups hold on to their members by stripping them of the ability to make decisions for themselves. A dependency is created that is especially attractive to the disillusioned, minorities and those stuck on the bottom rung of the economic ladder. All that is required in exchange for the kindness and care offered is that you follow some very sensible rules that are designed to help everyone live and work cooperatively together, and to show respect for one another, especially the leader.

At some point the leaders make even the most mundane decisions. These may include such things as: clothing, length of hair, make-up, your possessions and daily routine. Policies and doctrines are made that dictate every aspect of one's life. Disobedience often carries severe social and sometimes even

physical penalties. Do the names Jim Jones (People's Temple) and David Koresh (Branch Davidians) ring a bell?

God's word has given warning of the impending danger from false prophets. There shall arise false Christs and false prophets, and shall show great signs and wonders inasmuch that, if it were possible, they shall deceive the very elect. How much money should you be saving for your retirement? While there's no one right answer for everyone, most financial experts recommend that you put away at least 10 percent of your pretax income every year. Unfortunately, your fellow Americans are not exactly hitting that 10 percent mark; in fact, in 2004, the personal savings rate hovered around 1 percent.

If your name is Bill Gates, saving 1 percent of your pretax income each year would result in quite a nice retirement lifestyle. Sadly, for most of the rest of us, a 1 percent savings rate is probably not going to do it. Consequently, you'll want to ratchet up your savings as much as possible.

How? For starters, figure out how much you actually are putting away. Add up your contributions to your employer-sponsored retirement plan (including employer matches), IRA contributions and any retirement savings you put in your regular taxable accounts.

If you determine that you're not saving 10 percent, don't panic. You may have many years to go until retirement; if so, you can still get back on track toward

your goals. Even if you are within a few years of retirement, you can do a lot to help your cause. In either case, here are a few suggestions to consider:

Increase 401(k) contributions when you get a raise - If you have a 401(k) plan, you've already got a retirement savings vehicle working for you. Your money grows on a tax-deferred basis and you typically make pre-tax contributions, which can help lower your taxable income. To boost your overall retirement savings rate, increase your 401(k) contributions each time you get a raise. In 2005, you can put in up to \$14,000 to your plan, or \$18,000 if you are 50 or older. (You can also put in the same amount to a 457(b) plan, if you work for a state or local government, or a 403(b) plan, if you work for a non-profit organization.)

"Max out" on your IRA - Make a determined effort to contribute the maximum amount to your traditional IRA, which offers tax-deferred earnings growth, or your Roth IRA, whose earnings grow tax-free, provided you meet certain conditions. In 2005, you can put in up to \$4,000 to either of these IRAs, or \$4,500 if you are 50 or older. To help your savings grow even faster, try to put in your

full IRA contribution as early in the year as possible; this will enable you to take advantage of the power of compounding. But if you can't afford to put in all the money at once, make monthly contributions.

Pay yourself first - If you're saving money for retirement in a taxable brokerage account, contribute whatever you can on a regular basis. Of course, it's not easy to put aside money for investments after you've paid the mortgage, car payment and all your other expenses. That's why you should "pay yourself first" by setting up a bank authorization to move money automatically into the investment vehicle you have chosen.

By following these strategies, you may or may not reach that 10 percent personal savings rate. But at the very least, you'll boost your retirement savings considerably - and that's a 100 percent positive move.

today that they represent five-year-old Ja'eisha Scott, who was handcuffed and shackled by the St. Petersburg County Police Department after having a temper tantrum at school. Gary and his legal team plan to expose the blatant cruel and unusual punishment suffered by their client. Gary and his legal team also call for the police department and the Pinellas County School District to undergo significant reform so that no other child will be shackled for behavioral challenges. In fact, Gary and Hoffer intend to appeal to police departments nationwide to address police brutality against children.

"It is truly unfortunate that an incident like this could happen in today's society," said Hoffer. "There is no excuse for handcuffing and placing shackles

on a five-year-old child as a means of discipline.

"It is obvious that this young girl is facing some challenges and handcuffing her, placing shackles on her feet and allowing her to remain in a police car for hours, shackled, is not the answer to her problem," continued Hoffer. "In this instance, the punishment does not fit the conduct of the child and, without a doubt, the police used excessive force and violated this child's civil and human rights."

Both national and international civil rights and human rights leaders as well as state and federal legislators have galvanized to address the atrocity of what happened to Ja'eisha Scott.

"This type of oppression forces us to reflect on the values of this country and the civil rights Rosa Parks fought for," said Gary. "We

are seeking justice. It's not right and we intend to do something about it. This issue should be of concern to every parent, mother and father in America because if we allow law enforcement to treat a five-year-old child with behavioral issues as if she were a convicted felon, what's next?"

Gary and his firm are no strangers to seeking justice. They are noted for winning a \$240 million verdict in a case against the Walt Disney Corporation for his clients who alleged Disney stole their idea for a sports theme park. In 2001, a jury awarded Gary a \$139.6 million verdict for the Maris Distributing Company against Anheuser Busch. In addition, Gary was given a half-billion dollar verdict in Jackson, Mississippi, against the Loewn Group, a large Canadian funeral home chain.

ABC, and CBS canceling their late night news. After all, if the news can be more effective given to us at intervals throughout the day and night, why do we need to have any news at 10 pm or 11:00 pm? Just a thought for Brian Williams and company.

We look on as immigrants move their businesses into our neighborhoods, mumbling and complaining under our breath but crouched at the start-line ready to race to their stores to buy their products. Their profit; our loss.

We stand by, even in towns where we are the majority, while projects funded by our tax dollars are being doled out, yet the lion's share is always given to outside developers, contractors, and workers. The most ridiculous thing is even when we get control of a project some of our people ask, "What's the minority portion of this project?"

A prime example of this "inappropriate behavior" is occurring right now in Cincinnati, Ohio. Check this out: After wresting control of 60 acres of prime real estate by putting some 500 Black families out of their homes (132 of those families had to go into homeless shelters) under false pretenses and lies, the city gave the property to two adjacent Black churches to carry out the rest of their dastardly scheme. The two Black churches, having not raised a hand to stop the takeover, immediately went to work by giving a significant

portion of the deal to a White developer.

To add insult to injury, the two Black churches then brought in a White-owned company to build the houses, despite there being a Black faith-based housing developer in that same neighborhood. The company they brought in has annual revenues that exceed the aggregate revenues of all Black businesses in Cincinnati. As if they had not rubbed Black faces in the mud enough, the White builder, with the help of Black "economic inclusion" experts, puts an article in the local Black newspaper calling for "minority" subcontractors to work on the project.

As I say on my radio show sometimes, "Do we practice being this stupid, or does it just come naturally?" Why do we, even when we get control of economic development projects, continue to play the minority game and act as though there are no Black folks who can develop land and build houses? As Brother Claude Anderson always says, "Black folks can't even do wrong right."

But Steven Biko said, "The greatest weapon in the hand of the oppressor is the mind of the oppressed."

Massa doesn't even have to be in the room or in charge of the deal, and some of us will still do his bidding anyway. Carter G. Woodson was so correct in his comment regarding, "If you control a man's thinking..." Their profit; our loss.

Is there a Black CPA out

there somewhere who is willing to do an annual report on our people? Is there an accountant who will show us exactly what our profit and loss statement says about how we spend our money and how we allow others to exploit us? Is there a bookkeeper available who will tell us that it makes no sense to turn over our own projects to White males (the ones who already get 70 percent-85 percent of the contracts anyway) when we finally get control of those projects?

Sadly, by the moves we make and the ones we fail to make, Black people make-profit and loss statements everyday, but they always end up being, "Their profit and our loss."

that if the Strong Mayor ballot becomes implemented, the city manager position will be eliminated and, in theory, the Mayor will have all of the power.

Under the current city charter the appointment, hiring and firing of key department heads, including the city's attorney, secretary, the chief of police and chief of the fire department is appointed by the city council, city manager and human resources director.

But, as an example, under the Strong Mayor proposal, Miller will be responsible for hiring personnel, and all will report to the mayor and not the council.

Should that happen, along with all of the other powers one will have under a Strong Mayor, the majority of African-Americans in attendance voiced their concerns on what impact it will have on black communities.

"Dallas, for years, has treated us (blacks) as the economic stepchild," Friendship-West Baptist Church Pastor Frederick D. Haynes, III, said when addressing the crowd before the panel discussion kicked off.

"Without question this is the most important election we have had in Dallas history."

Aside from Blackwood, joining her on the panel as those for a Strong Mayor was civic and community leader Betty Culbreath and David Laney, who is a former Dallas chairman and is on the Dallas Charter Review Commission.

Also on the panel and against the campaign was Dallas Deputy Mayor Pro Tem Don Hill, former council member Don Hicks and Dallas area Rapid Transit Board member Lynn Flint Shaw.

Before the panel discussion started, Blackwood explained why she started the petition for the Strong Mayor proposal.

"The welfare of this city has been heavy on my heart for a long, long time," Blackwood said. "People ask me why did I do this. I got tired Dallas being one of the worst city's (crime rate). I got tired of the unemployment rate. Tired of the tax base and tired of having no-one held accountable. I just want to have a direct say in that."

Prior to Blackwood's reasoning behind the proposal, Dallas City Council representative Veletta Lill voiced her rebuttal to the position. "We are here this evening because somebody decided to rewrite the constitution because they

have been watching the TV," she said of Blackwood.

"I'm only grateful she wasn't C-SPAN, or we would have seen a revolution. Believe in the city and don't believe the hype."

As for the actual panel discussion, each member had two minutes to voice their opinion about the Strong Mayor proposal — or related issues — before the floor was open to questions.

"A lot of people seem to wrap this around the Mayor, but this is the best deal for Dallas, which has been in decline for a number of years," Laney said. "We have more people leaving Dallas than coming in. This is an opportunity for Dallas to change."

A change that Shaw said ancestors in the past fought and died for. "I'm against it (Strong Mayor) because the people who crafted it are against me, and people like me," Shaw said in reference to African-American's.

"We have the same

problems that other cities with Strong Mayor have. This particular Mayor hasn't proven to be a friend to the African-American community."

As to the panel discussion, Shaw was pleased with the turnout and the response. "I thought it was a shame that Mayor Miller didn't show up to talk to her detractors and that's unfortunate. But I thought that the discussion was a good debate," she said following the event.

"I think that we got a lot of things settled, and I think the people are enthusiastic about voting."

And to Casey Thomas, chairmen of Precinct 4401, that's the most important topic of discussion. "If we don't vote this is all for nothing," Thomas said about the high turnout. "Education is essential. You have to know what the issues are so you can make an educated decision when you go into the polls. That's why this was so important."

## History of Cinco de Mayo

So, why celebrate Cinco de Mayo? Because 4,000 Mexican soldiers smashed the French and traitor Mexican army of 8,000 at Puebla, Mexico, 100 miles east of Mexico City on the morning of May 5, 1862.

The French had landed in Mexico (along with Spanish and English troops) five months earlier on the pretext of collecting Mexican debts from the newly elected government of democratic President (and Indian) Benito Juarez. The English and Spanish quickly made deals and left. The French, however, had different ideas.

Under Emperor Napoleon III, who detested the United States, the French came to stay. They brought a Hapsburg prince with them to rule the new Mexican empire. His name was Maximilian; his wife, Carolota. Napoleon's French Army had not been defeated in 50 years, and it invaded Mexico with the finest modern equipment and with a newly reconstituted Foreign Legion. The French were not afraid of anyone, especially since the United

States was embroiled in its own Civil War.

The French Army left the port of Vera Cruz to attack Mexico City to the west, as the French assumed that the Mexicans would give up should their capital fall to the enemy -- as European countries traditionally did.

Under the command of Texas-born General Zaragosa, (and the cavalry under the command of Colonel Porfirio Diaz, later to be Mexico's president and dictator), the Mexicans awaited their orders. Brightly dressed French Dragoons led the enemy columns. The Mexican Army was less stylish.

General Zaragosa ordered Colonel Diaz to take his cavalry, the best in the world, out to the French flanks. In response, the French sent their cavalry off to chase Diaz and his men, who proceeded to butcher them. The remaining French infantrymen charged the Mexican defenders through sloppy mud from a thunderstorm and through hundreds of head of stampeding cattle stirred up by

Indians armed only with machetes.

When the battle was over, many French were killed or wounded; and their cavalry was being chased by Diaz' horsemen miles away. The Mexicans had won a great victory that kept Napoleon III from supplying the confederate rebels for another year, allowing the United States to build the greatest army the world had ever seen. This grand army smashed the Confederates at Gettysburg just 14 months after the battle of Puebla, essentially ending the Civil War.

Mexicans, you see, never forget who their friends are, and neither do Americans. That's why Cinco de Mayo is such a party -- A party that celebrates freedom and liberty. These are two ideals which Mexicans and Americans have fought shoulder to shoulder to protect, ever since the 5th of May, 1862. Viva! el Cinco De Mayo!!

in the recent city survey. What leadership in Irving has to understand is that 6 out of every 10 people in Irving are either Black, Hispanic or Asian. Change is going to happen."

Mr. Waldrum did not return calls or emails to MON-The Gazette regarding this story.

The vast differences in perception of Irving's potential racial divisions are evident in the varied answers of the mayoral candidates to questions about race. When asked if there is underlying racial tension between whites and Hispanics in Irving, candidate Marvin Randle responded with a terse "No."

Incumbent mayor Joe Putnam gave a more realistic answer.

"It is clear that changing demographics have created apprehension among long-term Anglo residents, as shown in the citizens survey," he said.

The divide between the vision for an old and a new Irving was summed up in the comments of candidate

Herbert Gears, who has the endorsement of every Irving civil rights organization.

Mr. Gears responded: "My goal, as the political leader, is to re-invent Irving's identity into that of an international city. We have a very diverse population and we are next to a large international airport. We should celebrate our diversity and avail ourselves of the opportunities that brings."

The most progressive comments came from candidate Owen DeWitt.

"Whites are becoming a minority in Irving," he said. "With that comes a handoff of political power." Mr. DeWitt also pointed out how the cultural divide in Irving is evident in the way the city celebrates.

"Our Fourth of July celebration should not just be one stage featuring the symphony, but four or five stages representing different parts of our cultural diversity."

Candidate Thomas Spink suggested an approach of leadership and education.

"We need to create name

recognition for all minority leaders that have ability. It's not just Hispanics, we have no African Americans on the city council," he reflected. "The city needs that input, they should be represented."

He further remarked, "We should provide grants and loans for education so the people that are best qualified to represent their community are given the opportunity to

become leaders."

Political change, like all other change is inevitable. The challenge of political leaders in Irving is how to address the needs of the new majority without disenfranchising and alienating those that are used to controlling the political landscape. That challenge and the change associated with it will not be easy. Crying is easy. Change is not.

## XXX: State of the Union

 Bottom line: Ice Cube keeps the action-movie franchise alive with a pleasing one-two punch of humor and burly physicality. With "XXX: State of the Union," a follow-up to the original "XXX," its producers have clearly positioned the action-thriller franchise as a film series with a twist: Its death-defying protagonist will change with every new movie, thus allowing the filmmakers to build each episode around the personality of that actor. While "State of the Union" shows little interest in challenging the extreme stunts of the first Van Diesel movie, guest star Ice Cube is a much more ingratiating and amusing personality, so the movie has a better balance between its implausible stunts and characters. The movie, directed by James Bond refugee Lee Tamahori, should draw at least some of the action fans that made the first film a \$276.8 million worldwide success. Plus, Ice Cube gives the film street cred, so it should bring in an even greater urban audience. "State of the Union" is a throwback. The hero uses no martial arts; he simply slugs it out with opponents until he prevails. Vehicle mayhem and explosions are

emphasized over CGI. And writer Simon Kinberg deploys racial humor and political situations that feel a tad antique. Indeed this alternate reality of the current state of our union, channeled from John Frankenheimer's "Seven Days in May," imagines a popular sitting U.S. president (a stiff Peter Strauss) determined to cut military spending and a renegade Secretary of Defense (Willem Dafoe, almost as stiff) willing to stage a coup to




thwart that ambition. A raid on the National Security Agency's top-secret Virginia headquarters results in many dead agents, but the prize, Samuel L. Jackson's agent Augustus Gibbons, returning from the first film, escapes. Suddenly, Gibbons needs a new Agent XXX -- that last one died, someone says -- to get to the bottom of this home-grown terrorism. Only his choice, ex-Special Ops soldier Darius Stone (Ice Cube), is in military prison. You would think a top NSA agent could snap his fingers and his man would be

released, but then you wouldn't understand the action requirements of "XXX" movies. Darius must escape his high-security lock-up through fights, chases, rooftop leaps and a helicopter rescue. Once inside the Beltway, the world shrinks to the point where all the characters have a past with one another. The Defense Secretary is the guy responsible for having Darius imprisoned (for breaking his jaw). Augustus and Secretary Deckert have also clashed previously, creating no little animosity between them. And Darius instinctively seeks help from an old flame, Lola (the spectacular Nona Gaye), an improbably chop-shop operator who runs an equally improbable car-theft ring just down the street from the White House. Darius and gadget expert Toby Lee Shavers (Michael Roof), another returnee from "XXX," gradually uncover a plot against the U.S. government. Yet Deckert and his nasty toady, FBI agent Kyle Steele (Scott Speedman), seem two or three

steps ahead of the heroes, while a beautiful senatorial aide named Charlie (Sunny Mabrey) switches sides more often than a politician in an election year. Essentially, the film comes down to Ice Cube's line that the fate of the Free World lies in the hands of "a bunch of hustlers and thieves." Ice Cube's burly physique -- more that of a tenacious linebacker than a quick-responding half back -- makes for a different kind of action hero. Surly stares and glowering cynicism replace the bon mots of the more suave international spies of moviedom. But Ice Cube certainly has his own brand of cool that covers up the widest plot holes and lamest stabs at humor. Jackson gives the film an indispensable whiff of reality, but apparently Dafoe has run out of ways of making villains interesting. Tamahori, who showed promise as an eclectic and edgy director early in his career, now seems content to guide large-scale, impersonal Hollywood productions to the screen. At least he's getting good at that game. "State of the Union" is a smooth blend of visual special effects, exceptional stunts, fluid photography, sharp design and a possible best-selling soundtrack into a box office package. I'm taking bets now, though: The next Agent XXX will be a woman. **Columbia Pictures PG-13**
