Breast Cancer Awareness Month

In October, during National Breast Cancer Awareness Month, we remember those who have lost their lives to breast cancer, and those who are battling it now, by recommitting ourselves to their fight and spreading the word of the importance of

prevention and early detection. Despite significant ad-

vances in treatment and prevention, breast cancer remains the second leading cause of cancer death for women in the United States. However, because of the Affordable Care Act, it's a new day for women's health and the

fight against breast cancer.

United States

We know that the chance of successful treatment is highest when breast cancer is detected early. While not a perfect tool, mammogram screenings are key to early detection. But budgets are tight,

DISD M/WBE participation in bond program work exceeds goals

Participation of minority- and women-owned businesses in bond-funded projects exceeded district goals in the fourth quarter of fiscal year 2011-2012, according to a Minority /Women Business Enterprise (M/WBE) report presented to the Dallas Independent School District Board of Trustees on Sept. 13.

For construction projects in the 2008 Bond Program, 59 percent (\$21.6 million) of construction work was completed by M/WBE companies between April 1 and June 30,

2012, during which \$36.4 million was spent on bond projects for construction.

During the same period, 57 percent (\$5.8 million) of professional services relating to the 2008 Bond Program were provided by M/WBE firms, during which \$10.1 million

was spent on bond professional services. The participation in

both categories exceeds the district's M/WBE goals, which are 30 percent for construction and 35 percent for professional services. Further, M/WBE par-See BOND. Page 6

True the Vote has said they want to make the experience of voting "like driving and seeing the police following you." Earlier this year, we saw what happened when an overzealous citizen decided to follow and confront a teenager with a hoodie whose only "crime" was walking while Black. As the new report states, "There is a real danger that voters will face overzealous volunteers who take the law into their own hands to target voters they deem suspect." These mostly conservative groups claim their purpose is to protect against voter fraud – a solution in search of a problem, since the incidence of voter fraud in America is miniscule. The only fraud is their real intent, which is to gain political advantage for their preferred candidate by disenfranchising,

suppressing or bullying progressive voters who tend to be people of color, the elderly, students and people with disabilities.

The "Bullies at the Ballot Box" report raises awareness about this threat and outlines what is legal and permissible when it comes to challenging a voter's eligibility both before and on Election Day. It also assesses the ability of 10 key swing states to protect the rights of voters who may face this type of poll-stalking intimidation. According to the report, "In examining the ten states' laws governing challenges to voters' right to vote before Election Day, including the use of voter lists created through caging or other unreliable practices, we find Colorado, Nevada, and Ohio are satisfactory, North Carolina and Texas are mixed, and Florida, Missouri, New Hampshire, Pennsylvania, Virginia – five out of the ten states - unsatisfactory.'

The intimidation tactics by True the Vote and others, along with new voter ID laws in at least 30 states, and the elimination of early and weekend voting in several others, could seriously impact the outcome of the November election. Teamwork a key feature of patient safety improvement program

If you're a football fan like I am, you know that teams win or lose depending on teamwork. A good team may have a quarterback who can throw an accurate pass. But a great team also has players who can protect the quarterback and catch those passes.

In short, when teams work together, everyone can do their best job.

Today, this approach is catching on in health care in a big way. Doctors, nurses, and other staff have always depended on each other to provide high-quality care to patients. Now they're learning how to apply specific teamwork principles to produce better and safer care

A terrific example is how clinicians are reducing-and even getting rid of-infections that patients can get while they are in the hospital. Healthcare-associated infections happen when patients are in the hospital getting treatment for another condition. They affect 1 in 20 patients at any point in time.

People used to think that these infections couldn't be avoided.

Now, we know this is not the case. In fact, a newly completed program showed that a combination of teamwork, the best clinical practices, and a strong commitment to safety reduced by 40 percent the chance that patients would get one type of these infections. The national project was funded by my agency, the Agency for Healthcare Research and Quality, and involved partners from the American Hospital Association and Johns Hopkins Medicine

The type of infection tested in this project happens in intensive care units when germs infect the central line that delivers drugs and fluids patients. The infection is very serious and can be

deadly. By following this teamwork-based approach, hospitals prevented more than 2,000 infections, saved 500 lives, and avoided more than \$34 million in health care costs

Results of this project, called the Comprehensive Unit-Based Safety Program, or CUSP, are exciting for two reasons. One is that it proves how a careful, teamworkbased approach can prevent a deadly type of infection. The second reason is that the pro-

gram can also make care safer for patients with other health conditions.

Let's take the case of Laura, a hypothetical 70year-old patient who is in the hospital after having a stroke. She is on a ventilator to help her breathe until she recovers. But being on a ventilator also puts her at higher risk for getting pneumonia.

Laura is fortunate that her hospital team is using CUSP as a part of her care. See SAFETY, Page 6

Young cholesterol

Not just middle aged adults have cholesterol problems. The Centers for Disease Control and Prevention says almost 1 in 10 children and teen-agers also have cholesterol problems. And higher cholesterol levels put them on a track that could lead to heart disease as adults.

However, the analysis of 22 years of national data on more than 16,000 young people finds some signs of improvement. At CDC's National Center for Health Statistics, researcher Brian Kit:

"Over the study duration, we found improve-

and even moderate copays can deter many women from getting those important screenings.

Because of the Affordable Care Act – the health care law signed by President Obama two years ago – many private health plans and Medicare now cover mammograms and certain other preventive services with no copays or other out-of-pocket costs. This means that women can get the potentially life-saving services they need to detect breast cancer before it spreads, without worrying how a copay would affect their family budget. Last year, more than 6 million women with Medicare got a free mammogram.

Under the health care law, other services to help prevent breast cancer are also covered, such as a

well-woman visit - at no additional cost- so women have the opportunity to talk to their doctor about their health care needs, their personal risk for breast cancer, and their best options to reduce their risk. The Affordable Care Act gives women, not insurance companies or the government, control over their health care.

Women also have new rights and protections under the law against insurance company abuse. If diagnosed with breast cancer or another illness, women cannot have their coverage taken away when they need it the most simply because of a mistake made on paperwork. And beginning in 2014, it will be illegal for insurers to discriminate against anyone with a pre-

existing condition, such as breast cancer

The health reform law is also helping women who are going through costly breast cancer treatment by preventing insurance companies from imposing lifetime dollar caps on coverage. This means that women fighting breast cancer can focus on their health, their families, and living their lives, and not worrying that their insurance will run out while they still need treatment.

We have made substantial progress in reducing the burden and toll of breast cancer on American women and their families. Initiatives under the Affordable Care Act, along with ongoing research, are making real differences in the lives of American women and their families.

New study cites UT Arlington's \$13.6 billion impact on Texas

The University fuels 131,200 jobs a year, and its impact on business activity reflects about 4 percent of the North Central Texas economy, the study found.

The University of Texas at Arlington has a \$13.6 billion total annual impact on the State of Texas and fuels 131,200 jobs a year, according to a new assessment of the University's operations, research and workforce enhancement effects on business activity by The Perryman Group.

UT Arlington's impact reflects about 4 percent of the North Central Texas economy, the study found. Economic activity associated with the University also leads to incremental tax receipts of about \$310 million a year to local governments and \$639 million to the state, the study said.

The prominent consulting firm analyzed data ranging from enrollment and ongoing University operations to expanding research activity and the enhanced workforce productivity of rising numbers of UT Arlington graduates, among other factors.

The study notes that UT Arlington has made "great strides toward becoming a nationally recognized research institution" and said: "Through its ongoing and expanding instructional and research endeavors, UT Arlington serves as an ever-increasing catalyst for individual opportunity and economic and social development."

President James D. Spaniolo said the Perryman report underscores the significant advantage diverse and active research institutions give their regions and the state overall.

"This report clearly demonstrates the tremendous benefit UT Arlington brings to North Central Texas and the Texas economy overall," Spaniolo said. "Our students, alumni and faculty provide a highly-educated workforce to our region and are constantly advancing innovation and new technologies. Their work helps make North Texas one of the nation's best places to live."

The study also found that UT Arlington generates:

•\$1.1 billion in total annual economic benefits to the state of Texas and more than 15,400 permanent jobs stemming from ongoing operations, including educational and research spending and student and visitor outlays. •\$64 5 million in incre-

mental tax receipts to the State of Texas and \$34.5 million to local taxing entities each year related to ongoing University operations.

•\$502.7 million in output and 5,861 person-years of employment in the North Central Texas region related to recent and ongoing University construction projects.

Ray Perryman, president of the The Perryman Group, said the UT Arlington study reinforces his earlier findings about the potential economic impact additional Tier One institutions can have on Texas.

"When you look at the hard data, institutions like UT Arlington are major centers of employment

As a result, Laura's doctors, nurses, respiratory therapists, and others make sure the head of her bed is raised to the right level, check that hands are always washed properly before all exams, and follow all other infection-control steps. Laura's care team members talk to each other every day to make sure that everyone follows the care plan. In addition to the clinical staff, Laura's family members are considered part of the team. The care team explains to the family why pneumonia is a risk, what steps they are taking to prevent it, and how to help.

You may not know whether your hospital is using CUSP. But you should speak up if you're concerned or unsure about the care your loved one is getting. Of course, teamwork and other important elements of CUSP can't change the outcome of every illness or condition. But they help many patients avoid getting sicker and help clinicians work together to do what they do best.

•Record levels of research activity, with \$66 million in related expenditures last year.

•Record levels of recent construction activity, with

the completion of the Engineering Research Complex as well as the 20-acre College Park District, a residential and retail development anchored by the 7,000-seat College Park Center.

The report concludes that UT Arlington "serves as a source of economic stimulus through its ongoing operations and construction projects. Spinoff companies stemming from funding research provide still more growth, and the benefits of the enhancement of the regional workforce is sizable."

CFPB orders American Express to pay \$85 million refund to consumers harmed by illegal credit card practices

Federal regulators fine American Express an additional \$27.5 million

The Consumer Financial Protection Bureau (CFPB) on Monday announced an enforcement action with orders requiring three American Express subsidiaries to refund an estimated \$85 million to approximately 250,000 customers for illegal card practices. This action is the result of a multipart federal investigation, which found that at every stage of the consumer experience, from marketing to enrollment to payment to debt collection, American Express violated consumer protection laws.

"Several American Express companies violated consumer protection laws and those laws were violated at all stages of the game – from the moment a consumer shopped for a card to the moment the consumer got a phone call about long overdue debt," said CFPB Director Richard Cordray. "Today's orders require the American Express companies to fully refund about \$85 million to consumers and it requires them to make specific changes in their business practices. The American Express companies will identify the harmed customers, notify them, and make sure they get back their money."

The Federal Deposit Insurance Corporation (FDIC) together with the Utah Department of Financial Institutions discovered the illegal activities during a routine examination of an American Express subsidiary, the American Express Centurion Bank. The FDIC transferred portions of the investigation to the CFPB when the Bureau opened its doors last year and together the agencies pursued the matter. The CFPB later concluded that many of the same violations that occurred at American

Express Centurion Bank also took place at American Express Travel Related Services Company, Inc. and American Express Bank, FSB.

The investigations found that the violations occurred at various points in time between 2003 and spring 2012. They occurred at every stage of the consumer experience, from shopping for cards, to applying for cards, to paying charges, and to paying off debt. More specifically, American Express subsidiaries:

•Deceived consumers who signed up for the American Express "Blue Sky" credit card program: Consumers were sometimes led to believe they would receive \$300 in addition to bonus points if they signed up for this American Express Centurion Bank program. But consumers who met the qualifications did **See AMERICAN. Page 11**

Ticket to Work + Volunteer work = The right answer for disabled workers

Robert Statam is a veteran who spent seven years serving in the U.S. Army. After a surgery mishap in 2000, he sustained a spinal cord injury that left him with limited mobility. No longer able to perform the tasks required in his previous position as a U.S. Postal Carrier, Statam was awarded Social Security Disability Insurance (SSDI) benefits and focused on regaining mobility through rehabilitation at a Department of Veteran's Affairs (VA) hospital. He had to make significant changes to his lifestyle. Adjusting to life on a fixed income was also humbling and challenging.

"In this mode, I was taken down a level," he says. "... And I knew that when the time came when I'd be able to get in better condition and back into an improved lifestyle, I would do everything I could to get there."

Statam was determined to return to the workforce as soon as he was in a position to try. But he had concerns.

"The main thing I was worried about was whether my health would get in the way," he says. "What if I really wasn't ready and employment didn't work out? SSDI was my only source of income. Getting approved is such a process that I didn't want to tamper with my benefits in any way.'

Connecting with Ticket to Work

The VA put Statam in touch with the Paralyzed Veterans of Åmerica (PVA), an employment services pro-

vider that also offers benefits counseling. They talked about his employment options and the impact that work would have on his benefits. Statam's counselor told him about Social Secu-

rity's Ticket to Work program and Work Incentives. The Ticket to Work program is voluntary, and offers free employment support services to Social Security disability beneficiaries ages 18 through 64. Work Incentives are rules that make it easier for adults with disabilities to return to work or to work for the first time. Among other things, Work Incentives allow most Social Security disability beneficiaries to receive Medicaid or

Medicare coverage and some cash benefits even after they get a well-paying iob.

"It cleared up some unknowns about work and benefits. I learned there are options which would allow me to prepare for work or make an attempt at work. During that transition period, I would continue to receive benefits. This took away some of the fear and doubt I felt. I knew that if of the Ticket program's 1,000+ authorized service providers known as Employment Networks (ENs). ENs and state vocational rehabilitation (VR) agencies offer Social Security disability beneficiaries a range of services, including rehabilitation, career and benefits counseling, vocational training, job placement, job-coaching and ongoing employment support. Program participants may speak with several pro-

viders before finding a good

what types of work would incorporate both and developed an Individual Work Plan (IWP) to help him achieve his employment goals. The plan included continuing education. Statam decided to go back to school to study social work and improve his job prospects.

While he made progress in school, Statam's EN helped him find a volunteer program at the Heinz Veteran's hospital in Chicago. He became a peer coun-

selor and enjoyed helping fellow veterans get the services needed for a smoother transition back into civilian life. It took time to learn each service member's story, establish trust and piece together a profile of needs and eligibility. Patience and kindness paid off with Statam 's clients.

Success in this program renewed his confidence in his ability to contribute and help others. PVA's vocational counseling services helped Statam discover that assisting other veterans was his next calling. The education and training he received laid the groundwork for future success

"I learned a lot about myself, and it gave me an opportunity to kind of refocus my life. So, the disability (and the help that came with it) played a major role in ... where I am today. It kind of slowed my life down; gave me a chance to refocus and look at things in another way. If it wasn't for my disability, maybe I wouldn't have gone back to school, or [taken] such a strong interest in helping others as I have today,' Statam shared.

Volunteer Work: A **Stepping Stone**

Volunteer work turned out to be a valuable stepping-stone. Together, Statam and his career counselor updated his résumé and sent it to the National PVA office. Statam applied for a position as a National Service Officer. In this role, he would advocate for other veterans to make sure they are getting the services and benefits they need. Many veterans qualify for multiple benefits, and Statam would help them navigate the complex rules surround-

ing them. It is a job for which he is uniquely suited. His knowledge of both disability and veterans' benefits combines with a personable style and resourceful approach that would allow Statam to serve his peers in a fulfilling occupation. PVA saw this, and hired him in 2010.

Cover Story

It is somewhat unusual for an EN to hire a client. More often, ENs help clients like Statam in their efforts to find work with another employer. But PVA had a need, and Statam was the right fit for the job.

"I never imagined I would get a job like the one I've had as a National Service Officer. It's rewarding to advocate for someone else. So many vets don't get the help they need because they don't know where to begin and how to go about the process. Ticket to Work helped me go to work where my heart is."

Statam says the Ticket program and employment have helped improve both his health and his outlook. Working shifted focus from his condition to helping others

At first, he was "...waiting on that check month to month, trying to find a way to keep occupied..." Today, Statam is learning new skills and building a new future

"Ticket to Work did its part for me. I would encourage anybody to give it a try. When I took that first step, everything fell into place," according to Statam.

not receive the \$300. This violates federal laws prohibiting deceptive practices

•Charged unlawful late fees: American Express Centurion Bank and American Express Bank, FSB billed late fees on certain cards based on a percentage of the debt in violation of the Credit CARD Act.

•Unlawfully discriminated against new account applicants on the basis of age: American Express Centurion Bank used a credit scoring system that treated charge card applicants differently on the basis of age. For a period of time, the bank did not fully implement the system for applicants over the age of 35. This violated the Equal Credit Opportunity Act because it requires credit scoring systems that take age into account to be properly designed and implemented.

•Failed to report consumer disputes to consumer reporting agencies: American Express Centurion Bank and American Express Bank, FSB failed to report the existence of certain customer disputes to credit bureaus, which is a violation of the Fair Credit Reporting Act.

consumers •Misled about debt collection: All three of the American Express subsidiaries deceived consumers into believing there were certain benefits to paying off old debt. Consumers were wrongly told that if they paid off the old debt, the payment would be reported to credit bureaus and could improve their credit scores. In fact, American Express was not reporting the payments and the debts were so old that even if they had tried to report them, many of the payments would not have appeared on these consumers' credit reports or affected their credit scores. American Express also told some consumers that a portion of their debt would be waived or forgiven if they accepted certain settlement offers. But for customers who applied for a new American Express card, the company was not really forgiving or waiving the debt.

Enforcement Action

In accordance with the orders issued, the American Express subsidiaries have agreed to correct their practices and refund consumers who were harmed by the illegal practices. Specifically, they have agreed to the following:

•End the illegal practices: American Express Centurion Bank will not deceive consumers with marketing for the Blue Sky credit card, or any other card, by falsely promising a rebate or points feature. The banking subsidiaries will not charge illegal late fees. They will properly report disputes to credit bureaus and will make sure that cardholders are told about their rights regarding such disputes. American Express Centurion Bank will not unlawfully discriminate based on age when it comes to credit decisions, and it will be required to certify that all qualified consumers who suffered unlawful age discrimination were given an opportunity to reapply for credit.

•Full repayment of an estimated \$85 million to approximately 250.000 consumers: These American Express entities will be paying their customers full restitution, specifically:

o Consumers who were misled into paying old debt because they thought it would be reported to the credit bureaus will be reimbursed the money they paid plus interest.

o Consumers who were promised their debt would be forgiven and who were denied new credit cards because the debt was not really forgiven, will receive \$100 and a pre-approved offer for a new card with terms the CFPB and the FDIC find acceptable. If the consumer already paid the waived or forgiven amount in order to get a new card, they will be refunded that amount plus interest.

o Blue Sky customers who were promised \$300 for signing up will get their \$300

o Consumers who paid an illegal late fee will be reimbursed, with interest.

 Convenient repayment for consumers: These American Express companies are responsible for notifying the affected consumers. Consumers are not required to take any action to receive their credit or check. If the consumers are still American Express customers, they will see a credit in their account. If they no longer have a card account with American Express, they will receive a check in the mail. American Express expects that consumers who will be receiving payment will receive the payout by no later than March 15, 2013.

•Inform consumers of debt collection rights: These American Express subsidiaries will inform consumers when the debt they are seeking to collect will not be reported to a

consumer reporting agency because it is too old. And they will not collect debt unless it has documentation evidencing the debt. Going forward, this will include, at a minimum, the complete terms and conditions of the account and a complete transactional history of the debt

•Independent audit: These American Express subsidiaries will implement new procedures to ensure compliance with consumer financial protection laws. They will also use independent auditors to ensure compliance with the terms of today's orders.

•Pay civil monetary penalty of \$27.5 million: Several federal government agencies seeking action against these American Express companies have ordered monetary penalties. With jurisdiction over the three subsidiaries, the CFPB's fine is \$14.1 million; with jurisdiction solely over American Express Centurion Bank the FDIC's fine is \$3.9 million; with jurisdiction over American Express Travel Related Services Company, Inc. and American Express Company, the parent company, the Board of Governors of the Federal Reserve System's fine is \$9 million; and with jurisdiction over American Express Bank, FSB, the Office of the Comptroller of the Currency's fine is \$500,000.

The Texas Workforce Commission (TWC) Wednesday announced a nine-week extension of Emergency Unemployment Compensation (EUC) Act benefits (Tier III) for unemployed Texans. The extension comes as a result of the state's average unemployment rate reaching an estimated 7 percent or higher over the previous three months.

Claimants currently receiving unemployment benefits will automatically have the additional benefits added to their

benefit period and will receive a letter showing the additional amount of benefits they could potentially receive. Claimants do not need to contact TWC unless they receive a letter instructing them to do so.

The U.S. Department of Labor authorized TWC to begin processing claims beginning Oct. 7, 2012. This extension is not retroactive, and therefore does not cover weeks of unemployment prior to Oct. 7, 2012.

The letter will direct claimants who are still unemploved to call a special toll-free phone number, available 24 hours a day, to apply for the latest extension.

This extension brings the total number of benefit weeks an individual in Texas may qualify for to a maximum of 63

weeks. Claimants currently receiving unemployment insurance (UI) benefits should continue to request payment as scheduled. Claimants may update their address information online at ui.texasworkforce.org or by contacting a UI Tele-Center toll free at 800-939-6631. Reemployment services are available through local Workforce Solutions Offices statewide or job seekers may visit www.WorkInTexas.com to register and search for job postings.

"The Lord's anger burned against Uzzah, and He struck him down because he had put his hand on the ark. So he died there before God." **1 Chronicles 13:10**

There are some people that do not like to read. They have found it to be a difficult discipline. However, if they don't commit themselves to reading and knowing what is in God's Word and following His word for them, they will fail to know and experience God Himself. God's Word is life to a Christian's soul, that's why He gave Christians the Bible. It provides knowledge that leads to life.

The Word of God is a Christian's initial point which is a reference point of a Christian's life and their guide. Nothing can compare to it; therefore, it is essential that Christians read it for instructions.

The Word of God tells us, "My people are destroyed from lack of knowledge. Because you have rejected knowledge, I also reject you as My priests; because you have ignored the law of your God, I also will ignore your children." Hosea 4:6.

God has given us His Word that has specific laws and principles that must be followed if we expect His blessing. King David forgot to follow one of those laws related to the ark. "...But they must not touch the Holy things or they will die..." Numbers 4:15.

When they were transporting the ark, Uzzah innocently reached to steady the ark but was immediately stricken dead when his hands touched the ark of God.

Ask yourself, did David know this law or did he simply forget? Did Uzzah know this law? If so, did he really believe it? David thought it was okay to carry the ark the way Uzzah did. A man lost his life for his presumption.

Many believers take God's Word lightly. They believe they can violate His Word without consequence. This is not true; the Lord stands by to uphold His Word. It can be life, or it can bring death. When God provides instructions, Christians need to follow them.

Knowing this about God brings a healthy fear of the Lord. "David was afraid of God that day and asked, 'How can I ever bring the ark of God to me?' " **1 Chronicle 13:12.** Christians must all have a fearful respect of God's Word; because His Word is life or death to Christians. They must feed upon His Word daily so that they might know Him and know His precepts. They must delight in God and feed upon this knowledge and be blessed of God.

When Christians read God's Word and follow His commandments only they can allocate their time and not have any stress in their life. The Holy Spirit will lead and guide them in the right direction.

Christians can back up their reading of God's Word with prayer (talking to God) and reflection on their lives. Jesus' life had a balance of quiet moments and active ministry into the lives He came in contact with.

How do Christians determine what they will be involved in each day of their lives? What keeps them in sync with The Will of their heavenly Father for the daily tasks He calls them to do? Jesus tells us that He was only involved in those things the Father was involved in; nothing more, nothing less. So often we determine our participation in an activity based on whether we have the time to do it or whether we desire to participate. The real question we should ask is, "Does the Father want me to participate in this activity?" "Lord, should I

So you're feeling skeptical about some of what those expecting-a-baby books expect you to believe? You might have good reason for that ...

In Why Have Kids, author Jessica Valenti is sometimes deliciously in-your-face, sometimes ranting, but always eyeopening and quite a bit shocking as she looks at research and viewpoints, takes on baby-wearers, "elimination communica-

tion" and Attachment Parenting, and examines laws that can chill parents to their bones. She presents reasons to have children and reasons not to have them, which is something prospective parents and the vehemently child-free should both know.

Then she explains how all of the above have created a kerfuffle that will affect us for generations to come.

Overall, this is a thoughtprovoking, controversial, but fascinating book and I liked it a lot. I think that, for parents and non-parents alike, Why Have Kids? will give birth to a lot of interesting conversations.
