Have the 'good debt' vs. 'bad debt' rules changed?

Before the Great Recession of 2008 overturned many long-held financial beliefs, it wasn't uncommon for people to differentiate between "good debt" and "bad debt." The thinking was that certain kinds of debt were worth taking on because you come out ahead in the long run. Buying a home and financing a college education were two notable examples.

But when home values plummeted and the cost of a bachelor's degree soared into five or six digits, those

once-safe investments in your future suddenly seemed risky or unattainable.

Now's a good time to step back and examine the concept of good debt vs. bad debt and why, in certain cases, acquiring debt may still make sense - pro-

Such was the case with SB 1636, better known as the "Rape Kit Bill" which helped to eliminate the backlog of untested rape kits by creating a timeline and structure for the collection and testing of sexual assault evidence. Shelton has also repeatedly stated he is opposed to the Affordable Healthcare Act and his objective is to replace legislatures who support it. He is a Tea Party Candidate and proudly acknowledges this touting his "conservative family values." Matt Glazer, executive director of the activist group Progress Texas is calling this race the most critical in all of Texas.

Another pivotal race Texans should be following is Congressional District 14, Ron Paul's seat. African-Americans, Latinos, women and any disenfranchised people in the state of Texas should be highly concerned. There is much at stake in this upcoming election and no time for apathy. Unfortunately Texas' history does not give us much hope for optimism. The Lone Star state has one of the worst voter participation records in the entire country. In the 2006 general election, Texas ranked 48th among states for voter turnout. In the presidential election of 2008 it ranked 47th and in 2010 it was last. This past May only 1 in 10 voters in Dallas and Fort Worth actually cast a ballot in the primary elections. Lack of awareness of sudden cardiac arrest leads to increased risk of death for African Americans, warns Heart Rhythm Society

Lack of awareness and treatment of sudden cardiac arrest (SCA) puts African Americans at greater risk of death from the condition, according to a new national survey released today by the Heart Rhythm Society (HRS). The survey findings uncovered significant perception gaps between healthcare providers and consumers when it comes to understanding the condition, its symptoms, risk factors and treatments. Responsible for more than 350,000 U.S. deaths each year, SCA occurs when the heart suddenly and unexpectedly stops beating. Approximately 95 percent of SCA cases result in death; however, it is proven most deadly in African Americans

The new study, conducted by HRS with Ipsos Healthcare, found African Americans are significantly less familiar with sudden cardiac arrest, with only 18 percent able to correctly identify the condition, compared with 24 percent of the general population. More than sixty percent of African Americans who reported experiencing heart disease symptoms report not going to the doctor as a result. In addition, ninety percent of African Americans say their doctor has not talked to them about their risk for SCA. These considerable disparities impact the immediate, life-saving treatments needed to prevent the deadly condition.

To reverse these inequalities and increase the dialogue between patients and physicians, HRS today launched a nationwide public education campaign in partnership with the Association of Black Cardiologists (ABC) and Shaun Robinson, Emmy-award winning journalist and weekend coanchor and correspondent for "Access Hollywood." Coined "Arrest the Risk." the initiative is designed to overcome the barriers to proper diagnosis and treatment of SCA through educational resources, an SCA symptom tracker available on www.ArrestTheRisk.org, as well as a powerful public service announcement featuring Robinson. Additionally, HRS and ABC will conduct specific educational initiatives in cities with a high prevalence of SCA.

"Racial disparities in the prevention and treatment of sudden cardiac arrest result in too many preventable deaths. The first step toward reducing these substantial discrepancies is to treat the underlying causes and man-



"However, to bridge the gap, both at-risk consumers and their physicians must better understand the signs and symptoms of SCA, and physicians must translate evidence-based treatment guidelines, including the use of indicated medical devices, into their everyday clinical practice."

Treatment guidelines recommend implantable cargists) in the U.S. regarding their awareness of SCA as well as their treatment and referral history. Results of the survey showed that many physicians are unaware of the significant deadly impact of SCA. Nearly half of physicians (49 percent) did not identify SCA as the condition that poses the greatest risk to Americans today, even though SCA claims more lives each year than stroke, breast cancer, lung cancer or AIDS. When asked to assess a case study, the majority of PCPs do not identify "at risk" patients, even when three or more risk factors are apparent. In addition, only half of primary care physicians believe ICDs are the standard of care for patients at risk.

"By offering insight into the incidence of the condition, addressing diagnosis and treatment related challenges faced by healthcare professionals and working to ensure the implementation of guideline-based care, we can ensure that all patients - regardless of their race, gender or age $\frac{3}{8}$ receive access to the best possible cardiac care," said Ola Akinboboye, MD, MPH, MBA, President, ABC.

"The Association of Black Cardiologists is proud to partner with HRS to lead this innovative, educational effort that sheds light on the current disparities in care, while also working on practical education to help eliminate these healthcare inequalities."

"Since my grandfather and some other family members have suffered from heart disease, this is a condition that is very personal to me. However, I didn't realize that this family history means I could be at increased risk for sudden cardiac arrest," said Robinson. "Because SCA is so deadly, it is absolutely critical to talk to your doctor because early intervention can literally save your life.'

"Arrest the Risk" is a nationwide public education campaign from the Heart Rhythm Society in partnership with the Association of Black Cardiologists (ABC) and Emmy-award winning journalist Shaun Robinson. The project addresses the critical need for effective teen pregnancy prevention programming in the Dallas-area. The most recent County Health Rankings and Roadmaps study shows that Dallas County has a birth rate of 76 per 1.000 women ages 15-19. in a state ranked the fourth highest in teen birth rate by the Centers for Disease Control and Prevention (CDC). The children of teenage mothers are more likely to drop out of high school, have more health problems, be incarcerated at

some time during adolescence, give birth as teenagers, and face unemployment as young adults, says the CDC.

"These unsettling statistics clearly illustrate the need to equip Dallas-area girls with the information, skills, and competencies to avoid teen pregnancy and STIs, complete high school, go to college, and pursue careers of their choice," noted Lori Palmer, Girls Inc. of Dallas CEO. Pacifica Foundation rejects Chicago's WBEZ-FM's negative characterization of "Advocacy Identity" in American media

Pacifica Foundation, the founder of listener-sponsored radio in the United States with the birth of KPFA-FM in Northern California in 1949, joins with Chicagoans and people across the country to express its concern about the removal of the broadcast collaboration Smiley & West from Chicago public radio station WBEZ-FM. But the Foundation also "rejects" WBEZ-FM's maligning of advocacy journalism, which is the heart of community radio in America and provides opportunities for groups and individuals to speak for themselves.

Tavis Smiley and Professor Cornel West are African Americans. This action in Chicago is especially worrisome therefore, when

groups from Rainbow PUSH to Free Press to Color of Change have pointed out repeatedly that Blacks own less than one percent of full power commercial television stations and less than three percent of commercial radio stations, yet make up nearly 14 percent of the total U.S. population. As a consequence, there is a severe lack of Black voices in American media and there needs to be more not fewer voices of independence along with challenging thought provoking analysis

WBEZ President Torey Malatia ascribed the decision at least in part to Chicago Public Radio uneasiness with the "advocacy identity" of the Smiley & West Show, comparing it to Pacifica Radio's Democracy Now!



Romney supports many of Obama's foreign policy positions

BY GEORGE E. CURRY, NNPA EDITOR-IN-CHIEF What was billed as the third and final debate between President Barack Obama and Republican challenger Mitt Romney on Monday night often featured the former Massachusetts governor agreeing with actions taken by the president on foreign policy.

Unlike his acerbic performance in the earlier debates, Romney agreed with at least a half-dozen actions taken by Obama, including instituting economic sanctions against Iran, wanting Egyptian President Hosni Mubarak to step down, increasing the use of drones, implementing a troop surge in Afghanistan, and supporting the killing of Osama bin Laden.

At one point, Obama said: "What you've just heard Gov. Romney say is that he doesn't have different ideas.'

A CBS News/GFK instant poll of uncommitted voters showed that 53 percent thought Obama won the debate; 23 percent favored Romney and 24 percent called it a tie.

During the 90-minute debate in Boca Raton, Fla., Romney repeated his charge that Obama had taken an "apology tour" around the world when he first entered office.

The Washington Post fact checker stated: "...it is an article of faith among top Republicans that President Obama has repeatedly apologized for the United States and its behavior. Even more, the argument goes, he does not believe in American strength and greatness. The assertion feeds into a subterranean narrative that Obama, with his exotic, mixed-race background, is not really American in the first place."

It concluded, "The claim that Obama repeatedly has apologized for the United States is not borne out by the facts, especially if his full quotes are viewed in context."

When Romney mentioned that the United States has fewer naval ships than it had in 1916, "Well, Governor, we also have fewer horses and bayonets, because the nature of our military's changed. We have these things called aircraft carriers, where planes land on them. We have these ships that go underwater, nuclear submarines. And so the question is not a game of Battleship, where we're counting slips. It's what are our capabilities."

Obama repeatedly accused Romney of being "all over the map.²

He specifically criticized the Republican nominee for saying he would have asked Pakistan's permission before entering that country to hunt down Bin Laden. Obama made no such request before approving the mission that ended with the killing of Bin Laden.

Summarizing his foreign policy accomplishments, Obama said: "We ended the war in Iraq, refocused our attention on those who actually killed us on 9/11. And as a consequence, Al Qaeda's core leadership has been decimated. In addition, we're now able to transition out of Afghanistan in a responsible way, making sure that Afghans take responsibility for their own security. And that allows us also to rebuild alliances and make friends around the world to combat future threats.

Libva, as I indicated in the last debate, when we received that phone call, I immediately made sure that, number one, that we did everything we could to secure those Americans who were still in harm's way; number two, that we would investigate exactly what happened, and number three, most importantly, that we would go after those who killed Americans and we would bring them to justice. And that's exactly what we're going to do.'

In a shift of tactics, Romney tried to attack Obama from the left, saying the United States "can't kill our way out of this mess" of religious extremism.

Even though the debate focused on foreign policy, each candidate eased in references to domestic issues.

On one, the bailout of the auto industry, the Washington Post fact checker said: "In the tangled debate over whether the auto industry would have survived under Romney's bankruptcy plan, Obama has the edge on the argument. This exchange is drawn from a headline ----'Let Detroit Go Bankrupt'on an opinion article written by Romney for the New York Times. But he did not say that in the article. (He repeated the line, however, on television.)"

It continued, "Ultimately, along with getting nearly \$80 billion in loans and other assistance from the Bush and Obama administrations, GM and Chrysler did go through a managed bankruptcy. But many independent analysts have concluded that taking the approach recommended by Romney would not have worked in 2008, simply because the credit markets were so frozen that a bankruptcy was not a viable option at the time."

In one lively exchange, Romney again boasted that Massachusetts students led the nation in standardized

The Washington Post fact checker stated, "He is correct, but many educational experts credit the scores to a comprehensive education overhaul that the state began a decade before the Republican presidential candidate became governor."

Turning to Romney, Obama said: "But Governor, when it comes to our foreign policy, you seem to want to import the foreign policies of the 1980s, just like the social policies of the 1950s and the economic policies of the 1920s."

It is unclear how much Monday night's debate will have on voter preferences.

Various polls show both Obama and Romney with a small edge. However, it is important to remember that state figures are far more important than national numbers because that's the pathway to victory in the Electoral College where the election is decided.

An Ohio poll released Monday by Quinnipiac University/CBS News showed Obama with a 50 -45 percent lead over Romney.

"The good news for Gov. Romney is that he has sliced President Obama's lead in Ohio in half in the last month," said Peter A. Brown, assistant director of the Quinnipiac University Polling Institute. "The bad news for Romney, and the

At the age of 15, Drake dropped out of high school to join Degrassi, a Canadian-



gral part of the well-orchestrated media show and are eager to participate in postdebate polls to enhance their candidate's electability.

To qualify for a debate, a candidate has to have a statistically feasible chance of being able to win a majority of the votes available in the Electoral College. The candidate also must have at least 15 percent of voters' support in polls before the debates begin.

Except for Thomas Dewey in 1948 no presidential contender who was leading in the polls six weeks before the election has lost the popular vote. There have been four cases where the popular vote winner has not been sworn in as president due to the peculiar anomaly known as the Electoral College.

The Electoral College is a controversial mechanism of presidential elections that was created by the framers of the U.S Constitution as a compromise for selecting a president by majority vote. At that time, some politicians believed it was too risky to let the people directly elect a president, while others objected to giving Congress the power to select the president. The compromise was to set up a system that allowed voters to vote for electors, who would then cast their votes for the candidates. This system is described in Article II, section 1 of the Constitution.

Each state has a number of electors equal to the number of its senators plus the number of its representatives. Currently, the Electoral College includes 538 electors, 535 for the total number of congressional members, and three who represent Washington, D.C.

On the Monday following the second Wednesday in December, the electors of each state meet in their respective state capitals to officially cast their votes for

don't exceed what you can reasonably expect to repay.

This simple distinction still applies: Taking on socalled good debt can help boost your credit rating or allow you to buy something that will increase in value over time, whereas bad debt often fuels the purchase of items that are disposable, unnecessary or rapidly depreciable.

One of the best ways to build strong credit history is to show lenders you can pay off debt responsibly. You're more apt to qualify for a mortgage, car loan, or other large debt if you've demonstrated sound repayment behavior. Just remember: Carrying multiple loans or highlimit credit cards could harm your rating, since lenders might worry you're taking on repay.

Student loans. The average college graduate earns \$47,422 a year, compared to \$26,349 for high school graduates - a difference of \$21,073. Using simple math, some calculate the difference in total earnings over a 40year work life as more than \$800,000.

However, such estimates don't factor in the crippling student loan debt many graduates face or their inability to worthwhile investment for many people if they don't go overboard on loans and choose a degree with good
