## We Demand, and they Supply

"But I must own, to the shame of my own countrymen, that I was first kidnapped and betrayed by some of my own complexion, who were the first cause of my exile and slavery; but if there were no buyers there would be no sellers."

It seems the real law of supply and demand, when it comes to the so-called "Black Community," is "We demand, so you had better supply."

And, according to recent statistics, the original principles of supply and demand do not apply to our consumer group; we will pay the price no matter how high it goes, as a matter of fact the higher the better, and we don't seem to care how low or how high the supply goes; we want our stuff and we want it right

now.

What a dangerous twist on the basic law of economics. Too bad it doesn't also apply when it comes to Black support of Black owned businesses.

Can you imagine what suppliers of the Black consumer market must be saying as they hear and see us demanding they supply more and more stuff for our conspicuous consumption habit?

I can hear them laughing now, as they gleefully count their daily receipts from demand-crazed Black purchasers of 24-inch rims that keep spinning when their truck stops, Black tourist who are always willing to turn their money over for the finer things in life, such as top-shelf liquor, suites and meetings in hotels we don't own, and admission to events we do not control.

We demand everything and supply very little of our own material desires. We demand that Arab grocery stores in our neighborhoods sell us good meat and treat us courteously, but we fail to take advantage of the same opportunity they exploited by starting our own grocery stores.

We demand the latest designs for our nails, and decry the Vietnamese for taking over the industry in less than 10 years, while many of our sisters walk past the Black-owned nail shop on their way to do business with someone else.

We demand the best service and response from a Black businessperson, paying attention to every detail of their business practices, and yet we go into major department stores each week knowing we are being watched because we are Black.

We demand "concessions" from convention bureaus in exchange for our tourism dollars, and they supply us with everything we demand, such as sumptuous banquets fit for Henry VIII, chauffeur-driven limousines, and fruit baskets in our rooms.

In extreme cases we allow them to invest, say, \$400,000 in pitching and wooing us, as was the case with the National Baptist Convention U.S.A., in exchange for a \$21 million return on their investment. They brag about

## For starters, Tyson to get \$14M from King

will have to fight — and fight often — to get out of debt, despite the prospect of a \$14 million payment from Don King to settle his claims against the promoter.

Tyson will drop his \$100 million suit against King in exchange for the payment, but the former heavyweight champion will see none of the money. It will go toward paying some \$38.4 million Tyson owes to various creditors, the Internal Revenue Service and his ex-wife, Monica.

To pay off the rest, Tyson's attorneys have laid out a plan in federal bankruptcy court in New York under which Tyson will fight seven times over the next three years. The plan is ambitious, if only because Tyson has fought only twice in the last three years for a total of about eight rounds.

## National Hip-Hop Summit set for St. Louis on Aug. 22

Vote! That's the rap that Ben Chavis and Russell Simmons hope to flow into the minds of the "hip-hop generation" through their Hip-Hop Summit Action Network from 12-4 p.m., Friday, August 22 at America's Center.

The Summit will be part of the 2004 Missouri Black Expo.

According to Chavis, president and CEO of the Hip-Hop Summit Action Network, 12 million "hip-hoppers," 18 to 35-years-old have registered to vote in the last three years.

The voting rate for African Americans also increased by four percent to 57 percent in the 2000 election, according to the U.S. Census Bureau.

The organization has held 22, "incident-free" summits in the United States, but the former NAACP national president said

they will convene what will be one of the largest and most impacting hip-hop summits ever in St. Louis.

The emphasis will be on voting in November's election.

"This is the first time we're having a summit in the context of a Black expo," Chavis said.

"And we know one of the largest gatherings in the state of Missouri is in fact the Missouri Black Expo, so we are very pleased to convene the St. Louis Hip-Hop Summit amidst the Missouri Black Expo."

Since St. Louis-based Anheuser-Busch is a major sponsor of the Hip-Hop Summit Action Network (and a 13-year sponsor of the MBE), Chavis said it should be one of the best.

## America Seeks Forgiveness Without Contrition

The statement President Bush issued at his news conference following the European Union reconciliation meeting in Ireland was as naïve as his May 2003 "end of war" pronouncement aboard the aircraft carrier Lincoln. "I think the bitter differences of the war are over. The United States and the European Union share a common commitment in our support for the Iraqi people... as they build a free, secure, democratic, unified, and prosperous country, at peace with itself, its neighbors, and with the wider world."

In his haste to get the Iraq political anchor off his back the President is now begging the European Union, the United Nations, NATO, and other world leaders for help in dealing with the Iraqi quagmire. Mr. Bush in his infinite wisdom stated, "NATO has the capability, and I believe the responsibility, to help the Iraqi people defeat the terrorist threat that's facing their country."

But just eighteen months ago the President along with his inner circle minions was waging a tactless, non-diplomatic, arrogant campaign that publicly humiliated those same organizations and world leaders as irrelevant and unnecessary to America's pre-emption war policy. There would be no discussion, no negotiations, and no supporting evidence -just the President's edict "you are with me or you are against me."

Down in the depths of this childlike philosophy Mr. Bush has discovered a rationale that not only absolves his administration of responsibility for the terror perpetrated by his misdirected war but also ordains tossing the resultant Iraq hot potato over to the international

community for resolution.

Somehow it has not dawned on him or his advisors that 'forgive and forget' does not relieve the people's bitter experience related to the dishonesty and violence at the hands of America. If the anger, humiliation and shame borne by the victims are not mitigated the likely result will be a continuance in the form of violence (terrorism) against other people. By asking victims to forget America is asking them to ignore their suffering or worse America is indicating their suffering has no meaning.

Now, as America races to divest itself of the war albatross and grovels before the same nations that it previously ignored there is still no indication of the slightest contrition.

The perpetrators of violence must acknowledge the injury caused before asking for forgiveness or seeking reinstatement into the world community. Forgive and forget is a convenient crutch for oppressors who are anxious to forget the pain and suffering they have caused.

By calling for instant reconciliation America is not demonstrating to the victims an understanding that forgiveness takes time. The survivors of the war violence need to experience justice and some form of restitution by which the perpetrators of violence acknowledge responsibility for their callous actions.

While America conducts a war to expand democracy around the world, the world is becoming increasingly distrustful of the democracy being sold. If democracy in the Middle East is so important why does America spend so much money propping up dictatorships in countries like Saudi Arabia, Turkey, Egypt, Jordan that we are friendly with?

A group of distinguished

scholars from the American Political Science Association recently released their report on Inequality and American Democracy. They found that, "The voices of American citizens are heard unequally. The report presents facts that support what many of us have experienced: A government that should be helping ordinary citizens rise up tends to help the privileged few who are already on top."

Too many Americans betray their obligation to be good citizens by turning a deaf ear and a blind eye to the irresponsibility of a president who continues to bring dishonor to the high office that he has sworn — in the name of God — to uphold.

America's Messianic myth currently propagated by the Bush administration (that God has sent him to save the world for democracy) illustrates profound arrogance. And until we change this hypocritical charade of promising democracy and freedom while delivering oppression, violence, suffering and death we will never convince the world that our democracy is an acceptable alternative for political, social and economic change.

Now is the time to make amends. The administration's arrogance and hypocrisy prevents the White House speechwriters from incorporating the humbling words "I've made a mistake and I'm sorry?" The President should throw out the hawkish cabal that has played this evil game of deceit, offer restitution to the countries America has wronged and take meaningful steps to deliver the best of America to the world instead of the worst.

That is the road to Christian forgiveness.

# Beloved Plano Matriarch, Library Founder dies

## Gladys Harrington 1901-2004

Mrs. Gladys Harrington, well known in the Plano community and loved by so many, passed away Sunday evening in her Plano home.

Harrington who was 103 years old is credited for establishing the Plano library system. Along with the Federation of Church Women she set up the first lending library to share with the community one of her favorite pastimes, reading.

"She will be missed in the community," said John Hightower, Advisory Board member of MON-The Gazette.

Hightower says he came to know Mrs. Harrington while working to help get the library built. Mrs. Harrington had recently celebrated her birthday at Henry Gentry's ice cream parlor and the celebration had to be split because so many wanted to wish her well.

Born Gladys Haggard Bishop, Harrington lived in Plano ever since she was 16, when she and her family moved

to the area. She married Fred Harrington fresh out of high school and together they tended and managed their farm, while raising two sons, Connor and



Joe.

Mrs. Harrington was a member of several civic and service organizations, including the Collin County Republican Party in which she has been called a "pioneer."

She was honored last year as a Collin County Community College inaugural Living

Legend where she also received an honorary associate of arts degree.

MON-The Gazette Advisory Board member Ben Thomas remembers Mrs. Harrington as having been a great friend of the family.

"She was a wonderful person to talk to and always had interesting things to say. We would share our thoughts on Plano and the way things were changing," Thomas said.

# Fireworks went on sale at midnight; Collin County officials offer safety tips

McKinney — Fireworks went on sale at midnight Thursday, June 24th in anticipation of Fourth of July activities, and officials in Collin County are urging residents to be responsible and play it safe.

In Texas, fireworks can be sold twice a year, from June 24th through July 4th and from December 20th through January 1st. Collin County's fire marshal is expecting approximately 55 retail fireworks stands to open this week.

The stands must be supervised by someone at least 16 years of age, and the vendors cannot sell fireworks to anyone under the age of 12. Additionally, smoking or open flames are prohibited within 10 feet of the stand.

Most cities in the county have specific ordinances that prohibit the sale, possession and discharge of fireworks within the city limits. Some of the larger cities with populations over 5,000 can also extend that ordinance and the enforcement into their ETJ.

There are certain regulations that persons must follow when igniting fireworks in the county. A person may not:

(1) explode or ignite fireworks within 600 feet of any church, a hospital other than a veterinary hospital, an asylum, a licensed child care center, or a public or private primary or secondary school or institution of higher

education unless the person receives permission in writing from that organization;

(2) sell at retail, explode or ignite fireworks within 100 feet of a place where flammable liquids or flammable compressed gases are stored and dispensed;

(3) explode or ignite fireworks within 100 feet of a place where fireworks are stored or sold;

(4) ignite or discharge fireworks in or from a motor vehicle;

(5) place ignited fireworks in, or throw ignited fireworks at motor vehicle;

(6) conduct a public fireworks display that includes fireworks 1.3G unless the person is a licensed pyrotechnic operator;

(7) conduct a proximate display of fireworks that include fireworks 1.3G or fireworks 1.4G as defined in NFPA 1126 Standards for the Use of Pyrotechnics before a proximate audience unless the person is a licensed pyrotechnic special effects operator and has the approval of the local fire prevention officer.

Violations of the above section 1-5 are Class C Misdemeanors and 6-7 are Class B.

In recent years, fireworks have been one of the leading causes of injuries serious enough to require hospital emergency room treatment. They can cause severe burns, fractures, scars or even death.

To help celebrate the holiday safely, the Consumer Product Safety Commission and the National Council on Fireworks Safety offer the following tips:

- Always read and follow label directions

- Always have an adult present

- Only buy from reliable fireworks sellers

- Only ignite fireworks outdoors

- Be sure to have water handy

- Never experiment or attempt to make your own fireworks

- Light only one at a time

- Never re-ignite malfunctioning fireworks

- Never give fireworks to small children

- Store fireworks in a cool, dry place

- Dispose of fireworks properly

- Never throw fireworks at another person

- Never carry fireworks in your pocket

- Never shoot fireworks in metal or glass containers.

"Although these are excellent tips, the best thing to keep in mind is that truly safe fireworks don't exist," says Collin County Fire Marshal Steve Deffibaugh. "My office will be out each night from the 24th through the 4th, doing fireworks stand inspections and assisting the sheriff's office on calls relating to fireworks."

Over the past few years the Hall of Fame has included legendary Dallas Cowboy Stars Tony Dorsett and Drew Pearson. The list of sports luminaries also included the late Dick "Night Train" Lane, NFL Hall of Famer; Rafer Johnson, who is a charter member of the U.S. Olympic Hall of Fame, the Hillsboro, TX, native competed in the Decathlon and won the Gold at the Rome Olympics in 1960. twice led the Cougars to the NCAA Final Four; Barbara Jacket, head coach of the 1992 Olympic women's track team in Spain; Ernie Banks, former player with the Chicago Cubs; and Bill Blair, former player with the Indianapolis Clowns, both were former Negro Leagues Baseball players.

In addition to the public recognition of these sports figures at the Banquet, the Hall of Fame's objectives are to collect and preserve objects documenting the history of the African American Texas athlete, create a permanent exhibition on the subject, and to develop educational programs for both children and adults.

Each year on the morning before the Banquet, the Museum presents A Family Day and Sports Clinic featuring current and former inductees. School age children and their families get to meet the athletes, secure photos and autographs.

Proceeds from the Banquet and Auction benefit the education programs and exhibitions of the African American Museum.

it, and a Black preacher says "This is good for the African-American community."

We demand reciprocity in the marketplace; they supply donations to our annual dinners. We demand fairness and equity from our tax dollars; they supply "economic inclusion goals" that never come to fruition - and we fall for it every time.

We demand better schools with all the bells and whistles and all the accoutrements of the finest prisons anywhere in the land; they supply padded construction contracts to their friends and relatives, sweetheart deals that contribute millions to their wealth.

Oh yes, they throw in the usual token contracts to the same token "minorities," and the beat goes on.

A Black construction company owner told me the situation in his city was so terrible that if Jesus paid them a visit He would think White folks were our slaves, because they were doing all of the work in Black neighborhoods.

That's funny, but the same would be true where I live as well. We have a billion-dollar school construction program in progress, and you can count on one hand the Black workers on the individual construction sites - right in the middle of 100 percent Black neighborhoods.

Yes, we demand and they supply. Our demands are so vehement and urgent that we have become personified profit margins, across the board, for virtually every business area in this country.

We demand to be served, and we are being served up by our timid, weak, greedy, so-called leaders. We demand to be treated properly, but oftentimes mistreat one another. We demand all of the things we need and want in life, but we are reluctant to supply those needs and wants to ourselves.

Other groups in this country are using us to create wealth for their families by supplying what we demand. Black people must decide to get on the supply side of this economic equation; we must decide to take control of more of our

resources and stop selling them to the lowest bidder.

We must decide to create a demand for our supplies by supporting our own businesses and growing them into bigger and better businesses.

There is no reason, except for lack of will, that Black folks could not have several billion-dollar businesses. How? By simply supplying more of our demands for food, clothing, shelter, and all the necessities of life that along with them.



The first of those fights will be formally announced Tuesday at a news conference in Louisville, Ky. Tyson will take on unheralded Danny Williams on July 30 at Freedom Hall in a bout that will earn him several million dollars to help satisfy his debts.

Assuming Tyson, who will be fighting for the first time in 17 months, beats the British journeyman, he could fight again as soon as the fall. That could be against the likes of light heavyweight champion Antonio Tarver or Lamon Brewster, who holds the lightly regarded WBO heavyweight title.

"He wants to put the past behind him and believes he can be champion again," Tyson's

manager, Shelly Finkel said. "And that would be a great story."

The other part of Tyson's story is well-known. The most feared boxer of his time, he spent three years in prison for rape and squandered some \$300 million in purses over the years.

At the age of 38, he's broke and living in a small house in Phoenix, where he's in training. His two homes in Las Vegas are up for sale, with the proceeds already earmarked for the bankruptcy court fund to pay his numerous debts.

The settlement with King is a key part of solving Tyson's financial problems. If the bankruptcy judge approves, King will pay \$8 million up front, with another \$3 million in January 2005 and \$3 million

more in January 2006.

Tyson had pinned his financial hopes on winning an even bigger settlement in court on his claims that King stole some \$100 million from him while promoting Tyson after he got out of prison in 1995.

But although Tyson's attorneys were confident in their case, they were concerned about how effective Tyson would be as a witness on his own behalf during a trial and whether King could win a jury over with charm.

For King, the settlement removes one more barrier between him and his former fighter. Since King controls many of the top heavyweights, there's a good possibility he will end up promoting Tyson fights again.

Tyson, who once vowed never to fight for King again, said in an interview last week that he wouldn't rule it out.

According to the plan filed Thursday in bankruptcy court in New York, Tyson will contribute the \$14 million from King, an estimated \$4.2 million from the sale of his two houses in Las Vegas, and \$19.5 million from future fight purses to a fund to pay creditors.

Tyson's first contribution will be a \$2.475 million payment on Aug. 4, followed by a \$2.31

million payment next Jan. 5. The biggest payment from the proposed series of seven fights will be in January 2006 when Tyson pays \$4.95 million.

The IRS is Tyson's biggest creditor, owed \$18 million by the former champion. He also owes taxes in several different states, including \$834,000 in Tennessee for his 2002 fight there against Lennox Lewis.

Under the plan, Tyson will also pay Monica Tyson \$9 million, beginning with a \$2.3 million payment when King

makes his first payment. Monica Tyson will also get \$750,000 from each Tyson fight.

Tyson also owes millions to unsecured creditors, who will be paid negotiated settlements totaling an estimated \$10 million.

For King, the \$14 million is the second big settlement he has made with an ex-fighter in recent months. In December he agreed to pay former 154-pound champion Terry Norris \$7 million to settle a lawsuit.





shared his culture and his language reaching out to his native community in the name of the Lord. Using praise and prayer, the evangelists spread the word and encouraged others to participate.

"He asked me to read just one verse from the bible and before I knew it I was preaching on the corner," said Santillan.

Daily, the evangelists set out to save souls. Their dedication to the Lord stayed with Santillan even as he strayed away from the teaching of Christ during his adolescent years.

Tired of ignoring his calling while living the street life, Santillan returned to the street corner.

"I just grabbed my guitar and my bible," Santillan says. "And I began reaching out to my neighborhood."

During this time Santillan met his future wife Diana Santillan. As husband and wife the Santillans made a promise to each other and to God. They would serve God together and he would keep them together.

One day while spending time with the Lord, Santillan heard his voice. From that day forward he knew he needed to come to The United States to share his vision, but how? For weeks Santillan tried to quiet the voice inside of him while trying to make a way to get his family to the U.S. By plane, by

train, by bus, he didn't know how to get to the place he needed to be.

While the Lord worked in Santillan's life, breaking down his resistance to follow his heart to the U.S. he delivered an answer.

"I had not told my wife about going to The United States or how the Lord had been working in my life, but she came to me. She said we must go to the U.S.

in our car going from country to country, city to city preaching the word of God until we arrived in the U.S.," Santillan said.

In 1989 the Santillans arrived in Florida to begin their life in a new land with a new language. Initially, the language barrier presented obstacles for the Santillan's ministry vision. Faith in God kept both pastors from losing their vision.

"It takes faith, knowledge and action to be a servant of God" according to The Rev. Pedro Santillan of Mount Olive Church of Plano. Christians must step out on faith daily and know that God has an action plan for their lives.

The Lord led the Santillan family to MOCOP in 1997

when they relocated to Plano.

"Pastor Sam and I have the same spirit," Santillan said. "I didn't talk to him about starting Hispanic services he just approached it."

Pastors Santillan and Fenceroy participate in various activities to unite their members. According to Santillan church members will understand more about multiculturalism the more involved members become in both ministries.

Santillan's vision for his ministry resembles his childhood street corner experience. The church has the ability to reach people, give them knowledge and send them out to teach others about what the Lord can do in their lives.

As part of a developing community outreach program, Santillan will begin a bilingual Christian day care which encourages children to take pride in their language and their culture. Additionally, Santillan will offer an evening ministry targeted toward the Hispanic youth. As productive citizens, Santillan believes the youth should give back to the community which has given them so much. The adult programs will include an education ministry educating men and women about the process involved in being a pastor. The program will last for 8-12 months and is intended to be a shortcut to becoming a minister according to Santillan.


Currently, Santillan and his wife hold services every Thursday and Sunday night.






