Cheryl Smith's commitment to historically Black colleges and universities is no secret so it was not a surprise when the veteran journalist was nominated for Alumnus of the Year.

Alumni from various (HBCU) across the nation gathered at the Holiday Inn in Dallas for the 7th Annual Black College Alumni Night, featuring dinner, memories and the crowning of Dallas Metroplex Council of Black Alumni Association's (DMCBAA) honoree.

Ultimately, KKDA-AM Talk Show host, Paul Quinn College Professor and Executive Editor of the Dallas Weekly, Cheryl Smith, walked away with the prestigious award.

"This award means so much to me," said Cheryl Smith during her acceptance speech. "I am and continue to be committed to providing support of Historically Black Colleges and Universities. It is important that when our children decide what college to go to, that they look to HBCUs as viable institutions of learning."

The DMCBAA was founded in 1987, by alumni of HBCUs who felt that collectively they could do more to further and champion the cause of HBCUs. The council is the brainchild of Ms. Smith.

Mr. Jones says about his involvement with literacy, "My role as a spokesperson gives me an opportunity to be a literacy advocate and travel across America reading to children to talk to them about the importance of books in their lives. It's by far the most enjoyable thing that I do."

Harry Belafonte And Farrakhan Speak At Economic Convention For African-Americans

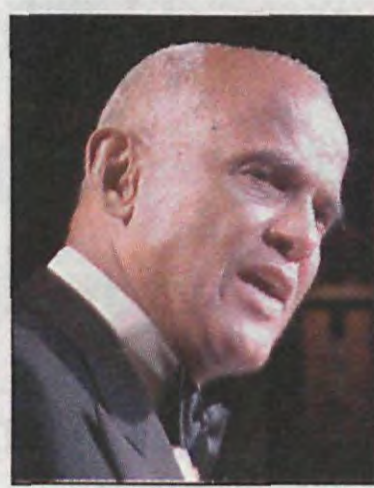
Entertainer Harry Belafonte renewed his criticism of President George W. Bush and black Muslim leader Louis Farrakhan urged education reform during the second day of the 2006 National Black Peoples Unity Convention.

The four-day gathering is aimed at developing a long-term economic empowerment plan for blacks.

Farrakhan, the head of the Nation of Islam group, said the U.S. educational system has failed to teach blacks basic skills and how to succeed after graduation and requires massive restructuring.

"Black people all over America and all over the world, there is something wrong with the way we have been trained in a white supremacist, racist environment," Farrakhan told about 700 people gathered in the gymnasium of Gary West Side High School on Friday, the Post-Tribune newspaper reported.

"You have not been trained to succeed," he said.



"We must never sell that lie to the next generation of black children, that the system works for all. It does not!"

The NAACP urged the Justice Department on Monday to block the upcoming mayoral election, claiming more must be done to reach

displaced city residents, most of whom are black.

The elections "cannot be conducted in a way that would guarantee, or provide some level of assurance, that substantial percentages of African-Americans, substantial percentages of New Orleanians, in fact would be able to vote," said Bruce S. Gordon, president of the National Association for the Advancement of Colored People.

Haitian President-Elect To Tour Americas For Economic Help

Haitian president-elect Rene Preval is to begin a multinational tour on Friday, visiting Argentina, Chile and Brazil, and later the United States, to drum up economic support, reports from Port-au-Prince said on Thursday.

Seeking the support needed to rebuild his country's infrastructure, boost economic growth and create jobs in Haiti, the winner of the Feb. 7 elections will first fly to Brazil to meet President Luiz Inacio Lula da Silva.

He will then attend the inauguration ceremony of new Chilean President Michelle Bachelet before visiting President Nestor Kirchner in Argentina. Finally, Preval will head to the United States to meet President George

Irving: Equal Access Or The Good Ole Boy Network?

Irving, Texas engenders an image of one of the more successful North Texas cities in recent decades. In addition to the National Football League Dallas Cowboys, Fortune 500 companies such as Exxon Mobil, The Associates and Microsoft have their national and regional headquarters in Irving. Success such as this is reflected in the tax base of the city, reportedly over \$14 billion. However, recent questions have surfaced regarding the fairness of the business practices of the city. Eyebrows were raised when it came to light that Irving has no written policies regarding the awarding of contracts to minority or women owned businesses (MWOB). The fact the city

has never had such a policy, causes community leaders to suggest the Good Ole Boy system is alive and very well in Irving.

Irving is the only North Texas city with a population of over 250,000 without a formal policy in place. While city leaders suggest there is no need for such a program, others strenuously disagree. Irving is one of only 19 cities in the United States to receive a bond credit rating of AAA, which qualifies the municipality for loans from financial institutions around the world. Community activist and founder of the Irving branch of the NAACP ten years ago, Mr. Anthony Bond, points out that one criteria utilized by

Answer To AIDS Mystery Found Behind Bars

It is one of the most puzzling mysteries of the AIDS epidemic: Why did blacks, in little more than a dozen years, become nine times as likely as whites to contract a disease once associated almost exclusively with gay white men?

Two researchers say they found the answer in an unlikely place: prison.

Rucker C. Johnson and Steven Raphael of the Goldman School of Public Policy at the University of California at Berkeley analyzed census data and a federal database containing detailed information on about 850,000 men and women who contracted AIDS between 1982 and 1996.

They discovered that the surge in black AIDS patients — particularly women — since the early 1980s closely tracked the

increase in the proportion of black men in America's prisons, which by the 1990s had become vast reservoirs of HIV, the virus that causes AIDS.

The percentage of prisoners who

were black increased from 40 percent in 1982 to well over half in 1996, according to government data. At the same time, get-tough sentencing policies more than doubled the prison population, producing even more infected black men who passed the disease on to black women after they were released.

Proud To Be An Active Partner In The Community

No Requiem For A Black Conservative

In a tear-jerk moment toward the end of Claude Allen's abortive Senate confirmation hearing for a spot on the federal appeals court in 2003, Sen. Orrin Hatch tossed him a puffball question. Hatch asked what Allen's grandfather, who was the first in his family born out slavery, would say to him about his pending judgeship. Allen, visibly moved by the question, said that he would tell him to give back to those who he received from.

Allen's answer told much about the GOP's two-decades long court and tout of black conservatives. And that hasn't changed, even when some of them embarrass the party with their shoot-from-the-lip gaffes or fall from grace in a swirl of corruption and scandal. Allen has fit the bill on both counts. In 1982, he embarrassed the GOP with his slurs against "queers," and two decades later during his confirmation hearing he didn't back away from those comments, claiming he had simply meant "odd or unusual" people. Now Allen, President Bush's former

domestic policy advisor, has been arrested on charges of stealing from department stores.

Last year, black Republican pitchman Armstrong Williams was reviled for grabbing nearly a quarter of a million dollars from the White House to pump Bush's education policies, all the while masquerading as a neutral media commentator. In each case, the disgraced black Republican administration appointees and boosters did not tumble as far from grace as might be expected. Their names quickly disappear from the scandal sheets. They are simply too valuable to be summarily tossed to the wolves.

But none of their efforts toutting GOP policies have helped much. Bush still got only a marginal bump up overall in the black vote in 2004, and with his Katrina bumble his poll ratings are stuck even deeper in the tank with blacks. Still, Republicans have done everything possible to ease the way up the political ladder for their bevy of black conservatives. Allen's career is a textbook example of that. He was barely out of the University of North Carolina

when he became the spokesman for Sen. Jesse Helms' re-election campaign in 1982. He moved from there to work for Republicans on the Senate Foreign Relations Committee. He then bagged a prize clerkship on the U.S. Court of Appeals for the D.C. Circuit. Next, he was appointed counsel for Virginia's Attorney General, and then he became Virginia's deputy attorney general and later secretary of health and human services. When his nomination for appeals court judge didn't pan out, Bush made him his top domestic policy advisor.

In years past, scandal-plagued black Republican boosters and appointees pretty much skated away with little more than a spate of bad publicity and a hand slap. Allen may not be as lucky. He may eventually be prosecuted. But as long as Republicans find men like him useful in their drive to make the party appear to be an authentic voice in black America, they'll do whatever they can to keep them as far out of legal harm's way as possible.

A friend of mine used to talk about "killing a mosquito with an ax", usually in reference to trying to make a bid in game of bid whist. It is a term that is applicable to any situation of extreme overkill. And, after some heated debate last week among the Dallas City Council, it is a term that applies to the city's new policy on towing the cars of uninsured motorists involved in accidents.

According to the Texas Department of Public Safety, one in five Texas drivers don't have the minimum liability insurance on their car as required by law. The soup du jour among area city governments is to pass law requiring requiring police departments to tow the cars of uninsured motorists. Such laws are now on the books in Arlington, DeSoto, Haltom City, Garland, Irving, Mesquite, Plano and Rockwall county. San Antonio, and now Dallas have joined Atlanta, Baltimore, Chicago and Philadelphia who have passed this type of ordinance. The Houston City Council is expected to consider a similar policy soon.

On the surface, towing the cars of uninsured motorists involved in accidents is great idea. As I've listened to this debate over the past few months, virtually everyone has a story about being hit by someone who had no car insurance. I moved to the Dallas area in 1989 and have been hit twice by uninsured motorists. I was faced with the unpleasant decision of fixing the car on my own or submitting a claim to my insurance company and watching my rates go up. For accidents that were not my fault. Not a good deal.

But like most things in life, the arguments you hear on the surface are not all there is to an issue. I've heard the stories,

which almost invariably end with some version of: "not only did they not have any insurance, but they didn't have a driver's license and spoke no english". The implication is that the offender was Hispanic and possibly an illegal. Last year, the Dallas Police wrote 94,000 citations to drivers for not having liability insurance. 32% of those drivers were Hispanic. Numbers aren't available on how many of those drivers were illegal, but it brings up a larger question:

Are implementing emotionally driven policies against uninsured motorists because of frustration with our state and federal governments in passing meaningful immigration legislation?

The problem with the towing ordinances is they are often full of loopholes which limit their effectiveness.

J. Robert Hunter, who specializes in insurance for the Consumer Federation of America, questioned whether such policies were effective in pushing people to obtain insurance. He has studied programs such as the one in Dallas and said they don't work-primarily because poor people who don't have insurance usually don't have a lot of assets at stake.

When the question is, "Do I feed my child or do I buy liability insurance? People just won't do it," he said.

If you are driving a car you bought for \$700, are you going to spend \$600 per year to insure it? Probably not. And if you are involved in an accident, get towed and charged a \$95 tow charge, a \$25 towing fee and \$15 dollars a day for storage-are you going to go buy insurance and pay all those charges to get your wrecked \$700 car back? Not hardly. What will happen is these folks will abandon the car at the impound and go buy another car for \$700.

One of the other potential downsides is a dramatic increase in the number of hit and run

accidents as the uninsured simply leave the scene in order to keep their vehicle. Or alternatively, the uninsured can, under Texas law, simply go buy a one month liability policy, present it to retrieve their vehicle and be back on the streets driving uninsured again in four weeks.

And I'm not even going to get into the logistics of adding an estimated 30 cars per day to an already overloaded Dallas City Impound; or the idea of police officers dealing with towing cars in a city with one of the highest crime rates in the country.

Nearly half the council members in Dallas expressed concern over the logistics and effectiveness of the policy.

"Sure, everybody should have insurance," said councilman James Fantroy. "But I don't want us putting something together that is creating revenue off poor people."

Council member Pauline Medrano said she fears problems from the discretionary power of the officer. "I'm afraid of someone in Oak Cliff being stopped and having their car impounded, and someone in another part of the city being let off the hook."

"I have heartburn about how this is going to operate," said Deputy Mayor Pro Tem Elba Garcia. "I hope we look at the big picture."

I've been poor and one thing I know for certain is that poor people find a way. That's why there are six year olds with utility bills in their names. If people can't afford insurance they will find a way around it. That doesn't mean we need to enact knee-jerk laws without thinking them all the way through.

Bridges For The Disabled: Marriott Foundation And DISD

The disabled in society face challenges from acceptance to education to employment.

The Marriott Foundation and the Dallas ISD are teaming together in a new program to help eliminate some of those challenges.

The Marriott Foundation for People with Disabilities established Bridges... from school to work 16 years ago to address the high level of unemployment experienced by people with disabilities. Studies indicate that adults with disabilities are much more likely to be employed if they enter the workforce at an early age.

Over half of the 250,000 young people that finish special education annually remain unemployed or significantly underemployed a year later. Most are willing and able to work, but have not been given the opportunity.

Bridges from School to Work, was instituted by the Marriott family in 1989 as a result of the birth of a disabled

child. The program was created to include disabled as well as special needs students who will be graduating from high school. The program parameters expanded to incorporate at risk students as well.

The Foundation provides job placement for the targeted students to businesses within the communities they serve. Currently, the program is active in Philadelphia, Washington D.C., Atlanta, Chicago, San Francisco, Los Angeles and most recently, Dallas. They work with over 1500 employers within the 7 metropolitan areas it serves. Over 89% of the participants receive offers for ongoing employment. Bridges partnered with the Dallas ISD in November of 2005.

Since its inception in 1989, the program has placed 8,500 high school seniors into active employment. Dallas ISD is acting as a pilot for the program in Texas. The initial funding for this program in Dallas was granted by Pitney Bowes.

"We have anticipated bringing

Bridges to Texas for some time, and greatly appreciate the support of the Pitney Bowes Literacy and Education Fund in helping make this a reality," said Richard Marriott, chairman of Host Marriott Corporation and the Marriott Foundation for People with Disabilities. Mr.

"DISD has been focusing on transition efforts for the past

five years to help our students with disabilities prepare for living and working in the community once they leave school," said Superintendent Michael

Hinojosa. "The 'Bridges...from school to work' program offers a great opportunity for the district's youth to continue learning as they acquire skills that will help them become productive citizens in their adult life."

Emi Williams, program coordinator for Dallas, states that the goal is to expand the program to include other ISD's around the Metroplex. According to Ms. Williams, participants will remain in the Bridges database for a minimum of 2 years to track their progress. Since November, ten participants have been placed and thirty are in process from DISD. Participants for the program are referred by the Vocational Adjustment Coordinator from DISD.

"I believe that the opportunities that are created by the program are rewarding for both the students as well as the employers," Ms. Williams said.

The employers that are currently involved in the Dallas area are; McDonald's, Olive Garden, Albertsons, Kroger and

the Dallas Renaissance Hotel. Ms Williams is very passionate about the program and the students it serves.

"For most employers, there are usually only minor accommodations required to place participants of the program, such as writing down tasks instead of verbally assigning them," she added.

In addition, Ms. Williams believes that Marriott Foundation... Bridges from School to Work will prove to be a valuable asset to the Dallas communities as it has for the other cities it currently serves.

House Of Blues Deal Set For Downtown

Representatives from developer Hillwood Capital said Friday they have finalized a deal with the House of Blues to open a live-music venue on the edge of downtown.

The location? The historic White Swan building, at the crossroads of the West End and the Victory development.

"We have made a deal, and we're working through some of the final details," said Jonas Woods, president of Hillwood Capital. "We want them open ASAP."

House of Blues representatives declined to reveal specifics of the deal, which they described as "not quite finalized." They first considered opening in Dallas in 2000, but those plans didn't materialize.

Said Jack Gannon, senior vice president of marketing: "We're very excited about the Dallas market. The addition of a club

is very attractive to us."

House of Blues already promotes concerts at Smirnoff Music Centre.

Mr. Woods confirmed that House of Blues will be leasing the building on North Lamar Street and hopes to open its doors by late this year or early next year. The White Swan building is owned by Hillwood Development in partnership with Tomlinson-Leis Corp.

The deal came Friday afternoon after a closed-door meeting at City Hall, where House of Blues officials quizzed city planners and put the finishing touches on their plan. Dallas director of development Theresa O'Donnell said the city has agreed to make some infrastructure changes, such as moving some curbs on North Lamar Street for easy tour-bus entry, to accommodate House of Blues' needs.

"We are incredibly excited about being one of only two locations in Texas to bring this type of stellar, national-caliber entertainment venue," Ms. O'Donnell said. "We think it's a tremendous catalyst to re-energize the West End." House of Blues plans to open in Houston in 2007.

City officials aren't the only ones welcoming the House of Blues to Dallas. Mike Schoder, owner of the Granada Theater on Greenville Avenue, takes an optimistic, capitalist view on a House of Blues in Dallas: Any competition is good.

"It's like fast-food restaurants, really: Put five or six of them together in one place, and all of them usually do good," he said. "Dallas doesn't have a lot of promoters, comparatively speaking, especially compared to places like Houston and Austin, so figuring out how to get people interested in the idea of going to

see music will be key. And House of Blues is good at that.

"House of Blues has the financial backing to take chances with artists, such as ones that demand a sellout, that demand that you promote the show to make it sell out. It has the tools to wrap around that to make that happen through a lot of advertising, a lot of promotional techniques."

David Card, owner of Poor David's Pub on Lamar Street just south of downtown, was a bit more skeptical for the same reasons. Another big live-music player could threaten his and other locally owned venues.

"A venue of that stature and reputation will certainly ... put Dallas a little more on the map for relevant acts," he said. "It will help downtown. Will it help everyone downtown? Probably not. Will it put another nail in the coffin for Deep Ellum? Very possibly."

Twenty D-FW Residents Make Forbe's Annual Billionaire List

Twenty Dallas-Fort Worth residents made the latest Forbe's list of the world's richest people, including Fort Worth homebuilder Don Horton, who's on the list for the first time.

Horton debuted at No. 606 with an estimated net worth of \$1.3 billion.

Alice Walton, whose family founded Wal-Mart Stores Inc., ranked 20th on the list, the highest of North Texas residents with an estimated net

worth of \$15.7 billion. Walton, who lives on a ranch in Mineral Wells, was one of several Waltons on this year's list.

Robert Rowling, whose main source of money is oil and gas and other investments, ranked 52nd with a \$4.8 billion net worth. Ross Perot, whose main source of money is from investments, ranked 75th with a net worth of \$4.3 billion.

The Bases of Fort Worth, regulars on the list, were also there, ranging in rank from No. 200

(Robert Bass/\$3.4 billion) to No. 746 (Perry Bass/\$1 billion).

Mark Cuban, owner of the Dallas Mavericks, who became instantly wealthy after selling Broadcast.com several years ago, ranked 428 with \$1.8 billion.

Others from Dallas-Fort Worth on the list included philanthropist Harold Simmons, oilman Ray Hunt, investor Richard Rainwater, banker Gerald Ford, oilman T. Boone Pickens, Dallas Cowboys owner Jerry Jones,

Excel Communications' Kenny Troutt, Fort Worth socialite Anne Windfohr Marion, and businessmen Todd Wagner and Samuel Wyly.

Texas had 33 on the list, with Michael Dell of Dell Computer leading the pack at No. 12 with \$17.1 billion in net worth. Microsoft Corp. founder Bill Gates is the world's richest man -- for the 12th year, according to Forbes.

UTD Releases Business School Rankings

Only one Texas business school ranks in the top 10 on the 2006 list of the top 100 business schools released Friday by the University of Texas at Dallas School of Management.

The "UTD Top 100 Business School Research Rankings" are based on the research productivity of the business schools' faculties. UTD has tracked the publications of business school faculty worldwide since 1999 in 24 leading academic journals, all of which are peer-reviewed, according to a news release. Stern School of Business at New York University; Columbia Graduate School of Business at Columbia University; and the Sloan School of Management at Massachusetts Institute of Technology.

Rounding out the top 10 schools are the Graduate School of Business at the University of Chicago, No. 6; The Red McCombs School of Business at the University of Texas at Austin, No. 7; UCLA Anderson School of Management at the University of California at Los Angeles, No. 8; Kellogg School of Management at Northwestern University, No. 9; and the Ross School of Business at the University of Michigan at Ann Arbor, No. 10.

Other Texas business schools on the list are the School of Management at the University of Texas at Dallas, No. 33; Mays Business School at Texas A&M University at College Station,

No. 43; Edwin L. Cox School of Business at Southern Methodist University, No. 57; Jesse H. Jones Graduate School of Management at Rice University, No. 61; C.T. Bauer College of Business at the University of Houston, No. 70; and Neeley School of Business at Texas Christian University tied for No. 99 with the College of Business Administration at Oklahoma State University.

Chamber Develops Campaign For Texas Stadium Redevelopment

The Las Colinas Chamber of Commerce has formed a special committee to garner support for two Texas Stadium propositions on the ballot of the May 13 special election in the city of Irving.

If the propositions are approved the city council will

be able to impose a \$3 per vehicle parking fee at the stadium, charge state approved user fees of up to 10 percent per ticket and charge up to a maximum of \$5,000 per game for each football team member, including visiting teams.

The money would be used to

support redevelopment of the Texas Stadium in Irving that will be vacated when the Dallas Cowboys new stadium in Arlington is built.

Redevelopment options for the 400-acre area are being looked at by the City of Irving and adjoining property owners,

including the University of Dallas and Southwest Premier Properties.

Future development options include a convention center, civic center, a hotel, apartments, shops and waterfront retail development, recreational facilities and park space.

strongly denounced by Louisiana's top election official.

"This will be the most accessible race in the history of America," said Secretary of State Al Ater.

A federal judge has turned back challenges to the election and pressed state officials to make sure it is held by the end of April. But before the election can take place as scheduled April 22, the Justice Department must give its blessing.

Gordon said the department is expected to rule this week. Eric Holland, a Justice Department spokesman,

would not comment.

Primary races for mayor and many other city positions were originally scheduled for Feb. 4, but were pushed back because so many polling stations were destroyed and election workers and voters scattered by Hurricane Katrina.

In the city itself, there will be super-polling places on election day that combine flooded-out precincts. Around Louisiana, polling places will be set up for displaced voters to cast early absentee ballots. Also, state workers will be deputized to help local offices. Around the country, full-page newspaper ads and television spots are being used to inform voters how

to vote by mail.

The NAACP says satellite polling stations should be set up in cities outside Louisiana, especially in Houston and Atlanta where there are large numbers of displaced New Orleanians. Ater said it would not be possible now to add that to the plan.

"We're just in a new territory, a new area where this has never

been done before," said Linda Walker, head of New Orleans branch of the League of Women Voters. The plan "is probably adequate for what we have right now, but is it completely fair? I can't say at this point."

The fairness of the election probably can't be determined until after the primary when it's clear who voted and who didn't, Walker said.

sugar and coffee industries, two sectors in which the largest South American country has had major successes. Haiti's agriculture has been ravaged by bad farming practices, exhausted earth and a lack of investment.

He will make a trip to the U.S. on March 27 and March 28, meeting with the President Bush, as well as officials from the Organization of American States, the World Bank, the International Monetary Fund

and the United Nations.

The tour is the second foreign trip Preval has made since winning the elections. At the end of last week he visited the Dominican Republic, the state which shares the island of Hispanola with Haiti.

Preval is due to take office on March 29, but there are signs that he might postpone his inauguration till the completion of the second round of legislative elections. Haiti's constitution prescribes that the inauguration must take place before a full parliament.

University of North Texas Chancellor Lee F. Jackson hosted a "topping out" ceremony to celebrate the completion of the framing stage in the construction of the first building on the campus of the future University of North Texas at Dallas on March 9 (Thursday).

Dallas Mayor Laura Miller, State Senator Royce West of Dallas and a distinguished gathering of city, regional and state officials; UNT regents; and North Texas business leaders joined Jackson in commemorating the event on the 264-acre UNT at Dallas campus site.

The UNT System and Hunt Construction Group Inc. sponsored the event.

Chancellor Jackson, Mayor Miller, Senator West and Mark La Voy (executive vice president of Hunt Construction Group) made brief remarks about this landmark step toward the estab-

lishment of the first public university in the city of Dallas. Then, all ceremony participants signed the last beam before the construction crew hoisted it into place on the three-story structure.

"This building is already visible for miles around, and it will be a landmark symbol of what Dallas and UNT are building together in southern Dallas County," Jackson said.

Construction of the \$25 million facility began in October 2005. The 75,000-square-foot academic and administrative building will be completed in December of this year and will open for UNT Dallas

Campus classes in January 2007. A team led by Hunt Construction Group Inc. — including firms

classified as Historically Underutilized Businesses — is managing the project.

The new building, with its panoramic views of the downtown Dallas skyline, will provide

classrooms, meeting rooms and office space and serve as a gathering place for students until the next phases of campus development are completed.

A \$500,000 grant from the Hoblitzelle Foundation of Dallas, awarded last November, will help the UNT System equip the new building with an infrastructure of state-of-the-art technology.

High tech equipment planned for the new building (and eventually for the entire campus) includes electronic signs at the door of every classroom, video conference rooms, a wireless data network and other networking and communications and audio-visual infrastructure.

Until the new university officially opens, the UNT System is offering an increasing number of classes and programs at the UNT Dallas Campus (also known as the UNT System Center at Dallas).

RHS Mock Trial Team Finishes Second In Texas

The Richardson High School Legal Eagles competed in the 27th Annual Texas High School Mock Trial Tournament on March 2-4 in Dallas. The Legal Eagles, after capturing the Region 10 championship, faced four rounds of preliminary competition against Hooks, Edinburg North, Woodrow Wilson and Boerne High Schools. The team advanced to the Final Four and defeated Skyline High School in the semifinals.

The state championship was held before Federal District Court Judge Jerry Buchmeyer in the Earle Cabell Federal Courthouse against Carrollton Creekview. Creekview prevailed as the jury split 8-5.

Mock trial competitions require students to act attorneys for the plaintiff or defense in fictitious cases argued in

actual courtrooms, adhering to legal protocols. Pitted against students from other teams representing the other side, a jury listens to the evidence and votes on a winner.

The civil case, Kerry Grandt vs. Special Operations Security Inc, involved a claim of negligence security that resulted in the poisoning of a water reservoir with a biological agent - Blumetheria. The students were given basic fact statements from six witnesses, excerpts of pleadings and modified federal rules of evidence. The students then must prepare both the plaintiff and defense sides of the case - playing the roles of attorneys (3 per side) and witnesses (3 per side).

Teams are judged by local attorneys and judges.

"The Mock Trial program at Richardson High School contin-

ues to be outstanding," said RISD Superintendent Jim Nelson. We are proud of their

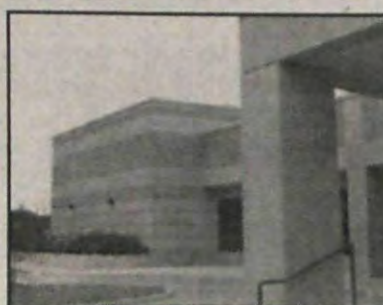

So powerful is the relationship between race, prison and AIDS that it almost completely explains why half of all new AIDS patients in 2002 were African Americans even though only 12 percent of the population is black; in 1982, African Americans made up less than a quarter of new AIDS cases. The link remained strong even after researchers controlled for factors associated with AIDS, including the use of crack cocaine, Raphael

said.

Part of the reason for the rapid spread of AIDS among African Americans is that so many black men spend time behind bars, Johnson said. About one out of 12 black men are in jail or prison, compared with one in 100 white men; at current rates, a third of all black males born today will do time.

What explains the black-white prison gap? Raphael said the question is beyond the scope of the study, but other researchers point to poverty, a lack of

opportunities, racism in the criminal justice system and the lure of the "thug life."

Whatever the cause, the AIDS gap is not going away. Other studies suggest that half of all prisoners engage in homosexual sex. But safe-sex programs, key to controlling AIDS in the gay community, are unwelcome inside prison walls.

In fact, "it's illegal to distribute condoms in prisons in all but one state" because lawmakers fear it would encourage gay sex, Johnson said.

Isaac Hayes has quit "South Park," where he voices Chef, saying he can no longer stomach its take on religion.

Hayes, who has played the ladies' man/school cook in the animated Comedy Central satire since 1997, said in a statement Monday that he feels a line has been crossed.

"There is a place in this world for satire, but there is a time when satire ends and intolerance and bigotry towards religious beliefs of others begins," the 63-year-old soul singer and outspoken

Scientologist said.

"South Park" co-creator Matt Stone responded sharply in an interview with The Associated Press on Monday, saying, "This is 100 percent having to do with his faith of Scientology. . . . He has no problem -- and he's cashed plenty of checks -- with our show making fun of Christians."

In November, "South Park" targeted the Church of Scientology and its celebrity followers, including actors Tom Cruise and John Travolta,

in a top-rated episode called "Trapped in the Closet." In the episode, Stan, one of the show's four mischievous fourth-graders, is hailed as a reluctant savior by Scientology leaders, while a cartoon Cruise locks himself in a closet and won't come out.

Stone told the AP he and co-creator Trey Parker "never heard a peep out of Isaac in any way until we did Scientology. He wants a different standard for religions other than his own, and to me, that is where intolerance and bigotry begin."

Patent Offense: Wayans's Hip-Hop Line

Officials Reject Actor's Bid To Trademark Racial Slur

It appears that Homey D. Clown still has a few tricks up his sleeve. You remember Homey -- the nutty street clown on the comedy show "In Living Color" who kept kiddies at birthday parties in line by whomping them over the head with a heavy sock and saying, "Homey don't play that."

The character disappeared when the show's run ended in 1994, but the guy who portrayed him, Damon Wayans, is still around. He recently starred in the now-canceled ABC sitcom "My Wife and Kids" and is trying to launch a hip-hop clothing line -- with a trademark that rapper Jay-Z famously rhymed with "Jigga."

But the U.S. Patent and Trademark Office don't play that. Its blunt rejection of Wayans -- twice so far -- amounts to its own sock over the head. Officials won't comment on their decision, but trademark attorney Paul Fleischut of St. Louis says the dismissal is a no-brainer.

"There is an act by Congress

that says you cannot register a word that is scandalous or that disparages a particular group," says Fleischut. Wayans's New York lawyers are pressing his case, but, says Fleischut, "It doesn't look good."

And it turns out that Wayans's



idea isn't all that original. The files at the patent and trademark office are littered with the remains of "dead" applications seeking exclusive rights to one or another version of the N-word.

In 1995, Marc Anthony Fitzgerald and Fred Harris of Houston sought to trademark the words "Naturally Intelligent God Gifted Africans" and turn it into a peculiar acronym. Four

years later, Scapheld Productions in Cincinnati sought to trademark "Rilniga -- any individual true to his actions and or statements."

The next year, Damon James of Houston put "Field" in front of the word and tried to trademark it. In 2001, Wayne Jeffery Davis of New Orleans tried to trademark a 78-word rant that ended with the N-word, so that he could stick it on a T-shirt.

When 2003 rolled around, Keon Rhodan of Charleston, S.C., gave it a try, seeking exactly what Wayans asked for, except that Rhodan added the word clothing on the end.

Wayans, whose application was submitted early last year, could argue that the word he hopes to trademark, "Nigga," is different, says Todd Boyd, a professor of critical studies at the University of Southern California and author of the book "The New H.N.I.C.: The Death of Civil Rights and the Reign of Hip Hop."

"I don't think it's the same thing," Boyd says. "Hip-hop has redefined the word. It can mean a number of things. It can be a term of admiration. It can be a term of recognition."

Earlier this month, for example, a mostly white jury in Boulder, Colo., cleared a man of ethnic intimidation for using the

comparison, Plano reportedly offers an open house for MWOB's monthly resulting in awarding about \$20 million contracts to MWOBs in fiscal 2004-05.

Mr. Bond, and Mr. Fletcher Yates, current Vice-President of the Irving NAACP, along with key Hispanic leaders are holding a series of meetings on racial reconciliation in Irving. The first meeting held in October and attended by over 250 people, resulted in a recommendation to the city leaders: form a cultural advisory community board. Recently elected Irving Mayor Herb Gears and the city council have agreed and the advisory board is currently in development. The meetings regarding a dialogue on racial reconciliation will continue independently with at least three more slated.

Mayor Herb Gears, who did not return phone calls for comment, has received favorable reviews from community leaders due to his responsiveness thus far to concerns. However, the leadership caution talk is cheap and promise to remain watchful to ensure that the mayor and city follow through

and promised results are forthcoming. "The minority community put him in office and we will hold him accountable to make sure we open up the contracting opportunities," according to Mr. Bond.

While Mr. Leininger emphasizes Irving awards contracts to vendors based on factors such as lowest bids is an effort to wisely spend the taxpayers money, Mr. Yates, retired Manager/Supervisor of Passenger Services for American Airlines for 31 years, points out that vendors routinely submit change order requests for additional funds. Therefore, although the awarded contract was initially a lower bid, the amount spent can ultimately be the same or higher dollar figure submitted by competitor bidders.

The concerns regarding the contracts are not the only issues on Irving's radar. As a result of recent incidents related to problems in the school district, incidents of police brutality and alleged racial profiling - the US Department of Justice is working with community leaders such as Mr. Bond, the NAACP and others to investigate concerns regarding civil rights abuses.

several of the major companies when selecting Irving, was the city's diverse population and work force. Yet, while city leaders may use this as a selling point in promoting the city to the business community, it is suggested that Irving does not appear to make diversity a priority with their own procurement policies.

Chief Financial Officer of Irving, Mr. David Leininger, points out, "We do not have a procurement policy that picks out any category of vendor. You could also ask about Irving based vendors." Instead, Mr. Leininger stresses that the city made a determination to focus on ease of access and communication to the broadest base of vendors in the marketplace and to not have set asides steering contracts to a particular vendor category.

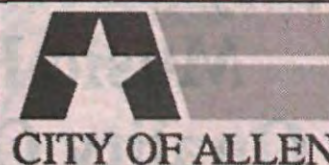
Mr. Leininger feels it is important the procurement management team of the city reflect the population they serve and highlights that his staff includes bi-lingual Hispanic and African American personnel. Mr. Leininger also indicated that the suggestion set asides should be in place for MWOB can be insulting to these parties, as he says many feel "I just want the opportunity to compete and I am confident that I would be successful."

Until recently the city did not track demographic statistics on those bidding on contracts, but in December instituted changes to record this information. However, Mr. Leininger points out it will take between two - three years to capture bench marking statistics. According to Mr. Bond, other cities with a population over 50,000 participate in the North Central Texas Regional Certification Agency which track MWOB. When asked about Irving's lack of participation in the program, Mr. Leininger stated that without the bench marking statistics to compare Irving's current status there is means of determining the need for the city's participation. He stated he is anxious to see how Irving has done in this area in comparison to participating cities.

According to Mr. Leininger, Irving does not rely only on the newspapers and Irving's website, but utilize other appropriate websites and direct mailings to inform potential vendors of contract opportunities. In addition, they host an annual meeting with MWOB owners regarding potential contracting opportunities and suggested this program may be expanded to bi-annually. In

We continue to address the importance of Black women in America; and about the myriad (innumerable) ways they have changed the world. This year's theme: "Women: Builders of Communities and Dreams," honors the spirit of possibility and hope set in motion by generations of Black women in their creation of communities and their encouragement of dreams. Black women have always played a vital role in shaping Americans history; I will continue to honor them in my column this month.

Bessie Coleman, the first Black American woman aviator, had a postage stamp issued in her honor in 1995. Sarah E. Goode, the first Black female patent holder. She was issued a patent in 1885 for a Folding Cabinet Bed. Miriam E. Benjamin, the second Black woman in history to receive a patent; it was for a Gong and Signal Chair for motels in 1888. Patricia Bath was the first Black female doctor to receive a patent for a medical invention; a machine for ablating and removing cataract lenses.

Ruane Jeter invented a digital Toaster in 1987. Henrietta Mahim Bradberry invented a bed rack which was an attachment to the bed that permitted air to pass through and refresh worn clothes in 1943; and in 1945, the device operated pneumatically and was adapted to discharge torpedoes under

the water surface (the Torpedo Discharger.) Virgie M. Ammons invented a Fireplace Damper actuating tool in 1975. The instrument opens and closes a fireplace damper and is also intended to operate as a securing means to prevent fluttering of the damper due to wind.

Marie V. Brittan Brown invented the Video Home Security System that utilized television surveillance in 1969 (the same year that Minister Sheila Tarpley Lott, my only daughter

Mary McLeod Bethune founded the National Council of Negro Women; now known as Bethune-Cookman College. A postage stamp for her was issued in 1985. Mahalia Jackson, "Queen of Gospel Music." 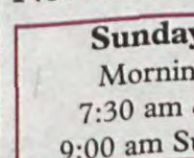

New Orleans Black Parish Faces Uncertain Future

After Hurricane Katrina, Roman Catholic Church considers consolidation

Mass as one of the nation's oldest black Roman Catholic parishes was filled with jazzy renditions of gospel songs and prayers that church officials would reverse their decision to merge it with another parish, a move prompted by the financial strain of Hurricane Katrina.

"A parish is family. A parish is generations. A parish is your history," said Sandra Gordon, who began attending St. Augustine Church as a child, after Hurricane Betsy wiped out her family's previous parish in 1965.

St. Augustine, founded in 1841 by slaves and free people of color, is among the parishes the archdiocese plans to consolidate as it seeks to deal with \$84 million in uninsured losses.

The archdiocese is careful to point out that St. Augustine's will only close as a parish but will still be open for Mass on Sundays and some other functions like funerals and weddings.

Heavy cross to carry

Its building suffered only wind damage from Katrina and will remain open. "Show up on Sunday, and you won't miss a beat," said the Rev. William Maestri, a spokesman for the archdiocese.



But members of the parish, though, say it's not enough. They officially appealed the decision to the Archdiocese of New Orleans on Thursday and expect a response Monday.

St. Augustine sits in a low- to middle-income racially diverse neighborhood near the French Quarter; the music, this Sunday played by Ellis and Bradford Marsalis, is jazz. About half of the 350 pre-Katrina families that belonged to the parish have returned, and many have suffered heavy damage to their homes,

including Gordon.

"This is a very, very heavy cross for us to carry right now," said Gordon, likening the parish's struggle to the Friday before Jesus' resurrection. "The church will be resurrected. We will have the victory."

Hundreds of structures in the archdiocese, including schools, churches and administrative buildings, were damaged when the storm blew in Aug. 29 and four-fifths of the city was covered in water.

Many at the church note how important the church is historically.

It was founded by slaves and free blacks with the blessing of the archdiocese and birthed the second order of black nuns in the United States in 1842. It was largely a parish of Italian immigrants in the early 1900s but morphed back into a predominantly black church in the 1960s as white residents left the Treme neighborhood.

Its long history in New Orleans means many of the city's black residents have some tie to St. Augustine, which was standing room only on Sunday.
