



Known for her uncompromising integrity and drive, Kennedy made history when she graduated as the first black female in Texas with a degree in architectural engineering and again when she became the first black female to

Leadership of 5 House Panels, Majority Whip's Job Could Go to Caucus Members

Three days after workers broke ground for the Martin Luther King Jr. Memorial on the Mall, the Congressional Black Caucus is preparing to break new ground of its own.

Five of its members are poised to take the helm of key House committees when Democrats assume control of Congress next year: John Convers Jr. (Mich.) of Judiciary, Alcee L. Hastings (Fla.) of intelligence, Juanita Millender-McDonald (Calif.) of House Administration, Reps. Charles B. Rangel (N.Y.) of Ways and Means, and Bennie Thompson (Miss.) of Homeland Security.

Another member, Rep. James E. Clyburn (S.C.), is slated to be named majority whip, which would make him the third-ranking

On top of all that, Black Caucus members, who tend to be more liberal, might find it hard to push their traditional social agenda. Conservative and moderate "Blue Democrats, whose numbers are nearly equal to those of Black Caucus members, have vowed to counter agendas that they deem too liberal.

# King Family **Dedicates New Crypt**

Coretta Scott King, MLK Rest Together

On April 3, 1968, Coretta Scott King kissed her husband goodbye before he flew to Memphis to organize a march. An assassin's bullet would ensure that it would be the last time she would see the Rev. Martin Luther King Jr. alive again.

On a blustery Monday afternoon 38 years later, the two were united spiritually when the King family unveiled a blinding white crypt that would house their

"It is altogether fitting that Martin and Coretta are here in this place, just as their spirits are together for all of eternity," said Christine King Farris, Martin Luther King Jr.'s "Martin and Coretta are free at last, united forever in God's love."

In what was one of the coldest days of the season, hundreds of people - common folks and dignitaries - braved the weather to pay their respects to the Kings.

Among the several hundred people attending were U.S. Rep. John Lewis, civil rights leader the Rev. Joseph Lowery and his wife, Evelyn, activist Dick Gregory and Bishop Eddie Long of New Birth Missionary Baptist Church. Former Atlanta

# **UN Flies In More Aid To Hundreds Of Thousands Of** Flood Victims In Horn Of Africa

Plano Fire Station 11

**Begins Operation** 

By truck, donkey cart and on foot, thousands of Somalis who have already fled fighting and drought in their homeland are trekking from flooded refugee camps to drier ground in northeast Kenya as United Nations agencies rush in emergency supplies for up to 1.8 million people hit by the worst floods in years in the Horn of Africa.

"Health and sanitation remain a serious concern," UN High

Commissioner for Refugees (UNHCR) spokesperson Jennifer Pagonis told a news briefing in Geneva today of the Somalis in the Dadaab complex, where the agency has already flown in five planeloads of relief supplies since Sunday. "The general health of the population has deteriorated due to the conditions, lack of food and sleep and difficulty in accessing medical care.

"Latrines throughout the camps have been flooded, contaminating standing water and posing a serious health risk. Fever, diarrhoea,



eye and skin infections are common. UNICEF [UN Children's Fund] and other agencies are bringing in vaccines and other supplies to combat the spread of disease," she added.

Silly me, I actually thought we were finished with O.J. Simpson.

For some strange reason, I believed white people were fresh out of hatred and loathing for Orenthal James Simpson. I also believed black people were finished being angry at O.J. for playing them like a fool during his murder trial at subsequent acquittal, (actually, very few black people got played, but I'll get to that in a minute).

Was 1994 really that long

1994 was when we first associated Mr. Simpson with murder, following the gruesome June 12 stabbing death of Nicole Brown Simpson and Ron Goldman in posh Brentwood California. Up until then he was just a grinning ex football player who couldn't make it in sports commentating, but pitched cars for Hertz and appeared in some Naked Gun movies. O.J. was acquitted of the double murder in 1995.

I found out this week exactly how long memories run in these United States, at least when it comes to hatred.

For reasons that escape nearly everyone on the planet, (insert the word money here), O.J. recently announced that he was releasing a book with the ludicrous title of "If I Did It". The preposterous book was to highlight Simpson "theorizing" on how he would have killed his ex-wife and her friend "if" he had committed the murders. If this was not crazy enough, O.J was schedule to give a two-part interview Nov. 27 and Nov. 29 on Fox, with the book to be released on Nov. 30.

At least that was the plan until Fox owner Rupert Murdoch put the brakes on the whole shebang on Monday.

"I and senior management

that this was an ill-considered project," said Murdoch, whose News Corp. owns both Fox Broadcasting and publisher HarperCollins. "We are sorry for any pain that this has caused the families of Ron Goldman and Nicole Brown Simpson."

That Rupert Murdoch is one funny Australian.

This is the same Fox network that has introduced us all to quality programming like "When Animals Attack".

Murdoch canceling the O.J. book and TV interview had nothing to do with taste or concern for the families of Nicole Brown Simpson and Ron Goldman. After all, the TV special was supposed to air on the final three nights of the November sweeps. None of Fox's fall shows have found an audience and the network has to wait until January for new episodes of "American Idol" and "24".

What Murdoch was referring to was the firestorm of criticism that Fox received over their tasteless sponsoring of Simpson. I'm thinking that criticism came almost exclusively from white

White people hate O.J. They hate him more than Ted Bundy, Jeffery Dahmer and Son of Sam all rolled into one:

White people revile O.J. Simpson so much because he fooled them. He hoodwinked and bamboozled them. O.J. fooled white people into believing that he was one of them.

From his days at USC on, Simpson spent all of his time convincing white people that he was "different" from all the Fox. other black people. He had little or no use for black folks in his

One of my favorite journalists of all-time, the late Ralph Wiley, summed up the O.J. situation

"White people were confused and let down, because white people had decided that O.J.

agree with the American public Simpson was a 'unifying symbol of all races.' Black people didn't decide that. Black people didn't think that up. Black people didn't even believe that. Who was he unifying, and to what end?"

Black people only got mad at O.J. after the trial for being black just long enough to get their support for him playing the race card during his trial. That served to only further disappoint white people.

Mary Jo Kane, a sport sociologist at the University of Minnesota said, "Up until that point (Simpson) had been accepted in white American's homes like no other black athlete had ever been accepted. So one could make the argument that he was one of us, quote unquote ... the minute he gets into a jam of his own making, what does he do? He falls back on the race card. So you really aren't one of us when it gets down to it, you are one of them."

As Ralph Wiley pointed out, O.J fooled himself. He fooled a lot of rich and powerful white people. But he didn't fool very many black people. Black people can smell phony through a television set.

Black people weren't cheering for O.J. when the verdict was announced. They were cheering for a black face beating the judicial system. They were cheering for the late Johnny Cochran. That's why black people weren't surprised when O.J. went back to being super-white after he got off. And that's why we really didn't care whether he wrote a stupid book or not. We were all set to watch the interview on

But white people aren't through with O.J. yet. And that's why whenever he pops his huge head out from now until the day he dies, white people will make sure he feels the hate of a nation.

# Trent Lott: Record Of A Racist

After expressing support four years ago for Senator Strom Thurmond's pro-segregation 1948 presidential campaign, then-Senate Majority Leader Trent Lott went on Black Entertainment Television to repudiate himself, calling his comments insensitive, repugnant and inexcusable.

Lott was apologizing for having said at Thurmond's 100th birthday party, "I want to say this about my state. When Strom Thurmond ran for president, we voted for him. We're proud of it. And if the rest of the country had followed our lead, we wouldn't have had all these problems over all these years."

When interviewed on BET by Ed Gordon, Lott, in an unsuccessful attempt to save his Senate leadership position, said he was wrong to have voted against establishing a Dr. Martin Luther King Jr. federal holiday and said that he now favors affirmative action "across the board." He said, "As majority leader, I can help move an agenda that would hopefully be helpful to African Americans and minorities of all kinds and all Americans."

The groveling didn't stop there. "I'm trying to find a way to deal with the understandable hurt that I've caused," he told Gordon. "I obviously made a mistake, and I'm going to do everything I can do to admit that and deal with it and correct it. And that's what I hope the people will give me a chance to

And what has Lott done to "correct it?"

Nothing. On the NAACP Legislative Report Card for the 109th Congress (Jan. 4, 2005-Dec. 22, 2005), Lott received an "F," voting in favor of issues supported by the NAACP only 5 percent of the time.

Instead of contrasting Lott's words with his record, the media has been covering Lott's one-vote victory margin to

An Associated Press headline proclaimed, "Sweet Redemption: Republicans return Lott to Senate Leadership." The New York Times called it an "unlikely study in professional redemption." To its credit, the Los Angeles Times noted that Lott has "a credibility problem on issues of race."

In describing Lott's noxious comments, some outlets were especially timid. For example, the Associated Press gingerly described them this way: "At Senator Strom Thurmond's 100th birthday bash, Lott had saluted the South Carolina senator with comments later interpreted as support for Southern segregationist policies."

Although Lott denied being a racist on BET, his record arguably supports such a conclusion. Both Fair.org and MediaMatters.com, media monitoring groups, have Trent's civil rights record posted on their sites, pointing out:

- In 1981, Lott filed a "friend of the court" brief opposing the IRS's decision to terminate Bob Jones University's tax exempt status because it prohibited interracial dating;

- In 1982, Lott voted against the extension of the Voting

- In 1983, he voted against creating a national holiday to honor Dr. Martin Luther King

- He voted against the Civil Rights Act of 1990, a measure that reversed five Supreme Court rulings that would have made it more difficult for people of color to win job discrimination lawsuits;

- In 1992, he spoke to the Council of Conservative Citizens, a successor to the White Citizens' Council of the 1960s, saying "the people in this room stand for the right principles and the right philosophy.

- In 1994, he voted to terminate federal funding for the King Holiday Commission;

- In 1995, he criticized Rep. Thompson, Bennie Mississippi's lone African-American member Congress, for seeking FBI documents on the death of civil rights leader Vernon Dahmer and

- In 2001, he was the only U.S. Senator to vote against President George W. Bush's nomination of Roger Gregory, an African-American, to the Fourth U.S Court of Appeals.

In acknowledging to Ed Gordon that he had been wrong to vote against the federal holiday honoring Dr. King, Lott said: "I'm not sure we in America, certainly not white America and the people in the South, fully understood who this man was, the impact he was having on the fabric of this country."

Linda Chavez, a leading conservative, didn't buy that

"Sorry, Senator, that statement reflects willful ignorance. No one who lived through the civil rights era can fail to appreciate the social transformation that occurred through the efforts of Rev. King and other civil rights leaders.

"Sen. Lott's problem is not that he didn't understand what Rev. King was fighting for, but that, at that time, he was on the other side."

If Lott was sincere when he said he favors affirmative action "across the board," there could be no better time than now to prove it. If he's not sincere, we should see Trent Lott for what he is: a politician willing to say anything to regain power.

# Forming An Investment Club? Here's a guide to get you started

Starting an investment club is in three easy steps: a great idea, but to run it successfully, you need to do more than select a broker, pool money with a few friends, and sub-



scribe to financial publications.

One of the first steps in forming an investment club is getting the right mix of people together. Your best friend may not be someone who will do well in such a setting, so recruit carefully, says Patricia Edwards, a founding member of the Beanstalk Investment Club of Miami. Also, it's essential that investment clubs establish order and stability by creating bylaws that help to set up a system to collect money, choose stocks to beneficiaries.

"We had more than one member pass away," says Edwards, 62. Clubs also need to establish exit strategies for those who aren't pulling their weight, says Edwards, who co-wrote In Search of the (Authorhouse; \$15.49), a book about forming an investment club, with two other members Ellen Pryor.

Establish a club name, legally. Choosing a club name goes beyond a catchy phrase, such as the African American clubs,

in the Umoja, Washington, D.C. area, or Sisters Together Achieving Financial Freedom (STAFF) in Miami. For legal reasons, you need to make sure no other local entity has that name. So, follow registration process at your local Clerk's County Office, which may include announcing in the local newspaper your intent of

appropriating the name. With name in hand, download the SS-4 application from the IRS Website or call 800-829-4933 for a tax ID number, known as an Employer Identification Number. You'll need this for filing your club's annual tax return.

Next

Set membership and officer requirements. Elect officers, with each role rotating annually or biannually. Draw up a membership application and in the bylaws state the maximum number of buy and sell, and even name members, specific educational seminars potential new members should attend before they can join, and whether or not they must live within a certain distance so that they can attend monthly meetings, which are typically 90 minutes to two hours long.

You can meet via conference call or online, but preferably, members "should be in the same area because an important part of Lisa-René Charles and Mary an investment club is the educational portion of it," says Ken Here is how to start your club Janke, the chairman of Madison

Michigan-based BetterInvesting, formerly the National Association of Investors Corp., which has 200,000-plus members with an aggregate portfolio of about \$117 billion. "If all you're doing is sending a check in, you may as well just have a mutual fund." Plus, the face time helps maintain trust.

Establish member fees and open accounts. Set a monthly investment fee, which is the minimum amount of money a mem-

ber must contribute each month for stock purchases in order to remain active in the club. "Invest a small amount, about \$20 to \$25 a month," suggests Ann McNeill, a founding member of STAFF and the first African American female appointed to the BetterInvesting board of trustees. "I say that because people won't stay in a club if it is \$100 and they can't afford it," she says.





# Lawmaker Says He Will Introduce Bill To Reinstate Military Draft

AP Americans would have to sign up for a new military draft after turning 18 under a bill the incoming chairman of the House Ways and Means Committee says he will introduce next year.

Rep. Charles Rangel, D-N.Y., said Sunday he sees his idea as a way to deter politicians from launching wars.

"There's no question in my mind that this president and this administration would never have invaded Iraq, especially on the flimsy evidence that was presented to the Congress, if indeed we



Rangel, a veteran of the Korean War who has unsuccessfully sponsored legislation on conscription in the past, has said the all-volunteer military disproportionately puts the burden of war on minorities and lower-income families.

Rangel said he will propose a measure early next year. Although he said he is serious about the proposal, there is little evident support among the public or lawmak-

can't do that without a draft," Rangel said.

He said having a draft would not necessarily mean everyone called to duty would have to serve. Instead, "young people [would] commit themselves to a couple of years in service to this great republic, whether it's our seaports, our airports, in schools, in hospitals," with a promise of educational benefits at the end of service.

Polls have shown about seven in 10 Americans oppose reinstatement of the draft, and officials say they do not expect to restart conscription.

The new ordinance also provides contractors the opportunity to use power washing

equipment as long as a portable water tank is used as the source of water.

Another significant change in the new ordinance is the way that enforcement will be handled.

The process has gone from a municipal penalty process to an administrative fee process.

Instead of a citation, violators will see a small blue flag placed in the ground out by the water meter and a door hanger will be placed indicating a water violation has occurred.

For a se with automatic sprinter stems, the irrigation syste locked off and will not be unlocked until a fee is paid to the city. Similar provisions have been made for those who irrigate manually. Water for domestic (i.e., indoor) use will not be turned off due to water restriction violations.

"This process will be far more effective in getting irrigation

water use under control, which is one of our primary goals during a drought response stage," states Lorrie Reeves, Water Education Coordinator for the city.

Even though North Texas has received some rain lately Stage 3 restrictions remain in place. The lake level at Lavon, Plano's primary water source, remains 16 feet below normal and the recent rains have had very little effect in making up for the lack of rain this past year.






