### Sudan Rejects Plan for UN Peacekeepers in Darfur

Sudan's president rejected a proposal Thursday to send thousands of U.N. troops to Darfur to boost 7,000 African peacekeepers there, crushing hopes for a quick solution to a crisis that is spreading across central Africa. African leaders, however, extended the mandate of the AU force currently deployed in Darfur by six months, the African Union's peace and security com-

missioner Said Djinnit told reporters. The mission's mandate was set to

expire Dec. 31. "We want an African force," Sudanese President Omar al-Bashir told reporters after leaving a closed-door African Union summit in Abuja at which African leaders were advocating a proposal for an expanded mission that would include blue-helmeted U.N. soldiers. "We can take technical advisory and financial support from the U.N., but no U.N. force," al-Bashir said. Sudan, the United Nations and the AU agreed in principle earlier this month to create a hybrid mission, raising hopes that a stronger U.N.-backed force could be deployed to help stem the violence. But confusion has remained, with some Sudanese officials saying they want U.N. support - but only

in the form of finance and logistics, rather than U.N. troops on the ground. Djinnit said no agreement had been reached on expanding the peacekeeping mission, saying "the size and strength of the force should be based on the assessments of the African Union. Sometimes, what seems like a really good idea on paper can turn out to have a completely undesirable result in practice.

Plano residents have seen this concept in action as results of the city's Automated Red Light Camera Enforcement Program recently revealed some disturbing trends. The red light cameras were supposed to reduce the number of red light runners, decrease the number of intersection accidents, all while garnering the city traffic violation revenue without tying up police officers.

Not.

Ironically, since the installation of red light cameras in March, the overall number of accidents at four Plano intersections has actually increased. While the number of right angle crashes from drivers running red lights have dropped, the number of rear-end crashes have increased by 50% in the same period. Motorists, aware that they are on camera, tend to slam on their brakes at yellow lights rather than driving through the intersection. This increases the odds of the driver behind them being unable to avoid an accident from the rear.

This phenomenon is nothing new with red light cameras. Portland, Oregon reported that use of red-light cameras produced a 140% increase in rearend collisions at monitored intersections. A Virginia Transportation Research Council study found the same thing-while cameras decreased accidents from motorists running red lights, the cameras significantly increased the number of accidents.

This week I'm going to have to restate my tried and true maxim on how to determine the exact reason why any gov-

ernmental program continues after producing less than desired results. This maxim usually works regardless of whether one is analyzing a city, state or federal government program.

Follow the money.

The reason that so many North Texas municipalities have implemented red-light cameras is revenue. The cameras generate so much revenue that they've drawn the attention of the State of Texas who now wants a cut.

The tickets drivers receive from being caught by red-light cameras are civil violations, not traditional traffic tickets. That's the meat of the issue-the state gets a portion of revenue on traffic tickets, but not from civil violations from the cameras.

Plano has collected \$370,186 in gross revenue from March, when the program began, through August. According to Plano Police Chief Gregory Rushin, the net income for the city is almost \$250,000 after deducting operating expenses for the cameras.

collected Denton has \$329,727, with \$219,446 in net revenue, on citations written off six cameras from May through August, said Jon Fortune, Denton assistant city manager. Garland, the first city in the state to use the cameras, has col-

lected about \$3.2 million in fines since the program began in

September 2003, said Shelley Franklin, program administrator for the city's red-light cameras. The city's program has grown from four cameras to 12.

That's a lot of cash, and a lot of reasons to keep a program up and running even if the number of accidents. Municipalities from Dallas to Forth Worth and all places in between have implemented or are considering implementing red-light cameras. The role of money in this issue

might be larger than safety. Many contend that safety gains can be achieved without the use red-light cameras. A Texas Transportation Institute Study discovered that simply lengthening yellow-light times dramatically reduced the niumber of red-light violations. And a University of Central Florida study found that improving intersection markings reduced reduced red-light running by 74% without increasing the number of rear-end collisions.

Maybe that's why the American Automobile Association and the National Motorists Association oppose the use of red-light cameras as a "tax on drivers."

Barring legal challenges, redlight cameras have now become a fixture in North Texas. And ironic or not, drivers better get used to being watched.

## America Still Owes Dr. King

Marian Wright Edelman NNPA Columnist On November 13, a historic event took place on the National Mall in Washington, D.C. on a plot of land near the national memorials to Presidents Washington, Jefferson, Lincoln, and Franklin D. Roosevelt: the groundbreaking ceremony for the memorial honoring Dr. Martin Luther King, Jr. Like many other Americans, I am overjoyed that our nation is honoring Dr. King this way. On the hallowed ground surrounded by memorials to soldiers and leaders of wars, it is especially moving to

see the first memorial to a leader who preached and practiced nonviolence and peace. But even as we celebrate the enormously important symbolism of building a memorial to Dr. King in this special place, this monument should also serve as a powerful reminder that there is still much more left for our nation to do to honor him and his teachings that can't be accomplished with a statue or words carved in stone. In his remarks at the groundbreaking ceremony, President Bush said building this memorial to Dr. King alongside the memorials to the many other Americans honored on the Mall "will unite the men who declared the promise of America and defended the promise of America with the man who redeemed the promise of America." Dr. King may have redeemed the promise of America. But has America redeemed the promise of Dr. King?

When most Americans think of Dr. King's speech on the steps of the Lincoln Memorial during the historic 1963 March on Washington for Jobs and Freedom, they only know the famous "I Have a Dream" section. For four decades the powerful words in that part have been quoted all over the world. But too few people remember or even know about the central theme that begins the speech: the bounced check America had written to its Black citizens. Dr. King said we had come to the nation's capital that day to cash a check America had written nearly 200 years earlier. He said that when our nation's founders wrote the Declaration of Independence and the Constitution, they had created a promissory note that guaranteed all Americans the inalienable rights of life, liberty, and the pursuit of happiness. But instead of honoring that promise for Black Americans, America had defaulted on it and given us a bad check that had come back marked "insufficient funds."

Dr. King said those of us who had come to the March were there to cash our checks because we refused to believe "the bank of justice is bankrupt" or that "there are insufficient funds in the great vaults of opportunity of this nation." I sure still refuse to believe it, and never will until America's promised commitment to justice and our great wealth converge in ending poverty and hopelessness for millions of people struggling to get enough to eat, a place to sleep, a chance to make a living, and a good education for their children.

Right now too many American children and families are still getting bounced checks from our economic, health, education, and housing banks. It is intolerable that more than forty years after Dr. King dreamed of a day when his own children would be judged not by the color of their skin but by the content of their character, the gap between rich and poor is widening and huge disparities of opportunity persist for Black

children. Dr. King's warnings that "returning violence for violence multiplies violence" and "a nation that continues year after year to spend more money on military defense than on programs of social uplift is approaching spiritual death" speak to us more loudly today than ever. It's hard not to think of the words written about Dr. King by Carl Wendell Hines:

Now that he is safely dead Let us praise him build monuments to his glory sing hosannas to his name. Dead men make such convenient heroes: They cannot rise to challenge the images we would fashion from their lives. And besides, it is easier to build monuments than to make a better world. So, now that he is safely dead we, with eased consciences will teach our children that he is a great man...knowing that the cause for which he lived is still a cause and the dream for which he died is still a dream. a dead man's dream.

Those who helped lay the groundwork for this memorial to Dr. King know that planning this monument hasn't been easy; it's been a long and hard-fought struggle, and the fundraising needed to complete the vision continues. But building the monument has been far, far easier than building the beloved community and just nation and world Dr. King envisioned.

Will the new memorial inspire us to recommit to making sure his dream doesn't stay just a dream?

## Why So Many Black Women Are Behind Bars

Some years ago I briefly worked as a social worker. Occasionally I would visit clients in jail to determine their eligibility for continued benefits. They were all men-with one exception. She was a young black woman serving time for theft. She had two small children. She entered the visiting room handcuffed to another woman and dressed in drab prison garb. We talked through a reinforced glass window. The guards stared hard and barked out gruff commands to the women. The idea of a woman in prison then was a novelty. It isn't anymore. According to a recent Justice Department report on America's jail population, women make up about 10 percent of the America's inmates. There are now more women than ever serving time, and black women make up a disproportionate number of those women. They are twice more likely than Hispanic, and over three times more likely than white women, to be jailed. In fact, black women have almost single-handedly expanded the women's prison-industrial complex. From 1930 to 1950 five women's prisons were built nationally. During the 1980s and 1990s dozens more prisons were built, and a growing number of them are maximum-security women's prisons. But the prison-building splurge hasn't kept pace with the swelling number of women prisoners. Women's prisons are understaffed, overcrowded, lack recreation facilities, serve poor quality food, suffer chronic shortages of family planning counselors and services, and gynecological specialists, drug treatment and child care facilities, and transportation funds for family visits. Female prisoners face the added peril of rape, and insensitive treatment during pregnancy. A United Nations report in 1997 found that more than two -dozen states permitted pregnant women to be shackled while being trans-

ported to hospitals for treatment. A report by the National Corrections Information Center revealed that the U.S. is one of only a handful of countries that allow men to guard women, often unsupervised. Author Donna Ann-Smith Marshall, who served several years at Central California Women's Facility, California's top maximum security prison, in her new book, Time on the Inside, tells in shocking and graphic detail the callous, often brutal treatment many women are subjected to in women's maximum security jails. Unfortunately, the tepid public debate over the consequence of locking up so many women is riddled with misconceptions. One is that women commit violent crimes for the same reasons that men do. They don't. Women are less likely than men to assault or murder strangers while committing crimes. Twothirds of the women jailed assaulted or killed relatives or intimates. Their victims were often spouses, lovers, or boyfriends. In many cases they committed violence defending themselves against sexual or physical abuse. Women's groups and even the more enlightened governors have recognized that women that kill abusive husbands or lovers have acted out of fear and have loosened parole standards. The governors have granted some women earlier release from their sentences. More women, and especially black women, are behind bars as much because of hard punishment than their actual crimes. One out of three crimes committed by women are drug related. Many state and federal sentencing laws mandate minimum sentences for all drug offenders. This virtually eliminates the option of referring non-violent first time offenders to increasingly scarce, financially strapped drug treatment, counseling and education programs. Stiffer punishment for crack cocaine use also has landed more black women in prison,

and for longer sentences than white women (and men). Then there's the feminization of poverty and racial stereotyping. More than one out of three black women jailed did not complete high school, were unemployed, or had incomes below the poverty level at the time of their arrest. More than half of them were single parents. While black men are typed as violent, drug dealing "gangstas," black women are typed as sexually loose, conniving, untrustworthy, welfare queens. Many of the mostly middle-class judges and jurors believe that black women offenders are menaces to society too. The quantum leap in black women behind bars has had devastating impact on families and the quality of life in many poor communities. black Thousands of children of incarcerated women are raised by grandparents, or warehoused in foster homes and institutions. The children are frequently denied visits because the mothers are deemed unfit. This prevents mothers from developing parenting and nurturing skills and deeply disrupts the parent-child bond. Many children of imprisoned women drift into delinquency, gangs and drug use. This perpetuates the vicious cycle of poverty, crime and violence. There are many cases where parents and even grandparents are jailed. There is little sign that this will change. The public and policy makers are deeply rapped in the damaging cycle of myths, misconceptions and crime fear hysteria about crime-on-the-loose women. They are loath to ramp up funds and programs for job and skills training, drug treatment, education, childcare and health, and parenting skills. Yet, this is still the best way to keep more women from winding up behind bars. # **GM Scaling Back Production At Arlington Plant**

The General Motors Corp. plant in Arlington will be reducing production in January, as demand for SUVs is leveling off, a GM spokesman said Wednesday. Effective Jan. 16, GM's Arlington plant will slash production by more than 10 percent, said GM spokesman Tom Wickham. Wickham said a year ago, when the Detroit-based auto maker was launching its







# Audit Says FEMA Squandering Katrina Aid

The government is squandering tens of millions of dollars in Hurricane Katrina disaster aid, in some cases doling out housing payments to people living rentfree, investigators said Wednesday.

The Federal Emergency Management Agency has recouped less than 1 percent of the \$1 billion that investigators contend it squandered on fraudulent assistance, according to the Government Accountability Office. Its report shows the disaster relief agency's struggles, one year after the deadly storm, to rush aid to those in need while also preventing abuse.

Last week, a federal judge in Washington ordered the Bush administration to resume housing payments for thousands of people displaced by Katrina. The ruling, which FEMA is appealing, cited a convoluted

process for applying for help.

"Our work shows for individual assistance payments, at least tens of thousands of individuals took the opportunity to commit fraud," said Gregory Kutz, who works for Congress' investigative arm. He said his previous \$1 billion estimate of

FEMA arranged for a free trailer to a family in Lacombe, La., in January, yet kept providing monthly

rental payments in late January, February and April totaling \$5,500 - a mistake resulting from poor communication within the agency, according to the report.

In addition, \$20 million was wasted on thousands of people who claimed the same property damage from two hurricanes, Katrina and Rita. FEMA paid at least \$3 million to more than 500 ineligible foreign students in the stricken Gulf Coast, the report said.

FEMA spokesman Pat Philbin did not challenge the findings. He did say the agency has sought to upgrade the registration process and strengthen its procedures for verifying names and addresses.

"FEMA continues to focus our rebuilding efforts to greatly improve our reliability, accuracy and response in providing aid to disaster victims," Philbin said. "The agency will consider and evaluate any new findings."

Among the audit's findings: -Even though the GAO found at least \$1 billion in disaster aid waste, FEMA has identified about \$290 million in improper payments and recouped just \$7 million.

"Absent effective fraud prevention, once money is improperly disbursed, the government can only hope to collect pennies on the dollar," Kutz said in criticizing FEMA's "shoot money out the door" approach.

-FEMA could not find dozens of laptops, printers and other items that employees purchased with government-issued credit cards for Katrina disaster work. In one case, FEMA purchased 20 flat-bottom boats, but could not find two of them and lacked the legal titles to any of them.

Sen. Susan Collins, who heads the Senate Homeland Security and Governmental Affairs Committee, lamented the waste.

"Just think of the additional relief and rebuilding that could be accomplished with the money lost to fraud, mismanagement and poor decision-making," said Collins, R-Maine.

"We can't wait for yet another disaster to hit and yet another round of investigations and hearings to spotlight once again the lack of safeguards and internal controls," she said.

Connecticut Sen. Joseph Lieberman, who will become committee chairman when Democrats take control of the Senate in January, said FEMA will be watched closely for signs of improvement.

"The record is clear that, going forward, FEMA has much work to do before we can be confident that it is providing assistance to those who are eligible and who need it, while denying it to those who do not," he said.

### Magic Johnson Campaigns To Stop HIV/AIDS In Black Communities



Fifteen years after disclosing he was HIV-positive, wide-smiling former basketball star Earvin "Magic" Johnson marked World AIDS day Friday by unveiling a campaign to end the disease within the black community.

"I Stand with Magic: Campaign to End Black AIDS" is a joint effort between the Magic Johnson Foundation and Illinoisbased HIV research leader Abbott Laboratories, Inc. that aims to help reduce new to the press release.

'HIV is now having a disproportionate effect on the African-American community, which accounts for more than half of all new HIV infections," said Abbott CEO Miles D. White. "Getting people tested is the first line of defense.

Johnson, who led the Los Angeles Lakers to five National Basketball Association championships in the 1980s, sent ripples through the sports world when he announced his retirement in 1991 at age 32 because he was HIV-positive.

He has made two unsuccessful basketball comebacks \_ one in 1992 and one during the 1995-96 season. Johnson then turned to raising HIV awareness and building a business empire that includes movie theaters, shopping centers, restaurants and a bank.

"He's doing wonderful. He's been blessed. The key is that he takes his meds and regularly," exercises

Towalame Austin, president of the Magic Johnson Foundation, told The Associated Press.

He played a basketball game at a high school on Thursday and was still sore, she said.

'The virus is undetectable in his system, meaning that it's just asleep. He takes three medications, including Kaletra. He has been on Kaletra since 1991," she said. Fortune magazine named

Johnson one of its 50 "Most Powerful Black Executives" in 2002.

Johnson established his foundation in 1991 to raise money for community-based organizations dealing with HIV/AIDS education and prevention programs.
