

## White House sees 'moment of

Bush To Address NAACP



After rebuffing the NAACP for five years, President Bush will speak at the annual convention of the oldest U.S. civil rights organization for the first time since taking office because he sees "a moment of opportunity," the White House said Tuesday.


Bush was the first sitting president in decades not to address the National Association for the Advancement of Colored People.

His decision to appear before the group Thursday comes as the Republican Party tries to court black voters ahead of crucial congressional elections in November.

The Bush administration also was widely criticized last year for a slow response to Hurricane Katrina that some charged was tinged with racism because the storm devastated mainly poor and black communities along the Gulf Coast. Administration officials strongly denied those accusations.

Bush did address the NAACP as a presidential candidate in 2000, but not since being elected to the White House. Relations with the group were strained amid what the White House considered unfair criticism from NAACP leaders.

But ties have warmed with current NAACP President Bruce Gordon. Bush expressed appreciation for Gordon's "strong leadership" during a tribute to civil rights leaders Martin Luther King Jr. and Rosa Parks in January.

# **House Votes To Extend Voting Rights Act**

Southern conservatives efforts to amend the act easily defeated

The House voted Thursday to renew the 1965 Voting Rights Act, rejecting efforts by Southern conservatives to relax federal oversight of their states in a debate haunted by the ghosts of the civil rights movement.

The 390-33 vote sent to the Senate a bill that represented a Republican appeal to minority Civil rights marchers being met by Alabama State

voters who doubt the GOP's Troopers on the Edmund Pettus Bridge, March, 1965. "big-tent" image. Ten representatives did not vote. Southern conservatives had complained that the act punishes their states for racist voting histories they say they've overcome. "By passing this rewrite of the Voting Rights

Act, Congress is declaring from on high that states with voting problems 40 years ago can simply never be forgiven," said Rep. Lynn Westmoreland, R-Ga., one of several lawmakers pressing for changes to the law to ease its requirements on Southern states.

By a vote of 288-134 the House overwhelm-




ingly rejected an amendment that would have shortened the renewal from 25 years to a decade, It also defeated, by a vote of 238-185, another amendment that would have struck its requirement that ballots in some states be printed in several languages.

Supporters of the law as written called the amendments

# Proud To Be An Active Partner In The Community

Have you read any of the recent news about the war in. Iraq? If you are a news junkie like me, you'll find that news out of Iraq on the war effort is scarce, and "real" news about what is going on in that country is virtually non-existent. One of the ironic things about this war has been that the best sources for information have been the international news agencies, like the BBC World News and the ITN Network.

I recently re-read some old articles on the war to gain some perspective and reacquaint myself with the timeline of events. The first thing that struck me is how difficult it is to fathom the fact that President Bush gave the orders to begin the war on March 19, 2003. I couldn't figure out why it just doesn't seem like the war had been going on that long. Then I realized that the information/ disinformation we've been fed about the war by the Bush Administration and the mainstream media has in many ways desensitized us to the carnage that is taking place in Iraq.

Consider these disappointing numbers on the war: Somewhere between 45,000 to 50,000 Iraqi civilian deaths, 2,500 U.S. service members, 226 coalition troops from other countries, 100 journalists and 350 private contractors. These numbers don't include the estimated 200,000 totally disabled veterans the war is expected to produce. It also doesn't include the number that continues to amaze me- a U.S. cost \$4 billion dollars a month, with total expenditures approaching \$400 billion.

So in light of the negative numbers and lack of tangible progress in the war, the question I keep asking myself is where is our collective outrage over the war in Iraq? Why aren't

more American citizens in the streets exercising their right to protest a war that was justified on the basis of deception and out-

We should be outraged, for all the lives that have been lost and all the money that has been spent in this war, but we should be just as outraged at the fact that the situation in Iraq is growing worse by the day. The Bush Administration doesn't want to admit it, but daily events in Iraq confirm that there is nothing short of a full civil war taking place between the Sunni and Shia religious sects.

The death toll from this civil war is rising daily in Iraq, one mortuary in Baghdad received 1,595 bodies in June alone.

On Tuesday in Kufa, a city south of Baghdad, a suicide bomber pulled his minivan into a busy market, invited laborers onboard with the promise of jobs and then blew himself up. The blast killed at least 59 people and wounded 132 others in one the bloodiest attacks in Iraq this year. The attack sparked a clash between the police and angry protestors who called the police "traitors" and "American agents".

The immediate response to civil war in Iraq from Americans might be a disinterested-so what? Admittedly, that was my response until I started looking at it from a historical perspective.

Civil war is what the conflict in Vietnam was all about, and that war gives us some ominous foreshadowing about what may eventually happen in Iraq. The first problem is that it converts our military stance from a fighting force into an occupational, peacekeeping force. That type of mission drags on for years and usually decades before concluding, and the reasons for being there in the first place become fuzzier over time in the minds of Americans.

That's what happened during the end of the Vietnam War. Americans no longer understood why we were there, and got outraged over the nightly pictures of dead soldiers and civilians being broadcast into their living rooms. That's when they took to the streets in protest. The Bush Administration has banned the media from showing pictures of dead soldiers in this war, but even that shouldn't keep us from being outraged.

People are dying unnecessarily in an unnecessary war, and the citizens of this country have the ability and the right to shape policy for our nation. Generally, Americans have to get really angry to be moved to action on an issue. I wonder what it's going to take for us to get angry and outraged about the war in Iraq.



## **Voting Rights Hall Of Shame**

After defeating several amendments that would have neutered legislation to renew key sections of the Voting Rights Act set to expire next year, the U.S. House of Representatives finally passed the Fannie Lou Hamer, Rosa Parks, and Coretta Scott King Voting Rights Act Reauthorization and Amendments Act last week by a vote of 390-33. No Democrat voted against the bill and Republicans approved it by a margin of 192-33. The bill now moves to the Senate, where it is expected to easily win approval before the August recess.

Northup from Kentucky, Pete Sessions of Texas, Louise McIntosh Slaughter of New York and Todd Tiahrt of Kansas.

That any member of Congress would vote against such important legislation would be bad enough. But I have even less respect for the Brown-Waite, Cliff Stearns, hypocrites who voted for crippling amendments to the legislation and after those efforts failed, voted for the final measure so that they could save face.

In an effort to gut the Voting Rights measure, four amendments were offered in the House.

Amendment 4, proposed by Rep. Lynn Westmoreland (R-Ga.), would have the Attorney General make an annual determination of whether certain jurisdictions must meet the Section 5 preclearance requirement of the Voting Rights Act as well as shift the burden of proving whether a community has stopped discriminating from the jurisdiction to the Justice Department. Amendment 8, sponsored by another Republican from Georgia, Charlie Norwood, would use turnout figures from the three previous presidential elections rather than past record of discrimination to determine which states are covered under the Act. Based on figures from the 1996, 2000 and 2004 elections, it would essentially repeal Section 5 of the Voting Rights

Amendment 7, sponsored by Republican Representatives Steve King of Iowa, Candice Miller from Michigan, Ginny Brown-Waite of Florida and Spencer Bachus of Alabama, would repeal Section 203 of the Voting Rights Act that provides language assistance to voters who have difficulty speaking English. And Rep. Louie Gohmert (R-Texas) proposed a reauthorization period of 10 years rather than 25.

A band of Southern legislators almost derailed the bill by claiming that their region was being treated unfairly. However, Congressional hearings showed Black voters were the real victims.

Seven Southern supporters of the final bill voted for the Westmoreland amendment, but not the one offered by Norwood. They were: Mike Roberts and Spencer Bachus of Alabama, Michale Bilirakis and C.W. Bill Young of Florida, Louisiana's Jim McCrery, William L. Jenkins of Tennessee and John R. Carter from Texas.

## NAACP Ought To Give Bush Some Credit

Gregory Kane NAACP board Chairman Julian Bond might not know it, but he just proved a black Republican is right.

When I met Christopher Alan Bullock during a reception at the Venezuelan Embassy this month, the Delaware Republican told me that President Bush, whom he supports, "hasn't done enough to get the message out about what he's done for African-Americans." Bullock then elaborated.

Homeownership among blacks has risen under Bush, Bullock said, as well as Small Business Administration loans to black entrepreneurs.

According to a Feb. 22, 2006, New York Times article, homeownership among black Americans was less than 43 percent before 1995, rose to 49.7 percent in 2004 and dipped only a wee bit to 48.8 percent in 2005.

A July 15, 2005, Louisville Courier-Journal article quoted Bush as saying that SBA loans to black businesses increased 28 percent in 2004. But black elected officials - Democrats, as you might have guessed - were quick to point out that Bush slashed funding for the SBA.

Bullock also praised the number of blacks Bush selected for his Cabinet, figures that are hard to dispute. Bullock mentioned former Secretary of State Colin 1. Powell, current Secretary of State Condoleezza Rice, former Secretary of Education Rod Paige and current Secretary of Housing and Urban Development Alphonso R. Jackson, to name a few.

Clearly, one of the people who didn't get the memo about the historic occasion of a president naming the first two black secretaries of state in the nation's history is Bond. You'd think, as board chairman of the country's oldest civil rights organization, Bond would at least give the president credit

In fact, genuine nonpartisanship - which Bond claims is a principle the NAACP cherishes ever so dearly - requires mentioning it. But did we get it from Bond in his opening address at the NAACP annual convention this week?

Ah, yet another "Do rich folks eat welfare cheese?" ques-

"We need balance," Bullock told me Monday night. "If [Bond is] going to criticize the president for what he's not doing, he should give him credit for what he is doing, especially in the area of economic development for African-Americans."

Bond's speech this year wasn't any more balanced than the invective he has hurled at Bush in prior NAACP convention speeches, but at least it wasn't as nasty. Gone were the references to Bush Cabinet appointees being from the "Taliban wing" of American politics. Absent were remarks about Republicans having an idea of equality that amounted to "the American flag and the Confederate swastika flying side by side."

Still, there was plenty of criticism of Republicans and Bush, enough for a skeptical reader to

wonder whether Bond's speech had been written at the Democratic National Committee headquarters. But Bond prefaced the criticism by saying he had extended yet another invitation for Bush to speak to the NAACP annual convention.

It occurred, Bond told NAACP delegates, at a reception held before the White House correspondents' dinner. Bond said Bush asked him how old he was. Bond answered that at 66, he was now too old to be president.

"You're not too old," Bond said the president told him. "[Sen.] John McCain is 70."

"I guess I'll ask John McCain if I can be his vice president," Bond answered. "No," Bush said, "A confi-

dent man would ask John McCain to be his vice presi-Bond told the delegates he

felt confident enough to ask Bush to address the convention. He said the president "made a sound, which at the time I took to mean either 'I'll think about it' or 'not in your lifetime."

Bullock, for one, was hoping Bush meant "I'll think about

"I think the president should accept the invitation to speak this year," Bullock said. "It would be a good gesture."

Bullock and Bond will get their wish. Bush is scheduled to speak to the NAACP convention tomorrow, though I have no idea why. NAACP leaders - notably Bond - and



## Foreclosures Continue To Soar In Collin County

By: Jim Kilpatrick

Foreclosures of residential homes continue to soar in the Collin County area, according to Foreclosure Listing Service Inc. in Addison.

"Postings of Collin County homes climbed 34 percent with 342 postings filed for the Aug. 1 auction, compared to only 255 filings at this time last vear," said George Roddy, president of Foreclosure Listing Service. "August's filings represented the sixth time this year that monthly home postings within Collin County have exceeded 300."

He added Dallas-Fort Worth-area foreclosure postings filed on residential homes for the upcoming auctions in than at this time last year.

"The largest gain in residential postings for the August auctions in the Metroplex was found in Collin County," he said. "While Collin County's posting activity for the month of August ranked as the metro's highest gain in monthly postings over the last year, the county's year-to-date posting performance ranks as the Metroplex's lowest gain in residential postings for the year thus far."

Just 9 percent more homes have been posted for foreclosure during the first eight months of the year than during the same period last year. According to the report 2,616 postings were filed on Collin homes compared

## NAACP Urges Blacks To Avoid Certain Businesses

Even companies that make an effort to work with minorityowned businesses typically spend barely 5 percent of their contracting dollars with them, the NAACP president said Monday as his group released report cards on several industries.

Blacks shouldn't spend money with companies that don't hire them or advertise in their communities, NAACP President Bruce S. Gordon said.

"If corporations spend their money on us, we'll spend our money with those corporations," he said. "It's real simple."

Gordon's comments were part of his first keynote convention speech as head of the civil

rights group; he took over as president last August. More than 4,000 people are attending the 97th annual meeting of the National Association for the Advancement of Colored People, which runs through Thursday.

The NAACP has graded corporations since 1997 on how well they work with blacks in employment, charitable giving, advertising, contracting and community service. This year, the civil rights group looked at the telecommunications, lodging, finance, retail and auto industries.

Most companies did best on charitable giving and community service, and worst on hiring and contracting. Gordon said the contracting numbers were "totally unacceptable."






## Ex-Destiny's Child Member Letoya Takes Solo Spotlight

By: Gail Mitchell

Most artists are lucky to get one shot at stardom. But six years after being forced out of Destiny's Child just as the R&B stars were about to break big, LeToya Luckett is poised for success once more. And the now single-monikered singer/ songwriter is not taking the second chance for granted.

Which is partly why delivery of her self-titled Capitol debut, originally scheduled for release last year, was postponed until July 25. It looks like the delay is paying off. "Torn" is No. 3 on the Hot R&B/Hip-Hop Songs chart, No. 36 on the Billboard Hot 100 and No. 12 on Hot 100 Airplay.

Other than mentioning LeToya's seven-year stint in Destiny's Child (including cowriting the career-building singles "Bills Bills Bills" and "Say My Name"), Capitol is treating her as a new artist. "Our initial objective was to introduce a hit song and video to establish her as the H-town girl that she is and let her tell that story," says Fabian "Fade" Duvernay, vice president of urban marketing for Capitol. "We really want to go into making LeToya the urban 'It' girl."

"LeToya" stretches from soulful, sensuous ballads and club jams to spotlighting the city's trademark "screwed-up" cuit while cutting demos that

"I'm a Southern belle who likes heavy-hitting beats," LeToya, who co-wrote nine of the album's 16 songs. "I can give



it to you hard or I can be soft and soulful, hip-hop with grace."

That versatility wasn't fully realized during her Destiny's Child tenure. She and former fellow group member LaTavia Roberson gained more notoriety for their unceremonious ouster from the group in March 2000. Ensuing breach-of-contract and defamation-of-character lawsuits were settled out of court in 2002.

A subsequent pairing with Roberson in a new girl group called Angel was aborted. Moving to Los Angeles for six months, LeToya traveled the modeling and acting agency cir- and my voice."

"Being the ex-Destiny's Child member was the most awkward part," LeToya says of that period. "Some people didn't want to touch my music ... But at the same time, (Destiny's Child) got me in the door."

Spike Lee was in Venice, of all places, when the levees broke. Sitting in his hotel room in the submerged Italian city, where he was attending a film festival. Lee flipped back and forth between BBC and CNN, riding the roller coaster of emotions over what man and nature had wrought in New Orleans.

"I was really mad and sad," Lee told TV critics during a session to promote "When the Levees Broke," his upcoming HBO documentary. "I wanted to do something about it."

Mostly, though, Lee was, and is, angry at a country that let this happen, at a government that reacted indifferently to the suffering of black people in the Crescent City and at a short-attention-span culture that has already consigned Hurricane Katrina to the history files.

That's how the celebrated director, who is not known for making nonfiction films about

## No Political Party Can Contain Us

Members of the black clergy face a challenge in the upcoming political season to refrain from being used by any political party or ideological agenda to further their aims at the expense of the critical issues facing our communities.

As we approach the midterm congressional elections, poverty -- at home and abroad; economic and educational parity -or the lack thereof; voting rights and accessibility; reconstruction of the Gulf Coast; and the war in Iraq are all critical issues that African-Americans should consider as we head to the ballot box.

Overcoming many of the existchallenges African-Americans face can be achieved with a plan that encourages a more cohesive community relationship and the spawning of entrepreneurial endeavors and business initiatives, including investments and a thoroughly considered community development initiative.

Many people share these concerns and as a Christian leader committed to the equality of all people and the betterment of people of color, I believe that from the most secluded country church to the largest megachurch, the black church as a corporate body has and will play a vital role in the attainment of these aspirations.

I do not believe that African-American ministers should allow their political views to dictate the subjects and tone of their sermons. Some believe their calling is to consistently petition society to address its role in depriving African-Americans of the full benefits of citizenship. Others

believe they are called to inform, encourage, coax and propel people of color to provide for themselves, shape their own reality and build institutions to better their communities.

Though the black community was served well by ministers who doubled as political leaders in an era when the pulpit was often our only podium, today, the African-American community is no longer limited to the pulpit as our primary lecture post. We now have thousands of African-American politicians elected to



serve our interests, nonprofit leaders funded to lead our communal efforts and academics educated to research our options, and convey their findings to the world.

Just as the black community is not monolithic in its religious choices, personal opinions, or political affiliations, the black clergy is not limited in its sermonic topics to one perspective. Enforcing unanimity of voices is a dangerous proposition.

Throughout our history, various voices have served our communities well simultaneously. Booker T. Washington shared the public spotlight with W.E.B. DuBois. Ida B. Wells worked against the lynching of black men, while Mary Church Terrell worked on behalf of black women. Martin Luther King Jr.'s voice calling for nonviolent integration echoed alongside that of Malcolm X demanding freedom to do for self by any means necessary. As it is in all American communities, no one person or perspective speaks for all African-Americans.

If we as African-American ministers allow anyone to script our sermons for us, where will it end? I respect each minister's views and recognize his right to tout them, but it is dangerous to try to force all members of any group to align themselves with anyone's viewpoints, including my own. Each of us must answer the call that he or she receives from God, not the direction of any man.

In the final analysis, no singular approach will end America's most pressing problems. Rather, a multiple approach that includes direct assistance, personal empowerment lessons and self-help initiatives as well as speeches, marches and organized resistance, will help to dismantle the political and civic structures working against us. We are better together than we are apart.


