## Nonpartisan commission announced to study and inform policies on youth voting

Tufts University's center for the study of youth engagement, announced the formation of a nonpartisan Commission on Youth Voting & Civic Knowledge, which will be charged with investigating exclusive data -- much of it collected during and immediately after the recent 2012

elections -- with regard to the civic knowledge, voting behavior, and beliefs of young Americans ages 29 and under.

Following an investigation, the diverse, bipartisan group of scholars and experts from across the country will release a report in the Spring of 2013 outlining their rec-

ommendations on how to strengthen both the civic knowledge and participation of young Americans.

Commissioner Trey Grayson, Director of the Harvard Institute of Politics and former Kentucky Secretary of State, said, "I'm excited about

## Cornyn Should Keep Promise on Confirming Judges

Now that he is the second highest-ranking member in the Republican caucus, it's time to hold Sen. John Cornyn (R-Texas) to his word.

In June, the Republicans blocked confirmation of President Barack Obama's pending judicial nominees, holding off until after the presidential election. At the time, Sen. Cornyn told the Capitol Hill newspaper, Roll Call,

that the president shouldn't be overly concerned with this, since "if he's elected [again], it means only a few months delay anyway."

Now that President Obama has won reelection and it's been more than a few months since Republicans began blocking confirmation votes, Cornyn and other Senate Republicans need to get a move on and work to end the crisis in our courts. They need to stop drag-

## UTD's BrainHealth Team Studies Overeating as a Type of Addiction

A similar, insidious craving plagues all addicts, no matter the substance of choice. A new study published in *NeuroImage* from Center for BrainHealth scientists Dr. Francesca Filbey, assistant professor in the School of Behavioral and Brain Sciences, and doctoral student Samuel



DeWitt has found that for binge-eaters, as with all addiction sufferers, the compulsion to overeat is rooted in the brain's reward center.

In the last 20 years, the incidence of obesity has doubled in the U.S. and many European countries,



## Beyond the Rhetoric: Cable Television – An American Success Story

It seems so natural today. Having cable television in our homes, giving us a vast selection of channels from which to choose, is a given condition for the vast majority of us. I can remember in my early years it was not like that. We had the three networks and a few local channels. A Black face on television doing something productive was very few and far between. When the great singer Nat King Cole got his own television show in Los Angeles we were all so proud. Our music was available to us and we were indeed becoming a valuable part of American culture. Gone are those simple years that discounted and downplayed Black intellect, talent and culture.

It was 1948, when entrepreneurs would introduce cable television to three markets – Arkansas, Oregon and Pennsylvania. They would service the mountain areas of these states where normal television signals were extremely difficult to pick

up. In just 4 years, there were 70 cable systems servicing over 14,000 households. By the 1960's, there were over 850,000 households and 800 cable providers. This was phenomenal growth but was seen as a great threat to the local television owners. They convinced the federal government (Congress and the Federal Communications Commission –FCC) to slow the pace down and bring in tighter controls through enhanced regulation.

Cable television hit an anemic growth rate throughout the 1960's because of the above obstacle. They would limit cable operators offering movies, sporting events and syndicated programming. It was actually an assault on freedom of speech. Please keep in mind that the cable growth was coming from private funds such as venture capitalism and equity investment. There was not a drop of government money – county, state nor federal. This was true Americana as the founders of our government intended it to be.

The FCC was, in fact, a prohibitive entity to the growth of this new technology which targeted information, entertainment and thought.

Champions of the upstart cable industry finally convinced the government authorities to lessen the blockage they created and let this valuable technology grow and become available to the American marketplace. The demand should determine if it should expand and the demand was about to blow up to incredible levels. The creation of satellite technology along with friendlier regulation caused a spike in available capital. Great American entrepreneurs like Jack Kent Cooke, Charles Dolan and Ted Turner would gather the needed capital and revolutionize programming based on the demands of the American consumer. By 1980, nearly sixteen million households were subscribing to cable companies. It was just the beginning.

As these entrepreneurs began to populate and jobs

were being created exponentially, Black Americans happily found that they were included. Thank the Civil Rights Act and the Voting Rights Act for this. Local regulation and licensing would come from the city and county level. The face of city and county government had now become a "rainbow" in most local communities. The newly formed cable companies knew they had to be inclusive. Job hires, training and ownership were being "dipped in chocolate". Cable companies were coming with diversity in the entertainment and ownership industry. The late Mayor Coleman Young of Detroit and past DC Mayor Marion Barry along with other vanguard Black mayors in the nations demanded Black ownership participation. Two notable beneficiaries of this new opportunity were the late Don Barden of Detroit and Robert Johnson of Washington, DC (BET).

As cable progressed and the more successful

ing their feet and quickly holding long-overdue confirmation votes on the 19 judicial nominees whose nominations have been languishing on the Senate floor all this time. That's what Sen. Cornyn promised the country and his state he would do.

There should be no problem moving forward because these nominees are not controversial. A majority passed through the Senate Judiciary Committee with strong bipartisan support. Yet Senate Republicans didn't want to confirm these nominees – not because they wouldn't be fair judges – but because they simply wanted to obstruct Obama's every move, hoping for a different outcome November 6.

But what they should have been focusing on is the dire need to fill these

vacancies. While the Senate was busy playing political games with our judiciary, millions of Americans were being denied access to justice. Our federal courts hear cases on many issues including Social Security benefits, immigration, employment issues and civil liberties. Every day a vacancy goes unfilled, people's lives are impacted. The federal bench currently has 83 vacancies across the country – leaving millions of Americans without a judge to hear their case.

This is a major problem in Texas. Right now, we have three judicial emergencies in our district courts and two in the 5th U.S. Circuit Court of Appeals. That means there are too many people and not enough judges to hear their cases. We are importing judges from out of state just

to keep up with the current Texas caseload. Put simply, we have been planning for failure and denying millions of Texans access to justice.

Sens. Cornyn and Kay Bailey Hutchison (R-Texas) play a key role in filling these vacancies, not just because the Senate must confirm all judicial nominees, but because the president relies on the recommendation of Texas senators before selecting a nominee for Texas federal courts. There are currently no nominees to fill these Texas vacancies, and until Cornyn and Hutchison begin to take this seriously, Texans will continue to be denied access to the courts.

Beginning with the lame-duck session, Cornyn should make good on his June promise that it would only be a "few months

delay" in confirming pending judicial nominees. In previous lame-duck sessions, the Senate has confirmed large numbers of nominees. For example, after the 2002 midterms, the Senate confirmed 18 of President George W. Bush's judicial nominees in one day. There is no reason that can't happen now. And why should Senator Hutchison retire and leave the problem she helped create for her successor?

We've all waited long enough for a fair and functioning court system. Senator Cornyn promised quick action if President Obama was elected to a second term. It is time for Cornyn, the now Senior Senator and party leader, to keep his word and fix the problem caused by gridlock and obstructionism in Washington.

## Children's Medical Center designated a Level IV NICU facility

The Neonatal Intensive Care Unit (NICU) at Children's Medical Center (www.childrens.com) has been designated a Level IV NICU, the highest qualification for such programs, as established by the American Academy of Pediatrics under newly revised standards.

Children's offers the most advanced medical care for the most complex and critically ill newborns of any of the three facilities in the Dallas-Fort Worth area to achieve this status. Children's also is the only hospital in the area with a NICU program academically affiliated with UT Southwestern Medical Center.

With its new designation, Children's offers a regional NICU program going

beyond the capabilities of other hospitals by performing surgical repairs on site of complex congenital or acquired conditions; maintaining a full range of pediatric medical subspecialists, pediatric surgical subspecialists and pediatric anesthesiologists at the hospital 24 hours a day; facilitating transport and providing outreach education.

The American Academy of Pediatrics recently revised its standards for NICUs, creating a Level IV designation for hospitals providing the most specialized care for newborns.

"The American Academy of Pediatrics' Level IV designation is important as it recognizes the highest level of care for neonates that is provided in the Chil-



dren's NICU," said Dr. Rashmin Savani, division director of Neonatal-Perinatal Medicine at Children's and UT Southwestern Medical Center. "There is a close partnership between UT Southwestern Medical Center and Children's to provide the excellence in neonatal and other subspecialty care needed for such a designation."

"This is a highly coordinated system that goes from the FETAL Program through the newborn period," said Savani, who is also a professor of Pediatrics at UT Southwestern. "Our Level IV NICU provides the support needed by Level III NICUs in north Texas and beyond that have babies needing a higher level of care. This allows

concentration of the best imaging, equipment, trained and experienced personnel and the highest level of subspecialty care available."

"The Level IV designation was created to help the community and families understand where the highest level of specialty care for newborns is offered," said Dr. James Moore, medical director of the Children's NICU and an associate professor of Pediatrics at UT Southwestern.

"The support that these complex babies out in the community need is available here at Children's," Moore said. "One of the things I am very proud of at Children's is that we provide these services, but believe in family-centered care. Part of that is returning

the babies to their home institutions so the family can have their own support networks once the baby is stable enough to be in that environment. I'm proud that we've always provided that, but now we have a way to designate what we are capable of," Moore said.

"The Children's NICU program has admitted more than 400 babies so far this year," said Lisa Mason, clinical director of Children's Neonatal and Perinatal Services.

"We are the only hospital in Dallas-Fort Worth that does not ever have to send a baby to another hospital because the breadth of our specialty services is so robust," Mason said. "We offer the highest level of care."

and related chronic diseases such as heart disease and diabetes are on the rise. One-third of Americans are obese, and more than two-thirds are overweight. Obesity has become a leading health problem in the United States, and its challenging personal and economic ramifications fuel the desire to quell the pandemic.

Until now research and treatment focusing on physiological factors, such as metabolic disorders, and psychological causes, such as eating when depressed or bored, have failed to solve the problem. However, recent research from Center for BrainHealth's lead addiction scientist, Dr. Filbey, seeks to further understand how addiction manifests in the brain and drive innovative treatment solutions.

"The reason I'm interested in studying the brain's reward system in response to food is that current treatments for obesity often do not work. Only 5 percent of those who seek interventions such as diet and exercise are successful in maintaining a healthy weight. Even in the case of gastric bypass, many still experience dependence symptoms like extreme desire to overeat and the associated

feelings of guilt after surgery," Filbey said.

"For someone with addiction, they are constantly bombarded by temptation, which is triggered by cues. For someone with an alcohol addiction, a cue might be driving down the road and seeing a bar or just seeing a wine glass. For someone who has problems with food, it might be the image of a milkshake or the smell of popcorn. Constant cues or triggers are what often makes it very difficult to abstain from substances," Filbey said.

Filbey and her team examined 26 obese individuals who exhibited binge-eating symptoms without purging behaviors. Obese is defined as having a body mass index above 30. Binge-eating symptoms were measured using a questionnaire called the Binge Eating Scale. All participants had moderate to severe binge eating behavior.

Participants were asked to divulge their favorite high-calorie beverages and complete self-assessments about their eating behavior. Using functional MRI technology, researchers then observed each participant's brain while the chosen, high-calorie beverage was

pipled into the participant's mouth.

As researchers suspected, the brain showed heightened activity in the reward, motivation, and memory areas of the brain. The more severe the binge-eating symptoms exhibited by the participant, the greater the activity in the brain. The results demonstrate similarities between brain disorders of the reward system commonly seen in other forms of addiction and binge eating.

Despite the cognitive connection between addiction and obesity, the term "food addiction" is up for debate in the field. "It is not a concept people have been open to in the past. Right now, it does not exist as a recognized disorder." However, Filbey concedes, "The National Institute on Drug Abuse has begun supporting research into food addiction, and although previously not considered a legitimate diagnosis, the next *Diagnostic and Statistical Manual of Mental Disorders* will list binge eating as a disorder."

This study provides evidence that the solution to weight loss for some goes beyond preaching behavior changes such as "just say no" to another milkshake, and urges us to better under-

stand brain-based issues that lead to obesity. Further research into binge eating, addiction, and the brain's reward system will help iden-

tify risk factors for weight problems and provide the basis for treatments helping those who struggle with "food addiction".

The National Institutes of Health recently awarded Filbey \$2 million to study addiction and marijuana.

anything to do with the 1971 firebombing of a white-owned grocery store, or sniper shots at responding firemen - that they are guilty.

The legal petition to pardon all of the ten - nine African-American males and one white female - of false conspiracy charges they were convicted of in 1972, has been pending in Gov. Perdue's Executive Clemency office since last May.

Perdue, a Democrat, is expected to make her decision in December before she steps down.

Churches, fraternities, sororities, community and civic organizations in North Carolina and beyond are being asked to support the cause by sending letters to Gov. Perdue, or signing the online petition.

Benjamin Todd Jealous, NAACP president/CEO, has agreed to send out a mass email nationwide to all NAACP members asking them to sign a special online petition that will be delivered

to the NC governor the first week in December. The national NAACP Board of Directors unanimously passed a resolution last May supporting the Wilmington Ten pardon effort, and the NC NAACP will be calling a special press conference Nov. 27th in Raleigh to urge Gov. Perdue to grant the pardons.

Thousands of signatures in hard copy and online petitions have been collected, but organizers with the Wilmington Ten Pardons of Innocence Project - an outreach effort the National Newspaper Publishers Association adopted in 2011 - say that still many more are needed by December 1st.

The next two weeks are critical, they say, towards garnering more petition signatures and letters of support in order to document widespread sentiment across the state and nation that the false prosecution of the Ten forty years ago was wrong, and the state needs to correct it.

Add to that the most recent and explosive revelation that James "Jay" Stroud, the state prosecutor who had the Wilmington Ten falsely convicted and sentenced to 282 years in prison collectively, not only sought to gerrymander the jury of the first June 1972 trial to include "KKK" and "Uncle Tom" types, but also, documented evidence from his own handwritten notes now show, succeeded in having that first trial aborted because it had a jury of ten blacks and two whites.

The second trial, in Sept. 1972, had a Pender County jury of ten whites and two blacks, in addition to a judge that history shows was more favorable to the prosecution.

"The prosecutor's notes are clear and convincing evidence that race was not just a factor in his selection of the ten whites and two blacks on the Pender jury that convicted the Wilmington Ten," veteran civil rights attorney Al McSurely says. "Race was the only factor. Forty years later,

we know his real motives. I believe when the governor studies this evidence, she will do the right thing and sign the pardons."

"I can barely contain my outrage at the blatant racism of an officer of the court," attorney McSurely added.

UNC - Chapel Hill law Professor Gene Nichol agreed.

"It is crucial that North Carolina act to admit and concede such a potent and defining abuse of power," Nichol said. "To allow public servants to behave in such a fashion, without remedy, is literally intolerable."

Attorneys for the Wilmington Ten pardons effort met with Governor Perdue's clemency staff several weeks ago, presenting their case, based on the Dec. 1980 US Fourth Circuit Court of Appeals ruling which overturned all ten of the convictions, based on prosecutorial misconduct, and the fact that not only was exculpatory evidence hidden by the prosecu-

tor, but three witnesses for the state admitted they were enticed to perjure themselves in testimony.

However, the state of North Carolina, in the 32 years hence, has refused to grant pardons of innocence to the Wilmington Ten, thus maintaining their false felony convictions.

In the six months since the pardons effort campaign publicly kicked off, support has come from North Carolina congressmen G. K. Butterfield, David Price and Brad Miller; the NC Legislative Black Caucus and state Rep. Deborah Ross of Raleigh.

The 2012 NC Democratic Party platform also adopted a plank supporting the Wilmington Ten pardon effort last summer.

In terms of grassroots support, the NC NAACP has led the way, and most recently, the NC chapter of the Southern Christian Leadership Conference has issued a resolution.

In each case, supporters have said that Gov. Perdue,

given her progressive record of advocacy to stop racially biased death penalty sentences; push for reparations to the victims of North Carolina's old forced sterilization program; and her veto of the Republican legislature's voter ID bill; is well positioned before she leaves office, to add to her progressive legacy pardons of innocence for the Wilmington Ten.

# Homeowners still waiting on billions in foreclosure relief

Thanks to a federal program, homeowner Pretti Hilton could be getting just what she needs to resolve her longstanding foreclosure case: a referee.

Under the Independent Foreclosure Review program, eligible homeowners can request a review of their foreclosure file by a third-party consultant. If the independent auditor finds that the bank made errors in processing their foreclosure, the homeowner can recoup money – from \$500 to as much as \$125,000.

For Hilton, who has been fighting foreclosure of her home for nearly four years, the program offers a ray of hope.

So far, her attempts to work with her lender, Bank of America, on modifying her home loan to produce a lower monthly mortgage payment, have failed. In fact, the bank tried to auction off her property several times. If she were to lose her two-bedroom home in Moreno Valley, California, says Hilton, she and her two sons -- a 15-year-old and a disabled 27-year-old -- would be on the street.

"The stress is astronomical," she says, adding that she is taking medication for hypertension, something she'd never done before. "I don't believe I was blessed with a house in order to lose it.... I will not go down without a fight."

A home health worker, Hilton says her income took a hit with state budget cuts to programs that subsidize in-home care. When she got back on her feet, she resumed making mortgage payments, which by then included late fees. But even after paying off the late charges, she says, her bank did not lower the monthly payment back to the original amount. Because of that discrepancy and others, Hilton says she hasn't paid her mortgage for three

years, and her case is still in limbo.

Then Hilton received a letter in the mail about the Independent Foreclosure Review program run by the Federal Reserve Bank and the Office of the Comptroller of the Currency (OCC). Hilton applied for the program two months ago, and says she's "expecting to hear something soon."

But the wait could be longer than Hilton originally expected.

More than a year after its launch, the program has yet to pay out any compensation, and just a fraction of the requested reviews have been completed.

Last April, federal regulators ordered the nation's biggest banks to overhaul their foreclosure procedures in the wake of the "robo-signing" scandal – when it came to light that banks were approving foreclosures without verifying the underlying documents. As a result, the banks were required by the government to offer third-party reviews of foreclosure cases to their customers who request it, and hire independent consultants to do the work.

Of the more than 4.4 million homeowners who were potentially eligible for the program who were sent letters, about 250,000 requested a review. Banks were also ordered to "look back" at a representative sample of cases, accounting for another 159,000 homeowners, bringing the total number of reviews to more than 400,000.

Bryan Hubbard, a spokesman for the OCC, says about 260,000 reviews are underway. According to an interim report released in June, consultants had completed just 11,000 reviews.

"No compensation has been approved yet because we have not reached that point in the review process," Hubbard says.

In June, regulators came up with a compensation pay scale, attaching dollar amo-

unts or other remedies to a list of about a dozen possible errors made by the banks. If consultants determine that a homeowner suffered financial harm, they will recommend what type and amount of relief should go to the borrower. The banks then need to submit a "remediation plan" to regulators, and then the checks can go out, Hubbard says.

"We hope that remediation will begin in the fourth quarter of this year, but continue through 2013," he says. As of yet, the banks have not submitted those plans to regulators.

The most common complaints prompting a request for review, Hubbard says, involve denials of loan modifications, improper and incorrect fees, timeliness of payments and disputes in amounts owed.

In Hilton's case, if a review of her file found she was wrongfully denied a loan modification, the foreclosure would be halted and the bank would have to grant or deny her application, and compensate her either \$2,500 or \$10,000.

Compensation to individual homeowners is capped at \$125,000, but the total amount the banks would have to pay out to all homeowners is "unlimited," Hubbard says.

The independent review program contrasts with a parallel but separate restitution program instituted earlier this year as a result of a multi-state lawsuit. The National Mortgage Settlement promised homeowners who were financially harmed by bank errors a "one-size-fits-all" check of about \$2,000. It set a "low bar to get some benefit," according to Paul Leonard, director of the Center for Responsible Lending's California office. The compensation would shrink as more homeowners tap the fund.

In contrast, the federal program, says Leonard, is a complement to that.

"[It] takes a fine-tooth-comb approach to really identify specific borrowers harmed and how much harm they actually suffered," Leonard says.

Although it doles out stiffer penalties for errors, and mandates that those deficiencies in each bank's

With the deadline to file a request for review under the federal program looming (Dec. 31), housing counselors say more effort is needed to publicize the program to eligible homeowners. Any homeowner whose primary residence was in any stage of foreclo-

"It's been disappointing. I feel that there have been tools that were created that should have worked really well," she says, referring to HAMP (the loan modification program that formed the cornerstone of the Obama administration's efforts to stem the foreclosure crisis).

foreclosure process be fixed, recent revelations have come to light that the independent reviews may be flawed. ProPublica revealed cozy ties between the banks and the third-party consultants that were hired to conduct the reviews, resulting in bank employees trying to influence the outcome of reviews.

News reports also revealed that the third-party consultants are reaping record profits through their contracts with the banks.

"The purpose of this [independent review process] was to remedy financial harm to borrowers; it wasn't meant to be 'The Consultants Full-Employment Act,'" Leonard says. "The irony is, it appears that they [the banks] are going to spend a lot more money [on] paying for the consultants...[than] providing remedies to borrowers."

He adds, "Nobody knows for sure [how much money will be paid to homeowners]. No money has been put into the pocket of borrowers yet."

sure in 2009 or 2010, and whose mortgage was serviced by participating loan servicers, is eligible to request a review.

Maria Cabildo, president of East LA Community Corporation, says her organization has helped just a handful of people apply for the program. Unfortunately, she adds, many homeowners may have simply tossed the letter from federal regulators informing them of the program, thinking it was a scam. She says many of her clients have been inundated by mailings from mortgage scammers.

Hubbard, the OCC spokesman, says mailings about the program were sent out in English and Spanish, with a note about translation services in other languages.

Cabildo says homeowners have been hearing about numerous programs meant to provide different forms of relief to homeowners, but those remedies have been slow to materialize.

HAMP didn't live up to its billing, says Cabildo, partly due to banking practices such as "dual-track," which is when banks carry out foreclosure proceedings before a decision is given on a loan modification application.

In the meantime, some banks have started to offer relief to homeowners, but "not the forms of assistance most of us had in mind," says Maeve Elise Brown, who directs Housing and Economic Rights Advocates (HERA).

She says, so far, the majority of relief for homeowners under the settlement has come in the form of wiping out second mortgages (rather than offering loan modifications) that were uncollectible anyway – a move that provides little real relief to homeowners.

"When I look at the universe of opportunities for assistance available to [homeowners] now, the opportunities are still a little more limited than they need to be," she says, adding that

the commission. Too often we talk about issues such as voting and civic education without the data necessary to draw the right conclusions. I look forward to serving."

Spencer Foundation President Michael S. McPherson said, "The policy choices our nation makes in coming years will affect profoundly the lives and fortunes of today's young people. Helping them to become active and effective participants in shaping their and our common future is a profoundly important challenge. We are proud to help support this commission, which we expect will do much to help us learn how to address that challenge."

The Commission on Youth Voting & Civic Knowl-

edge was formed in response to controversies about recent voting laws (for instance, the new state photo ID laws) as well as debates about civic education in schools and colleges. It will, however, take a broader view, considering a wide range of potential influences on political knowledge and engagement. The commission begins with no position on the existing or proposed policies; its deliberations will be heavily influenced by new data collected during and immediately after the 2012 election.

The Commission is funded by the Spencer Foundation, the S.D. Bechtel, Jr. Foundation, the Youth Engagement Fund, the W.T. Grant Foundation, and the

Chicago Community Trust and will be under the leadership of CIRCLE director Peter Levine and staffed by CIRCLE's team of researchers and analysts. The grants will support scholarly research to aid the work of the commission in the following ways:

- Conducting an ambitious, free-standing national youth survey to investigate the effects of state policies on informed youth voting;
- Analyzing two waves of a national longitudinal survey of young adults, with a specific focus on the 2012 voting experience and photo ID laws;
- Surveying and assessing state civic education policies;
- Interviewing key stakeholders.

homeowners need to be pro-active about taking advantage of all available programs. "The Independent Foreclosure Review process is a little pinpoint of light, and it could be a year before people will see any money, but it would be good for them to eventually see it."

Peggy Mears of Fontana, Calif., applied for the federal "independent review" program in April, and is still waiting to find out if she'll receive any compensation.

"We were on a so-called trial modification, which is three months [long]," Mears says. "We paid for nine months and all of a sudden we were being foreclosed upon."

Mears, who now advocates on behalf of homeowners as an organizer for Alliance of Californians for Community Empowerment, says the bank should have stopped charging them after the third month and switched them from a trial to a permanent modification.

Mears eventually struck a deal with her lender OneWest Bank (formerly IndyMac Bank) to lower

her monthly mortgage payment to a level, she says, that is only

"slightly lower" than what she had been paying.

The long wait for resolution under the federal program is not daunting, Mears

says, because after going through the lengthy and frustrating process to mod-

ify her home loan with her bank, she says "nothing they do surprises me."


Every night before he went to bed, fourteen-year-old K'wan Taylor felt beneath the mattress to make sure the knife was still there.

As residential programs went, Healing Souls wasn't bad. The counselors were nice and K'wan liked his roommate, but he wished everybody

would stop trying to make him talk about that night, the blood, the anger he felt. He hated his father, but he couldn't say how much. He couldn't say anything, in fact, because words just wouldn't come out of his lips.



K'wan had been silent for months.

Everybody told him that he'd talk when he was ready, but they pushed him to trust, listen, journal, think, get his anger out in the open, maybe even forgive

both his parents. Then one of the counselors, Miss Daisy, gave him a pamphlet and K'wan learned that children who are abused often grow up to be abusers.

There was no way he'd let that happen, either. There was

no way he was going to be anything like his father...

Open this book to the first chapter, and you know that *Silent Cry* is going to try to teach you something. It practically drips with lessons and warnings, and that's all good. The problem is that it's also saturated with repetition.

Now, don't get me wrong. I firmly, indubitably believe that author Dywane D. Birch's message – that domestic violence is wrong and that it can spill into the next generation way too easily – is something every man and woman needs to know, twice.

But between the pages and pages of identical flashbacks, too-similar-sounding

counseling sessions, tired obscenities, interchangeable bursts of anger, and an awful lot of blinking, I thought the message could've been hammered home in fewer pages. *Silent Cry* is just too long.

It's not unreadable. It's just wordy, and if you can keep that in mind and don't get too impatient, you'll like this book just fine. You might, in fact, have someone in mind while you're reading and if that's the case, then look for this book because *Silent Cry* is one you'll want to pass forward.
