## Local doctors are urging families to get their flu shots now



Post-its and scrawled notebook paper will trumpet "new" resolutions. Eat less, relax more, volunteer, tithe, save, all that good stuff. Some will even compose a bucket list of things they'd like to do before the end of their lives. Others will have a list of wants and wishes, both realistic and unrealistic. My wish list focuses on public policy, since better public policy means a bet-

I WANT JOBS, JOBS, JOBS FOR BLACK PEOPLE. With the last reported official unemployment rate for African Americans at 12.5 percent, and the unofficial rate exceeding 25 percent, I'd really like to see some

more jobs in the African American community. Joblessness leads to poverty leads to all kinds of maladies. While the stock market is soaring, is it too much to ask for a little job creation? Don't Republicans, also, represent unemployed people? Help me, somebody. By the way, I'd like more jobs for everyone, but first things first.

And while we're at it, why not fairer (and more equal) wages. There is talk of raising the minimum wage to \$10 or more by 2015, and some states are already moving to wage levels even higher. More than half of those now earning the minimum wage are raising children. If their employers don't pay enough for them to live on, the government will end up subsidizing their employers' (and them) with programs such as SNAP (food stamps) and Section 8. Ooops! Those programs are being cut as well. What is a poor person to do in a nation that is both hostile to poor people and also absolutely needs them?

I want President Obama to say "Black" or "African American" sometime other than Black History Month. And I'd like him to say it enthusiastically, not reluctantly. His Dec. 4 speech on poverty issues in Washington, D.C. went a long way toward addressing the concerns (education, housing, poverty) of the least and the left out, but his lips won't be permanently puckered in a putrid position if he managed to give his most loyal constituency a shout out. I guess I've been wishing for this for the past five years; I guess I'll be wishing for the next few. (And don't tell me that President Obama is president of everyone. He doesn't cringe when saying Latino, women, or GBLT).

I want our Congress to think longterm and provide more dollars for education, and for HBCUs, especially, because need more resources; most colleges that enroll fewer than 1,500 students with small endowments can

Republicans have a better than even chance to take over the Senate if they nominate the best conservative candidate that is "electable." The GOP should be able to pick up seats in Alaska, Arkansas, Louisiana, North Carolina and West Virginia. Republicans need only a net of six seats to win the Senate.

The Black vote could be the margin of victory in states such as Arkansas, Louisiana and North Carolina. Each has Black voters who thoroughly turned off by the Democrats and Obama. If these Republican candidates take their message to the Black community, Republicans will take over the Senate.

I know many of my Democratic friends will laugh at me and my Republican friends will continue to want to dismiss the Black vote; but I dare my Republican leaders to call my bluff if they really want to win the Senate.

As I often say, I have been Black most of my life and I know the sentiments of my community very well. To prove my point, what was unthinkable just a month ago is going to happen more frequently going forward. Democrats, especially Blacks, for the first time are publically voicing their dissatisfaction with Obama.

A group of very liberal Blacks are about to file a lawsuit against Obama for enacting policies that have decreased the number of Black students attending HBCUs. By 2016, I predict that morals and values will be in the top five issues of importance to voters. This liberal drift towards pluralism and relativism will begin to reverse itself with a lot of help from within the Black community. Republicans, are you listening?

Look for a major reduction in corporate support for many of the reality TV shows that have proliferated over the past several years. These corporations will find it increasingly more difficult to justify the expenditure of their corporate dollars from a cost/benefit analysis.

I expect to see more suicides from those who played professional football and hockey. The issue of trauma to the brain during violent sports is a lot worse than the public is being told. I think over the next few years, pro football will become unrecognizable as we know it today.

There will be no comprehensive immigration reform. However, as a compromise, there will be a path to legalization, but not citizenship. Republicans who vote for citizenship will lose their next election and some will even be recalled before their next election (on the local level).

Journalism will continue its downward spiral towards the cult of personality. Journalists will continue down the path of becoming bigger than the story they are supposed to be covering. They will continue to put more emphasis on being famous versus being accurate.

My final prediction is that Obamacare will be a huge albatross around the necks of the Democrats for the next three years and will make their retaining the White House very problematic. ## Parkland prenatal care helps prevent birth defects

DALLAS — Simply taking an inexpensive vitamin pill daily during pregnancy can prevent life-threatening and disfiguring birth defects like spina bifida. According to providers at Parkland Health & Hospital System, expectant women who take adequate amounts of folic acid, a B vitamin, can prevent serious birth defects to their baby's brain and spine, abnormalities known as neural tube defect that occur in the first few weeks of gestation. During January, National Birth Defects Pre-

vention Month, and this week, Jan. 5-11, designated as National Folic Acid Awareness Week, the staff of Parkland's Women and Infants' Specialty Health (WISH) division is stressing the importance of nutrition in averting preventable and tragic birth defects.

As many as 3,000 babies are born each year in the United States with neural tube defect. Folic acid has been found to be very important for women considering pregnancy and during pregnancy in the prevention

of neural tube defects. Folic acid is a B vitamin that every cell in the body needs for normal growth and development. The U.S. Public Health Service has recommended since 1992 that all women of childbearing age take 400 micrograms of folic acid per day to reduce the risk of neural tube defects that affect the brain and spinal cord.

It's never too late to quit. While it's best to quit smoking as early as possible, quitting smoking at any age will enhance the length and quality of your life. You'll also save money and avoid the hassle of going outside in the cold to smoke.

Every smoker can quit. The ALA said each person needs to find the right combination of techniques that will for them, and above all, they need to keep trying.

## Prosper's credit rating is upgraded by Standard & Poor

PROSPER - A strong economic future, a stable fiscal past and a population with a collective buying income well above the national average are among the reasons for an upgrade of the Town's credit rating, according to Kent Austin, Director of Finance.

"Standard & Poor's, one of the nation's largest credit rating agencies, has sent word that the Town's credit rating has been upgraded from A to AA. This is the second highest category that the rating agency assigns, and means they feel that Prosper has a very strong capacity to meet its financial commitments," he said.

Credit ratings are forward-looking opinions about credit risk. Standard & Poor's credit ratings express the agency's opinion about the ability and willingness of an issuer to meet its financial obligations in full and on time.

The upgraded rating is assigned to the Town's General Obligation bonds, monetary instruments used by local governments to finance infrastructure, capital expenditures and other large-scale purchases. The upgrade means that lenders should feel certain that any debts incurred by the Town

are a very worthy risk, and can thereby offer the Town better lending rates.

"The advantages of a higher rating are, on one hand, easy to calculate since we can expect better financing rates, but they are also indirect because a higher rating makes us far more attractive to other kinds of investors. Developers, financiers, brokers and real estate companies want to do business in a city with a stable economic outlook, and a higher rating gives us that intangible benefit," added Town Manager Harlan Jef-

For example, the previous A rating meant that while Prosper had a strong capacity to meet financial commitments, it was somewhat susceptible to adverse economic conditions and changes in circumstances. Such uncertainty can have an adverse effect on investment decisions by outside companies looking to establish a foothold in a city.

In addition to a stable financial past, illustrated by a conservative outlook on expenditures and impressive reserve levels, the rating agency noted that Prosper's economy is very strong, with its projected per capita effective buying income at 139.4 percent of the U.S.

Moreover, S&P found: a per capita market value of \$106,974; access to the broad and diverse economy of the Dallas-Fort Worth metropolitan area; a county unemployment rate of 6.1 percent; strong flexibility in the budget, and; reserves above 30 percent of expen-

The report also cited Prosper's management conditions as strong, with good financial practices, strongly supported and encouraged by the Council. And, unlike cities struggling to fund their own retirement system, putting them at risk, Prosper participates in the Texas Municipal Retirement System to provide pension benefits for employees.

Even with a strong economy, though, the rating agency noted that a more diversified tax base, including more commercial investments, would put the Town in better financial footing.

"With the guidance of a fiscally conservative Council, we certainly plan to continue to maintain our financial strength at its highest," said Austin.



## A better deal for kids in the budget? Politicians say 'Yes'

(New America Media & NNPA) June Jimenez of Silver Spring, Md. was pregnant when she was laid off from her job at a public affairs firm last year. She tried unsuccessfully for months to find a job and worried about losing her home.

"My mortgage is \$1,500 a month and I only received \$320 a week in unemployment," she says.

Her health insurance policy at the time didn't provide her with maternity coverage, and when she tried to purchase an individual plan, she discovered that she couldn't because her pregnancy qualified as a preexisting condition. She qualified for Medicaid, which covered the cost of her pregnancy, including an emergency C-section.

But she found herself facing the possibility of having to choose among making her mortgage payments, paying for utilities, and buying food.

What sustained her, she says, was that by her sixth month of pregnancy she was able in enroll in WIC (the Special Supplemental Nutrition Program for Women, Infants, and Children). She used WIC to buy food for her and her daughter for the next nine months.

Today Jimenez is working again, and her daughter Karanda is now almost a year old. "Without a doubt, Medicaid and WIC saved us," she says. "[Those programs] provided a crucial bridge for me."

At a congressional briefing last week, children's advocacy organization First Focus Campaign for Children, in conjunction with advocacy group MomsRising, presented the results of a nationwide poll that found bipartisan public support for pro-

tecting funding for children's programs in the federal budget.

The survey of 800 voters, commissioned by First Focus and conducted by polling firm American Viewpoint, found that strong majorities of both Democrats and Republicans opposed cuts to programs like the ones that sustained Jimenez.

Voters were surveyed by landline and cell phone in the first week of December.

"Kids were affected significantly by the budget sequestration that took effect earlier this year," says Ed Walz, vice president of communications at First Focus. Cutbacks, he says, have disproportionately impacted programs serving children.

While some federal programs such as Social Security are mandatory, children's programs like WIC, Head Start (which provides early childhood services to low-income families, including education and child care), and K-12 education are funded through the appropriations process.

Head Start programs, for example, had to cut services for close to 60,000 children in the 2013-2014 school year.

According to the survey, three in four voters oppose cuts to K-12 education funding, including 87 percent of Democrats, 63 percent of Republicans, and 71 percent of independent voters.

Voters specifically oppose cuts to early learning for young children by a ratio of nearly two-to- one (62 to 32 percent), including half of Republicans, more than three in four Democrats, and almost 60 percent of independents. Nearly two in three voters oppose cuts to Head Start.

Sheila Arias of Durham, N.C. says that when she lost her job as an interpreter, she

during pregnancy could prevent up to 70 percent of some types of serious birth defects. Spina bifida, a birth defect of the spine, can cause paralysis of the lower body and learning disabilities. Another type of birth defect affects the brain and causes babies to die within a few days of birth.

"At Parkland Women's Health Centers, all prenatal clients are started on folic acid and iron at their first visit to help ensure good outcomes for mother and baby," Taylor stated.

"Moms are encouraged to eat foods rich in folic acid such as leafy green vegetables, whole grain products and cereals enriched in folic acid. In addition, women who are seeking pregnancy receive pre-conception counseling that includes education about taking folic acid, proper nutrition and the avoidance of alcohol and smoking."

"More than 90 percent of Parkland's prenatal patients receive at least four prenatal care visits. The average number of visits for Parkland's prenatal patients is nine," stated Paula Turrichi, Senior Vice President, WISH. "Consistent prenatal care leads to healthier moms and babies, better birth outcomes and lower neonatal and infant mortality," she added.

Because up to half of all pregnancies are not planned, it's important for women of childbearing age to get enough folic acid daily if there is any chance they could become preg-

"It's a seemingly small thing that can make a huge difference in the health of your baby," Taylor said.

## **HBCU leaders leaving in alarming numbers**

(NNPA) Only three months into the academic year and headlines have been littered with announcements about HBCU leadership turnover. There have been a plethora of reasons, including university presidents being fired, being encouraged to leave their posts by their boards of trustees or opting for retirement. Gone are the days of decades of top-down leadership, now replaced by a need for charismatic personalities

who are well-skilled at fundraising while navigating internal needs and external stakeholders, as well as politics and long-standing traditions.

Harvey shares his 36 years worth of knowledge with other presidents during the annual Executive Leadership Summit held each November at Hampton. Harvey said 15 of his former university officers are now university presidents.

"I've had a lot of people who helped me," Harvey said. "I try to share the lessons I've learned."

Exiting leaders

While some may have seen the handwriting on the wall, others stepped down under arduous circumstances or planned for their next career move since the start of the 2013-14 academic year.

For example:

• Tuskegee University: two weekends ago, the fall meeting of

the Tuskegee University Board of Trustees was rocked by Dr. Gilbert L. Rochon resigning from his role as president. By the following Monday, Dr. Matthew Jenkins was posted on the university's web-site as acting president. Rochon served three years.

• Howard University: On Oct. 1, university President Dr. Sidney A. Ribeau abruptly stepped down after months of wrangling over the management and financial health of Howard University. Ribeau served five years and extended his tenure through December.

His departure comes on the heels of a drop for the university in a major national ranking and a downgrade in its credit rating, as well as a 5 percent fall in enrollment

• Stillman College: On Sept. 6, one day after the fall convocation,

couldn't afford to keep her daughter, Jaslene, who was two at the time, in daycare. Arias went to the local Children's Developmental Services Agency for help, and was told that Jaslene would probably qualify for Early Head Start.

The agency helped Arias apply, and three weeks later, her daughter was accepted into the program. Jaslene has developmental disabilities, and Arias says that the teachers "offered her important structure and a regular daily routine" that, in addition to therapy, have helped with managing her special needs.

Jaslene will start kindergarten next year, and Arias says that Early Head Start is now helping her with her younger child, who is showing signs of a disorder that also affects his sister.

Democrats and Republicans recently reached a budget deal that would restore some of the funding to programs that were affected by sequestration. First Focus reports that if sequestration relief were to be applied proportionally to children's programs, about \$3.6 billion federal dollars would be restored to these initiatives in 2014, including \$1.8 billion for K-12 education and \$370 million for Head Start.

The poll found that when voters are asked to prioritize deficit reduction or protecting investments in children,

31 percent of respondents place a higher priority on investments in children and 41 percent rate the two options as equally important. "Voters reject what they consider a false choice," says Walz. "What this shows is that 72 percent of voters reject that the way to reduce the budget deficit is to cut children's programs."

"Congress has struggled to prove responsive to the concerns of the American people," he says. "What the current deal does, in a nutshell, is create an opportunity for Congress to undo some of the damage done in this budget year."



## **Retirement Plan Limits Largely Unchanged in 2014**

Anyone who's bought groceries, filled their gas tank or paid insurance premiums recently would probably be surprised to learn that, according to Department of Labor's Consumer Price Index for Urban Consumers (CPI-U), the rate of inflation is relatively flat – only 1.2 percent from September 2012 to September 2013.

That's bad news for people who were hoping to boost their contributions to an IRA, 401(k) plan or other tax-advantaged retirement savings accounts, since the IRS uses the CPI-U's September year-overyear performance to determine whether or not to make cost-of-living adjustments to many of the retirement contributions you and your employer can make in the following year.

Here are highlights of what will and won't change in 2014:



**Defined** contribution plans: The maximum allowable annual contribution you can make to a workplace 401(k), 403(b), 457(b) or federal Thrift Savings plan remains unchanged at \$17,500. Keep in mind these additional

People over 50 can also make an additional \$5,500 in catch-up contributions (unchanged from 2013).

The annual limit for combined employee and employer contributions increased by \$1,000 to \$52,000.

Because your plan may limit the percentage of pay you can contribute, your maximum contribution may actually be less. (For example, if the maximum contribution is 10 percent of pay and you earn \$60,000, you could only contribute \$6,000.)

**Individual Retirement** Accounts (IRAs): The maximum annual contribution to IRAs remains the

same at \$5,500 (plus an additional \$1,000 if 50 or older – also unchanged from 2013). Maximum contributions to traditional IRAs are not impacted by personal income, but if your modified adjusted gross income (AGI) exceeds certain limits, the maximum amount you can contribute to a Roth IRA gradually phases out:

For singles/heads of households the phase-out AGI range is \$114,000 to \$129,000 (increased from \$112,000 2013's \$127,000 range). Above \$129,000, you cannot contribute to a Roth.

For married couples filing jointly, the range is \$181,000 to \$191,000 (up from \$178,000 \$188,000).

Keep in mind these rules for deducting traditional IRA contributions on your federal tax return:

If you're single, a head of tirement plan, you can household, a qualifying widow(er) or married and neither spouse is covered by an employer-provided re-

deduct the full IRA contribution, regardless of income



the university announced that Stillman College President Ernest McNealey was removed from his position by the Board of Trustees. McNealey served as president since 1997. Despite his accomplishments, critics blamed him for enrollment declines, high employee turnover and poor relations with the business community.

- Shaw University: In September, President Dorothy Cowser Yancy announced that she would retire after serving since 2011, when she was tapped to fill the post after former president Irma McClaurin resigned. She also served as interim president for 15 months prior to McClaurin and was credited with restructuring the school's finances during that time.
- Norfolk State University: In August, after a lengthy closed door session, Dr. Tony Atwater was fired by the Norfolk State Board of Visitors in

a seven to four vote that took Atwater by surprise. Atwater described the news as "sudden and disappointing." He served for two years with ten months remaining on his contract. According to reports, the university's accrediting agency had signaled trouble at the HBCU.

• Wilberforce University Dr. Patricia A. Hardaway is slated to retire in December after serving as president

The burning question that remains is about the fate of HBCUs and how to stop the trend that's making it difficult for presidents to lead.

"If you look at the landscape now for all of us, it's a tough landscape," said Hampton University president, Dr. William R. Harvey. "There are a number of factors impacting all HBCUs, including the federal government debacle on the Parent Plus Loan situation, [and] support is down for Title III, which strengthens HBCUs. All of the support for HBCUs across the board is down. In addition, there are some institutions that don't have enough students there.

"It's a tough climate right now."

The pride and traditions of HBCUs is a source of its strength and legacy, but navigating the gauntlet of closely held traditions while fulfilling the requirement to bring new life and resources to the university can be a daunting task for presidents.

Some describe it as a juggling act of trying to please too many masters, including boards of trustees who, at some institutions, have significant influence and demand compliance. Some presidents have operated in-dependently of boards until problems

seen at the high end. The flagship S-Class, which reset the luxury benchmark with an all-new generation for model year 2014, posted an annual increase of 12.8 percent to 13,303 units. Total sales for the SL-Class roadster rose 43.0percent at 7,007.

A best-ever December for the Mercedes-Benz brand vielded sales of 33,007, increasing 17.3 percent from the 28,145 vehicles sold in December 2012. The E-Class model line was the top volume performer for the month, jumping 25percent to 8,727. ## The World Honors Dr. Martin Luther King, Jr.

(My father, Mr. Lloyd David Demus, once told me, "Strive to leave the world a better place than when you found it." Dr. King did just that, he made a difference and we are better off as a world. Thank God for Dr. King.)

On January 20, 2014 our nation will celebrate the life of Dr. Martin Luther King, Jr., a Nobel Peace Prize winner in 1968 at age 35, for his contributions to our nation and to the world.

Dr. King (January 15, 1929-April 4, 1968) was born Michael Luther King, Jr., but later he had his name changed to Martin. His grandfather began the family's long tenure as pastors of the Ebenezer Baptist Church in Atlanta honoring and praising God, he served from 1914 to 1931.

Dr. King's father served from then until his death; and from 1960 until his death Dr. Martin Luther King, Jr. acted as co-pastor.

Dr. King attended segregated public schools in Georgia, graduating from high school at the age of 15; he received his B. A. degree in 1948 from Morehouse College, a distinguished Negro institution of Atlanta from which both his father and grandfather had gradu-

After three years of theological study at Crozer Theological Seminary in Pennsylvania where he was elected president of a predominantly white senior class, he was awarded the B.D. in 1951. Dr. King received his doctorate degree in 1955. In Boston he met and married Coretta Scott, a young woman of uncommon intellectual and artistic attainments. Two sons and two daughters were born into the family.

In 1954, Reverend Martin Luther King, Jr. became pastor of the Dexter Avenue Baptist Church in Montgomery, Alabama and he was a member of the executive committee of the National Association for the Advancement of Colored People, the leading organization of its kind in the na-

first great Black nonviolent demonstration of contemporary times in the United States; the bus boycott lasted 382 days.

On December 21, 1956, after the Supreme Court of the United States had declared unconstitutional the laws requiring segregation on buses, Blacks and Whites rode the buses as equals.

In 1957 he was elected president of the Southern Christian Leadership Conference (SCLC), an organization formed to provide new leadership for the now burgeoning civil rights movement. The ideals for this organization he took from Christianity; its operational techniques from Gandhi.

In the eleven-year period between 1957 and 1968, Dr. King traveled over six million miles and spoke over twenty-five hundred times, appearing wherever there was injustice, protest, and action; and meanwhile he wrote five books as well as numerous articles.

In these years, he led a massive protest in Birmingham, Alabama, that caught the attention of the entire world, providing what he called a coalition of conscience.

Dr. King planned voter registration drives in Alabama and he directed the peaceful march on Washington, D.C., of 250,000 people to whom he delivered his address, "I Have a Dream", he conferred with President John F. Kennedy and campaigned for President Lyndon B. Johnson.

He was awarded five honorary degrees; was named Man of the Year by Time magazine in 1963; and became not only the symbolic leader of American Blacks but also a world figure.

At the age of thirty-five, Dr. Martin Luther King, Jr., was the youngest man to have received the Nobel Peace Prize. When notified of his selection, he announced that he would turn over the prize money of \$54,123 to the furtherance of the civil rights move-





Care centers. "Based on what we're seeing so far, this flu will be very different than last year. We expect to see many more flu cases in younger children and younger and middle-aged adults."

"The CDC recently added Texas to its widespread flu activity list, and we're definitely seeing a surge in people coming in to AFC Doctors Express looking for treatment for symptoms. It's not too late to get your flu shot, though, so it's better to be safe than sorry when it comes to the flu," said Beata Toth, owner of AFC/Doctors Express Dallas.

Flu Strikes New Victims Last year, the dominant flu strain was H3N2 that tended to hit older people.

This year, the predominant flu strain in the U.S. is H1N1, the same virus that caused the international pandemic in 2009-2010. That flu hit younger chil-

dren, and younger and middle-aged adults. The CDC estimates that 284,000 people died worldwide during that flu season. This year's flu vaccine should offer good protection against this flu strain.

The H1N1 strain can be cut short by antiviral drugs such as Tamiflu because they haven't developed much resistance to these drugs. If you suspect you have the flu, doctors say vou should be treated, especially if you have serious medical conditions like asthma, diabetes and heart disease.

"The recent cold weather, coupled with the surge in flu activity, has really impacted our area. The easiest way to combat the flu is to come in and get a flu shot. People should also avoid others who are showing flulike symptoms, and be sure to wash their hands when they come in contact with public spaces," said Dr. Donald Dunlap, doctor with AFC/Doctors Express Dal-

Flu Shot Fast Facts:

You are 60 percent less likely to need treatment for the flu if you get a flu shot. According to the U.S. Department of Health and Human Services, the shot can also reduce illness, antibiotic use, time lost from work, hospitalizations and deaths.

You can get a flu shot even if you're feeling mildly sick. Health and Human Services advises thatpeople with mild respiratory illnesses can still get the vaccine. Those with fevers should wait until the fever has broken to get the vaccine. If nasal congestion is a problem, wait until the congestion has cleared before getting a nasal-administered vaccine.

Mild reactions such as soreness, headaches, and fever are common side effects of the flu vaccine.

The CDC is recommending the flu shot to anyone older than 6 months.

Pediatricians typically offer vaccines for children only. Pharmacies typically offer vaccines for only for adults. AFC Doctors Express Centers offer onestop-flu shots and mists for the entire family - both children and adults. (ages of children vaccinated vary by center.)

Even with a vaccination, you still need to protect yourself - here are a few tips to beat the bug:

Bring your own pen – to the bank, grocery store, even to touch the ATM. Anything a sick person touches can get infested with germs, including money, mail, ATM keypads, elevator buttons, etc.

Use paper – replace hand towels in bathrooms with paper towels. They're not as pretty, but paper towels can help get rid of a ton of germs that live in damp towels.

Wash hands frequently use soap, warm water and rinse long enough to say the alphabet or sing "Happy Birthday." Recent studies show plain soap and water works just fine.

Use a proper hand sanitizer (at least 60 percent alcohol) anytime you touch anything. Make sure you use sanitizer, even under fingernails, where germs hide

Clean with disinfectant viruses and bacteria can live up to two hours or longer on doorknobs, toys, TV remote controls, keyboards, mouse pads, refrigerator handles, counter tops, railings, faucets, bathroom floors and more.

If you are covered by an employer plan and are single/head of household, the tax deduction phases out for AGI between \$60,000 and \$70,000 (up from \$59,000 to \$69,000 in 2013); if married and filing jointly, the phaseout range is \$96,000 to \$116,000 (up from \$95,000 to \$115,000).

If you're married and aren't covered by an employer plan but your spouse is, the IRA deduction is phased out if your combined AGI is between

\$181,000 and \$191,000 (up from \$178,000 to \$188,000).
