accountability for what happened. They say they are hitting a brick wall when it comes to responses from the Collin County Sheriff's office. The family and their supporters have pledged to keep up pressure on Collin County officials until their is-

sues are resolved. This led to a May 2 protest where an altercation between the protesters and a motorist delayed by the blocking of a roadway heated up and seemed to almost come to blows.

A video of the exchange has garnered more than 100,000 views on Youtube and has drawn comments condemning both the motorist and the protesters.

Even Texas Attorney General Ken Paxton has chimed in on the video, saying the protesters are the ones who should have been arrested, and implying that one motorist pulled out what appeared to be a gun.

Police later noted that the device was not a gun but a taser, and that the motorist had been charged with assault by contact, as he struck the hand of a protester while apparently trying to swipe a phone from her hand.

At Monday night's city council meeting in Plano, several people

the incident, with opinions ranging from those who feel the motorist should have been arrested, to others saying the police had not done enough to stop the "BLM agitators."

One speaker who addressed the council regarding why the protest was held in the first place was disrupted and heckled by audience members in attendance, causing the mayor to intervene.

"The cognitive disonance in here blows my mind," the female speaker said.

Another speaker who appeared in public suggested Plano being spotlighted this way made it more likely that future protesters would want to come to Plano and try to disrupt the peace.

Prior to the public comments, Plano City Manager Mark Israelson gave the council an update ont he incident with more context than what was shared online in the past week.

He told the council the officer was originally dispatched to a traffic malfunction call. It was then the officer arrived that he discovered there was no malfunction, but that protesters were in the intersection following a planned event in Frisco. At that point, Israelson said the officer's first priority was to de-escalate until other officer could arrive.

Because of the crowd, Israelson said the lone officer did not orgin-

Ask Esther Obeng, M.D., Ph.D., about her job title, and she's liable to offer up a variety of terms: physician-scientist, researcher, attending physician and assistant faculty member.

But there's another title, one that preceded her position at St. Jude Children's Research Hospital, that's a particular point of pride for her.

"I'm a first-generation American," she said.

Obeng's father came to the U.S. from the West Af-



rican nation of Ghana. Her mother emigrated from the Caribbean. They brought to their new country a strong work ethic and a yearning for excellence.

For media mogul and entrepreneur Cathy Hughes, this year's Mother's Day was going to be difficult.

Last July, Hughes's mother, Helen Jones Woods, 96, died from complications of Covid-19. For the 74-yearold Hughes, multi-millionaire and founder and chairperson of Urban One Inc., this year marks Hughes's



first Mother's Day without her mother present. And while many might consider those individuals able to spend more than seven decades with their mother as fortunate, Hughes said such longevity also created a startling realization. "The longer God blesses you with having your mother in your life, the more difficult it is to adjust to life without her," she said.

It was during Hughes's mourning, that she birthed an idea to not only celebrate her mother's life with a national TV program, but to also celebrate and honor the lives of other African American women who -specifically during the pandemic – worked at protecting and spotlighting Black Americans.

On Sunday, May 16, 2012 at 9 p.m. (EST) Hughes's cable TV networks, TV One and its sister network CLEO-TV, will air the network's annual "Urban One Honors" celebration. The two-hour program this year will be a first; all honorees are African American women. The show is doctors and scientists like Obeng to conduct research and help find cures while ensuring no family treated at St. Jude ever receives a bill. Obeng is able to attend to bone-marrow-transplant patients and has her own research lab. That combination of functions, research along with treating patients, appeals to her.

One of Obeng's favorite experiences came when she emerged from her lab one day and saw a patient who previously had experienced complications waving to her as she left the hospital to go home.

A Transformational President

Facebook is close to getting it right

However, the board punted the final decision back to Facebook, to "reexamine the arbitrary penalty it imposed on January 7 and decide the appropriate penalty."

While we are relieved to learn that Trump will, at least temporarily, no longer be allowed to spread lies about election fraud and incite violence, as he did on January 6 and the years that led up to it, the Oversight Board must continue to do everything in its power to stop hateful activities and disinformation targeting marginalized communities around the world.

en a first step in preventing future Facebook-fueled tragedies, but beyond individual cases, Facebook's systemic problems promoting hate speech, violent rhetoric, and misinformation persist. As the only legitimate form of democratic oversight, lawmakers should investigate and address these systemic problems to prevent future violence.

Facebook must now make the indefinite suspension a permanent disabling of the page and account, and it should do so immediately.

Biden-Harris deliver funds to support older Americans' health

The U.S. Department of Health and Human Services' Administration for Community Living has released \$1.4 billion in funding from the American Rescue Plan for Older Americans Act programs, including initiatives to support vaccine outreach and coordination, address social isolation, provide family caregiver support, and offer nutrition support

The department also plans to fund justice programs to ensure the safety and protection of older adults.

According to a White House fact sheet released on May 3, officials plan to distribute the funds as follows.

• \$750 million for meals for older adults. With this funding for Older Americans Act nutrition programs,

states will be able to continue home-delivered meals as well as "drive-through" "grab-and-go" meals or for older adults who typically would participate in meal programs at community centers that have been closed due to the pandemic. It will also allow states to re-open meal program locations safely that might have closed during the pandemic. • \$460 million for Home

and Community Based Ser-

vices (HCBS) through the Older Americans Act. This funding provides help to those who need it for help with household chores and grocery shopping; transportation to essential services (such as grocery stores, banks, or doctors); and case management. The funding can also be used to vaccinate older Americans and address the effects of extended social isolation.

• \$44 million for evi-

dence-based health promotion and disease prevention. This includes programs to address fall prevention, managing a chronic disease, and programs to detect and reduce depression among older Americans.

• \$145 million to help family caregivers support their loved ones.

This funding for the National Family Caregiver Support Program will assist family and informal caregivers to provide in-home supports, including counseling, respite care, training and more.

• \$10 million to safeguard the health and welfare of residents in long-term care facilities. These funds will support State Long-term Care Ombudsman programs to advocate on behalf of residents of long-term care facilities across the country. This money will allow ombudsman programs that are advocating for residents to

safely go back into facilities ties to age in place for all after they had to discontinue that support during the pandemic, and continue to promote the health, safety, welfare, and rights of residents. The announcement co-

incided with a presidential proclamation honoring May 2021 as Older Americans Month.

"The proclamation recognizes that older Americans and families have faced substantial challenges during the last year, and their resilience and strength have made our country stronger," administration officials stated. "Older adults deserve to age with dignity and have equitable access to the longterm care system, regardless of race, sexual orientation or gender identity, disability, or socioeconomic status.

"The Biden-Harris Administration is committed to expanding access to health care, nutrition services, caregiving, and opportuniolder Americans."

• Expanded Funding for Home and Community Based Services.

· Increased Access to Affordable Housing for Seniors.

· Proposed Robust Investments in the Caregiving Economy.

Nordisk—began denying 340B discounts for drugs purchased by hospitals, community health centers and public health clinics that partner with community pharmacies to dispense certain outpatient drugs. Those denials have sapped resources from safety-net hospitals that are used to care for patients with low incomes and those in rural communities during the COVID-19 pandemic. 340B hospitals provide a

large proportion of hospital care for Americans in Medicaid and uncompensated and unreimbursed care.

In December, the HHS General Counsel issued an Advisory Opinion stating that drug manufacturers must provide 340B discounts for drugs dispensed

Texas Attorney General unblocks Twitter critics in Knight Institute v. Paxton Move signals victory in securing Texans' First Amendment rights

AUSTIN, Texas — Texas Attorney General Ken Paxton has unblocked the nine plaintiffs whom the Knight First Amendment Institute at Columbia University and the American Civil Liberties Union of Texas represent in an ongoing lawsuit challenging Paxton's practice of blocking critics from his Twitter account.

Paxton had blocked the plaintiffs from his @Ken-PaxtonTX account after they criticized him or his policies in their own tweets.

"We're pleased that attorney general Paxton has agreed to unblock our plaintiffs in this lawsuit and are hopeful that he will do the same for anyone else he has blocked from his Twitter account simply because he doesn't like what they have to say," said Katie Fallow, a senior staff attorney at the Knight First Amendment



Institute. "Multiple courts have recognized that government officials who use their social media accounts for official purposes violate the First Amendment if they block people from those accounts on the basis of viewpoint."

"This is a step in the right direction. Attorney General Paxton cannot prevent Texans from exercising their First Amendment rights, including their right to criticize his policies and qualifications in their responses to his tweets," said Kate Huddleston, attorney for the ACLU of Texas."It remains to be seen, however, whether the attorney general will unblock other Texans whose speech he's suppressed. It shouldn't take a lawsuit for Attorney General Paxton to comply with the Constitution "

As the complaint in the lawsuit explains, Paxton

uses the @KenPaxtonTX Twitter account to announce, describe, and defend his policies and legal challenges brought by his office; to comment on national and local issues; and to share news appearances and interviews related to his official duties. These tweets typically generate dozens, if not hundreds, of engagements on Twitter in the form of replies, likes, retweets, and quote tweets.

Some of the individual plaintiffs in the lawsuit found themselves blocked from Paxton's account after they tweeted their views about the top Texas law enforcement official's qualifications and policies, including tweeting about funding for lawsuits brought by his office; commenting on the fact that he was previously indicted; or tweeting "wear a mask nerd," after Paxton retweeted a photo of himself and another person at the Conservative Political Action Conference, with neither of them wearing masks. The U.S. Courts of Ap-

peals for both the Second and Fourth Circuits have held that public officials who block people from their official social media accounts based on viewpoint are violating the First Amendment, while the Eighth Circuit has adopted the same general framework for evaluating social media blocking by government officials. In Knight Institute v. Trump, the Second Circuit held that President Trump could not block users from his @realDonaldTrump account because "he disagree[d] with their speech." Earlier this year, the Supreme Court found the case to be moot and vacated the Second Circuit

The individual plaintiffs include a U.S. Army veteran, a journalist, a director of a Texas nonprofit, an immigration advocate, two students, a sales representative, a communications project assistant, and an attorney.

Rep. Sherman calls on Texas to 'make Juneteenth a state holiday'

AUSTIN – Juneteenth was recognized in the State of Texas as an official holiday on January 1, 1980. Currently however, the holiday is considered only a partial staffing holiday and government offices do not officially close on June 19th allowing instead for employees to officially celebrate only by choosing it as one of four optional holidays recognized by Texas.

State Representative Carl O. Sherman's (D-109) House Bill 736 encourages the passage of a paid Juneteenth holiday for public employees in the State of Texas.

"This Bill is important

in order to fully recognize Juneteenth as an important and recognizable holiday and not merely an added holiday that employees can choose to recognize as an option," Representative Sherman said.

House Bill 736 calls for the closing of state agencies and institutions of higher education for the observance of the Juneteenth Holiday.

To that end, State Representative Sherman will be supporting an upcoming inaugural Juneteenth Celebration March and Festival made possible by both The Blair Foundation and The Elite News as a reminder

of the importance of this holiday.

"It is about being respectful of our heritage and our culture," said Elite News' Editor-in-Chief Darryl Blair. "Dallas will be the epicenter for this Juneteenth celebration from all over Texas. Juneteenth is an example that if you don't

celebrate your own heritage and you don't bring respect to your own why should anyone else," Blair said.

Juneteenth is the oldest celebrated national remembrance of the ending of slavery in the United States.

ally see the contact between the motorist and protesters. It was after conferring with both parties, as well as reviewing video of the incident, that the assault charge was filed.

He also said the blocking of the intersection only lasted approximately seven minutes.

The fallout from this event continues to draw attention to the Scott case, and a family's efforts to find answers.

Scott had been arrested on marijuana charges following his interaction with officers from the Allen Police Department outside an

outlet mall. While in jail, officers said Scott began behaving strangely and was combative when they tried to restrain him.

Collin County's chief medical examiner, Dr. William Rohr, listed the cause of death as "fatal acute stress response in an individual with previously diagnosed schizophrenia during restraint struggle with law enforcement."

There were seven officers placed on leave and then fired after the death of Scott. However, one of the officers has since been brought back to the facility.

Elizabeth Michel, a fam-

ily friend, has been looking for answers from the Sheriff as to why.

"Well, now you have an employee that you terminated for violating 'wellestablished policies and procedures' back working in that facility," Michel wrote in an email. "So again, I ask you, what have you done to retrain, re-educate, and ensure that your officers know the training and follow the training? You are responsible for their behavior. What is your plan to fix this internally???"

As of press time, it was Michel's sixth attempt to get answers to these questions from the Collin County Sheriff's Office.

The headline in the article was headlined by the words "Kam on in." The "news" story claimed that migrant children were being given "welcome" packets with a copy of the Vice President's 2019 children's book, "Superheroes Are Everywhere."

Daniel Dale, a fact checker at CNN, pointed out that The New York Post "temporarily deleted, and then edited and republished,"

the debunked piece.

An editor's note at the bottom of the current version of the story now reads: "Editor's note: The original version of this article said migrant kids were getting Harris' book in a welcome kit, but has been updated to note that only one known copy of the book was given to a child."

A CNN poll released on April 30 indicates that the "big lie" strategy is working on some Americans. The question "Did Biden Legitimately Win Enough Votes for The Presidency," resulted in Republicans answering "no" 70 to 23 percent.

Consumer groundswell calls for end to bank-supported predatory loans OCC calls it 'True Lender,' but coalition says it's really 'Fake Lender'

Last October during the throes of the COVID-19 pandemic and its rippling economic downturns, a key federal financial regulator adopted a rule that blesses the "rent-a-bank" scheme where predatory lenders partner with banks to evade state interest rate limits.

Known as the "True Lender" rule, the Office of the Comptroller of the Currency (OCC) gave a green light to predatory lenders. It effectively overrides a string of state laws in almost every state enacted to end abusive payday, cartitle, and installment loans with explosive interest rates of more than 100%.

Taking effect in late December 2020, the rule facilitates a scheme whereby payday and high-cost installment lenders pay fees to banks for use of their name and charter to dodge state interest rate laws by claiming the bank's exemption from those laws for itself.

Ironically, the mission of the OCC is to ensure that national banks and federal savings associations provide fair access to financial services, treat customers fairly, and comply with applicable laws and regulations. Yet this OCC regulation helps predatory lenders evade state laws and harms consumers in direct violation of the agency's stated mission.

To more accurately describe how bank charters were used to sell predatory loans, consumer advocates refer to the rule change as a 'Fake Lender' as the real lender is the predatory nonbank lender – not a bank.

The OCC's ill-advised regulation has also unleashed a swarm of consumer advocacy from diverse spheres of influence but united in opposition.

For example, 138 academicians across 44 states and the District of Columbia registered their opposition to Rent-A-Bank and

include law professors from prestigious institutions such as Cornell, Columbia, Georgetown, Harvard, Howard, Notre Dame, and Northwestern. In an April 20th letter, the professors wrote in part, "If this Rule is not undone, it will spell disaster for untold numbers

of Americans who are trying to recover from this time of unprecedent health and economic disaster."

A day later on April 21st, a bipartisan group of 25 state attorneys general also urged corrective actions.

"During an unprecedented economic down-

turn, brought on and exacerbated by Covid-19, the OCC seeks to expand the availability of exploitative loans that trap borrowers in a never-ending cycle of debt," wrote the attorneys general. "We urge Congress to use its powers under the Congressional Review Act to invalidate the OCC's True Lender Rule and safeguard the right of sovereign states, and the ability of an independent judiciary, to safeguard our citizens from rent-a-bank schemes designed to work end runs around essential consumer protections."

The Congressional Review Act (CRA) enables rules to be rescinded with simple majority votes in both the House and Senate before advancing to the President for his signature. In late March, Representative Jesus "Chuy" García of Illinois and Maryland Senator Chris Van Hollen introduced joint resolutions providing for congressional disapproval under the CRA. Each awaits floor votes expected to occur in mid-to-late May to comply with the law's deadline for action within its allotted 60 legislative days.

Other organizations active in the regulatory reversal effort include: Conference of State Bank Supervisors, Credit Union National Association, Cooperative Baptist Fellowship, National Baptist Convention, USA, Inc., National Association of Federal Credit Unions, and Veterans Education Success

Consumer advocacy to reverse the "Fake Lender" rule reached a zenith on April 28 when a hearing was convened by the U.S. Senate's Committee on Banking, Housing and Urban Affairs. Its Chair, Sen. Sherrod Brown's opening

statement set the tone and purpose for the forum.

"Like so much we do, this comes back to one question: whose side are you on?", queried Sen. Brown. "You can stand on the side of online payday lenders that brag about their creativity in avoiding the law and finding new ways to prey on workers and their families. Or we can stand up for families and small businesses, and the state attorneys general and state legislatures who have said 'enough' and are trying to protect themselves and their states from predatory lending schemes."

Witness testimonies at the hearing made clear the concerns as well as the choices before Congress.

- member congregation but also Faith for Just Lending, a coalition of Christian denominations who believe that fair and just financial practices respect human dignity.

"For decades banks used maps to deny loans to communities of color and now they are using maps to serve as loan sharks of those same communities", testified Rev. Dr. Haynes. "That the OCC would make a rule giving predatory lenders a way to charge 200-400% interest and more, even in states that have fought hard to stop this predation with a 36% interest rate cap -- that is indeed obscene, and as we would put it in my faith community, sinful and demonic."

"We ask, finally, for your strong and proactive support of the Congressional Review Act that will overturn the OCC's true lender rule,", he continued, "and remember the wisdom of Thomas Piketty who warns, 'When private interests exceed the interest of the public, we cease to be a republic or a democracy'."

republic or a democracy'." Lisa Stifler, State Policy Director with the Center for Responsible Lending (CRL) reviewed her decade-long consumer advocacy, addressed which lenders benefit from the rule and their actions.

"How the OCC's rule will work is already clear, because OCC-regulated banks are enabling some of the most predatory loans on the market," noted Stifler. "For over a year, Stride Bank has been helping the payday lender CURO pilot installment loans of up to \$5,000 with rates as high as 179% annual percentage rate (APR). This outrageously priced loan is illegal in almost every state. Yet, the OCC rule invites predatory lenders to evade state laws by paying a bank to put its name on the paperwork."

"Another OCC-regulated bank, Axos Bank, rents its name and charter to the predatory small business lender World Business Lenders (WBL)," continued Stifler. "WBL loans range in the tens – even hundreds of thousands of dollars – and carry rates as high as 268%. Often secured by the borrower's personal residence, these loans are causing small business owners to lose their homes."

North Carolina Attorney General Josh Stein shared his state's experience with Rent-A-Bank before warning Senators of looming doom that would befall the nation if timely action was not taken.

"The OCC, through the Acting Comptroller, not only rammed through the Fake Lender Rule one week before the 2020 election, but it did so unlawfully," testified AG Stein. "The OCC radically exceeded its statutory authority in issuing the rule. Although the OCC purports to be interpreting portions of three federal banking laws, none of them authorize rent-abank schemes or give the challenges," said Guy Primus, CEO of Valence. "Companies are slowly understanding that merely hiring Black talent is not enough; they must help cultivate their success. The professional development, mentorship, and community provided by BONDS creates an enduring ecosystem, with professional and organizational success as the output."

"BONDS is an important step to how corporations can empower and retain great Black talent - helping them grow from emerging executives to senior leadership," said James Lowry, the first Black consultant hired by McKinsey in 1968, and now a senior advisor at The Boston Consulting Group and advisor at Valence. "Companies today recognize that diverse leadership is critical to their success. BONDS provides a comprehensive roadmap

"This rule, if not reversed, provides a get-outof-jail-free card to predatory lenders who violate state laws limiting interest rates and fees on consumer loans," Stein concluded.

Perhaps the most succinct summary of the day came from Chairman Brown.

"Some issues that come before this committee are complicated, they divide people, there are thorny nuances to consider" noted the Ohio Senator. "This isn't one of them. It's simple: Let's stop predatory lenders instead of encouraging them."

Here's hoping that it is just that simple when Senators on both sides of the aisle face a vote and opportunity to stand up for consumers.

race and culture, to hold a series of insightful conversations about sports and race in America. The virtual events will feature sports and entertainment figures, scholars and writers, preview clips from the film, and examine Ali's life and career in the context of America-and the worldtoday. PBS LearningMedia will also build out full educational materials focusing on the intersection of race and sports in 20th century America to support the film.

As with all Florentine Films productions, an accomplished group of historians, writers and other topic experts provided input on the script and film, including USC professor of media studies Todd Boyd, author Howard Bryant, Washington University history professor Gerald Early, long-time Burns collaborator and author Geoffrey C. NDG Book Review: 'The Final Revival of Opan & Nev'

It's got a good beat.

The melody is fun, too; it makes your body move, and you've already caught yourself singing along when you hear it again. That song's a hit, but in the new novel, "The Final Revival of Opal & Nev" by Dawnie Walton, there's still something off-key about it.

For most of her life, Sunny Curtis had "taken great pains to conceal" what had happened in 1970. It's not that she was embarrassed that her father and Opal Jewel had an affair – he was beaten to death at the Rivington Showcase, she



never even knew him – she just preferred to make her own mark. But after she became the first Black editor-in-chief at Aural magazine, Curtis realized that there was her chance to do something she couldn't do

Abrams and Rosaline "Roz" Brewer, chief executive officer of Walgreens Boots Alliance and the nation's third Fortune 500 company ever led by a Black female executive. The program will also honor the four African American, Greek sororities; Alpha Kappa Alpha, Inc., Delta Sigma Theta, Inc., Sigma Gamma Rho, Inc. and Zeta Phi Beta, Inc.

The show will also pay tribute to Hughes's mother, who before becoming a wife and mother, was a famed trombone player who played with an all-girl, integrated swing music band called the International Sweethearts of Rhythm in the 1930s and 1940's. Hughes called her mother's group, "the original Freedom Fighters" who traveled by bus through the South playing for audiences and even played clubs overseas. At one point, white and Hispanic band members had to wear dark makeup to look like their Black bandmates to avoid being stopped by police for promoting integration, Hughes recalled. The segment will be introduced by a longtime fan of the group, political activist, author and college professor Angela Davis.

Hughes's excitement about the upcoming evening is electric. An hour before "Urban One Honors" airs, TV One will broadcast an exclusive, hour-long interview with legendary rapper DMX. The interview was recorded for the network's weekly show "Uncensored" about three weeks before DMX's sudden death April 9 at age 50. The show's producers said DMX spoke, at times through tears, about his life, his music and his legacy. The producers said hearing DMX's commentary just weeks before his death, is more sobering and haunting today.

After the celebration of one of the kings of rap music with "Uncensored," the TV network will then celebrate its queens with the "Urban One Honors."

"I think it's going to be the biggest night in TV One's history," Hughes exclaimed.

Hughes, along with a group of Urban One executives chose the honorees because they wanted viewers, especially young girls, to see Black women who were not celebrated singers, dancers or actresses, but instead who were ideological firebrands, making differences in their communities and around the nation.

Nev Charles had grown up in Birmingham, England, and was a tall, geeky, red-headed fourteen-yearold the year he started writing songs for the Boys from Birmingham, a smalltime, local band. Rivington Records signed him but owner Howie Kelly wanted Nev to have a female singing partner.

Hughes described Abrams as "voting rights champion" who not only changed the political landscape of Atlanta, but also helped ensure all voters were recognized on behalf of two U.S. Senate Democratic candidates and helped flip Georgia from majority Republican to majority Democrat.

As a youth growing up in Washington, Ford volunteered serving and handing out meals with the nonprofit organization. Then in 2019, she was chosen as the company's president and chief executive. Prior to being named Martha's Table chief executive. Ford served as deputy assistant secretary and acting assistant secretary for the U.S. Department of Education's Office of Career, Technical and Adult Education where she oversaw management of more than \$2 billion in career and technical education, adult education, correctional and re-entry education and community college initiatives for more than 25 million students a year. pion of Black residents in the city, Simmons was elected alderman in 2017. Simmons then led Evanston to becoming the first U.S. city to approve a reparations program. Since taking office, Simmons led the passing of the nation's first reparations program, which will be funded by the first \$10 million of Adult Use Cannabis sales tax revenue Simmons is also the director of the city's innovation and outreach at Sunshine Enterprises, which has supported more than 1000 neighborhood entrepreneurs - 98 percent of whom are African American and 74 percent of whom are women in starting or growing their own business ventures.

Also being honored is New York Times journalist Nikole Hannah-Jones. Hannah-Jones covered racial injustice for the Times's magazine before convincing the paper's top editors to create an entire investigative series tied to the U.S. slave trade.
