As artificial intelligence (AI) technology has evolved, it has become so easy to use that what formerly required a studio and production team now costs very little and can be achieved in a few simple clicks. Improved access to AI and its ability to reach a tremendous number of people, makes it a powerful tool, which in the wrong hands, could overwhelm and confuse the public leading up to the Fall elections.

We will see AI coming at the public at an increasingly fast pace in this election, said Jinxia Niu, program manager for Chinese for Affirmative Action, a nonprofit civil rights organization. With the vast number of videos circulating demonstrating how to generate fake videos, AI has made it all too easy to saturate our information waves with false narratives.

The truth is under assault every single day, said Jonathan Mehta Stein, executive director of California Common Cause. The organization is a state initiative, which works to protect democracy rela-

tive to technology within California.

Just this week, the Department of Justice disrupted a Russian campaign that used fake social media profiles to promote pro-Russia propaganda. The campaign, operated by a single individual, generated thousands of fake posts, noted Stein, successfully targeting different races in regions across the country.

Now, it is a relatively simple matter for practically any individual to amplify their voice with the new, easy-to-use tools that are widely accessible. This means any conspiracy theorist, anyone running for political office, or any foreign state can easily undermine our elections, said Stein.

Artificial intelligence is an amazing tool that can be used to generate sometimes artistic, and sometimes bizarre creations, he said. The technology can range from simple algorithms used by companies like Netflix to make **See ELECTIONS, Page 7**

## **Duane Thomas**

Longtime Dallas Cowboys fans will be quite familiar with Duane Thomas, who passed away on Sunday in Sedona, Arizona.

No cause of death was announced as of press time, Thomas was 77 years old.

While he wore the number 33, he was a hometown hero, having been born and raised in Dallas.

He was a standout running back at Dallas Lincoln before heading off to college at West Texas State University (now West Texas A&M) where he played under Joe Kerbel, the

## Gov. Tim Walz

The National Newspaper Publishers Association (NNPA) has learned that Vice President Kamala Harris, the Democratic presidential candidate, has chosen Minnesota Gov. Tim Waltz as her running mate after much speculation and a whirlwind of last-minute vetting and interviewing candidates.

As of Monday, August 4, reports suggested that Harris had narrowed her choices to Walz and Pennsylvania Gov. Josh Shapiro. Other considered candidates include Transportation Secretary Pete Buttigieg and Arizona Senator Mark Kelly.



Walz provides the ticket with a diverse and extensive background. His career spans over two decades in the Army National Guard, including deployment overseas after the 9/11 attacks and a dedicated period as an educator and coach. His political journey began with a surprising victory over a six-term Republican incumbent in 2006, during a Democratic wave year. Walz maintained his seat in a typically red district until he ran for governor in 2018, after which the seat reverted to GOP control.

## **Justice Clarence Thomas**

U.S. Supreme Court Justice Clarence Thomas is under fire again. This time, it was because of the failure to disclose more private jet travel funded by Harlan Crow, a wealthy conservative donor, according to a letter from Senator Ron Wyden, a top Democratic senator.

Customs and Border Protection records indicate that Thomas and his wife, Virginia Thomas, flew between Hawaii and New Zealand in November 2010 on Crow's private jet. In his letter to the donor's lawyer, Wyden, a Democrat from Oregon, demanded more information about the financial relationship be-



tween Thomas and Crow.

The *New York Times* reported that the inquiry is part of a more extensive investigation by Wyden, who chairs the Senate Finance Committee, into the ties between Crow and Thomas. The scrutiny comes amid calls from top Democrats for significant Supreme

Court reforms, including establishing an enforceable code of conduct.

"I am deeply concerned that Crow may have been showering a public official with extravagant gifts, then writing off those gifts to lower his tax bill," Wyden wrote in his letter. He highlighted the potential conflict of interest and stressed the need for transparency and accountability.

In response, Michael Zona, a spokesman for Crow, stated that Crow's legal team had already addressed Wyden's inquiries, which they deemed legally unfounded and politically motivated. "We consider this matter settled and refer

After a contract dispute and an unsuccessful attempt at a trade deal with the New England Patriots, Thomas returned to Dallas in time to score the first touchdown at the new Texas Stadium.

Also due to the contract dispute, Thomas went notably silent during his second season with the Cowboys, refusing to speak to the media. However, his performance on the field created plenty of noise. Thomas led the league

with 13 touchdowns during the season, 11 of them being scored on the ground

by early 2023.

Forbes Magazine highlighted Walz's appeal as a moderate Democrat with a working-class background and rural roots, making him an attractive option for independents and moderate Democrats. Former Senator Heidi Heitkamp praised Walz for his relatable life (also top of the league). He gained 95 rushing yards and a touchdown in the Dallas Cowboys' first ever Super Bowl win, beating the Miami Dolphins 24-3. He was named All Pro for the season.

Notorious writer Hunter S. Thompson remarked of Thomas' performance that season, "All he did was take the ball and run every time they called his number—which came to be more and more often, and in the Super Bowl Thomas was the whole show."

According to the official Dallas Cowboys website, Thomas rushed for a total

Walz's political career began with a stint on former Massachusetts Senator John Kerry's 2004 presidential campaign. ## Mental health problems often go undetected in youth who die by suicide

(Newswise) — Three out of five youth who died by suicide in the U.S. did not have a prior mental health diagnosis, signaling missed opportunities to identify children and adolescents for suicide prevention strategies, including therapy or medications to treat depression.

This finding comes from an analysis of over 40,000 suicides by youth of 10-24 years of age from 2010 to 2021, recorded in the Centers for Disease Control and Prevention National Violent Death Reporting System. Results were published in the journal JAMA Network Open.

"We discovered that certain youth who died by suicide were less likely to have a documented mental health diagnosis, including those who used firearms,



were of minoritized race or ethnicity, males, and children younger than 14 years of age," said co-author Jennifer Hoffmann, MD, MS, emergency medicine physician at Ann & Robert H. Lurie Children's Hospital of Chicago and Assistant

Professor of Pediatrics at Northwestern University Feinberg School of Medicine. "Our findings point to the critical need to increase equitable access to mental health screening, diagnosis, and treatment for all youth." Dr. Hoffmann and colleagues found that two out of three suicides by firearms – the most common method used by youth in this study – lacked a preceding mental health diagnosis. The authors highlight the need to increase barriers to firearm access, especially given the impulsive nature of many youth suicides. They note that an estimated 22.6 million U.S. children live in households with firearms, and 4.5 million are exposed to firearms stored loaded and unlocked.

"To reduce the risk of youth suicide by firearms, counseling is needed to encourage parents to store firearms in the home safely. These messages should be delivered in community and school settings, in addition to doctors' offices," said Dr. Hoffmann. "Secure storage laws, also known as child-access prevention laws, have also been demonstrated to reduce firearm suicide rates, and more states need to enact this type of life-saving legislation."

Dr. Hoffmann also emphasized that to help prevent suicide, parents should talk more with their kids, especially with preteens and boys, about potential worries or distressing events kids might be experiencing.

"Stressful life circumstances can be risk factors for youth suicide, even in the absence of a mental health diagnosis," she added. "It is also important to bring preteens and teens in for a wellness check every year, so their pediatrician can screen for mental health issues."

Co-authors from Lurie Children's also include Elizabeth Alpern, MD, MSCE, and Karen Sheehan, MD, MPH.

# Something to chew on before you sink your teeth into those gummy vitamins

Newswise — Whether in the grocery aisle, at the pharmacy, or at a dispensary, little gummy treats containing vitamins, supplements, or THC have become ubiquitous. But do the benefits of gummies (and closely-related chewies) outweigh the risks they can pose to oral health?

Here's some advice from Aikaterini Papathanasiou, professor and chair of Tufts University School of Dental Medicine's Comprehensive Care Department, and Cheen Loo, professor and chair of Pediatric Dentistry at the School of Dental Medicine.

We hear all the time that sticky substances, especially those containing sugar, are bad for our oral health. Is that true?

Papathanasiou: Sticky substances that contain sugar can create oral health issues—especially issues related to the teeth, such as decay.

Loo: The bacteria in our mouth break down sugars and produce acid, which causes cavities, and that stickiness is also important. Do chewables and gummies affect other parts of the mouth, or just the teeth?

Papathanasiou: Chewables and gummies can mainly affect teeth, but they can also affect the gums around the teeth because sticky residuals stay between or around the teeth and near the gums. Gummies can also loosen fillings and crowns. If a patient has a new filling or a temporary crown and starts chewing on a gummy, it could pull out the filling or crown.

Are gummies and chewables as much of a risk to oral health as candy?

Loo: Because of the sugar content, I think gummies probably have the same risk as candy. Chewables are a little less risky because they're less sticky. And there's another alternative: dissolvable vitamins that do not contain sugar. They typically use plant-based sweeteners that don't cause cavities, instead of sugar. They're tablets that dissolve in water, or there's a kind that kids can let dissolve in their mouth. Do the benefits of gummy

or chewable vitamins and supplements mediate their oral health drawbacks?

Loo: For children, it is important to provide good nutrition, and if that's not possible with their regular diet, then it is important to have the supplements. Ideally, they should be taken with or after the meal, not as a snack.

Papathanasiou: It would would be better to avoid any gummies or chewables when possible, but the benefits of vitamins and supplements often outweigh the oral health drawbacks. It is important to consider other available options, including tablets and unsweetened alternatives. People should consult their primary care physician and their dentist. More specifically, they should ask their dentist about any concerns based on their oral health status, and if there are any concerns, find out how to maintain optimal oral health. For example, the dentist might prescribe a high-concentration fluoride

# ACLU launches major voter education campaign on abortion rights

The American Civil Liberties Union (ACLU), in collaboration with the ACLU Voter Education Fund and ACLU of Wisconsin, has announced a new seven-figure voter education campaign. The initiative aims to inform voters about candidates' positions on abortion rights in the upcoming 2024 U.S. Senate race and state legislative races across Wisconsin.

The campaign will com-



mence with a six-week hig radio advertisement featuring Wisconsin U.S. Senate tho candidates Eric Hovde (R) doe and Tammy Baldwin (D), cam

highlighting their stances on abortion rights. Although the ACLU said it does not endorse or oppose candidates, the effort by the ACLU Voter Education Fund seeks to provide voters with essential information on where candidates stand on crucial issues, par-

ticularly abortion rights. "The ACLU is engaging in these races because there's too much at stake in this election - most notably the right to essential, lifesaving healthcare," said Esete Assefa, chief political advisor at the ACLU. "Our goal is to ensure that Wisconsin voters have access to comprehensive information about where candidates land on abortion rights, enabling them to make an informed decision when they head to the polls."

The \$1.75 million campaign aims to reach over 1 million Wisconsin voters. It will target Assembly Districts 21, 26, 53, 61, 85, and 89, focusing on voter education about abortion rights. Additionally, the ACLU of Wisconsin has sent candidate questionnaires to all state assembly and Senate candidates to assess their positions on access to contraception and IVF, classroom censorship, and marijuana legalization, among other critical issues.

The campaign is part of the ACLU's broader \$25 million effort to safeguard and advance fundamental rights during the 2024 election. Officials said the pri-

# Biden and Harris celebrate return of Americans freed from Russia

Late Thursday night, August 1, President Biden and Vice President Harris welcomed home Americans freed from Russia in a historic prisoner swap. The White House emphasized Biden and Harris' commitment to reuniting every wrongfully detained or held hostage American with their families, showcasing a significant diplomatic achievement.

Officials said a complex negotiation involving sev-

en countries culminated in the release of Wall Street Journal reporter Evan Gershkovich, Paul Whelan, Alsu Kurmasheva, and green-card holder Vladimir Kara-Murza. The exchange, which took place at the international airport in Ankara, Turkey, saw 24 prisoners transferred from the United States, Germany, Poland, Slovenia, Norway, and Russia.

It also took place nearly 20 months after WNBA star Brittney Griner was released from a Russian penal colony in exchange for Viktor Bout. "Great day. It's a great day. It's a great day," Griner said. "We'll talk more about it later. But head over heels happy for the families right now. Any day that Americans come home, that's a win. That's a win."

Biden highlighted the unprecedented nature of the deal, marking the first time since the fall of the Soviet Union that Moscow freed prominent dissidents as part of a swap. In total, 16 people were released from Russian custody, including political prisoners who had endured years of suffering and uncertainty.

"Today, three American citizens and one American green card holder who were unjustly imprisoned in Russia are finally coming home: Paul Whelan, Evan Gershkovich, Alsu Kurmasheva, and Vladimir Kara-Murza," Biden announced. "This deal that secured their freedom was a feat of diplomacy. We've negotiated the release of 16 people from Russia, including five Germans and seven Russian citizens who were political prisoners in their own country."

The President thanked

the allies who supported the tough negotiations, including Germany, Poland, Slovenia, Norway, and Turkey. "This is a powerful example of why it's vital to have friends in this world whom you can trust and depend upon. Our alliances make Americans safer," he stated.

Biden also noted that Harris played a vital role in helping secure the release of the detainees. "They and their families have shown incredible courage in the face of atrocious and devastating circumstances," Harris said. The vice president and presumptive Democratic presidential nominee condemned the sham trials and long prison sentences imposed by Russian authorities, calling it an "appalling perversion of justice."

Harris also noted the inclusion of Russian political prisoners in the exchange, emphasizing the United States' support for freedom fighters in Russia. "Earlier today, I spoke with Aleksey Navalny's

# Bloomberg Philanthropies announces \$600 million gift to Historically Black Medical Schools

In a monumental move to address the underrepresentation of Black physicians in the United States, Bloomberg Philanthropies has announced a \$600 million donation to the endowments of four historically Black medical schools. Officials said the donation is part of Bloomberg Philanthropies' Greenwood Initiative, which aims to advance racial wealth equity and address systemic underinvestment in Black institutions and communities.

Howard University College of Medicine, Meharry Medical College, and Morehouse School of Medicine will each receive \$175 million, while Charles R. Drew University of Medi-



cine & Science will receive \$75 million. Additionally, Bloomberg said \$5 million in seed funding will support creating a new historically Black medical school in New Orleans, the Xavier Ochsner College of Medicine. The historic investment will more than double the endowments of three medical schools, significantly boosting their financial stability and capacity to educate future Black physicians

A recent study highlighted the need for such support, revealing that only 5.7% of U.S. physicians identify as Black or African American. This is despite Black Americans comprising 13% of the population. According to research, treating black patients by black doctors results in better health outcomes and more frequent medical care. For instance, Black patients are 34% more likely to receive preventative care if they see

Black doctors.

The four historically Black medical schools receiving funding reportedly graduate around half of all Black doctors in the U.S. but have been traditionally underfunded due to systemic inequities, including be lower federal and state support. Since the early 1900s, discriminatory practices and the impacts of the Flexner Report have led to the closure of 10 Black medical schools in the United States. The financial boost from Bloomberg Philanthropies should have a transformative impact.

Michael Bloomberg, the former New York City mayor, Democratic presidential candidate, and founder of Bloomberg LP, will formally announce the donation at the National Medical Association's annual convention. "This gift will empower new generations of Black doctors to create a healthier and more equitable future for our country," Bloomberg said.

In 2020, Bloomberg Philanthropies granted \$100 million to these same medical schools to reduce the debt load of enrolled students facing severe financial burdens exacerbated by the COVID-19 pandemic. Valerie Montgomery Rice, president of Morehouse School of Medicine, noted that the 2020 gift relieved an average of \$100,000 in debt for each student, significantly enhancing the school's ability to fundraise and support its students.

Denise Smith, deputy director of higher education policy and senior fellow at The Century Foundation, emphasized the importance of such philanthropic gifts. She pointed to MacKenzie Scott's donations to HBCUs in 2020 and 2021 as pivotal in sparking increased support from other large donors. "Donations that have followed are the type of momentum and support that institutions need in this moment," Smith told the Associated Press.

Dr. Yolanda Lawson, president of the National Medical Association, expressed relief upon hearing about Bloomberg's gift, especially in light of the Supreme Court's recent decision striking down affirmative action and attacks on programs promoting inclusion and equity.

"This opportunity and this investment affect not only just those four institutions but our country's health and future," Lawson asserted.

# Early childhood education endures during natural disasters

AVANCE-Houston, leading national non-profit organization working to transform the lives of underserved, under-resourced families, has experienced two major natural disasters in recent months: a derecho and then Hurricane Beryl. The executive director, Luz Flores, shared that out of their 18 centers, only six had power. Staff and families were similarly affected, with many lacking basic utilities during a time of an extreme heat warning

AVANCE's Head Start program is for children three to five years of age. The program prepares young children to enter kindergarten by helping them develop mentally, socially, emotionally, physically, and ultimately, school ready. Its Early

Head Start program promotes healthy prenatal outcomes and enhances the development of infants and toddlers from 6 weeks old to 3 years old and pregnant women, to create a healthy family environment. This program is offered in two different settings:

• Early Head Start Center-based is where services are in child development centers. More than half of the children are enrolled in center-based services, five days per week for at least six hours per day.

• In Early Head Start Home-based, services are mostly delivered in a family's own home, along with planned group socialization activities.

Both Early Head Start home- and center-based

include educational, developmental, nutritional, mental health and wellness. social and prenatal support services. With over 2,000 families served by nearly 400 employees, AVANCE has overcome significant hurdles because of the severe weather, including power outages, disrupted communications, and insurance claim difficulties. Despite these challenges, Luz emphasized the resilience and dedication of their team, who worked from home and assessed the situation via crisis teams. They sent out surveys to understand the impact on families and disseminated critical information through their mobile app and social media, both in English and Spanish.

Luz highlighted the importance of prioritizing employees' well-being, stating, "If employees can't take care of themselves and their families first, they can't take care of others." She remains optimistic, expressing gratitude for her resilient and committed staff, her resourceful Advisory Board, and other organizations, including the National Head Start Association (NHSA), for their continued support.

"NHSA always reaches out, and they're always available to help," said Luz. "When we were hit with these storms, they checked on us, provided resources, and helped us find funding sources." When natural disasters impact member Head Start and Early Head Start programs, NHSA is there to help with recovery through the Disaster Relief Fund. The funds are available for the program, employees, and families. The importance of this fund cannot be overstated, especially as more named storms and hurricanes are expected this season based on the National Hurricane Center's early forecast.

Programs that experience a natural disaster are encouraged to apply for the Disaster Relief Fund. This resource can provide essential support during challenging times, helping programs, employees, and families recover and rebuild. NHSA applauds Luz and her team for their courage and commitment to charting a path out of this crisis for AVANCE and the families while dealing with the impact of the hurricane personally. Their resilience inspires all in the face of adversity.

## Feature Allred leads bipartisan push to counter PRC investment in Africa releases mid-year report online

Washington, DC - Today, U.S. Representatives Colin Allred (TX-32) and Young Kim (CA-40), members of the House Foreign Affairs Committee, introduced the Stopping PRC Environmental Exploitation and Degradation Act (SPEED) Act to combat the negative environmental, ecological, and public health effects of investments linked to the People's Republic of China (PRC) in Africa.

The PRC has become Africa's largest trading partner, creditor, and source of foreign direct investment through the Belt and Road Initiative. The PRC's debt-trap diplomacy, often executed through corporations, can be destructive and harmful to local communities and key biodiversity areas.

"We cannot allow the People's Republic of China and Chinese-linked companies to continue their exploitation of African nations



as they subject their people to harmful ecological and public health risks," said Rep. Colin Allred. "The bipartisan SPEED Act will strengthen U.S. policy, authorize sanctions and hold the Chinese government accountable for the adverse environmental, ecological and public health incidents

film recommendations to more complex systems that can predict crime or help sustainable energy systems run smoothly. AI can also save manpower, which could help local government serve the public more efficiently, he added.

Even so, AI can have devastating effects. Take the last Presidential primary, when a spoof robocall using an image of Joe Biden directed New Hampshire Democrats not to vote. And a May 2023 deep fake even set off a dip in the stock market after convincing investors momentarily that the Pentagon was under attack.

Dangers may be most evident at the local level while fakes targeting higher offices will most likely be exposed quickly. Deep fakes targeting local officials or state representatives will take longer to surface, said Stein, making political impacts greater in state or local communities.

As the election draws near, new fake media websites are emerging, like the Miami Chronicle, a fake local news site created by Russian intelligence to carry propaganda. Stein recommends people be on the lookout for these sites. as well as fake county election sites attempting to confuse or influence voters.

Targeted for centuries, voters of color and immigrants face particular threats as political players attempt to make it harder for these groups to vote. Stein said AI technology brings new and crafty ways to achieve such goals.

Examples include multiple deep fakes that have been circulating to create a false narrative that the former president has more support in the Black community than he has.

color. AI technology continues to grow, making images and audio more realistic, adds Stein, and unless people know what to look for, it will be difficult to tell whether the images are real. Upon close examination, people may look idealistic almost cartoonish, with every hair in place. Certainly, perusing images on a small phone screen or quickly scrolling through Twitter, will make spotting such images very difficult.

Such misinformation campaigns are not unique to the U.S., said Stein. In India, deep fakes have emerged front and center as voters are bombarded with millions of fake videos surrounding the elections. Candidates have begun to embrace the fakes as a means of keeping up with the race, including candidates who prefer not to use them but feel they have no low Xi Jinping to get away with growing his global power and violating international environmental and labor laws in the process. I am proud to lead the SPEED Act to counter the Belt and Road Initiative and hold the PRC accountable for its exploitative practices, deliberate environmental degradation, and threat to African communities' livelihoods." The SPEED Act would

India serves as an example of what could happen if the public is not educated on AI technology, said Stein.

Political information found on social media should be approached with skepticism, Stein warns, and images too good to be true should be scrutinized, especially when reposting. Stein urges that when people see an image of political leaders in an activity that could harm them, they should get out of the social media environment and check the story with an objective or trusted media source.

A common goal of players who seek to mislead about politics is to saturate society with so much misinformation that people don't know what to believe, added Brandon Silverman, policy expert on internet transparency and former CEO of CrowdTangle, a social analytics tool acquired by Facebook.

such misinformation falls into a gray area. Silverman refers to the use of information that is not literally untrue and doesn't break any rules, but that is simply misleading. It's the difference between saying the moon is made of cheese and that some people are saying the moon is made of cheese, he explained. There is a tremendous amount of misinformation that is achieved in this way, he said.

As the issue peaks, social media platforms are walking away from the responsibility of addressing the problem, Stein added. Youtube, Meta and X have all stopped labeling and removing posts that repeat Trump's claims about the 2020 election. Twitter has stopped utilizing a tool that identifies disinformation on its platform, while Facebook has made some factchecking features optional. And all of the platforms have laid off key members of their trusted safety and civic integrity teams.

If social media platforms aren't going to take responsibility for the problem, Stein asked, whose job is it to protect our communities?

The current saturation of AI in our political discourse requires policy changes, said Stein. The State of California has legislation in the works that would offer some protections. Yet building a system to track political disinformation is more difficult than just flagging certain words, he said. Deciphering intended meaning in political discourse is complicated, requiring a great deal of work.

It seems that for those who rely strictly on social media to get their news, AI has the power to create a false reality that is too easily believed by the masses. It is a problem that has perhaps grown too big for policy solutions, and it may be up to trusted leaders and the media to help make communities aware of the problem.

Senator Wyden to our previous correspondence," the statement read. Zona also insisted that Crow had always adhered to applicable tax laws.

Thomas has previously argued that he did not need to disclose personal hospitality gifts from friends who had no pending cases before the Supreme Court. By law, Supreme Court justices are required to fill out an annual financial disclosure form listing outside income sources and gifts. However, Thomas's form for 2010 does not mention any flights on Crow's jet.

Wyden drew attention to this discrepancy by pointing out that Thomas had updated earlier records to include additional international travel that Crow had provided. "To date, Justice Thomas has never disclosed this private jet travel on any financial disclosure forms, even though Justice Thomas has amended disclosures to reflect other international travel on Mr. Crow's private jet," Wyden wrote.

The controversy surrounding Thomas's undisclosed travel highlights broader calls for Supreme Court reform. President Joe Biden has recently advocated for substantial changes, including a constitutional amendment to limit presidential powers and ensure former presidents are not immune from federal criminal proceedings. In an op-ed, Biden emphasized the need for reforms to restore public trust in the judiciary.


"I served as a U.S. senator for 36 years, including as chairman and ranking member of the Judiciary Committee. I have overseen more Supreme Court nominations as a senator, vice president, and president than anyone living today," Biden wrote. He stressed that current issues undermine public confidence in the court's decisions, affecting personal freedoms.

Biden's proposals include term limits for Supreme Court justices, suggesting 18-year terms to prevent any single presidency from exerting prolonged influence. He also called for stringent ethics requirements for Supreme Court justices, like those governing other federal judges.

President Biden is set to discuss these proposals further in a speech at the Lyndon B. Johnson Presidential Library in Austin, Texas, part of the 60th anniversary celebration of the Civil Rights Act. The event, initially planned for mid-July, was postponed following an alleged assassination attempt on former President Donald Trump at a Pennsylvania rally.

Despite the presidential push for the reforms, passing such legislation through a divided Congress remains a significant challenge. Senate Democrats proposals but acknowledge the political hurdles ahead. Democratic presidential nominee Kamala Harris has endorsed Biden's call, emphasizing the importance of restoring public confidence in the judiciary. "Our democracy de-

pends on the integrity of our institutions," Biden stated. "This is not just about reforming the Supreme Court—it's about safeguarding the future of our nation. We must act now to ensure justice and fairness for all Americans."



# Federal appeals court blocks SAVE program's student loan forgiveness

18 conservative states win temporary stay to deny relief to millions of borrowers

By Charlene Crowell

Higher education is believed by many to be a bridge to a financially secure future. But for the more than 43 million Americans who together owe \$1.6 trillion in student debt, that bridge gets longer and harder to cross when federal courts continue to block programs designed to relieve borrowers of the rising costs of loan repayment.

Until recently, student loan borrowers enrolled in the Education Department's Saving on a Valuable Education (SAVE) payments cut in half and their remaining loan balances forgiven. The SAVE Plan offered forgiveness for qualified borrowers with loans up to \$12,000 and promised that loan balances would not increase due to accrued interest if borrowers remained current on required payments. The Plan changed income calculations so that more borrowers would qualify for reduced payments - sometimes as low as \$0. About 8 million borrowers are enrolled in the SAVE Plan.

But on July 18th, the Federal 8th Circuit Court of Appeals issued a temporary stay to halt the SAVE program. It is not yet known when a final court resolution will occur.

The decision came at the behest of several conservative state attorneys general. To date, 18 states – including those with large Black and Latino populations like Alabama, Florida, Georgia, Louisiana, Missouri, Ohio and Texas – have challenged the SAVE program's constitutionality, as well as President Biden's executive authority.

"It wasn't so long ago that a million borrowers defaulted on their student loans every single year, mainly because they couldn't afford the payments," stated Secretary of Education Miguel Cardona. "The SAVE plan is a bold and urgently needed effort to fix what's broken in our student loan system and make financing a higher education more affordable in this country."

"Already, we've approved an unprecedented \$169 billion in relief for nearly 4.8 million Americans, including teachers, veterans, and other public servants, students who were cheated by their colleges, borrowers with disabilities, and more," continued Cardona. "And from larger Pell Grants to free community college, President Biden, Vice President Harris, and I continue to believe that college affordability is a cause worth fighting for – and we're not giving up."

The Department simultaneously announced the following administrative adjustments for SAVE program participants:

· Forbearance: Borrowers enrolled in the SAVE plan are being moved into forbearance. During forbearance, SAVE borrowers will not have to make payments. The time in forbearance will not count toward Public Service Loan Forgiveness or Income-Driven Repayment (IDR) loan forgiveness. SAVE borrowers will not accrue interest on their loans during the forbearance. SAVE borrowers will be notified about their forbearance by their loan

### servicers.

• Bills and payments: Borrowers enrolled in the SAVE Plan who have received a bill for August are being put in an interest-free forbearance – payments are not required during forbearance. Borrowers enrolled in the SAVE Plan who have not yet received a bill for August will also be put in forbearance and therefore will not receive a bill.

Borrowers affected by this court decision should hear from their loan servicers and/or the Department in coming days. Updates to these developments also will be posted at https://www.ed.gov/save.

The court decision was met with swift and emphatic opposition from advocacy groups.

"The role of government

is supposed to be to help its citizens, not cause intentional, undue harm," said Kristin McGuire, Executive Director of Young Invincibles, a national advocacy organization founded in 2009 that works to amplify the voices of young adults in the political process and expand economic opportunity. "Legal challenges to for-

"Legal challenges to forgiveness were to be expected, but it is disheartening to see our judicial system put politics over people time and time again," McGuire added. "Continually halting student debt forgiveness is reckless and cruel for borrowers, and jeopardizes the economy and the future of our higher education system."

Earlier, the ACLU of Marvland launched the Election Protection campaign, a statewide effort to reduce barriers to voting and combat voter disenfranchisement, particularly for Black, Indigenous, and People of Color (BIPOC). voters who are currently or formerly incarcerated, and people with disabilities. Officials said the Maryland campaign educates voters about their rights, advocates for equitable and accessible voting options, assists residents with questions and concerns, and addresses issues through

investigations and legal advocacy.

The ACLU of Maryland's Election Protection Hotline, (667) 219-2625, is available for residents to call with questions or concerns about voting in Maryland. Hotline staff provide information about voter eligibility, voter registration, voting by mail, early voting, Election Day, drop boxes, and more. Officials asserted that the Election Protection Team has worked diligently to reduce barriers to voting and fight against voter disenfranchisement, as documented in the 2022 Election Protection Report.

The ACLU has also made significant progress in increasing access to the ballot box in other areas, including Virginia. The organization successfully lobbied for same-day voter registration and no-excuse absentee voting in 2020, moving Virginia from one of the most difficult states to vote in to the top half of states with expanded voting access. They have challenged unconstitutional gerrymandering efforts and joined the League of Women Voters to ensure the CO-VID-19 pandemic did not prevent vulnerable people from casting their ballots.

However, officials said challenges remain. The ACLU notes that Virginia retains a Jim Crow-era law that bans individuals convicted of a felony from voting for life, unless the governor restores their rights. This law, enacted in Virginia's 1902 constitution, was designed to prevent Black Virginians from voting. Overturning it requires a constitutional amendment, according to the ACLU.

They said the ACLU's ongoing efforts are "crucial for protecting and expanding voter rights and ensuring a fair and just electoral process for all citizens."

toothpaste, in addition to providing oral hygiene instructions for flossing and brushing.

It sounds like it depends on each patient's individual health situation.

Papathanasiou: Yes, and as dentists, we want to make sure that people who consume gummies brush and floss regularly, and again, take the gummy as part of a meal, rather than as a snack. Rinsing with water and chewing sugar-free gum after meals also helps: chewing gum stimulates salivary production, which helps to neutralize acids and removes food particles. And always consider using sugar-free chewables or gummies.

What about the benefits and drawbacks of gummies and chewables for children who struggle to swallow pills but need to take medication or supplements orally?

Loo: Medication compliance is very important. Parents can ask the pharmacy about sugar-free or liquid versions of their children's medications. A lot of liquid medications are sweetened,

but some use alternative sweeteners. Liquids flow through the mouth, leaving more quickly than chew-

ies—and most kids drink water after taking medication, which washes it away from their teeth.



Remember God's love is everlasting and far reaching. It will touches your soul and lift your spirit.


God has give each person a gift and it is up to that person to use their gift to shoe God's love to His people.


You can kick a ball harder than any kid you know.

Track and field star Wilma Rudolph had polio when she was young, and had to re-learn how to walk. Little Usain Bolt was such an active kid that his parents were concerned but when he was just chilling, Bolt only wanted to play arcade games.

Paralympic wheelchair racer Tatyana McFadden was born with spina bifida, which left her paralyzed from the waist down. Because of that, her first years were spent in an orphanage,



where she didn't even have clothes of her own. She was five years old when she was adopted and brought to America.

Gymnast Nadia Comăneci once tried to climb a Christmas tree, and her mother knew little Nadia needed an "outlet for her energy" so she took Nadia to the gymnasium. Swimmer Michael Phelps likewise "simply could never sit still." Megan Rapinoe was an athletic kid who learned soccer by copying her soccer-playing older brother.

And little Simone Biles? Early in life, she spent time in a foster care home where there was a trampoline to play on. When her grandparents adopted her, she was excited to find a trampoline there, too. She "twirled and flipped and somersaulted" for hours before becoming the G.O.A.T of all G.O.A.Ts. Your child is riveted to the television this summer, cheering on their favorite athletes half a world away. Wouldn't your young fan love to know more about their favorite athletes? Sure they would, and "Kid Olympians: Summer" is the perfect companion for this years' games.

This is the book for kids who run, jump, tumble, slide, whack, leap, and twirl, because author Robin Stevenson lets children know that their heroes were once active kids, too, and that their needs to go-gogo sometimes got-got-got them into trouble. Some of the stories are funny, but most are inspiring for a variety of reasons, and will teach kids about overcoming bad situations; that there's some history to be had isn't a bad thing, either. 

Other organizations urged the Biden administration to stand against those seeking to block this needed loan relief.

"Right-wing politicians are using the courts to wreak havoc on the student loan system and put the economic stability of tens of millions of borrowers and their families at risk, said Persis Yu, Student Borrower Protection Center's Deputy Executive Director. "Make no mistake: these lawsuits are shameful political gamesmanship designed to hurt President Biden at all costs, and borrowers are merely collateral damage."

"These lawsuits reinforce an oppressive student loan repayment system that favors the interests of big businesses at the expense of low-income borrowers and borrowers of color," said Nadine Chabrier, Senior Litigation and Policy Counsel at the Center for Responsible Lending. "By choosing to protect the profits of exploitative loan servicers over students seeking relief from excessive loan repayments that limit their financial options, courts have created further confusion in a system that already was failing to effectively administer loan repayments or provide accurate information to borrowers about the status of their loans."
